There is attached a letterhead memorandum dated June 13, 1968, for the Attorney General, the Deputy Attorney General, Assistant Attorney General Pollak of the Civil Rights Division and Assistant Attorney General Vinson of the Criminal Division, setting forth results of the investigation conducted in Portugal concerning James Earl Ray.

The investigation was conducted by the Portuguese International and State Security Police and was made available to our Legal Attache, Paris. The memorandum shows that Ray arrived in Lisbon, Portugal, on May 8, 1968, and departed Lisbon en route to London on May 17, 1968; that he was issued a new passport by the Canadian Embassy in Lisbon since the original passport allegedly misspelled the last name he was using as Sneya rather than Sneyd; that he displayed a Canadian birth certificate in the name of Ramon George Sneyd; that he frequented bars or night clubs where he could pick up girls and was in the habit of staying out late at night and sleeping late during the day; and that inquiry had been made at the Rhodesian Mission in Lisbon but that employees there failed to recognize the subject's photograph, and there was no record of any inquiry having been made by Investigation previously revealed that Ray had exhibited interest in going to Rhodesia. During the inquiries in Portugal, particular attention was given to attempting to determine if subject was alone or was accompanied by other individuals. It was ascertained he was alone in all instances except those described above.

On the completion of the extradition hearings in London, the problem of safely returning subject James Earl Ray to the United States is of great concern. In view of this, I want to bring your attention to certain matters which will arise in connection with the subject's transportation. These relate to the objective of expediting the return of Ray to the United States once the order of extradition has been finalized.

In view of the above, it is suggested consideration be given to immediately resolving certain problems which may arise.

It would appear that the use of military aircraft would be more desirable in order to afford appropriate security. Necessary arrangements will have to be made with the United States Air Force for the aircraft to be used, insuring that it is appropriately staffed and equipped for the mission involved. Arrangements should be made through the British authorities to accomplish any necessary immigration exit controls such as validating Ray's certificate of identity at the London prison where he is incarcerated.

Arrangements should be made for a medical doctor appropriately equipped to accompany the subject and the escorting officers. Arrangements should also be made in connection with his entry into the United States with necessary Immigration, Customs and United States Public Health authorities.

If military aircraft is utilized, greater control can be exercised upon arrival in the United States over the subject, as well as in departing from London. It would be most difficult to maintain such control and a high degree of security in the event he

is transported by commercial airliner. All personnel on military aircraft can be screened. This would be impossible upon commercial aircraft. It would also be most difficult to control the departure crowds as well as the arrival crowds which would assemble in the United States as well as in London.

The escorting officers should be equipped with proper written authority to escort the prisoner to be presented to the British authorities. This authority should be in such form as is acceptable to the British in order to avoid any delays in obtaining custody of the prisoner at the time of extradition.

It is obvious that in order to insure that the subject will not in any way harm himself that the proper restraining devices must be employed. Such devices must necessarily be used to the degree necessary and according to the judgment of the transporting officers.

Upon arrival, arrangements should be made at the final destination for subject Ray to be given a thorough medical examination as proof of his safe delivery in good condition to local authorities.

The extradition hearing in the matter involving the subject James Earl Ray is set for June 27. If successful there is a mandatory waiting period of 15 days within which the defendant has a right to file an appeal. After this is resolved, then there usually is a 5-day waiting period until the Home Office signs the papers making the order of extradition official and it can be expected there may be delays for several days after this for the order to be returned and so forth.

Once the above is resolved, the question of who will transport the prisoner and return him to the United States has not been resolved. It is recalled the FBI sent two Agents to London on short notice for the purpose of being available to return the prisoner to the United States with the assistance of the Legat and another Agent in London. These four would be available and could adequately handle the prisoner for such a return. It should be recognized that their presence in London was required on short notice in contemplation of a deportation proceedings. Such did not take place and in the meantime the Department through its insistence was successful in seeking a removal on the basis of an extradition proceeding. This is presently in the mill.

DOES THE FEI HAVE AUTHORITY TO TRANSPORT RAY

There is a real question as to whether the FBI has any authority whatsoever to return Ray to the United States following a successful extradition hearing. The request for extradition is based upon two charges: (1) that Ray is wanted for the murder of Dr. Martin Luther King, and (2) that he is an escapee from the Missouri State Penitentiary at Jefferson City, Missouri. If either or both of these charges are supported, there is nothing that has been indicated to us by the Department which would suggest that we are to remove the subject.

It is also doubted whether the Department has any authority to designate the transporting authorities. This, of course, would depend on the authorities demanding his return. As we understand it, the United States Government merely acts as a transmission belt through accepted diplomatic channels and uses the Department of Justice as the vehicle through which any request for extradition is brought about on behalf of the demanding authorities which in this case is the State of Tennessee and the State of Missouri.

We have no request from either of the above jurisdictions to bring Ray back to the United States on their behalf.

The responsibility for extradition is a great one and there is no doubt the FBI can effectively handle it. Nevertheless, there are these questions which must be resolved from a jurisdiction standpoint before Ray is returned. There is ample time to resolve these matters and it would appear to be desirable that these matters be resolved at this time well in advance so that appropriate steps may be taken by the transporting agency, whoever that may be.

ACTION TO BE TAKEN:

It is recommended that these matters be taken up with the Department and confirmed thereafter in writing so that the Bureau will know without equivocation and in writing our responsibility, if any, for the returning of Ray.



FINGERPRINT TESTIMONY AT EXTRADITION HEARING

As you are aware, the testimony of the latent fingerprint examiner who effected the identifications with the fingerprints of James Earl Ray, has been requested in connection with the extradition hearing for Ray in London on June 27, 1968.

Fingerprint Examiner George J. Bonebrake is scheduled to arrive London at 8:05 A.M., on June 24, 1968. The attorneys in London have requested that Bonebrake be available for conferences two days prior to the hearing, and, inasmuch as all flights to London on June 24, 1968, are filled, it is necessary for the examiner to take a flight leaving Washington, D. C., the evening of June 23, 1968. Legat, London, advised by cablegram today.

Bonebrake is taking the following listed items as possible aids to his testimony:

Charted enlargements illustrating the identification of latent fingerprints on the rifle,
telescopic sight for the rifle, and the binoculars

John T. Minnich, Legat, London, advised that Agents Kenneth Bounds and George Zeiss will arrive at Dulles Airport at 5:15 p.m. tonight.

The Consul General of the American Embassy, Jack Herfurt, apparently is reporting any developments telephonically to Fred Vinson of the Department.

The British Attorney General, Sir Elwin Jones, conferred with U.S. Minister Kaiser and Berfurt and told them subject Ray was most uncooperative. He referred to the request that representatives of the American Government be allowed to interrogate Ray and indicated that there was little likelihood that this could occur prior to extradition on June 27; however, if the American Government would insist on interviewing Ray this would be given consideration to the extent that perhaps after extradition is ordered, assuming it is on June 27, he would favorably consider such a request.

John Minnich, Legat, wanted to know what position to take with reference to this. I advised him to make no comment with reference to his views but to point out that this matter is in the hands of the Department of Justice and any inquiry should be directed to the Attorney General of the Department of Justice.

Minnich stated that as a matter of cooperation Sir Elwin Jones wanted background information on attorney Arthur Hanes. We have previously advised him that he was a former Mayor of Birmingham, represented members of the Klan, and had been the defendants attorney

in the Liuzzo Civil Rights case. This was a matter involving the killing of Mrs. Liuzzo, who was working in the area on behalf of the civil rights movement. He said he specifically wanted to know whether he had a criminal record, date and place of birth, whether he has been issued a passport, and the passport number. I advised him that this would be checked and he would be advised.

Minnich inquired as to whether he could be furnished with the flight number and time of arrival of Fingerprint Expert George Bonebrake. Bonebrake's testimony is needed on June 27th in connection with the extradition and he plans to leave on June 25th. Flight number and time of arrival will also be furnished. It is noted the British authorities requested he be there two days prior to the hearing for a conference.

In a communication dated June 18, 1968, Mr. Fred M. Vinson, Jr., Assistant Attorney General, Criminal Division, Department of Justice, attached a telegram from the U. S. Embassy in Lisbon, Portugal, to the Department of State concerning the possibility of news stories in this country alleging United States authorities knew of Ray's presence in Portugal but took no steps to have him apprehended because of the weakness of the Portugal-United States extradition treaty.

No record has been located of any such news report in the files of this Bureau. This Bureau has at all times vigorously pressed this case both domestically and in foreign areas, through close cooperation with appropriate foreign authorities, in order to bring about the immediate apprehension of the subject whenever and wherever he might be located. The telegram from the American Embassy in Lisbon which was attached to the memorandum clearly states that reporters were unable to obtain anything in Lisbon other than local color.

On June 1, 1968, we learned that a Canadian passport was issued for subject in the name of Ramon George Sneyd for travel from Toronto, Canada, to London, England, on May 6, 1968. We learned that subject, on May 6, 1968, departed Toronto, Canada, and arrived in London, England, on May 7, 1968. He then departed London for Lisbon, Portugal, on May 7, 1968. It is to be noted that Ray returned from Lisbon to London, England, on May 17, 1968, and remained in London until his apprehension on June 8, 1968.

From the above it can be seen that Ray had already completed his travels to Lisbon, Portugal from London, England, and returned before the Bureau had received any information on his travels in this regard.

Reference is made to your memorandum of June 18, 1968, concerning possibility of news stories being reported in this country alleging that United States authorities knew of James Earl Ray's presence in Portugal but took no steps to have him apprehended because of the weakness of the Portugal - United States extradition treaty.

This Bureau has at all times vigorously pressed this case both domestically and in foreign areas, through close cooperation with appropriate foreign authorities, in order to bring about the immediate apprehension of the subject whenever and wherever he might be located. The telegram from the American Embassy in Lisbon, Portugal, which was attached to your memorandum, clearly states that reporters were unable to obtain anything in Lisbon other than local color.

For your information, on June 1, 1968, we first learned that subject was possibly issued a Canadian passport using the name of Ramon George Sneyd for travel from Toronto, Canada, to London, England, and return. Subsequent investigation determined that Ray returned to London, England, from Lisbon, Portugal, on May 17, 1968, which was prior to the date we learned of the Canadian passport.

A report concerning the details of subject James Earl Ray's apprehension in England is being obtained and will be forwarded to you upon receipt.

The attached memorandum is being furnished to Assistant Attorney General Stephen J. Pollak of the Civil Rights Division with a copy to Assistant Attorney General Fred M. Vinson, Jr., of the Criminal Division.

The Department is being advised of the closing of the tavern operated by the subject's brother, John Larry Ray, after three carloads of Negroes were reported to be observing the tavern; that the news report of his brother receiving a telephone call from a friend in Canada is false; that his brother is not planning a trip to London, contrary to press reports; that sources in England state his brother would not be given permission to visit the subject if he did come to England; that Attorney Arthur J. Hanes, Sr., of Birmingham, Alabama, intends to apply for a passport for himself and his son for travel to England in connection with his reported representation of the subject; and that the subject appeared in London on 6-18-68, on the local charges and was given a remand until 6-27-68.

Legat, London has also received information in the strictest confidence that Ray wrote the Birmingham, Alabama, Bar Association requesting assistance and suggested his letter be forwarded through former Birmingham Mayor Hanes. apparently refers to Arthur J. Hanes, Sr. London sources also advised that the subject refused to see two Scotland Yard officers on 6-14-68 and stated he would refuse to see FBI Agents if they asked to see him. Since the information has been furnished in confidence, it is not being given the Department.

A telephone number written in Portuguese, which was among notes found in Ray's possession when he was arrested, has been determined to be the telephone number of the South African Embassy in Lisbon, Portugal. That Embassy has no

knowledge of Ray. A check of banking institutions in Lisbon relative to Ray has been unproductive to date.

The following additional pertinent information is being furnished relative to captioned case. The material set forth herein is based on preliminary information and complete details will be incorporated in reports of results of investigation.

The Grapevine Tavern operated by the subject's brother John Larry Ray in St. Louis, Missouri, has been closed since early last week, according to John Larry Ray, for the safety of his patrons after Negroes in three automobiles were reported to be observing the tavern. John Larry Ray has also advised he has been hiding from newspaper reporters. He further stated that the news report of his receipt of a telephone call from a friend in Canada is false and that he knows no one in Canada.

John Larry Ray said that press reports of his planning a trip to London and reports of his intending to obtain a lawyer from Texas for the subject are false. He stated he has not heard from the subject but has written the subject to get in touch with Carol Pepper (sister of John Larry Ray and the subject) if the subject is in need of anything.

Sources in England have advised that if John Larry Ray travels to England he may not be given permission to land due to his criminal record. If he should be given permission to land, however, under the prison rules no one with a criminal record, even a relative, is permitted entry into the prison. As you were previously advised, John Larry Ray has a criminal record.

John Larry Ray is also of the opinion that the subject committed robberies for income during his travels.

Another of the subject's brothers, Jerry Ray, who formerly resided in Chicago, Illinois, is now in the St. Louis, Missouri, area and is using the name Jerry W. Ryan. It has been learned that he intends to leave for Memphis, Tennessee,

where he plans to obtain employment and remain there until after the trial of the subject. Both of the subject's brothers intend to contact the subject as soon as possible after his arrival in this country.

Information has been received from the Passport Office, United States Department of State, that Arthur J. Hanes, Sr., an attorney from Birmingham, Alabama, has advised that he and his son, Arthur J. Hanes, Jr., will appear at the Passport Office, Washington, D. C., on the morning of June 19, 1968, to file application for passports. They plan to depart for London from Dulles Airport at 7 p.m., June 19, 1968. Arthur J. Hanes, Sr., previously informed the Passport Office that he has been asked to serve as counsel for the subject.

On June 18, 1968, the subject appeared before the local magistrate in London concerning the charges relating to his entering Great Britain with a false passport and illegal possession of a firearm. He was given a remand until June 27, 1968. The magistrate said the extradition proceedings should take precedent over the local charges.

With respect to a telephone number written in Portuguese which was among notes found in Ray's possession when he was arrested, it has been determined this is the telephone number of the South African Embassy in Lisbon, Portugal. Inquiry has been made at the South African Embassy. They have no knowledge of Ray. All banking institutions in Lisbon were circularized for not only any bank account or safe deposit box, but also any letter of credit or other type of transaction. There have been no positive returns to date on this.

Attached is a telegram from our embassy in Lisbon, Portugal, to the Department of State concerning the above, and the possibility of news stories in this country alleging that United States authorities knew of Ray's presence in Portugal, but took no steps to have him apprehended because of the weakness of the Portugal - United States extradition treaty.

I would appreciate a report containing the details of Ray's apprehension in England, including when we learned of his travels to London and Lisbon.

I would appreciate it if this could be expedited, for it could have a remote bearing on the extradition hearing in London.

PURPOSE:

To recommend that the prosecutive summary report be disseminated to the Department, United States Attorney at Birmingham, and Phil M. Canale, State Attorney General, Shelby County, (Memphis) Tennessee.

BACKGROUND:

Reports were prepared by the field setting forth results of the investigation in this case and eight separate reports were disseminated to the United States Attorney at Birmingham and the Department. The reports were disseminated to the United States Attorney at Birmingham in view of the fact that the United States Attorney there authorized Federal prosecution. No copies of the reports were disseminated to the United States Attorney at Memphis. The reports that were disseminated contained, among numerous items, a listing of items of evidence recovered and the results of the FBI Laboratory examinations of such items. These reports, as well as the prosecutive summary report, contain no information of a confidential nature and have been prepared suitable for dissemination.

On May 7, 1968, an indictment charging subject James Earl Ray with murder, was returned by the authorities in Shelby County, Tennessee. In light of this and due to the fact that they will no doubt prosecute Ray on charges of murder, a copy of our prosecutive summary report as prepared by Memphis should be transmitted to Mr. Phil M. Canale, State Attorney General, Shelby County, Tennessee, who will be handling the State prosecution. When copies of this report are disseminated, the receiving persons will be issued instructions that the report or the contents thereof should not be disclosed outside the receiving agencies, except for prosecutive purposes

Investigation to date has not developed any concrete evidence of Ray's being involved in a conspiracy. Likewise, no information has been developed pinpointing the exact source of funds available to the subject. In order to thoroughly resolve the question of a possible conspiracy, Memphis and Birmingham have been instructed to initiate a specialized recheck.

Since subject on 3/29/68, purchased a gun in Birmingham, Alabama, in the afternoon and returned to the store early the following morning to exchange the gun, there is a good possibility that he may have stayed in Birmingham that night. (It is noted that on 3/24/68, he had rented a room in Atlanta, Georgia, and was there again, that we know of, on 3/31/68.)

ACTION:

SAC Gamble, Birmingham, was instructed on 6/17/68, to have Agents recheck registration cards, and other records at various motels, hotels and rooming houses in the Birmingham area in an effort to determine if subject can be identified as having been in Birmingham on 3/29/68, and further to determine if he was in contact with any other person at that time. Appropriate records, cards, etc. are to be furnished to the FBI Laboratory for handwriting comparison.

The Legat Attache's Office in London advised this morning that Ray, who is officially known as Sneyd in Britain, appeared before the local magistrate for about nine minutes this morning on the local charges outstanding against him. Those charges related to his entering Great Britain with false passport and illegal possession of a firearm. The magistrate gave him a remand until 6/27/68. The magistrate said the extradition proceedings should take precedent over the local charges. The defense counsel then referred to Section 3 of their Criminal Justice Act under which they can keep restrictions on the press regarding the proceedings. Defense counsel said he did not think this section applied to extradition proceedings so in order to make it perfectly clear, he did not want any restrictions imposed on press coverage.

The British Solicitor acting on behalf of the States of Tennessee and Missouri directed to the court the warrants outstanding against Sneyd for the murder in Tennessee and his conviction for robbery in Missouri.

The defense counsel then made reference to an article which appeared in the June 10, 1968, "London Times" headlined "United States Justice Department Chief interviews King Case Man."

Defense counsel for Sneyd said he was anxious to make it clear on behalf of Sneyd that Sneyd had not been interviewed by Assistant Attorney General Fred M. Vinson, Jr., or any other United States Government official. Defense counsel said he also had the permission of Chief Superintendent of the Metropolitan Police Department, Thomas Butler,

that Butler confirmed the fact that Sneyd has not been interviewed. Butler confirmed the fact, however, that Vinson did visit Canon Row Police Station when Sneyd was held there. Further hearing on the extradition proceedings were also set for 6/27/68.

Legat Minnich summarized the above by saying that Sneyd's being remanded on the local charges coincides with the deferment of the extradition hearing. At 6:00 a.m. this date, the Legal Attache's Office London telephonically contacted extra duty supervisor Kenneth A. Lofgren. Bureau supervisor Wilbur Martindale, on special assignment in London, advised that with respect to the telephone number written in Portuguese per London airtel 6/14/68, it has been determined this is the telephone number of the South African Embassy in Lisbon, Portugal. Inquiry has been made at the South African Embassy. They have no knowledge of Ray. All banking institutions in Lisbon were circularized last week for not only any bank account or safe deposit box, but also any letter of credit or any other type of transaction. There have been no positive returns, so at this time it looks like that investigation will be negative.

According to Martindale, when Ray arrived in Britain from Canada, he had a round-trip ticket which he exchanged in London for a ticket to Lisbon and in that transaction, he got a voucher in the approximate amount of \$14. A stop had been placed earlier in Toronto with BOAC on that voucher. Since that voucher was found in Ray's possession when arrested, that stop can now be removed. Being handled.

Legat, Minnich advised that Ray appeared before the local magistrate today, 6/18/68, on the local charges outstanding against him. Those charges related to his entering Great Britain with false passport and illegal possession of a firearm. The hearing was continued until 6/27/68 and the magistrate said the extradition proceedings should take precedent over the local charges. The Department is being advised of the receipt of passport documents on the subject furnished by the Canadian Embassy in Lisbon, Portugal, and documents furnished by Portuguese authorities. These documents indicate that the subject applied for and received a new passport from the Canadian Embassy in Lisbon since the passport issued by the Canadian Passport Office in Ottawa on 4-22-68 carried his name as Ramon George Snyea instead of Sneyd.

These documents are being examined by the FBI Laboratory and handwriting comparisons are being made.

ASSASSINATION OF MARTIN LUTHER KING, JR.

The following additional pertinent information is being furnished relative to captioned case. The material cet forth herein is based on preliminary information and complete details will be incorporated in reports of results of investigation.

Mr. Aubrey Morantz, Second Secretary and Couasel, Canadian Embassy, Lisbon, Portugal, has furnished the following documents from his files:

- (1) Carbon copy of memorandum from Canadian Embersy, Lisbon, to Canadian Passport Division, May 17, 1968, showing a new passport had been issued to Ramon George Sneyd on May 16, 1968.
- (2) Application for Canadian passnort executed by Ramon George Sneyd showing Passport Number was issued May 16, 1968.
- (3) Undated affidavit by Ramon George Sneyd to the effect that he had no guaranter available in Lisbon because he was only there on vacation.

Hr. Aubrey Morantz was interviewed and be explained that the subject, using the name Sneyd, appeared at the Canadian Embassy on May 15, 1888, to complain that there was an error in his Canadian passport issued at Ottawn on April 24, 1968, in that his name was shown to be Sneya. Atrangements were made to issue a replacement passport, which was given to the subject the following day, and his old passport was cancelled and returned to him. In his conversation with the subject, Mr. Morantz said that he made no mention of his activities in Lisbon or of his prior travel or future plant.

The was assisted in filling out the forms by Counselor Assistantials. Hanuela Texeira Lopes.

Mrs. Lopes was vacationing at a distant point in Portugal and was therefore telephonically interviewed. Described that when she assisted the subject in executing his passport application, he said he was staying in Lieben only

one or two days and debated whether to bother to change his passport because he "did not want to spend all of his time waiting around the Embassy." A new passport was then issued the following day. The subject displayed a Canadian birth certificate in the name of Ramon George Sneyd. He needed a great deal of help in filling out the application, leading Mrs. Lopes to believe he did not have a good education. She cancelled the passport issued at Ottawa by stamping it "Cancelled" on each page.

In addition to the above, Mr. Jose Manuel Passo of the Portuguese International Police furnished the following documents:

- (1) Entry card executed by Ramon George Sneya when he entered Portugal at Lisbon, May 8, 1968.
- (2) Exit card executed by Ramon George Sneyd when he departed from Lisbon en route to London, May 17, 1968.
- (3) Registration card for Ramon George Sneya at Hotel Portugal, Lisbon, dated May 8, 1968.

Mr. Passo advised that he had caused intensive but discreet inquiries to be made at the Hotel Portugal and had determined that the subject had checked out of the hotel shortly before his flight was to depart for London on May 17, 1968. He lived quietly and inconspicuously in the hotel, had no known associates and gave every appearance of being an ordinary tourist.

Inspector Antonio Rocha Fama, Immigration Officer at the Lisbon Airport has advised that he had checked Ramon George Sneyd out of Lisbon en route to London on May 17, 1968. He selected the photograph which the subject had used on the Ottawa passport as closely resembling Sneyd.

I received a telephone call this morning from one identifying himself as Lee Bailey, an attorney. He stated that he had gotten a letter which purported to be from Ray requesting him to serve as defense counsel in connection with the murder indictment in Memphis, Tennessee. Bailey was calling me to see if I had any knowledge of the bona fides of the letter. He also stated that he intended to tell Ray that "Because of his (Bailey's) close relationship with Dr. King, he would consider handling the matter only if Ray's defense was that he did not commit the crime".

Upon my inquiries about the substance of the letter, Bailey stated that it contained a convict number, gave his address as the prison in which he is actually being held, and named his solicitor as Michael Dresden and Co., 32 Tavistock Street, London. The letter also indicated that the writer thought he would be returned to this country on about June 19. I confirmed to Bailey that the information contained in the letter was accurate with the exception of the June 19 date which was uncertain. Bailey indicated that he would call Ray's solicitors in London to discuss the matter.

Prior investigation has indicated John Larry Ray visited James Earl Ray while the subject was in prison, on at least nine occasions, the last of which was April 22, 1967, the day before the subject escaped from the Missouri State Penitentiary in Jefferson City, Missouri. John Larry Ray sent his brother money while in prison. He denies any knowledge of James Earl Ray's escape or knowledge of his whereabouts following his escape. By way of background on John Larry Ray, records of our Identification Division on John Larry Ray, FBI number 368 725 A, indicate he received a sentence of two to five years for second degree burglary on January 24, 1950, and served time in the Indiana State Reformatory, Pendleton, Indiana. He also served time in the Illinois State Penitentiary at Menard, Illinois, for larceny of a motor vehicle being received there on June 2, 1953, and later discharged on February 1, 1960.

The above information is being made available to appropriate British authorities in the event John Larry Ray attempts to visit the subject.

According to the information furnished by the Passport Office, Mr. Hanes, Sr. was reportedly contacted by an unidentified British attorney on June 14, 1968, relative to representing James Earl Ray. Mr. Hanes, Sr. then reportedly claimed he had contacted "a Mr. Pollak" in the U. S. Department of Justice.
