Investigation at Blum's revealed this establishment destables a code similar to Code #028-6. Their code consist of 1-through 99 for lot number, a letter for week and last two digits for bundle numbers running -1 through 20. Red tape is used by Blum's for special work. They do not ordinarily place a tape on small items such as shorts unless the work only consists of two or three items. Blum's andhine has only five characters. The tape is cut one and one eighth inch long and there is no indication that the anchine has malfunctioned in the past causing tape to be cut one and one eighth inch long.

PRI Laboratory is requested to compare enclosed sample tapes with tape from suspect's shorte previously submitted by the Namphis Office.

> WILEY's wife is employed by Eastern Airlines and he can fly EAL anywhere for about \$2.00. He told GILLOLY that he had been to New Orleans and spent the week with his girlfriend. He stated he had flown EAL, but when GILLOLY mentioned the Delta envelope WILEY had with him, WILEY stated he had to fly via Delta from New Orleans.

WILEY is a white male, about 32 years, 5'10", 150 lbs., sandy blond hair, cut short and receding on sides. WILEY has not been known to make any threats against my anyone to GILLOLY's knowledge.

GILLOLY stated he would probably lose his job should he be revealed as source of above info. He has no reason other that the suspicious disappearance of WILEY last week to suspect WILEY has any connection with captioned case.

BROWDER, a white male, age 32 to 34, 5'6", 140 to 150 lbs., who is an expert on rifles. FRANK W. BROWDER is a well educated man, a self-made preacher who owns an Oldsmobile and has reddish-sandy hair. BROWDER, whose home is at 5180 Normandy Avenue, Memphis, Tenn., Telephone Number 683-4130, when visiting Atlanta, usually stays with his grandmother.

Detective HELMS does not know where BROWDER's grandmother resides, but CHARLES FERRELL can take them to this location. BROWDER's grandmother, a Mrs. CLARK, is believed to be a sister to former Governor of Georgia GENE TALMADGE and is believed to reside in Decatur, Ga.
