On 4-7-68 between 5:00 pm and 5:30 PM a male using a credit card number placed a call from Atlanta to ANDREW GAFEY, room 825, Sheridan Peabody Motel, Memphis, Tenn. GAFFEY never answered the phone and the call was cancelled.

While WARD was attempting to complete the call she overheard the caller and someone near him talking. One of the men said "There isn't that many people who know". She then heard some reference to SCLC. WARD believes the call was placed from a phone with the first three digits of 523. She explained that when a credit card is used the calling number is not required and she believes the call was from a 523 number becauses she only receives calls from certain exchanges.

WARD stated that if it is felt to be important enough the ticket she prepared re the call can be located and the credit card number obtained.

WARD goes on duty at 3:30 pm today at the telephone company office on Ivy Street. If when it is desired to talk with her today she should be called at home prior to 2:05 pm.

At Atlanta, he said he planned to confer with some of Dr. MARTIN LUTHER KING's successors.

Former SA WILSON had verified Dr. FRENCH's presence in Atlanta on 4/8/68, at which time Dr. FRENCH indicated he planned to stay in Atlanta until 4/10/68.



It was determined that several used "ribbonrite" machines manufactured by Textile Marking Machine Company, Syracuse, N.Y., which stamps a mark on the garment and could also be used to stamp a tag.

Based on description of machine mentioned in retel, at this time it does not appear that the "ribbon-rite" machine is identical with the "thermoseal" marking machine.

Search of premises believed occupied by Unsub who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be thermoseal type, manufactured by Textile Marking Machine Co., Inc., Syracuse N Y The tape is $\frac{1}{4}$ " wide and 1 1/16" long and bears letters and numbers 02B-6.

Experts at Textile Marking Machine Company advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are 18 point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape 1 / 16" long instead of 1 / 8" long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U. S. is as follows:

The first letter 0 stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6 Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
