NAME AS SUSPECT IN KING MURDER. GARNER STATED HE DID NOT FEEL IT WAS LIKELY HIS ROOMER WAS IDENTICAL WITH THIS SUSPECT AND THUS DID NOT FEEL COMPELLED TO ADVISE ANYONE ABOUT IT.

THROUGHOUT INTERVIEW GARNER MAINTAINED HE NEITHER SAW NOR HEARD OF GALT PRIOR TO APRIL FIVE LAST AND KNEW NOTHING TO INDICATE GALT HAD ANY CONNECTION WITH ANYONE AT ROOMING HOUSE PRIOR TO ARRIVAL. HE WAS UNABLE TO OFFER ANY EXPLANATION AS TO WHY GALT WOULD RECEIVE MAIL ADDRESSED TO HIM AT ONE ONE THREE FOURTEENTH ST BEARING APRIL ONE POSTMARK WHEN HE DID NOT MOVE IN UNTIL APRIL FIVE. GARNER STATED GALT LEFT NOTHING WITH HIM FOR STORAGE AND NOTHING LEFT IN ROOM. GARNER STATED ROOMS FOUR AND FIVE ARE RESERVED FOR STORAGE BUT CONTAIN NOTHING BUT LINEN AND POSSIBLY A FEW ITEMS OF NO VALUE LEFT BEHIND BY ROOMERS.

NOT POSSIBLE TO PURSUE WITH GARNER CONTENTS OF LOCKED ROOM WHICH CONTAINS TV WITHOUT RISK OF COMPROMISING SOURCE. THIS IS ROOM FOUR. ROOM FIVE AT ONE ZERO SEVEN FOURTEENTH ST. NOT RENTED SINCE VACATED BY GALT BUT CLEANED BY MAID WEDNESDAY APRIL TEN. ROOM SIX AT ONE ONE THREE FOURTEENTH ST. RENTED APRIL THIRTEEN TO NEW TENNANT PRIOR TO CLEAN UP BY MAID. BED MAKE UP BY NEW TENNANT AND SHEETS USED BY GALT OBTAINED DURING PROCESSING OF ROOM WITH GARNER'S CONSENT. ALL ITEMS OF POSSIBLE VALUE BEING FURNISHED BUREAU.

CHARLOTTE DETERMINE WHETHER WILLIAM LEE, ROUTE ONE GASTONIA, NC KNOWN THAT AREA. IF KNOWN SECURE FULL DESCRIPTION, BACKGROUND AND DETERMINE IF IDENTICAL WITH GALT.

DETROIT DETERMINE IF BETTY RETIRMAN OR PERSON OF SIMILAR NAME KNOWN AT ONE NINE FIVE TWO WALTZ STREET, WARREN, MICHIGAN. IF LOCATED, INTERVIEW TO RESOLVE WHETHER WILLIAM LEE IDENTICAL WITH ERIC GALT.

ATLANTA IS VIGOROUSLY PURSUING INDICATED ATLANTA LEADS IN EFFORT TO FULLY IDENTIFY AND LOCATE HAROLD G. ANDERSON AS WELL AS CONFIRMATION OF GARNERS STORY THROUGH OTHER INTERVIEWS.

RE: SECOND INTERVIEW OF JIMMIE D. GARNER, 4/15/68.

SAs KAAS and OGDEN interviewed FRED C. JONES, tenant who first met GALT when he, GALT initially came to rent a room at instant address. JONES mentioned individual named LEE (possibly GALT) in Room 206 and another individual named ANDERSON, who became friendly with "LEE". On 4/9/68, LEE and ANDERSON came to JONES' room and told him they were leaving then for Chicago for jobs as welders. JONES described the auto they were driving as a 1960 black Chevrolet convertible.

NOTE: Agents felt that LEE and ANDERSON were actual persons and that LEE was not GALT.

JONES described LEE (WILLIAM LEE) as white male, age 35 - 38, 5' 10", 160 - 170 pounds, black crew cut.

## TERMINATION OF INTERVIEW OF JONES

GARNER called office and wanted to relate some important information to change his previous story. He advised he was "confused" and said LEE has nothing to do with it. "It appears you want the person whose name is on this envelope." He advised that ERIC S. GALT arrived 3/24/68, paid \$10.50 in advance, which paid him through 3/31. He arrived in a white car, parking same in the rear of the apartments. He advised he could not say what kind of car it was, so he asked one of his permanent tenants who parks his car in the area, who advised it was a white Mustang, not sure of the year. GALT paid on 3/24, another week in advance and GARNER said he did not have much to say to him. GALT moved into Room 2, (not 5 or 6 in either 107 or 113). GARNER said GALT had a lot of "stuff", including a TV, so he, GARNER, let him use

a small storage room adjacent to GALT's room. GARNER described him as well dressed, neat, etc. He did not see him after 3/24, but on 3/31, GALT returned and paid him for another week. After this, on Friday, 4/5/68, they changed the linens in GALT's room, at which time they found a note from GALT to GARNER (which GARNER destroyed) which said in effect, "I have to go to Birmingham, can't take the TV now, will try to get back in a week to pick it up." GARNER unlocked the storage room for GALT initially, to store his things. At this time, everything was taken in his room, but the storage room was locked, with the TV in it. He described GALT as 33 - 35, thin face, around 6' or less, black hair, with possibly part in the middle, worn short.

NOEE: Agents advised GARNER "hard to read" in that he appeared either very frightened, "confused", etc. Possibility he is lying, but could very well be just extremely confused. He is a mild-mannered man, who never became upset at any question proposed to him. He admits being arrested approximately six weeks ago on a drunk charge and also admits to previously being arrested on the same type of charge various times.

Agents obtained guest register, which does not contain name of GALT; and letter with the printed name "ERIC S. GALT" which GARNER advised GALT printed himself.

#### POSSIBLE LEADS

1) Film coater found in one of the drawers in room. Could tie in with item found in white Mustang. It appears individual unloaded Mustang into something else, apparently overlooked items in trunk.

2) Check of safety deposit boxes; telephone checks for service and long distance calls over 90-day period for GARNER's phone in Room 107.

3) Interview other tenants in rooming house, under direction SAs KAAS, HAYNES and LEE.

a) HAROLD WATERS, permanent tenant who recalled white Mustang.

On 4/15/68, GLENN F. ANDERSON, Miller Road, Norcross, Georgia, was interviewed by SA JAMES E. RIORDAN and SA THOMAS J. BARRETT. GLENN ANDERSON stated that he has a brother, HAROLD GEORGE ANDERSON, white male, born 1922, Fulton County, Georgia. He stated that his brother HAROLD was considered to be the black sheep of the family and had spent all of his adult life drifting around the U. S. He stated that on 4/2/68, he received a telephone call from HAROLD at which time HAROLD stated he was staying at the Luckie Street Hotel in Atlanta and was working at a motor inn in the Peachtree-24th Street area. GLENN stated that prior to this he had not heard from HAROLD in approximately 1 1/2 years.

GLENN stated that his next contact with HAROLD occurred on the evening of 4/9/68, at approximately 7:00 PM. He stated that at that time HAROLD rode up to his, GLENN's, house as a passenger in a 1959 black Chevrolet. He stated that this car was being driven by an individual he had never seen before. He stated that this car pulled into his front yard and HAROLD got out and started a conversation with him. He stated that at this point the driver of the automobile got out of the car and introduced himself; however, he could not recall the driver's name. He described the driver as being a white male, 31-32 years old, 5'8" - 5'9", 165-170 lbs., black brush cut hair, round face, clean shaven, wearing a white tee-shirt and blue dungarees. He stated he observed the letters LOVE tattooed on the fingers of this individual's hand but he could not recall which hand.

GLENN ANDERSON stated that HAROLD and this other individual stated that they were planning to drive to Chicago, Illinois, that evening. HAROLD stated that they would either stay in Chicago, Illinois, or with an unknown female in Cicero, Illinois. At this point the other individual interjected that they could "always stay with his wife in Detroit if they had to." They did not state why they were going to Chicago or give any exact address they could be located at. GLENN stated that he knew nothing of his brother's prior travels to Chicago and would not be able to venture a guess as to where they would stay.

GLENN ANDERSON stated that he did not know how his brother HAROLD knew this individual or for how long he had known him. He stated he did not get the impression that they worked together and this individual did not volunteer any information about the type of work he did.

GLENN ANDERSON stated that in the course of conversation this individual stated that he could not understand why everybody was making such a fuss over the death of Dr. MARTIN LUTHER KING when nobody was concerned when his four-year-old child was killed.

GLENN ANDERSON further stated that during the course of conversation this individual mentioned that he had recently had the windshield of his automobile replaced due to the fact that a Negro male had fired a shot at him which went through the windshield on the driver's side and chipped the windshield post on the driver's side. He stated that he had this new windshield installed at a cost of \$37.50 by a Negro male. At this point he had GLENN ANDERSON look into the interior of the car and point out the chip on the windshield post. GLENN ANDERSON noted that the interior of the car was red.

GLENN ANDERSON stated that this individual mentioned the fact that he had served a sentence in the Penitentiary at Chillicothe, Ohio, in approximately 1952-1954, and that he had also served a jail sentence somewhere in Texas.

GLENN ANDERSON stated that there was some conversation regarding license tags for this car but that he could not recall what was said. He stated he did not note what license tags were on this vehicle.

GLENN ANDERSON stated that he does not believe that his brother contacted any other members of his family while he was in the Atlanta area.

GLENN ANDERSON stated that his brother had indicated that he had stopped at a package store and purchased some beer in the Norcross area just before they arrived at Glenn's home that evening.

During the course of the conversation a jet aircraft flew overhead and this individual mentioned that he had recently flown to Atlanta on a jet from the West Coast, exact location not mentioned.

At this point composite photograph available in this matter was shown to GLENN ANDERSON, and he stated that it resembled the individual who appeared at his home on 4/9/68, with his brother, HAROLD. He stated that the composite photograph exhibited gave him the same general impression that he had of this individual inasmuch as the hair coloring and hairline and the shape of the face were similar to that of the individual. He also stated that it gave him the same impression of age as did the individual.

GLENN ANDERSON stated that his brother HAROLD mentioned that he had some money coming to him in the form of his salary from the motel in which he worked in Atlanta. HAROLD stated that he intended to write a note to this motel when he got to Chicago and give them a forwarding address where they could send his back pay.

Re ERIC STARVO GALT, it is my understanding that when GALT's room at 113 14th St., Atlanta, was searched this date, some material of the John Birch Society was located. It is also my understanding that GALT was allegedly obtaining signatures for GEORGE WALLACE in California. It also appears that investigation of GALT to date indicates that he has been living in a manner similar to a Soviet illegal and I base this on the fact that GALT has moved to various localities rather frequently, stayed in places where he would not have to furnish much background concerning himself, seems to have a good supply of money, making most purchases with cash or money order, and apparently has had very little employment.

In my investigation of the "Minutemen", it has been noted that the "Minutemen" tend to emulate professional espionage agents in their ostensible efforts to defeat "Communism" in this country. There has been a suggested plan by "Minutemen" to assassinate "Communists" in the United States and in their study of underground and espionage type activities it is likely they would attempt to carry out an assassination plot through an individual who lives in a manner similar to that lived by GALT.

In the above connection, investigation in Atlanta reflects that JESSE C. MC COLLUM is the Director of Resistance Network #493 of "Minutemen" in this area and is or has been State Coordinator of "Minutemen". MC COLLUM has a deepseated suspicion of all people even to the extent that he will accept practically no one into the organization. It has also been learned recently that MC COLLUM has purchased 45 acres of land in an extremely secluded and isolated area

Following completion of assignments to make thorough and exhaustive search and processing of rooms 6 and 5 at 113 - 14th Street, and 107 - 14th Street, pertinent materials were returned to the Office, entered on green sheets and prepared for submission to FBI Lab. These items were taken personally by SA REYNOLDS, departing Atlanta at 6:20 A.M., Delta Airlines Flight 78.

Following receipt of teletype reporting results of interview of JIMMIE D. GARNER, rooming house operator, 14th Street, Mr. MARTINDALE of the Bureau called and requested that interviews at 113 - 14th Street and 107 - 14th Street, be held in abeyance until further authorization is received from the Bureau regarding such interviews. He advised that we must do everything possible to protect from news sources our interest in this area. Mr. MARTINDALE did authorize the interview of one FRED C. JONES, who occupies Room 1, 113 - 14th Street, at his place of employment, the Albert Pick Motel. The interview with JONES should be confined to "Where is ANDERSON?" No questions are to be asked of JONES concerning GALT. Mr. MARTINDALE suggested that the Atlanta Office pursue all logical efforts to locate HAROLD ANDERSON, who was last reported to have departed the 14th Street area with GALT and they ostensibly were enroute to Michigan for employment. It is noted, HAROLD ANDERSON furnished as next of kin, his father, G. F. ANDERSON, telephone 448-4672, Norcross, Ga., at the time he registered in one of the rooms on 14th Street. As best Mr. GARNER can recall, ANDERSON and GALT departed the 14th Street area on Tuesday, 4/9/68, in what he believed to be a 1962 or 1963 black Ford with out-of-state license tags. SA BEVERSTEIN, at the General Delivery window of the USPO, reported that two letters had been received addressed to GALT, which are described as follows:

In addition to above, SA PALFI transferred necessary mail at airport per request of WFO, for mail enroute to New Orleans. Also obtained mail containing 302s from Mobile which SA REYNOLDS carried with him along with evidence being submitted to the LAB.

New shifts assigned to appropriate spots for permanent lookout in truck in parking lot of National Services Industries. Two cars patrolling, one on the east side and other on the west side. be conducted without further Bureau approval, even though Mr. MARTINDALE suggested that at future contact with GARNER, efforts be made to examine his guest registers, particularly for dates of 3/19-29 and 4/1/68, looking for any pertinent names or aliases of GALT. It was pointed out to Mr. MARTINDALE, Mr. GARNER normally does not return to the rooming houses until 4:00 P.M. each day.

Agents assuming above shifts were cautioned about undue activity in the area and in their stopping or detaining or questioning of anyone in that vicinity who may have resemblance to GALT.

After SAs OGDEN and KAAS returned from interviewing GARNER and while still in the Office, DON BURGESS called to advise that GARNER had obviously not "come clean" with the interviewing Agents, as GARNER had told BURGESS that the TV set in the storage room next to BURGESS' room belonged to GALT. In addition, GARNER went into the room where the TV set was, folded the Atlanta City Map and put it on the table and put the John Birch Society booklet on top of the map so that the title of the booklet could not be observed. BURGESS said GARNER was obviously upset and agitated, apparently BURGESS felt because he thought GALT might be returning for the TV set and his other property. He wrote the name "GALT" on a piece of newspaper and gave it to BURGESS asking BURGESS to have GALT call him at GARNER's residence in the event GALT did come to the 113 address.

SAs OGDEN and KAAS have interviewed FRED C. JONES at the Albert Pick Motel and he had considerable information concerning ANDERSON and some information concerning a person he described as "BILL", who allegedly left with ANDERSON to find work in either Chicago or Michigan.

In view of GARNER's obviously lying to us, I (ASAC KEITH) advised the Bureau of this fact and Section Chief MC GOWAN gave permission to re-interview him to clarify the discrepancies. Before OGDEN and KAAS left the Office, GARNER called OGDEN and

told him he had some very important information which he wanted to give him.

I also instructed two Agents to attempt to locate ANDERSON's father at Norcross or Duluth, Ga. to obtain any information he might have as to the whereabouts of his son, as GALT could very well be with him. (This assigned to SAs BARRETT and RIORDAN). We determined that ANDERSON's father is G. F. ANDERSON, who is a self employed contractor with address on Cummings Road, Norcross, Ga., 30071, with unlisted telephone number of 448-4672.

The leads on the two additional items of mail for GALT at General Delivery, Atlanta, from Los Angeles and Baltimore were handled by telephonic leads to the respective offices with requests that we be advised telephonically of any positive results.

SA OGBEN called at 11:10 A.M. and stated he and SA KAAS had been interviewing GARNER again and that GARNER had admitted he was somewhat "confused" in talking to them about GALT last night. He said he now remembered that GALT actually first came to Atlanta and to his roominghouse on 3/24/68, at which time he paid one week's rent. He said GALT had given his name as ERIC S. GALT and that he, GARNER, had not entered in his record book but that GALT printed his name on an envelop which GARNER still has in his possession. He said on 3/31/68, GALT paid him for an additional week's rent for Room 2, which is the room adjacent to the storage room where the TV and other items are stored.

GARNER said the last he saw of GALT was 3/31/68, and in fact, he had seen very little of him between 3/24 - 3/31/68. He related that when GALT left on 3/31, he did not actually talk to him, but GALT left him a note, which he does not now have, stating GALT had to go to Birmingham, but he would be back to pick up the TV and his other items left in the room. GARNER has given permission to make the TV and other items belonging to GALT available to us and we are sending SAs SULLIVAN and LEE
