HAMMOND OBSERVED THIS INDIVIDUAL WORKING ON RED FIN AND TOLD FORBES THAT HE WAS SURPRISED TO SEE THIS MAN COOKING ON A BOAT BECAUSE HE IS A HIGH-TYPE FELLOW WHO USED TO WORK FOR A FINANCE COMPANY IN ARKANSAS, POSSIBLY AT MARIANNA, ARKANSAS. MR. OR MRS. HAMMOND TOLD FORBES THAT THIS INDIVIDUAL HAD ATTENDED COLUMBIA UNIVERSITY. are other charges which would indicate that CALDWELL
has purchased liquor. Mr. GONZALEZ advised that
CALDWELL's bill at the present time amounts to \$137
and that CALDWELL was billed for this amount on 4/10/68

While CALDWELL was rather reluctant to answer questions concerning his whereabouts and his identity, he did indicate that he had been in the Atlanta, Georgia area during and since the assassination of MARTIN LUTHER KING, JR.

CALDWELL is apparently identical to the HOWARD EUGENE CALDWELL, JR., referred to in Atlanta file number 87-14050. Inasmuch as CALDWELL did not come to close to fitting the description of the UNSUB in this case he was not interrogated further.

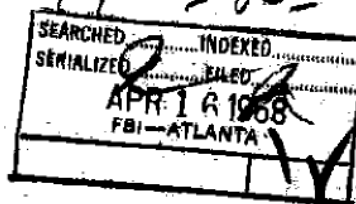

MARY BASS, Deputy Sheriff, Cobb County Sheriff's Office, Marietta, Ga., advised on this date that she had received information from the Mableton Mail Newspaper of Mableton, Ga., that an anonymous call had been received on 4-16-68 from a female indicating that the person who is wanted and who drove a white mustang lives in Mableton, Georgia.

MRS. MIRIAM HARKINS, Mableton Mail Newspaper, Mableton, Georgia, phone 948-7300, advised that that newspaper is one of several owned by Community Newspapers Company and that today was her first day of work at the newspaper office in Mableton, Georgia. She advised that earlier today, 4-16-68, she received a phone call from a woman who did not identify herself and who stated "I thought you ought to know, the person they are looking for and who drives a white Mustang lives in Mableton, Georgia". The unidentified caller then hung up. Mrs. HARKINS stated that her impression of the voice was of a white woman, in her 60's and nervous. She was sure it was not a young person and is not certain that it was a crank type call. At approximately 11:20 PM Gordon Siefferman, WAGA-TV reported that the night switchboard operator had received an anonymous phone call just several minutes ago to the effect that the person being sought for the King murder was staying at 61 13th Street, NE Atlanta. Siefferman could furnish no further info regarding this matter.

Mary Ann the operator receiving the call was immediately contacted telephonically regarding the call. She advised that immediately following the 11:00 PM news, she received a call from a person sounding like a white middle aged female, who reported that the person being sought by authorities for King's murder was staying at 61 13th Street no apartment number or other specific location in building being specified. Mary Ann asked the caller why she didn't furnish this info to the Police or the FBI and the caller replied that she didn't want to get involved; caller then terminated the call. The WAGA TV 11:00 PM news report had a taped interview by Paul Shields of the station with a cab driver who reported having transported individual to Peachtree and 14th St. who was similar in appearance to person being sought by the FBI. This newscast did not show face of cab driver, only his back.

Examination of current city directory reflects that building at 61 13th Street is a 16 unit apartment. No names listed are similar to any of known aliases of subject.

Above data was furnished to supervisor Harding at 11:21PM who requested that the SAC be advised.

SAC notified at 11:24PM who advised that this matter should be written up for ~~XXXXXXXXXX~~ handling on morning of 4-17-68 during regular working hours.

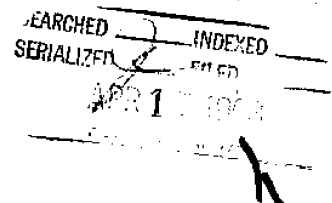
