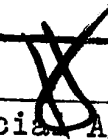
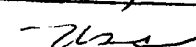

Mr. RAYMOND T. DIXON, Dixon Lake Road, Smyrna, Georgia, telephone number 436-6675, was interviewed April 18, 1968. Mr. DIXON is self-employed in a contracting business and is occupied principally with masonry work.

The business card bearing the name "HANEY'S SHEET METAL" and containing the name "RAY DIXON, Telephone Number 436-6675", was displayed to Mr. DIXON in an effort to determine the identity of the individual who had this card in his possession prior to its being located in the rooming house of 113 14th Street, NE, Atlanta, Georgia.

Mr. DIXON advised that the card bears his handwriting on the reverse side and he then explained that because he is in the contracting business he gets a large number of requests from individuals either to obtain employment or to obtain contracts with him to furnish supplies and building materials. Mr. DIXON says he recalls having a card of "HANEY'S SHEET METAL COMPANY", but he believes he has not seen this card in at least a year and he thought it more likely he had disposed of this card two or more years ago. Mr. DIXON said he is absolutely certain this card was not in his possession during recent months, but he could not recall the person he gave this card to.

Mr. DIXON was unable to identify the photograph of ERIC STARVO GALT as anyone known to him. Mr. DIXON said he probably gave this card to an individual seeking employment a year or two ago and has forgotten the matter entirely. Mr. DIXON knows of no one residing in rooming houses in the 14th Street area and said he doubted this card had any recent connection with anyone in the rooming house in question.
