He advised that HOLCOMB has been handled by the Adult Probation Office before and that he is presently on probation after having been arrested and convicted of larceny from house in Atlanta, Georgia. He has been on probation with the department from April 4, 1968. Mr. MEULLER advised that his records reflected that HOLCOMB is now residing at 68 Rawson Street, Southeast, Apartment 48, Atlanta, Georgia.

Mrs. DOMINICK advised that on April 5, 1968, at about 12:00 p.m., she put out a sign on her front lawn advertising that she had a furnished apartment for rent. At about 4:00 p.m. that same day, a man knocked on her door and asked to see the apartment that she had to rent. Mrs. DOMINICK stated that she thought at first that the man was a salesman but then realized that he was there to see the apartment. She asked him how many people he had in his family and he stated that there was just himself. Mrs. DOMINICK told him that it was a three room apartment and that she was asking \$95 a month. The man still insisted on seeing the apartment and was quite worried about whether Mrs. DOMINICK had any problem with bugs in the apartment. He told Mrs. DOMINICK that he had gotten "hooked" on apartments that were just full of roaches. Mrs. DOMINICK told him that she had a contract with an exterminating company and the apartment was regularly sprayed.
