Re SAC memo to file 4/24/68 (serial 1102).

Film strips containing color negative photos of the persons who made application for drivers licenses for the entire state of Georgia, beginning with 3/23/68 through 4/10/68 were reviewed on 4/24,25,26/68, with the exception that the film strips after 4/9/68 for Dalton, Georgia and from 4/6/68 to 4/10/68 for Canton, Georgia could not be located. Where possible, the film strips for 4/11-14/68 were also reviewed, however, of the 46 drivers license stations, 10 of the smaller stations have not yet sent in the film for processing, or the film is awaiting processing, for that period.

To date, no identification of Subject <sup>RAY</sup> has been made in this review.

Contact will be maintained with the Georgia Drivers License Bureau to complete the review for Canton and Dalton, Georgia as soon as those missing film strips can be located.

Re memo of SA CHARLES S. HARDING 4/24/68.

On 4/24/68, Mr. ROBERT E. THOMPSON was interviewed at his request in room 217 at the Rodeway Inn, 14th Street, Atlanta. THOMPSON stated that he arrived in the Atlanta area on the morning of 4/7/68 and was in Atlanta for two reasons, first to find a competent dentist and second to find employment. He stated that he was discharged from the Navy in November 1966 and for the past few months has worked as a warehouse serviceman for Sears in Greenville, S.C. He stated his residence in Greenville was #5, Lee Court.

THOMPSON advised that he thought he had information concerning the KING assassination which he obtained while drinking at the Club Peachtree, 160 Peachtree St., NW on the previous evening. He stated that he entered the Club Peachtree at approximately 10:30 in the evening and approached the bar. Standing to the right of the bar were two well dressed white males who were in their late 30s or early 40s.

He stated that he paid no attention to their conversation until he heard the name KING mentioned. He stated that following the mention of KING's name, the first individual who was sitting the closest to him attempted to quiet the second individual and the second individual stated that "PA is a clever man and scapegoat." THOMPSON continued that he was not certain that the individual had stated PA or BA. This statement was followed by a sentence which he did not overhear completely. This sentence was "but you told him interested in KING." The first individual responded stating "those are out of the conversation JOHN-okay; as a matter of fact let's go, you talk crazy." The men then exited the bar.

GEORGE MARSHAL, Personnel Director, Atlantic Steel, 1300 Mccasin, Northwest, advised SA MARION E. CHEEK JAMES P. RIORDAN was in his office on March 20, 1968, at which time he gave the address of 107 14th Street, Northeast, Atlanta, Georgia. He listed a former address of 94 11th Street, Northwest, and a permanent address of 97 Ward Street, Wallingford, Connecticut. He listed his wife as LOUISE, prior employment with United States Plastics, Wallingford, Connecticut, and claimed to be a retired service man from the United States Army with service from 1940 through 1945 and 1947 through 1963.

RIORDAN is described as a white male, 49 years of age, 6'3" tall, 215 pounds. He was offered employment in a supervisory capacity and was to report on March 25, 1968. He did not show up for work and Mr. MARSHAL called his wife in Connecticut. She did not know where he was located.

Mr. MARSHAL, who is a Shriner, saw RIORDAN on Clermont Avenue in Decatur, Georgia, on April 6, 1968, when he, MARSHAL, was marching in a Shrine parade. RIORDAN has not recontacted Atlantic Steel and he has no idea as to RIORDAN's present whereabouts.

The size and style of the numerals and letters on K172 through K175, as well as those appearing on some other known specimens received, are the same as corresponding portions of the laundry tapes appearing on the Q97 sheet and the Q99 pillow case.

Because of the lack of identifying features on which to base a definite opinion, it could not be established that one of the machines used to prepare K172 through K175 was used to prepare the questioned laundry marks. Of these known specimens, only K175 has the letters "O" and "R" spaced the same as on the Q97 and Q99 tags. There are an insufficient number of known specimens available imprinted "2OR-3" to assess the significance of this feature; however, prior examinations indicate this factor alone is not sufficient to identify a laundry tag with a particular machine.

On 4/24/68, this writer was telephonically contacted by Supervisor CHARLES S. HARDING to the effect that he had received a telephone call from R. C. PEACOCK, Chief of Police, Butler, Georgia, advising that a person looking similar to JAMES EARL RAY had been observed in Butler, Georgia, on 4/23/68, and was thought to have caught the Trailways Bus to Atlanta late in the evening of 4/23/68.

On 4/24/68, Chief R. C. PEACOCK, Butler PD, was interviewed and advised that on the evening of 4/23/68, his uncle, MURRAY WALKER, reported to him that he had seen an individual walking in to town on Highway 19 at approximately 7:00 p.m., and that this individual resembled the person who had killed MARTIN LUTHER KING. Chief PEACOCK stated that at about this time, the individual whom MURRAY WALKER had seen walked by the City Cafe and proceeded down towards the Trailways Bus Station, which he eventually entered. Chief PEACOCK stated that he and his night deputy, C. J. BICKLEY, went to the Trailways Bus Station cafe and observed the man from approximately 8:20 p.m., to 8:50 p.m. Chief PEACOCK stated he did not have a copy of the wanted flyer with the picture of JAMES EARL RAY but that he had recalled seeing the pictures in the paper and that the individual did resemble, as he could recall, the pictures of JAMES EARL RAY. Chief PEACOCK stated the individual was wearing a white, dirty, wrinkled shirt, dark brown charcoal trousers, white socks and black shoes. PEACOCK stated he was carrying a sky blue sweater and a small hand-bag with two handles and a zipper. Chief PEACOCK stated that the hair was dark brown and slightly curly and that it appeared the man had approximately a two days growth of beard. Chief PEACOCK stated that the individual would weigh near 165 pounds and 175 pounds. Chief PEACOCK stated that he noticed the indi-

vidual had a particularly protruding left ear but at the time, he was observing the person, he was not aware of the fact that subject JAMES EARL RAY is reported to have a protruding left ear and therefore did not think this individual to be the same as JAMES EARL RAY.

Chief PEACOCK stated that the man was reported to have inquired regarding the bus schedule to Atlanta, but he did not observe him get on any bus.

On 4/24/68, GARY D. WINDHAM, Attendant, Williamson's Shell Service, Butler, Georgia, advised that on the evening of 4/23/68, sometime around the hour of 7:00 to 7:30 p.m., a man came walking over to the service station from the bus station which is located next to the service station. WINDHAM stated the man was dressed in a white wrinkled shirt, had a couple days growth of beard and was carrying a bag or satchel and a sweater. WINDHAM stated the man drank a coke and ate some crackers and that at approximately 8:00 p.m., which is closing time for the service station, a car with Texas license plates pulled in with two white males. WINDHAM stated that they struck up a conversation with the individual in the white shirt and he heard them mention an eating place in Florida. WINDHAM stated that he closed the station, went home and ate and later came back to the bus station around 8:30 or 9:00 and saw the individual in the white shirt in the bus station. WINDHAM described him as being 35 to 40 years old, medium build, around 6 feet tall.

Mrs. MARVIN PEED, Ticket Agent, Butler Trailways Bus Station, advised that she had been on duty on 4/23/68, until approximately 2:30 p.m., at which time she left and did not return. She stated that anyone who would have gotten on a bus during the evening would have had to purchase the ticket from the driver.

On 4/24/68, W. C. ABBOTT, Trailways Bus driver, advised that he had made the run from Butler to Atlanta the previous evening of 4/23/68, and that he left at approximately 11:45 p.m. ABBOTT stated that the only

passenger he picked up in Butler, Georgia, was a Negro male and that while he was in the bus station, he did not observe any white males resembling the photograph of JAMES EARL RAY.

On 4/24/68, SHERMAN GRAY, Waitress, Trailways Bus Station, Butler, Georgia, advised that she worked on 4/23/68, from approximately 3:00 p.m., to approximately 11:00 p.m. She stated that at approximately 6:30, a white male dressed in a white shirt, gray pants, and carrying a bag with two handles and a zipper and a blue coat asked her about the bus schedule to Atlanta. She stated this individual left the bus station and returned at approximately 7:15 when the bus for Atlanta was just getting ready to leave. She stated she asked him if he were going to catch the Atlanta bus at which time he stated that no, it would get him in to Atlanta too soon and that he would wait on the later bus. At approximately 9:00 to 10:30 p.m., a truck driver who was driving an unidentified tractor and trailer unit coming from the South on Highway 19, parked the truck across the street from the Trailways Bus cafe and came into the cafe for a cup of coffee, a piece of pie and some ice cream. She stated that the individual who had earlier asked about the bus schedule to Atlanta struck up a conversation with the truck driver and they later left together. Mrs. GRAY stated she could not recall ever having seen this particular truck driver before and he was not in a uniform or did not have any other means by which he would be identified with a particular truck line. Mrs. GRAY stated that she did not get a close enough look at the truck and could not determine whether it had a truck line name or any type of identification on it. Mrs. GRAY stated that the truck was headed north towards Atlanta but that she did not overhear the driver make any statements as to where he was going. Mrs. GRAY was displayed the wanted flyer 442-A and advised that the individual who had been in the bus station dressed in the white shirt and carrying a bag who later left with the truck driver might possibly favor the middle picture of JAMES EARL RAY as displayed on wanted flyer 442-A; however, she could not state positively.

On 4/24/68, MURRAY WALKER, Butler, Georgia, advised that he closed his grocery store at approximately 6:30 p.m., on 4/23/68, and went out to the small airport where he has an airplane. He stated after staying there a short time, he drove back in to town and as he was coming in to town from the north on Highway 19, he noticed an individual walking along the road. He stated that the minute he saw this person, it struck him that he resembled the person who was supposed to have killed Dr. MARTIN LUTHER KING. WALKER stated he turned his truck around and drove by the person two more times in order to get a better look and was further convinced that this person resembled the photograph he had seen in the newspaper of JAMES EARL RAY. WALKER described the person as follows:

Height	Approximately 5'8"
Weight	165-170
Clothing	Short sleeve white shirt which was dirty and wrinkled.

WALKER stated the person had approximately a three days growth of beard, solid black curly hair and was carrying a satchel and a sweater. He stated the person was fairly young looking and he would judge him to be less than 40 years old. WALKER advised that he observed what appeared to be a tattoo on the left arm. WALKER stated he then went to the City Cafe and furnished this information to Chief of Police R. C. PEACOCK and pointed the individual out as he passed the cafe.
