Re Louisville teletype to Director dated 4/26/68; Atlanta teletype to Louisville dated 4/30/68; Atlanta telephone call to Louisville, 5/22/68; and Louisville telephone call to Atlanta, 5/23/68.

Re: Sears Roebuck Battery located in 1966 Mustang

With further reference to the tracing of Sears Roebuck All-State Battery located in 1966 Mustang recovered at Atlanta, Ga., on 4/5/68, and with particular reference to telephonic conversation between Supervisor CHARLES HARDING, Atlanta Office, and SA C. ADDISON KINCAID of the Louisville Office, the following additional facts are being furnished:

On 5/22/68, Mr. JOHN DARNELL, Globe Union Company, Louisville, Ky., manufacturers of All-State Automobile Batteries of the type recovered in instant 1966 Mustang, stated that this battery is a Model 52 which carries a stock number of 22-F. Mr. DARNELL informed that in a 1966 Mustang the battery normally installed would be a Model 25, 35 or 36 or Stock No. 24-F. He stated that this battery

could be purchased in any of the Sears Roebuck retail automobile store outlets located in Eastern Missouri, Southern Illinois, all of the State of Indiana, all of the State of Ohio, all of the State of West Virginia, or all of the State of Kentucky. He stated that as of the present time, there are 133 retail Sears Roebuck automobile stores which stock and sell this battery.

With reference to the possibility of obtaining this battery through mail order, Mr. DARNELL stated that this could be possible but only upon referral of the mail order to the Louisville plant of Globe by Sears Roebuck in Chicago, Illinois, for delivery direct from the Louisville plant. It is to be noted that the central distributing point and warehouse of Sears Roebuck in Chicago would not stock a 22-F battery manufactured at the Louisville plant inasmuch as Chicago is served by the Milwaukee plant of Globe Union.

With reference to the possibility of purchase of the battery by mail order, Mr. DARNELL checked all mail orders filled by the Louisville plant upon such referral by Sears Roebuck in Chicago and stated that no mail order received was for a Model 22-F battery, thus eliminating the possibility of purchase of instant battery through mail order.

Pursuant to conversation held with Supervisor CHARLES HARDING of the Atlanta Office, Mr. DARNELL was requested to furnish and did furnish copies of the Sears Roebuck retail automobile store outlets in the area surrounding Memphis, consisting of stores in the Greater St. Louis, Missouri, area and Southeastern Missouri, as well as Southern Illinois as far North as Alton, Illinois, as well as stores in Western Kentucky. Next to the name and address of the Sears Roebuck stores so listed in parenthesis are listed the total number of the type 22-F battery furnished these various stores during the pertinent period from 2/22/68, to April 5, 1968. It is to be noted that while instant battery carries a date code of 3/68, Mr. DARNELL explained that the code date is effective on the 21st of each month indicating that this battery was distributed possibly as early as 2/22/68, as a March product.

For the information of offices not previously receiving correspondence regarding tracing of instant

battery, this battery is described as an All-State high voltage, internal connector battery with the identifying Model 52 contained in white letters in a small circular plastic case on three sides of the battery. It also bears the marking "F-41 B E 8, square 48" located on the top of the lead shield washer on the negative post. The date code "C-8" indicating the battery was manufactured in March, 1968, is contained in a small white decal on the side of the battery.

Enclosed for the Bureau and each receiving office is a copy of the list of Sears Roebuck retail stores carrying this battery and through which retail outlet same may have been purchased during the above period from 2/22 to 4/4/68.

No leads are being set forth herewith by the Louisville Office relative to further tracing of this battery but same is being left to the descretion of the OO as indicated in referenced teletype of the Louisville Office dated 4/26/68.

The following investigation was conducted by SA BRUCE D. THOMSON and JACK M. WEBRECK on the dates and at the places indicated:

On 4/26/68, Mr. FORREST HAGAN, Clerk, Cedartown, Georgia Police Department advised his records are negative re RUBY DUGGAR.

A review of the Polk City Guide for Cedartown, Ga. (1966 edition) reflects that RUBY DUGGAR 416 Park Street is employed at the Polk County Hospital as a practical nurse.

Efforts to locate RUBY DUGGAR at 416 Park Street reflects that she had moved and left no forwarding address.

Investigation at the Polk County Hospital on the same date reflects that she has not been employed by this concern since early in Feb. 1967.

Post Master G. FIELDS WHATLEY (Protect Identity) Cedartown post office advised his records do not reflect that a RUBY DUGGAR or MARIE RUFF receive mail in the city of Cedartown. WHATLEY advised that he would contact the rural mail carriers and attempt to ascertain if any of these individuals are familiar with these persons.

On 5/17/68 WHATLEY advised that he had ascertained that RUBY DUGGAR is residing on the "Old Mill Road", Route 2, Cedartown, possibly in a house trailer.

Efforts to locate RUBY DUGGAR on the Old Mill Road to date have met with negative results.
