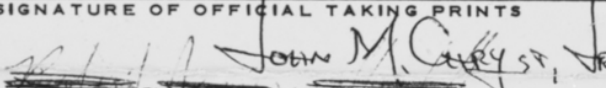
Four Fingers Taken Together
