



SUBJECT: MURKIN

At request of SAC TULLY, SA DAVIS interviewed Reverend MARION BASCOM in regard to any information that he might have had regarding the assassination of MARTIN LUTHER KING, JR. BASCOM advised that he had no idea as to who might have assassinated KING. However, he did note that he had a premonition that KING was going to be assassinated approximately six months ago and that he did discuss his premonition with several ministers on his trip to Miami Beach to the Southern Christian Leadership Conference convention held there earlier this year. He further stated that in his premonition it did not go so far as to state who or how MARTIN LUTHER KING would be killed and since his death, he has not heard nor as he any further information which might lead to the person or persons responsible for KING's death. Reverend BASCOM advised that he had never discussed MARTIN LUTHER KING's assassination with anyone other than the minister that accompanied him to the conference in Miami, Florida and he never talked of the assassination in his sermons. Reverend BASCOM appeared to be very sincere and honest in discussing this matter with the writer.
