Among articles recovered at scene of shooting, apparently abandoned by unsub, were a pair of brownish checkered print undershorts and white jockey tee shirt bearing cloth laundry tags. These tags were made by a thermo seal marking machine manufactured by the textile marking machine company, Syracuse, N.Y. These tags are one quarter inch wide and one and one sixteenth inch long, red in color and bear marking which appears to be "02B-6" or D2B-6." Only a portion of the first character is present on each tag, and this character is cut on a slight bias. No other visible laundry marks were found on either garment.

Immediate checks of logical laundries suggested by textile marking company have to date been unproductive.

They advised their son, born 8/12/27, served in the United States Navy for about 2 years, after enlisting at Rochester, NY when 17 years of age. He later attended Houghton College, Houghton, NY and secured a Medical Doctor degree from Albany, NY medical college. He also studeed psychiatry, as a resident physician, University of Michigan.

he went to Africa, as a medical missionary, and while there contracted encephalitis, which resulted in mental illness. He has been a patient in both the Rochester, NY State Hospital and Gowanda, NY STate Hospital.

He was married to the former BARBARA HARVEY but they are now separated and she is residing at 30 East Frederick Street, Corry Pennsylvania, with her three childrens The suspect, FRENCH, is in contact with his wife on occasion.

They loaned us a 5x7 photograph of ALVIN EUGENE FRENCH, taken

several years ago, and requested it be returned to them.

They advised their son has been in Florida and the southern U.S. since about mid-February. They have sent him money % Western Union and also persons, whom they declined to furnish identies of.

They stated he was in the Williston and Hillendale, Fla areas and the last they heard, about 2 weeks ago yesterday(which would have been 3/24/68,) he was in Georgia when he called his brother-im-law, PA UL SCIULTZ, New Road, Ransoville, New Fork.

REV. and MRS. FRENCH advised their attorney is ALFRED BRIM, Lockport, NY, who knows the background of this matter.

REV. and MRS. FRENCH advised they never knew their son be be interested in hunging or guns whem living at home. They had no idea of the real purpose of our inquiry with them.

The above was furnished to SA EDDY the afternoon of this date.
