She boarded this bus at Main and Chippewa, traveled North on Main to Ferry. The bus then turned East on Ferry and traveled to Wohlers, where she disembarked. When she got off the bus, he was still staring at her and also other Negroes who were passengers on the bus.

The bus continued up East Ferry. She related that the reason she is bringing this to the attention of this office is that she was reading the "Buffalo Evening News" on the evening of 4/10/68 and noticed a description of the suspect, with an artist's sketch. She assumed that the person that killed Dr. MARTIN LUTHER KING was from Tennessee and never discounted the white male mentioned above as possibly being connected with the KING assassination.

On 4/12/68, after going to work, she picked up a "Courier-Express" and noticed in this paper that the authorities were looking for a man from Alabama; therefore, she discounted her assumption that the killer was from Tennessee and that he possibly was from Alabama, according to the newspaper. Therefore, she thought she should furnish this information relative to the University of Alabama male for whatever purpose it may serve.

Recommendation

Furnish this information to SA R. GORDON EDDY, to whom the MURKIN case is assigned for whatever action he deems appropriate.



The Bureau has advised that a complaint was filed at Birmingham, Alabama on 4/17/68, charging GALT with conspiring to violate the rights of MARTIN LUTHER KING, JR. in violation of Title 18, USC, Section 241.

The complaint charges that on or about 3/29/68 at Birmingham, Alabama, GALT and an individual whom he alleged to be his brother, entered into a conspiracy, which continued until on or about 4/5/68 to injure, oppress, threaten or intimidate KING in the free exercise or enjoyment of a right secured to him by the constitution or laws of the U.S.; namely, the right to freely travel from state to state. In furtherance of this conspiracy, GALT on or about 3/30/68 purchased a rifle at Birmingham, Alabama.

The Bureau advised that a 30.06 rifle with a telescopic sight was recovered near the scene of the fatal shooting. It had been purchased from a Birmingham gun dealer on 3/30/68, along with a telescopic sight.

GAIT owned a 1966 white Mustang, which he purchased for \$2,000.00 cash on 8/30/67. This car was recovered abandoned 4/11/68, after having been driven more than 19,000 miles.

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT THE FEI HAS IDENTIFIED JAMES EARL RAY, AN ESCAPEE FROM THE MISSOURI STATE PENITENTIARY, AS ERIC STARVO GALT, AGAINST CHOM A FEDERAL COMPLAINT WAS FILED LAST WEDNESDAY IN CONNECTION WITH THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR.

DIRECTOR J. EDGAR HOOVER SAID THAT A SYSTEMATIC AND EXHAUSTIVE SEARCH OF LATENT FINGERPRINTS UNCOJERED IN THE DR. KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FROM WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI"S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND HAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

IN SEPTEMBER, 1966, WHILE SERVING THIS SENTENCE, HE WAS CONFINED FOR A TIME IN THE MAXIMUM SECURITY WARD AT THE STATE HOSPITAL AT FULTON, MISSOURI.

ACCORDING TO MR. HOOVER, RAY HAS A KNOWN ARREST RECORD DATING BACK TO 1949. PRIOR TO THE 1960 CONVICTION FOR WHICH HE RECEIVED THE 80-YEAR TERM, BAY HAD BEEN CONVICTED OF BURGLARY IN LOS ANGELES, CALIFORNIA, IN 1949; ARMED ROBBERY IN CHICAGO, ILLINOIS, IN 1958; AND FORGING UNITED STATES POSTAL MONEY ORDERS IN MISSOURI IN 1955.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PHISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENEORTH, KANSAS, IN 1955-58.

PAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE. WHILE IN THE ARMY, HE RECEIVED A THREE-MONTH SENTENCE AT HARD LABOR FOR BEING DRUNK AND BREAKING ARREST.

MR. HOOVER SAID THAT DURING HIS CRIMINAL CAREER, RAY HAS ALSO USED THE NAMES OF JAMES MCBRIDE, JAMES WALTON, W. C. HERRON AND JAMES O'CONNER. HE IS A WHITE MALE; CLAIMS TO HAVE

BEEN BORN MARCH 10, 1928, IN ILLINOIS: IS APPROXIMATELY 5 FEET 10 INCHES TALL AND LEIGHS ABOUT 163 TO 174 POUNDS. HE HAS PLUE EYES AND BROWN HAIR. THERE IS A SMALL SCAR ON THE CENTER OF HIS FOREHEAD AND A SCAR ON THE PALM OF HIS RIGHT HAND.

RAY HAS CLAIMED THAT HE ATTENDED SCHOOL THROUGH THE 10TH GRADE IN ALTON, ILLINOIS. HE HAS HAD THE REPUTATION OF BEING A "DRIFTER" SINCE LEAVING SCHOOL. HIS VOCATIONAL EXPERIENCE INCLUDES FORKING AS A BAKER, LABORER AND COLOR MATCHER.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AJOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEM.

RAY SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS.


