Other Offices receiving copies of this airtel were not furnished rerep and so the following background information is being set forth to assist these Offices in conducting the requested investigation:

Investigation has determined that the subject, using the name of ERIC GALT, left Los Angeles, Calif., on 12/15/67, driving his Mustang automobile, in the company of CHARLES J. STEIN, of Los Angeles. STEIN had formerly been a resident of New Orleans and the alleged purpose of this trip was for STEIN to pick up two children of his sister's who were residing in New Orleans and return them to California. According to STEIN, they arrived in New Orleans on 12/17/67 and left New Orleans on 12/19/67. STEIN stayed with relatives and investigation has determined that subject registered at the Provincial Motel, 1024 Chartres Street, New Orleans, on 12/17/67 as ERIC S. GALT and was assigned room 126. The registration card indicated GALT's automobile to be a Mustang bearing Alabama license 1-38993 and his address as 2608 Highland Avenue, Birmingham, Ala. The subject, as GALT, stayed at the motel until 12/19/67 when he checked out.

Interviews of motel employees in regards to the subject have been negative in that they cannot recall him.

There is set forth under a caption for each Office the identity or identities of persons staying at the Provincial Motel from 12/17 through 19/67. The identities of these persons were obtained from the motel registration cards as well as other information which is set forth under the name. The date listed under each name is the date the individual or individuals stayed at the motel. Each Office should locate and interview these individuals for any knowledge or contact they may have had with the subject. Various photographs of JAMES EARL RAY, which have been furnished to all Offices, should be displayed to these individuals to ascertain if they recall RAY.

In order to assist Memphis, the Office of Origin in this matter, each Office should set forth the results of this investigation in report form with copies of the reports designated for the Bureau and Memphis.

In the preparation of these reports, it is suggested that an appropriate predication for this part of the investigation be utilized in the details prior to reporting the results of contacts with these individuals. As an example, the following information might be used for this predication:

Information was Received from the New Orleans Office of the FBI that (insert name and address of person) had registered on (insert date) at the Provincial Motel, 1024 Chartres Street, New Orleans, Louisiana.

Of course, if any pertinent information is developed as a result of these contacts, this information should be brought to the attention of the Bureau and Memphis by the most expeditious means.

At 11:55 AM, 4/27/68, a person who gave his name as ROBINSON and refused to further identify himself, telephonically called the FBI Office and said he was at the Greyhound Bus Terminal, but was leaving immediately. He said that a man who looked like the fellow who killed the victim in this case was at the bus station, was with an attractive Eurasian woman, and was using a locker, number 101.

The writer and ASAC CAMPBELL immediately proceeded to the bus station. It was immediately determined that locker number 101 had been empty.

CARLSON MC FAYDEN, Dispatcher, recalled the man and woman mentioned above and stated they had made an inquiry of a ticket agent as to the location of the Statler Hotel. Mr. MC FAYDEN viewed a photograph on the wanted flyer depicting ERIC STARVO GALT and said that there was some resemblance.

JAMES O'BRIEN, Ticket Agent, recalled a man with an attractive Eurasian-looking woman, who made inquiry relative to transportation to the airport. He said that he was flying American and O'BRIEN directed him to the Statler Hotel for limousine service.

At the Statler Hotel it was determined that a limousine was loaded, however, there were no persons in this limousine fitting the description of the couple described above.

A survey was then made of the coffee shop in the Statler Hotel, and a dark-haired young man with an Eurasian-looking woman were noted therein.

It was readily apparent that this man did not closely resemble the subject of this case. His left ear was close to his head, while his right ear protruded.

When he left the restaurant, he was asked to identify himself; and he produced an Air Force Discharge Identification Card reflecting his name as FRANCES J. GALLAGHER, JR., AEN 11246982. This card also reflected that he had been an Airman, 3rd Class.

This man had straight long black hair, was 5'11" tall, 185 lbs., and had a medium complexion. He had no scar on the center of his forehead and had no scar on his right hand. He was expensively dressed and his bride of one week, with whom he was on his honeymoon, was a particularly chic and well-dressed person.

In connection with the captioned case there has been speculation that James Earl Ray concocted the alias of Eric Starvo Galt by combining the names of characters from books by Ian Fleming and from a book "Atlas Shrugged" by Ayn Rand. This speculation is based on the fact that in the James Bond books by Ian Fleming there is a character named Ernst Stavro Blofield and in "Atlas Shrugged" there is a character named John Galt, as well as one named Eric Starnes. Ernst Stavro Blofield is a formidable person, John Galt is a "social drop out" and Eric Starnes is described in the book as a "whiner" from a low-class family.

In view of the above and in order that Agents handling this investigation can be alert to the possibility of Ray's utilizing an alias based on characters in Fleming's books, there is set out as an attachment to this airtel a list of various characters in those books for your assistance.
