PRESENT MANAGER, LUCY PINELA, STATES SHE BELIEVES SHE HAS SEEN UNDERSHORTS OF TYPE IN PHOTO AS HAVING BEEN THROUGH HER LAUNDRY. SHE FURTHER STATED THE CODE ON THE GARMENTS WOULD HAVE BEEN USED SOME TIME AFTER MID-FEBRUARY, SIXTY EIGHT, AND THAT ALL RECORDS OF LAUNDRY, AS WELL AS TOOLS, WERE REMOVED FROM PREMISES BY VERNON. SHE LAST SAW VERNON MARCH TWENTY SEVEN, SIXTY EIGHT. PINELA DOES NOT KNOW IDENTITY OF PRESENT OWNER. HOWEVER, TELEPHONE BILL WAS SENT TO MAURICE HOWARD, LOS ANGELES FILE ONE HUNDRED DASH TWO THREE TWO NAUGHT NAUGHT, BUFILE ONE HUNDRED DASH THREE FOUR TWO SIX NAUGHT TWO, WHO IS SUBJECT RESERVE INDEX SECTION B, LOS ANGELES.

INTERVIEW PROSPECTIVE CLIENT IN BIRMINGHAM. THESE TELEPHONE CALLS WERE MADE FROM DOWNTOWN HOLIDAY MOTEL, ROANOKE, WHERE LEHMEYER SPENT NIGHT.

ON MORNING OF MARCH TWENTY-SIX, LEHMEYER FLEW FROM ROANOKE TO RICHMOND, VIRGINIA. HE WAS MET AT RICHMOND AIRPORT BY COOPER GILL AND HIS WIFE. GILL IS A CARMEN CLIENT, HAVING RECENTLY HAD ACCIDENT RESULTING IN LEG INJURY.

AFTER ARRIVING AT RICHMOND AIRPORT ABOUT MID-MORNING, HE MADE RESERVATIONS ON EASTERN AIRLINES FOR TRAVEL TO ATLANTA ON MARCH TWENTY-SIX. GILL DROVE HIM TO DOWNTOWN PETERSBURG, VIRGINIA HOLIDAY INN WHERE HE CANCELLED RESEVATION IN THAT MOTEL AND REQUESTED RESERVATION AT HOLIDAY INN, ATLANTA, GEORGIA AIRPORT. UNABLE TO GET RESERVATION AT ATLANTA AIRPORT HOLIDAY INN. HE THEN TELEPHONICALLY MADE RESERVATION AT ATLANTA HILTON HOTEL FOR NIGHT OF MARCH TWENTY-SIX. GILL AND HIS WIFE DROVE LEHMEYER TO PETERSBURG, VIRGINIA, N AND W RAILROAD YARDS AND SHOPS, WHERE HE INTERVIEWED J.B. MILLER, ASSISTANT LOCAL CHAIRMAN OF BROTHERHOOD OF RAILWAY CARMEN RE MILLER'S RECENT JOB INCURRED INJURY.

IN PETERSBURG HE ALSO CONTACTED CREDIT MANAGER AT SEARS ROEBUCK CO. IN BEHALD OF MILLER WHO WAS IN ARREARS RE PAYMENTS TO SEARS. AFTER CONTACT AS SEARS, HE WAS DRIVEN TO RICHMOND AIRPORT BY GILL. HE WAITED AT AIRPORT QUITE AWHILE AND DEPARTED RICHMOND VIA EASTERN AIRLINES, ENROUTE ATLANTA, GEORGIA, ARRIVING AT ATLANTA SEVEN PM, MARCH TWENTY-SIX.

UPON ARRIVAL AT ATLANTA AIRPORT, HE PROMPTLY MADE TELEPHONE CALL TO C.T. GODSEY RE INTERVIEW WITH PROSPECTIVE CLIENT AND WAS INFORMED BY GODSEY THAT CLIENT REFUSED TO TALK TO LEHMEYER. GODSEY WAS THE ONLY PERSON LEHMEYER CONTACTED IN ATLANTA. LEHMEYER SPENT NIGHT OF MARCH TWENTY-SIX AT ATLANTA HILTON HOTEL. WHILE AT HILTON, HE TELEPHONED RICHARD EVANS, BIRMINGHAM, ALABAMA, RE HIS PLANS TO ARRIVE IN BIRMINGHAM MARCH TWENTY-SEVEN. HILTON HOTEL BILL HANDLED WITH AMERICAN EXPRESS CREDIT CARD WITH NAME WILLIAM J. LEHMEYER.

AT ATLANTA AIRPORT, MORNING OF MARCH TWENTY-SEVEN, LEHMEYER PURCHASED EASTERN AIRLINE TICKET TO BIRMINGHAM DEPARTING ATLANTA MID-MORNING THAT DATE AND ARRIVING BIRMINGHAM FORENOON.

INFORMATION RE LEHMEYER'S ACTIVITIES SUBSEQUENT TO ARRIVAL IN BIRMINGHAM MARCH TWENTY-SEVEN FURNISHED IN REFERENCED MINNEAPOLIS TEL. LEHMEYER STATED HIS PLANS IN BIRMINGHAM ON MARCH TWENTY-SEVEN, LAST, WERE TO DEPART BIRMINGHAM SAME DAY AFTER INTERVIEW OF A MR. ELKOURIE. HE GAVE NO CONTACT POINTS FOR RESERVATIONS, NOR DID EVANS FURNISH PLACE OF CONTACT TO AIRLINE.

LEHMEYER SAYS HE TOLD AIRLINES RESERVATION CLERKS HE WOULD CONTACT AIRPORT TICKET COUNTERS RE FLIGHTS WHEN HE WAS AVAILABLE TO DEPART BIRMINGHAM ON MARCH TWENTY-SEVEN.

ATLANTA, BIRMINGHAM, RICHMOND SHOULD CONSIDER CONDUCTING DISCREET BACKGROUND INQUIRIES RE INDIVIDUALS CONTACTED BY LEHMEYER IN THEIR RESPECTIVE DIVISIONS AND OTHER APPROPRIATE INVESTIGATION TO DETERMINE IF THESE INDIVIDUALS MAY BE

SUBJECT: MURKIN

A comparison of the composite photograph of the individual who purchased instant murder weapon at Birmingham, Alabama and the photograph of JIMMIE EARL PARKS (BH-87-7049) appear to have some resemblances. Also the description of PARKS and UNSUB (ERIC STARVO GALT) appear to be close.

PARKS was traveling with JERRY LLOYD MC GILL, a notorious and intelligent criminal at Huntsville and Athens, Alabama in addition to other various states. MC GILL is from Memphis, Tennessee and has violated about every local and Federal law. He has a "devil may care" attitude and would do about anything to prove a point or for money. He has "nothing to lose" as he has 25 years to serve upon arrest, in addition to charges piled up since his release on bond.

It has been previously recommended that upon arrest, both be held without bond. It is noted that MC GILL also fits general description of UNSUB who killed DR. KING. Both are armed and dangerous.

MC GILL also has the knack of using akas wisely and cleverly as 87-7049 will prove. Both MC GILL and PARKS are known to be ~~fast~~ flashy dressers.

Photos of MC GILL and PARKS are attached and it is suggested they be shown to appropriate witnesses at Birmingham.

CIA has advised that one Dr. Robert Ervin Kramer bears a resemblance to an artist's drawing of the killer which has appeared in newspapers. (S)

Kramer was reportedly born [redacted] at Portland, Oregon, to Richard and Henrietta (nee Bineman) Kramer, both native-born U. S. citizens. He is described as 6' 1" tall, 170 pounds, brown hair and brown eyes. He reportedly attended University of Oregon, received BS degree in June, 1958; MS degree in June, 1963 and MD degree in June, 1963. Last known address is listed at 1472 C University Avenue, Berkeley, California.

Records of the Berkeley, California, Police Department reveal he was charged on 4/7/66 for cashing a fictitious check, no disposition shown. On 1/20/66, he was charged with possession of marijuana and sentenced to 90 days in jail with three years' probation. As of May, 1967, that charge was under appeal.

Kramer has frequently corresponded with CIA and has been interviewed at which time he reportedly engaged in a lengthy, rambling, disjointed discourse which ranged in scope from the future economic position of the world to the fact that a thermo nuclear conflict is eminent. (S)

On 4/10/68, PAUL L. WARE, Principal, New Castle High School, advised that about 7:00 a.m., 4/4/68, he was in the office of the Jones Valley Sausage Company, 1127 6th Avenue North, Birmingham, Alabama.

A company truck driver came into the room and said, "We're going to get ourselves a Nigger today." The driver was a white male, about 35 years old, 5' 10", medium-heavy build.

Also present in the room was a white man, the night shift man, seated behind a desk, and a Negro man who fills orders.

WARE said he "cussed out" the driver and told him that people like him were the cause of burnings, looting, and so on.

About 7:30 a.m., this truck driver called WARE at the school and apologized for his statement. He asked WARE not to report the incident to Mr. COOPER, owner of the company.

WARE stated that in view of the fact MARTIN LUTHER KING was killed the same date, he felt this statement and its source should be furnished the FBI.
