At 9:40 PM., instant date Mr. Billy Posey, 2118 Medaris Rd. Huntsville, Ala., telephone number 859-1732 telephoned the Birmingham Office and advised as follows:

Mr. Posey stated that he operates a rooming house in Huntsville, and that in 1963 and again in 1965 a man by the name of Kennedy, (he could not recall first name) stayed at his rooming house. Mr. Posey stated that the man named Kennedy fits the description, and is a perfect likeness of the profile view of the subject in this case, as published in the local news paper. He stated that Kennedy was always well dressed and that he was very particular about his cloths. Mr Posey stated that from conversations with Kennedy he learned that he traveled a lot to Memphis, Birmingham, Florida and California. Mr. Posey stated that Kennedy held several jobs in Huntsville but did not stay on one job very long. He stayed to himself a lot and did not go out very much at night. Mr. Posey stated that Kennedy made good money at his jobs but did not spend very much money. Mr. Posey stated again that the profile view of the subject of this case was an exact likeness of Kennedy and that the front view of the subject resembled Kennedy but needed some changes in the hair line, forehead and chin.

She said BRIDGES was about 35 years of age, 5'7 1/2" tall, weighed 185 pounds and known to Officer CHARLIE REED of the Gulf Shores PD. Caller would not identify herself or furnish any other information.

CHARLIE REED, Foley, Ala., on 4/8/68, advised that he is regularly employed at the Post Office in Foley and works nights as a policeman in Gulf Shores. He said he has known JIMMY HOWARD BRIDGES when BRIDGES was employed in Foley and Gulf Shores, Ala.

It is noted that JIMMY HOWARD BRIDGES is the subject of MOfile 88-6323, in which Denver is CO and which is entitled, "JIMMY HOWARD BRIDGES, aka - FUGITIVE; UFAP - Causing Injury While under Influence of Intoxicating Liquor." BRIDGES, according to Mobile investigation, has not been in South Alabama since about 2/1/68.
