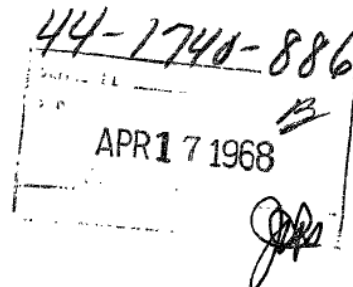

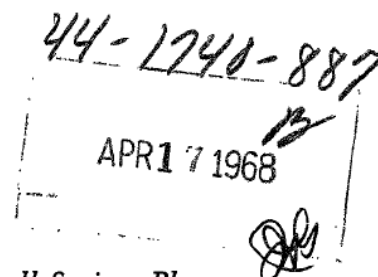

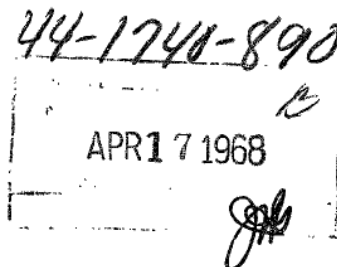

At approximately 2:35 p.m. on 4/14/68 a call was received by the writer from ROBERT H. RYAN, dispatcher, Tuscaloosa, Ala., PD. RYAN advised that he had just received a phone call from an anonymous party concerning an individual who closely resembled the composite of KING's alleged killer near the Greyhound Bus Station in Tuscaloosa. RYAN stated that this anonymous caller advised that he had seen this individual sometime around 11:00 a.m. in the morning near an outside locker between ramps 1 and 5 at the Greyhound Bus Station. This caller also stated that he had seen this individual with a brown-type shopping bag open the locker then close it, walk toward 8th Street and then come back to the locker and put the bag in one of the lockers. This caller advised that after the individual put this bag in one of the lockers he did not see him and could furnish no details as to where he might have gone.

This caller refused to identify himself to RYAN, but RYAN advised that he was a young-sounding individual and might be a university student.

On the same day the writer, along with SA CLARENCE E. WRIGHT, interviewed EUGENE WILSON, clerk, and DENNIS HOLLIMAN, porter, at the Tuscaloosa Greyhound Bus Station. Mr. WILSON advised that he was not on duty at the Greyhound Bus Station at 11:00 a.m. on 4/14/68, but that the manager, J. T. SHIRLEY, was on duty at that time. Interview with HOLLIMAN was also negative.

The bus station was searched and it was determined that there were no outside lockers at the Tuscaloosa Greyhound Bus Station, and that there are only three bus ramps.

On the same date, Mr. J. T. SHIRLEY was interviewed and advised that he does not remember anybody fitting the description of the UNSUB involved in this matter, and that there are no buses at the Greyhound Bus Station at 11:00 a.m. in the morning.

On 4/15/68 STEVE WAINGER, Apt. 12, 1814 11th Ave., Tuscaloosa, telephonically contacted the Tuscaloosa RA and advised that he was the individual who called the Tuscaloosa PD on 4/14/68 concerning his observation of an individual resembling the likeness of the drawing of MARTIN LUTHER KING's assassin.

On 4/15/68 WAINGER was contacted by SA A. L. KING and SA CLARENCE E. WRIGHT and he advised that between 11 and 11:30 a.m. on 4/14/68 he was in the Greyhound Bus Terminal in Birmingham, Ala., and he observed a white male with a long pointed nose that resembled the drawing in the paper of the assassin of MARTIN LUTHER KING standing near the lockers at the terminal. WAINGER advised that this individual was described as a white male, about 38 years of age, unshaven with dark hair graying on the sides, about 5'9" tall, and between 170 and 180 lbs. He said he was wearing a yellow sport shirt and dirty light trousers and was at an open locker next to locker no. 7-33. WAINGER advised that he did not observe any luggage and did not see this unknown subject get off or board a bus at this station. WAINGER stated that this unknown subject looked like an unemployed seaman.

WAINGER was shown the artist's conception of the suspect, and he advised the person he saw did not have hair as short as in the conception and was not dressed as neatly as the man in the conception, and that the unknown subject's nose was longer than the nose of the man in the drawing. WAINGER stated that the hairline of the unknown subject was also different than the artist's conception. WAINGER said he traveled from Birmingham to Tuscaloosa via the Greyhound Bus and then called the Tuscaloosa PD concerning the above matter and requested they furnish the information to the FBI.

The above is being furnished for the information of the file, and any leads will be left to the discretion of the case Agent.

Their records are filed by account number or address. Assuming a particular address is available, then it can be determined whose account is at that particular address by pulling the address files. MC GRAW advised his records concerning 2608 Highland Avenue, South, revealed PETER N. CHERPES subscribed for water service on 7/3/67. Prior to that subscription, the service at 2608 Highland Avenue was in the name of Scotch Realty and Insurance Company, Birmingham, for a period 8/13/63 to 5/5/66. No subscriber was shown between 5/5/66 and 7/3/67.

On 4/10/68, Mr. JAMES MILLER, Vice President, Alabama Power Company, was contacted and requested to determine through check of their recorded subscribers whether there was service listed in the pertinent names of GALT, LEHMEYER or WILLARD. Mr. MILLER advised this search would be conducted by the office of Mr. H. LISTON COOK and would be available on 4/11/68.

On 4/11/68, Mr. H. LISTON COOK, Customer Accounting Department, Alabama Power Company, Birmingham, Alabama, advised he and his staff reviewed all of the subscriber records in the area from 7th Avenue, South, to 18th Avenue, South, and from 14th Street to 29th Street, South, with negative results. He explained that the subscriber records of the Power Company are not maintained by name and that the only way to check the Power Company records is by address

or account number. He advised all customer accounting information is maintained on magnetic tape which is transposed from IBM type-punch cards onto the tape. He explained it is impossible to sort the punch cards to locate a certain name since the names on the punch cards are not punched by last name first. He further explained the only way their office is able to check by name is if the customer is delinquent in his account or has skipped without paying. Their Birmingham office is unique in that all their other major offices throughout the state can, by manual review of all subscriber listings, check their files by customer name.

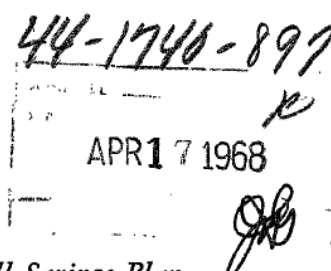

HOLLY stated that he recalled that on one occasion, GALT purchased two end tables, one coffee table, and a small pair of lamps for \$85 from the Abernathy Furniture Company, and GALT paid cash for this transaction. HOLLY stated this furniture was delivered by the Abernathy Company to GALT's residence which was located some where on Highland Avenue, Birmingham.

HOLLY stated that Mr. ABERNATHY's mother may recall GALT as GALT was in the furniture store on several occasions.

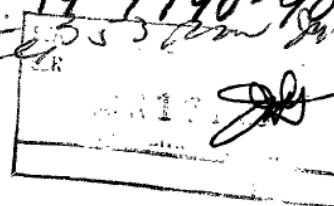
