Lynn H. Lockhart of Leeds, Alabama advised that while in Leo's Restaurant on South 18th street in Birmingham he overheard a conversation which contained some information which he thought would be of some value to the FBI.

Lockhart overheard two men talking about Galt, one replied that there is a boy that works at the ~~American~~ *Medical* Center Gulf Station on 19th street, who ran around with Galt, and can give information as to his whereabouts. *Thinks E.S. GALT IN BH.* This boy was in Leo's the night MLK was killed. When King's death was announced on T.V. this boy bought drinks for everyone in the restaurant.

Lockhart also advised that Leo's is a meeting place for the Klan, and that the owner, George Leos is a Klan member.

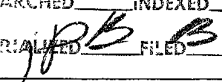

PAISLEY said he had recalled that at the time he sold his 1966 white Ford Mustang to ERIC GALT, on August 30, 1967, he told GALT that the car needed to have the oil changed as soon as possible and that the car needed a tune-up. PAISLEY recalled that the car at the time of sale to GALT had approximately 19,800 miles. He also recalled that the air filter was a factory replacement and that the oil filter was an A/C oil filter that had been purchased from the Texaco station in the Woodlawn area of Birmingham.

On April 17, 1968, WILLIAM DAVID PAISLEY, JR. advised he recalled he purchased this car on or about December 15, 1966. She stated that she started her dance instructor training at the Continental Dance Studios in New Orleans, Louisiana, on April 27, 1964, and completed this training around the first of June, 1964. Mrs. MYERS stated she recalls ERIC GALT took dance lessons in New Orleans, Louisiana, at the Continental Dance Studio. Mrs. MYERS stated GALT bought a one-year club membership for dance lessons, but did not have very much money so they had to budget his dance lessons at five hours a week. Mrs. MYERS stated that GALT did not pay for all his dance lessons and still owes the Continental Dance Studios some money for the dance lessons. Mrs. MYERS stated that in September, 1968, she and her husband, MARLIN, ran an advertisement in the Personal Want Ads of the Birmingham newspaper advertising adult dance classes being formed. She advised no address was listed in the advertisement, only a telephone number to call. Mrs. MYERS stated she does not recall if she or her husband took the telephone call from GALT. Mrs. MYERS stated that neither she nor her husband said anything to GALT about the money he owed for the dance lessons in New Orleans, Louisiana, since he was paying for the dance classes in cash. Mrs. MYERS stated that GALT never mentioned that he knew them or had taken dance lessons at the Continental Dance Studio in New Orleans, Louisiana.

Mrs. MYERS stated that GALT never indicated where he was employed or why he was in Birmingham, Alabama. She advised that she never saw GALT smoke and never saw him in any kind of a car. Mrs. MYERS stated that she does not recall GALT wore any type of jewelry. She advised that he was a neat, but careless, dresser. She stated GALT would never look at the person speaking to him and would answer all questions with either "yes" or "no." Mrs. MYERS stated GALT always came to the dance classes by himself and left by himself. Mrs. MYERS advised that GALT never had any conversations with any of the other students. She advised that the only student in the class who talked with GALT was her sister-in-law, DORIS LADNER.

Mrs. MYERS advised ERIC GALT was a white male, in his early thirties, 5' 11½", 165 pounds, sandy colored hair, worn in a crew cut, medium build, fair complexion, no confidence, light blue eyes, soft spoken with a southern accent. On 4/15/68, the writer interviewed Mr. BILLY POSEY, 2118 Medaris Road, Huntsville, Alabama, telephone number 859-1732. POSEY advised that on 4/14/68, he had observed artist's conception photographs in the local Sunday newspaper of the suspect in the assassination of MARTIN LUTHER KING, JR. at Memphis, Tennessee. POSEY advised that the profile view of the artist's conception strongly resembled an individual by the name of KENNEDY who had stayed periodically with POSEY's mother, Mrs. NELLIE POSEY, between 1963 and 1965. POSEY advised that his mother, NELLIE POSEY, operated a small grocery store located at 306 Church Street, Huntsville, Alabama, and that she had a group of rooms in the rear of this grocery store which she rented to roomers. Most of the occupants of these rooms were itinerant type individuals. POSEY noted that this address has subsequently been demolished and the entire area is now incorporated into an urban renewal area, and none of the former residences or places of business remain. Neither is Mrs. NELLIE POSEY available for interview. POSEY advised that he recalls this individual's name as either JOHN or JAMES KENNEDY, and that he was an itinerant painter or day laborer. He said that he seems to recall that this individual worked for approximately one week with the K & M Painting Company, and he does not know any other individual for whom he worked.

He stated that this individual roomed with his mother on two or three occasions during the period of 1963 to 1965, and he has not seen him since 1965. He described this individual as a white male whose age would now be 31-32, height 6', weight 175 pounds, build slender, complexion medium, hair brown and wavy, high forehead, eyes recessed and extremely deep blue (very noticeable deep blue). His voice was regional and no particular accent. He had an extremely heavy beard which was also very noticeable.

POSEY advised that the profile view looked very much like KENNEDY, however, the full front view was definitely not identical with him. He said that he recalled that KENNEDY was very antagonistic toward the Negro race. POSEY was unable to furnish the identity of any employment for KENNEDY or any other individual who might know him.

On the same date, the writer contacted Mrs. NELL ROGERS, Bookkeeper, K & M Paint and Glass Company, Inc., 105 Seminole Drive, S.W., Huntsville, Alabama, who employs a number of painters. Mrs. ROGERS has been the bookkeeper for K & M for a number of years and is familiar with many of the painters employed by the company. Mrs. ROGERS advised that she cannot recall any painters by the name of JOHN or JAMES KENNEDY working for K & M. She reviewed her records of present and former employees, and was unable to locate any employment record for an individual by the name of KENNEDY as having been employed by K & M.

In view of the vagueness of the identification on the part of POSEY, it is recommended that no further action be taken in regard to KENNEDY.
