The Atlanta Office intends to reinterview JIMMIE D. GARNER who operates the rooming house in Atlanta where GALT stayed. Interviews with GARNER have produced information was which not accurate in all respects and the Atlanta Office desires to run a background check on GARNER before the reinterview which will be conducted around 4:00 PM, 4/18/68. In connection with this, toll calls have been checked from GARNER's rooming house and two of these calls were made to Birmingham territory as follows:

2/7/68 call was made to Jasper, Ala., subscriber BRICE MOORE, Box 414, Jasper, telephone 384-4315.

3/2/68 to Albertville, Ala., subscriber EDWIN SMITH, 106 Lombardy St., Albertville, telephone 878-1773

OGDEN requested complete indices, credit and criminal check be run on these individuals and the results telephoned back to OGDEN or SA ROGER KAAS before the interview time.

In view of the common name EDWIN SMITH, indices check on this name should be remade following credit and arrest checks in Albertville.

On 4/18/68, SA JAMES D. SNYDER exhibited photographs of ERIC STARVO GALT to JULIA PARNELL and her two adult sons, BRIAN and WILLIE PARNELL, who reside at 5513 Norway Avenue, Cappstown, Alabama. All three individuals stated that they had never seen the man in the photograph. When asked by the agent if the man in the photograph resembled the man by the name of MOORE who accompanied a fish salesman by the name of OVERTREE, both men having been at the Parnell home in the last week, they said that they saw no resemblance. In addition, BRIAN PARNELL said he had purchased coal from MOORE for quite sometime and was sure he was not the man in the picture.

Neither JULIA PARNELL nor her two sons were acquainted with the name JOE WHITE but said at the time the fish salesman and MOORE were at the PARNELL home some other Negroes were in the neighborhood purchasing fish. It was his opinion that JOE WHITE was one of these individuals.

In view of the above, it appears the individual MOORE is not identical with ERIC STARVO GALT and is recommended no further investigation be conducted in this matter.

Re Philadelphia teletype to Bureau, 4/12/68.

On 4/12/68, JOHN PETRONELLA, 1731 Union Ave., Union, N.J., advised that on 4/11/68, he heard a fellow teacher at East High School, Bridgewater Township, N.J., one WAYNE C. MC AFEE, make a statement to the effect that he had relatives in the South, one of whom fit the artist's sketch of the killer of MARTIN LUTHER KING, JR. as it appeared in the newspapers. PETRONELLA also stated that MC AFEE remarked that this relative might be capable of the act.

After numerous attempts to contact WAYNE C. MC AFEE on 4/12/68, and 4/13/68, it was determined he was on a vacation trip, whereabouts unknown. On 4/16/68, WAYNE C. MC AFEE, 684 Donald Drive, North, Bridgewater, N.J., was interviewed at his residence. MC AFEE stated he has no relative who in the slightest way resembles the unknown assassin of Dr. MARTIN LUTHER KING, JR. He stated that last week he had commented to several other teachers at the Bridgewater East High School where he, MC AFEE, teaches, that he would feel sorry for the family

of the assassin since the family's reputation would be ruined by a senseless act. He further commented that he and his family are from the south and that if some member of the MC AFEE family had been responsible for the assassination it would ruin the MC AFEE reputation. He stated he has no knowledge whatsoever of the assassination and that anyone who may have reported that he had a relative resembling the unknown assassin was in error.

In view of these results, no further investigation is being conducted concerning the information attributed to MC AFEE in referenced Philadelphia teletype, UACB.

On 4/17/68 JOE WHITE, who resides at Route 1, Bessemer, Ala. but who has no telephone and is at the present time unemployed, telephonically contacted the Birmingham office of the FBI and advised that he (WHITE) had seen a man by the name of MOORE who resembled the sketch of the murderer of Dr. MARTIN LUTHER KING, JR., as WHITE had seen the sketch in the newspaper.

WHITE saw this man at the home of JULIA PARNELL, 5513 Norway Avenue, Capptown, Ala., telephone 786-9695. The look-alike MOORE was accompanying a man by the name of OVERTREE, as OVERTREE was selling fish at the PARNELL home. According to WHITE, OVERTREE lives in Docena, Ala. and drives a GMC truck with a red front which WHITE thought a 1967 model. OVERTREE travels through various parts of the southeast obtaining and selling fish and watermelons. WHITE observed both OVERTREE and MOORE about two or three nights ago, and at that time OVERTREE said he was going to Florida to get a load of watermelons.

WHITE described MOORE as being a white male, 28-37 years of age, 5'8" - 5'10", 165 - 175 lbs., brown, medium-length hair, and wearing work clothes.

WHITE could furnish no additional pertinent information but said JULIA PARNELL should be able to furnish the return date of OVERTREE from Florida.

U. S. Attorney MACON WEAVER telephonically contacted SAC this date and indicated that he had received a telephone call from EARL MORGAN, District Attorney, who had been in conference with Commissioner COOPER GREEN. MORGAN stated that he wished to know why Birmingham was chosen as the place in which the complaint was filed charging GALT with violation of the Civil Rights Statute.

WEAVER advised him that he did not know the answer to the question, but he would call Attorney General RAMSAY CLARK in Washington and attempt to get an answer for him. WEAVER said he spoke to the Attorney General, and the Attorney General indicated that he did authorize prosecution of GALT; however, he was not aware where the process was to be filed since that was the decision for FBI officials. He further advised WEAVER that he assumed that Birmingham was chosen because it was a place where the first overt act of conspiracy occurred.

WEAVER conveyed this information to Mr. MORGAN, and WEAVER stated that MORGAN appeared to be satisfied. Mr. WEAVER indicated that MORGAN's prime concern was that the filing of the process in Birmingham would result in Birmingham obtaining a bad reputation.

This information telephonically given to Supervisor McGOWAN at the Bureau.

LOVIN STATED THAT SHE WAS FORMERLY EMPLOYED AT THE EIGHT ZERO NINE CLUB AND THE "ATTIC" BOTH LOCATED IN THE FRENCH QUARTER NEW ORLEANS AND THAT SH WOULD SIT AND TALK WITH THE CUSTOMERS. LOVIN FELT THAT SHE MAY HAVE OBSERVED THIS INDIVIDUAL AT ONE OF THE ABOVE PLACES IN THE PAST.
