Included in material located was a portion of what appeared to be classified advertisement from a newspaper. Also included were bed linen which bore laundry mark 20R-3.

The following investigation was conducted regarding the above items.

Investigation was conducted to ascertain the name and date of the newspaper from which the two classified advertisement scraps had been taken. In doing so, Mrs. CARLTON SHAW, Carlton Shaw Realty, 13025 Ventura Boulevard, Studio City, California, telephone ST 8-7631, was contacted on April 18, 1968, as that firm had an advertisement appearing in one of the scraps.

Mrs. SHAW advised that their advertisement was in the Los Angeles Times on November 19 and December 3, 1967.

Inspection of library copies of the Los Angeles Times, Times Mirror Square, Los Angeles on April 18, 1968, developed that these scraps of newspaper were taken from the Los Angeles Times dated Sunday, November 19, 1967, pages 51, 52, 53, 54.

The December 3, 1967, issue was eliminated as the advertisement pertaining 626 South Alvarado, in that issue was not immediately preceded by the advertisement pertaining to 6326 Lexington, which was the case on the scrap of paper recovered in the Mustang.

The following investigation relates to investigation at the address of 626 South Alvarado, which is one of the addresses appearing on these scraps of newspaper.

On April 16, 1968, FRANK T. WOOD, Manager of The Palms Wilshire, 626 South Alvarado Street, Los Angeles, California, advised that he has been manager since November 27, 1967, but prior thereto he was relief manager since April 1, 1967.

When asked if he had any knowledge of any person named ERIC STARVO GALT, WOOD advised that he had none except that he may have heard it over the radio or television in connection with the murder of MARTIN LUTHER KING. WOOD advised that no person with that name is presently a tenant at this address and that this name was not recognized as that of any tenant since November, 1967. He said that he would make a check of the hotel's records in this regard.

When WOOD was furnished a description of GALT, he said that he could not identify any person on the basis of it, tenant or otherwise.

On April 18, 1968, WOOD was recontacted and he advised that a search of his hotel records, which go back to January, 1967, developed no information that ERIC STARVO GALT or any person named GALT was a tenant at The Palms Wilshire.

WOOD said that subsequent to April 16, 1968 he had spoken to ANN SMITH who was manager of these premises prior to November 27, 1967, but she had no knowledge of the name ERIC STARVO GALT and could not recall any person fitting the description which he (WOOD) had given her.

WOOD was shown photographs of GALT on April 18, 1968, with eyes open and with eyes shut, but he said he could not identify them.

FAYE BERNARD, Manager, Avalon Cleaners and Laundry, Incorporated, 5662 Hollywood Boulevard, made available a double entry ledger, Standard Blank Book Number 66, which contained records of the laundry customers covering the period from August 7, 1967, to April 18, 1968. A review of the records disclosed the following entries:

The following additional records were located:

Receipt number 30826 for wearing apparel rate section and customer receipt section of laundry list with GALT written on it.

Receipt number 31053 for wearing apparel rate section, flat rate section, and customer receipt section with GALT written on it.

FAYE BERNARD advised that all flatwear and finished laundry were marked with a Thermo Seal Marking Machine. She advised that all marking and laundry work was done at Avalon Cleaners and Laundry, Incorporated, main plant at 3020 Hines Avenue, Culver City, California. She further stated that the plant records would reflect the color of tape and laundry mark number given to a particular customer's laundry on any given day.

BERNARD was shown a photograph of ERIC STARVO GALT. She advised she was unable to identify the photograph as a person who had been a customer at the Avalon Cleaners.

FRED BACK, Owner, Avalon Cleaners and Laundry, Incorporated, 3020 Hines Avenue, advised that he used four Thermo Seal Marking machines at his laundry plant. The machine serial numbers were obtained:

Samples of laundry mark 20R-3 were obtained from all machines.

BACK advised that the Avalon Cleaners and Laundry, store number 20, located at 5662 Hollywood Boulevard, was one of 25 Avalon stores where laundry was picked up for processing at the main plant, and that this particular store was assigned the code number 20. BACK advised that all Thermo Seal Laundry Marks for this store would begin with the numerals 20.

BACK further advised that laundry list receipt ticket number 31053 for store number 20 reflected that finished laundry and flat laundry had been checked into the main plant and marked on December 18, 1967. BACK advised that all laundry was logged for store 20 according to receipt number and that receipt number 31053 shows that the flatwear laundry mark was 20R-3, which was printed on white tape.

BACK advised that the letter R and the white tape are used as a means of checking the particular day work is done and the numeral 3 is the lot number given to each separate bundle of laundry from a particular store.

BACK advised that the flatwear processed on December 18, 1967, cost \$.38 and would indicate that two sheets were processed. BACK stated sheets cost \$.19 each and pillowcases cost \$.09 each to launder. BACK further advised that the finished laundry cost \$1.14 which would indicate six shirts were processed according to price lists in effect at that time.

BACK furnished one Piece Count Ledger, labeled Laundry Prices and Count, covering the period May 14, 1963, to April 18, 1968, which shows on page 108 that on December 18, 1967, white Thermo Seal tape was used with the code letter R on flatwork.

BACK also furnished one lot control ledger for color marking tapes, which shows on page 62 that on December 18, 1967, white Thermo Seal tape with code letter R was used on flatwear laundry.

BACK also furnished one Ledger Sheet for cash inventory for store number 20, Hollywood and Wilton, dated December 20, 1967, which shows that laundry list number 31053 for flatwear laundry was priced to the customer for \$.38 and was marked 20R-3. Also received on this ticket was finish wear laundry priced to the customer at \$1.14 and marked 20F-7.

INVESTIGATION AT NATIONAL DANCE
STUDIO, LONG BEACH, CALIFORNIA,
WHERE RAY ATTENDED CLASSES DECEMBER,
1967 TO FEBRUARY, 1968

During the course of the investigation to determine background of JAMES EARL RAY it was ascertained that he probably attended some dance school in the Los Angeles area. Through a telephonic survey of the various dance schools throughout the Los Angeles area it was determined from Mr. RODNEY ARVIDSON, owner, National Dance Studio, 2026 Pacific Avenue, Long Beach, California, that ERIC GALT enrolled at this school during the first week of December, 1967 and took lessons until approximately February 12, 1968.

SHARON RHOADS, employed at Charter Title, 9033 Wilshire Boulevard, Los Angeles, California, was interviewed by SAs GEORGE E. AIKEN, Jr. and E. RHEAD RICHARDS in the vicinity of her employment on April 16, 1968, at which time she advised as follows:

She stated that she was employed on a part-time basis as an evening dance instructor at the National Dance Studio located at 2026 Pacific Avenue, Long Beach, California.

She stated that she recalled one ERIC S. GALT as a former student whom she instructed. She stated that as she recalled, GALT was her dancing pupil from about the first week in December 1967 through approximately the middle of February 1968.

In recalling GALT, she offered the following information concerning him:

She said that GALT was a very neat person and that he dressed immaculately, often in expensive clothes. He always appeared at the dance studio cleanly shaven, wearing white shirt and tie, and either a sport coat and slacks or a suit. She stated he also owned an expensive looking pair of alligator loafers, which he often wore with a sport suit. She stated that his hands were very well kept, and his nails may have been professionally manicured, but she could not state this with absolute certainty. She stated, however, that she had never seen his hands soiled or his fingernails dirty. His fingernails were well filed and trimmed and were worn short and neat. She stated that he was left handed inasmuch as she had noticed him on two occasions writing, and at the time she observed him writing, she made a mental note that he was a "south paw."

GALT was very ill at ease in crowds and gave her the impression that he prefers to be either alone or with no more than one other individual. He was an introvert and was very hard to converse with. She stated that in the approximate two months that she knew him, only towards the last did he feel confident enough with her that he would joke with her. She stated that toward the end he showed somewhat of a humor, which she believed very few people knew he had. He was always ill at ease around others and could not relax while in conversation with any other individual. He always fidgeted, pulled at his ears, played with his hands, and looked in every direction but at the person with whom he was conversing. She stated that he smiled with a one-sided smile and that he smiled very infrequently.

He would never talk about himself, but in general conversations she was led to believe that he came to Los Angeles from Mexico, possibly around Mexico City. He told her that he was unemployed; was a former merchant seaman; that he wished to return to sea, and that he received sufficient proceeds from the sale of a bar that he could "get along without being gainfully employed."

RHOADS stated that she was of the opinion that GALT entertained the thought of asking her for a date on many occasions, but his backwardness prevented him from actually doing so. During the dancing lessons he always centered his conversations around dancing techniques and never talked in general terms about himself. She believes he was a Southerner, and she recalled that possibly the first or second week during January 1968, he did not attend dancing instruction, and upon his return, stated that he had visited a brother in the State of Louisiana. RHOADS stated that during the two month period that she knew GALT, he changed residences twice in Hollywood, California. She at no time associated with GALT socially. She was not acquainted with any of his associates, and through conversations, GALT told her that he had no particular "hobby."

She stated that GALT seemed to compensate for his social inaptness by his attire and placing his schedule on precise projects which he was participating in.

As an example, she stated that GALT took dancing lessons she believed to overcome some of his shyness. He pursued the dancing lessons quite vigorously, doubling up on the number of lessons normally taught per week so as to take the maximum number of lessons in the shortest possible time. He abruptly quit dancing, telling her that he had enrolled in bartending school and was having a conflict in his schedule.

RHOADS was of the opinion that he had toyed with his dancing lessons sufficiently to satisfy himself and was "running off on another tangent." She also stated that GALT was not sufficiently busy she believed to have not pursued both courses, because GALT told her that he slept rather late, had lunch, took a nap in the early afternoon, went to bartending school in the late afternoon, and would then attend dancing lessons in the early evening. This, he explained to her, was his typical day, which was not a busy, productive, or strenuous one in her mind.

She stated that GALT was very slow in his mental processes. He often did not understand jokes and did not react favorably to a friendly gesture extended to him. RHOADS stated that during one conversation with GALT she made mention that it was odd that he did not wear any jewelry, that is ring or watch, since he was so well dressed otherwise. GALT replied that he detested jewelry of any sort, and to her knowledge, she never saw him wear a watch, ring, or cuff links, or any other items of jewelry.

RHOADS could remember nothing else of the mannerisms, background, etc. of GALT. She stated that GALT was a white male, weighing about 165 pounds. She stated that he had brown hair; was in his middle 30s; had a medium complexion, and spoke with a Southern accent. She stated that from his diction she believed him to be high school educated. To her knowledge, he spoke no foreign language.

His hair was short but not a flattop or Butch haircut. She stated that she could not recall whether or not he had a part in his hair but for some reason doubted that his hair was parted. His eyes were described as pretty and blue in color.

She stated that should she remember any further information pertaining to GALT, she would immediately contact the Los Angeles Division of the FBI.

PATTY HARRIS, 2027 Junipero Avenue, Long Beach, California, GE 8-9691, a student at Long Beach City College, telephonically advised she was formerly employed as a dancing teacher at the National Dance Studio at Long Beach and had as a student, ERIC GALT. She stated that as she recalls he had a course of some 50 hours, and she taught him on the average of about one hour a week for about a month and a half during the early part of this year. He did not finish all of his dance lessons.

During this period, on several occasions, she and he discussed Mexico in general. He told her that he was from Mexico and that he had a business there with someone else. She said he said he was in business with a friend. He told her something about being in the Los Angeles area to attend school but that he had not obtained any employment. He told her that he intended to return to Mexico.

She said he had a very limited knowledge of the Spanish language. In their discussions, he indicated that he had been in Mexico City and to Cuernavaca, Mexico. He did not tell her where his business was nor where he was living in Mexico.

Through conversation, he indicated that at least on one occasion he had visited a night club in Mexico City known as Senoryel (phonetic), which she also has visited. She stated that this night club had three separate rooms or lounges with different types of music in each. She stated that she thought he was in his early 30s and about 5'8" or 5'9" in height. She noted that she is 5'5" herself and did not regard him as too much taller than she.

She advised that she did not date GALT herself nor does she know anyone who did date him or had any social contact with him.

She said she believes that ROD, the owner of the dance studio, at one time or another had told her that GALT was a restaurant owner.

She stated that she could not recall if GALT smoked but believes that on several occasions she smelled liquor on his breath.

She stated that she would be agreeable to being re-contacted concerning this matter, and this was the only information she could recall at this time concerning GALT.

JOHN F. PRICE, manager of the Time Out Cafe located at 2054 Pacific, several doors north of the National Dance Studios, advised that during the months of December 1967 and January 1968, as he recalled, an individual who appeared identical with JAMES EARL RAY appeared at his bar about two or three times a week. This individual, according to PRICE, always appeared at the Time Out Cafe alone and sat alone. He was a good tipper; dressed well, and in conversation with people always talked about dancing. PRICE stated that he firmly suspected that this individual was attending dance lessons at the National Dance Studios several doors south of the Time Out Cafe.

PRICE stated that, as he recalled, this individual always wore a dark tie and on occasion was invited by other patrons of the bar to enter a game of billiards or shuffleboard, always declined the invitation.

PRICE stated that this individual always entered the bar on foot, and he, PRICE, never saw a vehicle which this individual might have driven.

He stated that this individual had a Southern drawl, or perhaps more actually a country boy manner of speaking.

PRICE could furnish no further information about this individual. He was shown photographs of JAMES EARL RAY, at which time he stated that he was certain that RAY was the individual who appeared at his bar during December 1967 and January 1968.

INVESTIGATION AT INTERNATIONAL SCHOOL
OF BARTENDING, LOS ANGELES, ATTENDED

During interviews of the personnel at the National Dance Studio, it was learned that RAY might possibly have attended a bartending school somewhere in the Los Angeles area. Investigation subsequently determined that RAY had attended bartending school at the International School of Bartending, 2125 Sunset Boulevard, Los Angeles.

TOMAS LAU, Director, International School of Bartending, 2125 Sunset Boulevard, advised ERIC GALT was not fluent in Spanish and could only say a few words in Spanish. These words, however, were correctly pronounced by him. LAU stated he now recalls that GALT had mentioned to him that he had lived in Puerto Vallarta, Mexico for about three years. The exact dates of this residence are unknown. LAU could not recall GALT ever mentioning the reason he had been living in Mexico.

LAU stated he thought it rather peculiar that someone would spend three years in Mexico and would not take the trouble to learn the language. He never questioned GALT in this regard.

RICHARD GONZALES, 1404 North Manzanita was interviewed at his residence at which time he furnished the following information:

He advised he is a former student of the International School of Bartending, 2125 Sunset Boulevard, Los Angeles, California at the same time that ERIC GALT, known to him as ERIC, attended the school. He stated they both graduated from the school on the same date and he has not seen GALT since. During conversations with GALT, while attending school, he learned from GALT that GALT had lived in Mexico for about three years, the exact dates and places unknown. GALT claimed to have gotten along well with Mexicans, liked Mexico very much and planned to return there to live.

On the date that graduation took place, in response to a question from TOMAS LAU, Director of the above school, as to what he, GALT, planned to do, GALT stated he was going to go to Birmingham, Alabama to visit his brother for about two weeks. He did not mention the name of his brother or his exact address. He indicated he would possibly return to Los Angeles after this trip to Alabama. GALT indicated he had been a chef in the Merchant marine, sometime in the past, serving on seagoing vessels. GALT never mentioned any other type of employment or members of his family but did imply he had been married once though was not presently married.

At the bartending school, GONZALES found GALT to be very quiet and one who kept to himself. He was also quite slow in mastering the bartending school curriculum and often displayed nervousness. GONZALES stated he thinks that GALT is right handed.

GONZALES stated that GALT never mentioned any women and it was not known whether he drank much. He did not smoke. GONZALES stated that GALT usually wore a business suit to school, however, gave the appearance of one who felt ill at ease in such clothing and it would be more fitting to his personality for him to wear more casual clothing.

GONZALES stated he never saw GALT's car and he was led to believe that GALT usually drove his car to school. GONZALES stated however that on at least one occasion did not drive his car to school because he, GALT, had allegedly lost his billfold, which contained his driver's license and it was not known if this billfold was ever recovered.

GALT claimed the reason he was taking this bartending course was because as a chef he had occasion to serve cocktails on board ship. He stated he did not feel qualified to mix these drinks properly and so was taking this course.

Concerning descriptive information on GALT, GONZALES furnished the following information:

He stated GALT never used profanity and talked like a fairly educated person. GALT was not observed wearing any rings although did wear a watch which had no distinguishing characteristics. He usually wore a short sleeve with his business suit and no tattoos or scars were observed. GALT's hair was brown with some graying on the sides. GONZALES stated that GALT wore dark brown wing tipped shoes and had a slight southern accent. He stated GALT had a medium frame although somewhat of a large stomach. He never mentioned being in the military and did appear to know a few words in Spanish and what words he did say in Spanish were correctly pronounced.

GONZALES stated that within the next two weeks he is going to move to Oakland, California and will be taking up permanent residence at 1640 Sixth Avenue, Oakland, California. He stated that his mother, Mrs. NINA GONZALES, who lives at 1625 Sixth Avenue, Oakland, California, telephone 832-3723, will always know his whereabouts.

PSYCHOLOGICAL TREATMENT RECEIVED BY
JAMES E. RAY IN LOS ANGELES DURING THE
PERIOD NOVEMBER 27, 1967 TO DECEMBER 14, 1967

On April 19, 1968, Dr. MARK O. FREEMAN telephonically contacted the Los Angeles Office of the FBI stating he believed he had information regarding JAMES E. RAY and desired to be interviewed.

Date April 19, 1968

Dr. MARK O. FREEMAN, Ph.D., Clinical Psychologist, was interviewed at his residence, 227 South Bedford Drive, Beverly Hills, California, April 19, 1968, at which time he furnished the following information:

On November 27, 1967, he received a telephone call from a JAMES E. RAY, who said he wanted to overcome his shyness, gain social confidence, and learn self-hypnosis in order that he could relax, sleep and learn to remember things better. As there was an open appointment that afternoon, an appointment was made for RAY to come to the doctor's office, 9952 Santa Monica Boulevard, Beverly Hills, at 5:00 p.m.

RAY did report for the scheduled appointment on November 27th, at 5:00 p.m. Dr. FREEMAN exhibited a leaf from his consultation notebook (approximately 3"x5" in size), on which he said he had made some notes regarding RAY on the occasion of their first appointment. This notebook page contained the name JAMES E. RAY; address, 1535 North Serrano; telephone 469-8096; and notations indicating the patient was single; had said he was from East St. Louis, and had worked on boats on the Mississippi River. Born .

In this first appointment and in subsequent appointments, RAY had very little to contribute about his personal family background. He said that he was unemployed. That he had worked as a cook on a Mississippi river steamer, but did not like the work, so had quit.

The doctor said he got the impression that RAY was an early riser, as he wanted early appointments, where ever possible. He also usually arrived at the office early, considerably ahead of his scheduled appointment time. He was not "shaky," when he arrived for the early morning appointments. No indications that he was suffering from "hang-overs," on those occasions.

RAY had no physical distresses. No headaches. Was in excellent health, trim and handsome. He gave no indications of being psychotic or of being plagued with neuroses. Impressed the doctor as having an average intelligence quotient. No evidence of any deep animosity.

Although he gave his birthdate as [] on the occasion of their first appointment, RAY impressed the doctor as being "young and immature."

In consultations subsequent to their first meeting, the doctor stated he felt that he and RAY developed a good rapport. RAY repeated his request that he wanted to overcome his shyness, and gain social confidence so that he would be able to talk to people. He was usually placid, cooperative, easily led in conversations, and did not fight against the doctor as some of his clients do. During either the second or third visit, the doctor asked RAY if he had any "deep dark secrets that he wanted to get off his chest." The doctor said he usually asks this question to determine if his clients have any criminal background or any sexual problems or aberrations. He said that RAY answered in the negative, and gave him no reason to doubt his answer.

RAY indicated he had read a lot of books on hypnosis. According to Dr. FREEMAN, "RAY had the old power idea of hypnotism. That is that you can go around looking people in the eye and can hypnotise them and make them do what you want them to." In subsequent appointments, Dr. FREEMAN placed RAY in a hypnotic state. He said he would have RAY lie down on a couch in his office, and stare at a little spiral on the ceiling. Then the doctor would talk to him. He was a very apt subject for hypnosis. Very eager, and very cooperative. He was an excellent hypnotic subject. He was likeable, and polite. He was making progress in overcoming his shyness. At the conclusion of each session, he thanked the doctor for his assistance; and indicated that he was satisfied with the progress he was making. He was learning to calm his body down, and overcome nervousness, and shyness. He usually did what the doctor wanted.

The doctor had no recollection of any particular habits or hobbies that RAY might have had. He did not recall any scars or peculiar physical characteristics that made any special impression on him with regard to RAY. He had no recollection of any discussions regarding sports, although their visits were during the height of the football season and the start of the basketball season. He was neat, and to the best of the doctor's recollection, usually wore a suit coat, without a tie. Two photographs of ERIC GALT (with eyes open and eyes closed) were exhibited to the doctor, who said they were excellent likenesses of his patient, JAMES E. RAY.

The doctor pointed out in his professional appointment book, entries for JAMES E. RAY covering six appointments and a seventh entry which was

crossed through. These appointment dates and times, as noted in the professional appointment book, were:

This latter appointment (12/18/67) was the one with the line through it. The doctor recalled that RAY had telephone him at the office, after making the appointment for December 18th, and told him that he would be unable to come to the office for the appointment as he had received information from his brother, that the latter had "found a job for him in the Merchant Marine in New Orleans, Louisiana." The doctor is not sure of the date or time that RAY telephone to cancel this last appointment; but feels sure that it was sometime after their 10:00 a.m. appointment on December 14, 1968.

Dr. FREEMAN said that RAY paid in cash, \$25.00 per visit. Except he has the recollection that RAY sent him a money order (he believes it was a postal money order) for the final \$25.00 payment.

Concerning his own personal history background and professional training, Dr. FREEMAN advised he had his college training at the University of Illinois (where he had a minor in Zoology), the University of Zurich, and graduate study at the University of Southern California. He said he was an agent in the Army's counter-intelligence corps in Europe during World War II. He is married, and has two children (a son and daughter) living with him. In addition to his travels and studies in Europe; he has travelled in Japan. His office is located at 9952 Santa Monica Boulevard, Beverly Hills, California, and his office telephone number is CRestview 6-2412. The doctor said that many of his patients come to him a referral from Mr. MELVIN POWERS of the Wilshire Book Company on the Sunset Strip in Hollywood, California; which he discribed as a publishing house that publishes numerous titles in the field of self-hypnosis. It was his recollection that RAY had indicated he had read some of these books and that he had been referred to the doctor from that source.

The doctor concluded by stating that JAMES E. RAY came to him seeking psychological help in the nature of self-hypnosis to gain confidence, overcome shyness, learn to sleep better, and to be able to talk to people. Following each session, he was instructed to go home and practice the methods of relaxation they had gone over in the office. He was shy, introverted, and withdrawn, but not psychotic or plagued with any deep seated neuroses. Although he indicated he was unemployed, he never seemed to lack money to pay in cash for his consultations during the period of their appointments. When he called to cancel their last appointment, he indicated he was going to New Orleans to accept a position his brother had obtained for him; but he told the doctor he hoped they would meet again sometime.

On April 25, 1968, Mr. HERBERT F. GREENBERG was contacted at his place of employment, 1640 South La Cienega Boulevard, by SAS THEODORE M. GARDNER and GILBERT G. BENJAMIN. After being advised of the identity of the contacting agents, he was interviewed regarding a purchase of a set of Japanese handcuffs by ERIC S. GALT, from the International Police Equipment Company, 806 South Robertson Avenue, Los Angeles, California.

GREENBERG stated he is the owner of the International Police Equipment Company, and that company is operated by him strictly on a mail order basis. He has no walk-in customers, and the address of 806 South Robertson Avenue, is nothing more than a mail drop utilized by him to receive mail directed to the International Police Equipment Company. He has been in business since 1953, and advertises police equipment for sale in all or the "trash" detective magazines; however, he does not advertise handcuffs. If a person ordered handcuffs from his company, this person would have to have been a former customer placing a re-order; or would have to have obtained a catalogue and order blank from a prior customer. GREENBERG explained that the only advertisements for handcuffs for sale by his company are contained in the police equipment catalogue that is also put out by his company. This catalogue is not readily available to the public, but is sent to a customer along with an original purchase. His catalogue is not distributed by mail lists, nor does his company utilize mailing lists in its operation.

Regarding the Japanese handcuffs, GREENBERG stated that he formerly sold a Spanish-made handcuff, and has only handled a Japanese manufactured cuff for the last ninety or one hundred days.

GREENBERG was advised that a package containing a set of Japanese handcuffs and a catalogue advertising police equipment for sale had been mailed by the International Police Equipment Company, 806 South Robertson Avenue, on March 16,

1968, to ERIC S. GALT, 5533 Hollywood Boulevard. GREENBERG advised that he did not personally recall filling such an order, but that he would check his records, and make available all information regarding the order. In this regard, GREENBERG stated that he would most probably have an original purchase order signed by the buyer, which he would make available.

During the late afternoon of April 25, 1968, GREENBERG telephonically contacted SA GARDNER at the Los Angeles FBI Office and advised that he had been in contact with the secretary who handled his company's records. She advised that she had located the above-described purchase order made by GALT, and that this order had been placed by him on February 26, 1968. She further advised that GALT had paid for the money order by check in the amount of \$9.98, but that for some reason the order had been delayed. GALT then called the secretary on the phone and asked her what had happened and requested she fill the order immediately. The secretary had then called GREENBERG and told him to ship the order immediately. GREENBERG advised that he would have the original order on the morning of April 26, 1968.

On April 26, 1968, GREENBERG was contacted at his place of employment by SAS GARDNER and G. J. MOOREHEAD. At this time, GREENBERG made available the following documents pertaining to the above-described sale:

(1) One Air Mail envelope, postmarked February 26, 1968, addressed to Tiffany Enterprises, 8512 Whitworth Drive, Los Angeles, California, bearing a return address of ERIC S. GALT, 5533 Hollywood Boulevard, Hollywood, California 90028.

(2) One typewritten letter, dated February 26, 1968, bearing the typewritten signature, ERIC S. GALT, as well as a written signature in the same name.

Inscribed on the letter were various notations in what appeared to be red-colored ball-point ink, and the numerals "998" in black ink. These notations, according to

GREENBERG, were placed there by himself at the time he filled the order. The above-described documents were inscribed on the back upper left hand corners, "4/26/68, TMC, IA, Calif." by SA GARDNER.

After furnishing the above-described documents, GREENBERG stated that he would have to revise the information previously furnished by him regarding the order and purchase of the handcuffs by GALT. He stated that Tiffany Enterprises is also a mail order business, and that two of the salesmen employed by Tiffany occasionally sell merchandise for him. In this regard, GREENBERG advised that in addition to the catalogue containing advertisements of police equipment for sale, he also put out a brochure which advertised the Japanese handcuffs.

He has furnished a number of these brochures to the Tiffany Enterprise salesmen, and they place a stamp on the brochure which indicates to a customer that these handcuffs can be purchased through Tiffany Enterprises. However, they do not carry handcuffs and any orders for them are filled by him. This would explain why GALT addressed his letter to Tiffany Enterprises. The secretary for Tiffany Enterprises, who is also utilized by him, advised him that GALT paid for his purchase with a money order in the amount of \$9.98. Her name is JANIE (last name unknown), and she can be located at Tiffany Enterprises. GREENBERG stated that in talking with her, she mentioned that agents of the FBI had already contacted her and other members of Tiffany Enterprises. GREENBERG described the brochures furnished to Tiffany Enterprises as a 8½" by 11" green sheet, a number of which were furnished to Mr. FLOYD CLEMENS of Tiffany Enterprises.

On May 6, 1968, Mr. GORDON W. SCHINDLER, President of Monogram Publications, Inc., and Futura Books, Inc., 21839 South Avalon Boulevard, Torrance, California upon hearing Agent introduce himself to the female clerk at the front desk, stated that he wanted to handle this matter personally.

SCHINDLER said that before he would answer any questions or make any matters available to the FBI with reference to ERIC S. GALT having made purchases from his concern, he wanted to ask some questions; (1) Did the Governor of Tennessee invite the FBI into this matter? (2) He had read in the newspapers that the Chief of Police in Memphis was unhappy with the FBI being there and just what jurisdiction did the FBI have in this matter?

As to the first question, Mr. SCHINDLER was advised that the President of the United States and the Attorney General had ordered the FBI into this matter in Memphis at which time Mr. SCHINDLER stated it appeared that the States have no rights anymore and that the Federal Government is taking over all their rights.

As to the second question, Mr. SCHINDLER was advised that the Chief of Police in Memphis was personally known to the interviewing Agent and did not believe the Chief of Police would have made such a statement. Secondly, Wanted Flyer 442-A dated April 19 1968 was displayed to Mr. SCHINDLER and the violations of Federal law set forth in this Wanted Flyer was explained to Mr. SCHINDLER.

Mr. SCHINDLER stated that so far as he was concerned, this whole matter was a waste of the taxpayer's money, that so far as he was concerned, the Federal Government had no jurisdiction in this matter,

Further, that if the United States Government wanted anything from him or his records that they would have to appear there with the proper papers or subpoena.

A Secretary of the corporation, whom the interviewing Agent had dealt with on the previous interview came into the room and Mr. SCHINDLER turned to her stating that she was to give the FBI nothing without his authority.

It was pointed out to Mr. SCHINDLER that during the previous interview, one of the clerks had indicated that the name of ERIC S. GALT had sounded familiar to them and believe perhaps he had a previous order, that now it had been determined that a money order in the amount of \$9.00 dated 7/24/67 had been sent to:

Mr. SCHINDLER was advised by his Secretary that during the foregoing period of time she did not believe they kept track of their money orders, however she would make a diligent search for this order. Mr. SCHINDLER stated that he would allow the FBI to make notes or a copy of this document, if it could be located, and that he intended to have the original document framed and hung on his office wall.

Mr. SCHINDLER claimed that he had not formed any personal adverse feelings towards the FBI other than it was another Governmental Agency involved in matters over which it has no jurisdiction.

Mr. SCHINDLER stated that he had just returned from New York and was amazed at the number of pornographic books he had observed in the book stores there, that he was sure that these books must have traveled in interstate shipments and thought the FBI and Postal Inspectors could spend more time in these types of cases rather than becoming involved in the matter in Memphis.

Formulas, 6311 Yucca Street, Hollywood, California, is a subsidiary of Barnett and Hersh. She stated that E.Z. Formulas pertains only to a magazine mail order business selling a single formula for making glass into a two-way mirror. She stated again that E.Z. Formulas sells only this single formula, not including the ingredients, for making glass into a two-way mirror. She provided a copy of the formula which consisted of a single printed yellow piece of paper of standard size.

She said that her firm has no record of any type of sale to a person using the names of ERIC STARVO GALT and/or JAMES EARL RAY. She said that when any subsidiary firm of Barnett and Hersh obtains a mail order, they immediately dispatch the item sold. They maintain no receipt or record of shipment. She said that they retain the addresses for a short period of time until a sufficient quantity has been accumulated to sell them to other mail order firms. She advised that all of these addresses have been sold, up to and including November 1967. She advised that these addresses were sold to Northwestern Company, 466 North Western, Los Angeles, California.

She advised that Barnett and Hersh utilize the addresses as provided by Postel, a mail box house and answering service located at 6311 Yucca Street, Hollywood, California.

Mr. TELUSI advised that his company manufactures tire molds and distributes them nationally. He added that 90 per cent of the companies distribution and sales of tire molds is in the Southern California area. He advised that there are over a thousand such tire molds sold by his company in California. Mr. TELUSI advised that his company does not place any type of identification marking or initials in its tire molds but he added that many of the people possessing such molds mark them with their own identification. Mr. TELUSI stated the initials "RGT" mean nothing to him. He stated that if he were to be able to examine the actual tires or a detailed duplication of the tread on the tires he would most likely be able to determine if the mold that made the tires was made and sold by his company.
