THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAWA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND 4, 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

THAT GALT HAS CLAIMED TO HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH, CALIFORNIA, FROM DECEMBER, 1967. WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2, 1968.





On April 12, 1968, R. OBESTER, Desk Clerk, Briarcliff Hotel, 1050 Ponce de Leon Avenue, NE, Atlanta, advised he thought he recognized a composit photograph of the assassin of MARTIN LUTHER KING, JR. as being identical with a guest registered as H. H. FLETCHER. FLETCHER called the hotel on April 7, 1968, and made reservations for a double and a single room. He appeared at the hotel on April 8, 1968, and made a \$10 deposit on these rooms. On April 9, 1968, two women approached the desk at the hotel and identified themselves as the wife and a friend of FLETCHER. FLETCHER and his wife occupied Room 501 and the other girl occupied Room 528. It appeared FLETCHER did not have an automobile but was traveling in the second girl's automobile.

Atlanta Police Department officer JACK POPHAM, assigned to the beat around the hotel also advised he also recognizes a composit drawing of the assassin as an individual he saw around the hotel.

DAVID ELLER, Alternate Desk Clerk, also advised he places a person similar to the composit drawing in and around the hotel.

Mr. and Mrs. FLETCHER gave an address of 615 Stirling Street, Greensboro, North Carolina. The second girl was identified by registration records as SARAH E. COLLINS, 601 Guilford Avenue, Greensboro. He mentioned that Captain LOHMEIER has not been accorded any military leave since he has been assigned to 2nd Battalion, 6th Marines. He stated that according to his officer qualification record, Captain LOHMEIER was on duty in Vietnam with the U.S. Marine Corps from 9/3/66 until 8/6/67. Captain LOHMEIER was on leave 12/14/67 until 12/19/67 and at that time gave as a leave address 304 Magnolia Boulevard, Radium Springs, Albany, Ga. Captain LOHMEIER also was on military leave from 8/26/67 until 9/9/67 and at that time gave as a leave address Magnolia Apartments, Number J-2, Albany, Ga.

Major HILL mentioned that since Captain LOHMEIER is the Commanding Officer of a unit in the Battalion, he as well as any other officer in the battalion, is not required to sign in or sign out at any time in the military unit, and it is very difficult to postively ascertain whether or not he would be on duty any specific date. He mentioned that once an officer departs his military unit after duty hours on a Friday, his activities are not governed by the military in any manner. He furnished a photograph of Captain LOHMETER which he stated was taken during 3/68 and advised that it was a very good likeness of the Captain. He stated further upon reference to the Captain's Officer qualification records that he was born at Lincoln, Nebraska, has Social Security Number at Lincoln, which was issued to him 7/27/66.

Major HILL mentioned that Captain LOHMEIER has three young children. Captain LOHMEIER has an insurance policy with Officer's Benefit Association, Policy Number 25482, P. O. Box 35, Birmingham, Ala.

Major HILL recalled that Captain LOHMEIER made a couple of trips to New Bern, N. C., during the last two weeks for the purpose of cancelling a Marine who is in the Captain's Unit and who is presently incarcerated in jail at New Bern, N. C.

Major HILL was not advised of the purpose of the inquiry regarding Captain LOHMEIER, and Major HILL was advised of the confidential nature of the inquiry and he agreed to hold the interview in the strictest confidence and not to advise anyone of the inquiry.

Staff Sergeant D. J. BUCKLE, Chief Investigator, Criminal Investigation Division, Camp Lejeune, N. C., advised that according to his records, Captain DONALD L.
