

Mrs. EURE, who appears to be a reasonably successful business woman, neat in appearance, and well spoken, said she now recalls how this alleged offer all started.

She said she recalls that in 1964 when she first met MC MANAMAN, he was out on some kind of a bond waiting for an appeal. At the same time the murder of the three civil rights workers in Neshoba County, Mississippi, was at the height of publicity. Sheriff RAINEY of Neshoba County was presumed to be, at the time, an official in the Klan in Neshoba County. At least the newspapers, radio and television news stories indicated this much. During the same period her real estate business was in minor financial difficulty and she recalls casually mentioning that if she approached the Sheriff of Neshoba County she could probably get \$100,000.00 to kill KING. She said she now feels in all probability that MC MANAMAN took her casual statement seriously. She said she now realizes the seriousness of such a statement since KING's murder.

Mrs. EURE stated that she is an outspoken business woman and often passes remarks of this nature more to attract some prospective customers than anything else. She said she believes that this is the basis for MC MANAMAN's information concerning the offer of money by the Klan in Mississippi to kill MARTIN LUTHER KING, JR.

In attempting to determine the circumstances concerning her meeting MC MANAMAN in 1964, Mrs. EURE said she met him through a mutual business friend. Her association with MC MANAMAN was business. She said in her opinion MC MANAMAN had a world of knowledge

in real estate business and that if he ever gets out of prison she will always be willing to hire him as an assistant in her real estate business.

After his appeal was denied in 1964, MC MANAMAN was returned to Kansas and began serving his sentence. She said she went out to the Penitentiary on two occasions in 1964, the first time to pick up MC MANAMAN's automobile which she financed for him. All other visits, two or three times in 1965 and once in 1966, were just friendly visits. She said the last time she visited him was early in 1966 and that she has not seen him or heard from him since that time. She said as far as she knows he is still in prison.

Mrs. EURE was very apologetic, very cooperative, and stated that she has no information whatsoever concerning the person or persons responsible for the assassination of MARTIN LUTHER KING, JR. If, in the event she receives any information which may be of help in this matter she will immediately contact the FBI.

Mrs. EURE is a white female, approximately 5 feet 9 inches, slender, moderately attractive, approximately 50 years of age.

A further review of the Leavenworth Penitentiary Classification Sheet for MC MANAMAN discloses that his nine year sentence was in an operative status for 375 days due to an appeal. The Classification Study form of MC MANAMAN, Register Number 81371-L indicates that MC MANAMAN was received at Leavenworth Penitentiary in April, 1964 after his appeal had been denied.

The Bureau, through FBI Identification Division records, may wish to compare the records of DONALD JAMES NISSEN, FBI Number 607320A; LEROY BASIL MC MANAMAN, FBI Number 1244125 (as indicated in prison records) with the known arrest record of JAMES EARL RAY to determine if they were ever confined in the same prison at the same time with subject RAY.

Mr. WILLIAM LINCOLN PIERCE, Rocky Waters Motel, Rural Free Delivery, Waynesville, North Carolina, was advised of his rights as to making a statement by SA ROBERT S. MOORE and the rights, as set out on the waiver of rights form, were explained to him. He stated he knew nothing concerning the matter under investigation and he declined to sign a waiver of rights form. He stated he was willing to discuss his activities in view of the fact he was not involved in this matter.

He viewed a photograph of JAMES EARL RAY and stated that he knew no one who could be identical with this individual. He stated he knew no one by the name of JAMES EARL RAY or any of his aliases.

He said he was from Miami, Florida, and has lived there since 1933, except during the last ten years, when he has spent approximately five months during the spring and summer operating the Rocky Waters Motel, Waynesville, North Carolina.

Mr. PIERCE stated he does not own an airplane, has no airport, nor does he have a financial interest in an airplane or airport. He stated he did not own a tourist court or any property at Belle Glade, Florida, nor did he own property on or near a lake named Okeechobee, Florida.

Mr. PIERCE stated he knows no one by the name of SAMUEL LEWIS or EDDIE WELBORN or WILBURN or JIM GARRISON, the latter from Louisiana (New Orleans). He stated he has no relatives by the name of WILBURN. He said he does not know a DAN THOMPSON, operator of a fishing boat in Florida, has never been a member of or associated with members of the Ku Klux Klan. He said he has had a private pilot's license for two or three years; however, he does not own an airplane and just flies occasionally for pleasure. He stated he has never been in business in Cuba or had any business connections in Cuba. However, he was formerly in the building contracting business in Miami, Florida, and the surrounding vicinity.

Mr. PIERCE stated that several years ago, a judgment was filed against him in Miami, Florida, on a financial obligation of a WILLIAM PIERCE, who he does not know personally.

He stated this WILLIAM PIERCE reportedly owns property on and in the vicinity of Lake Okeechobee, Florida. Mr. PIERCE stated on April 4, 1968, he and his wife were at their cabin on Conch Key, Florida, where they had resided most of the winter. He stated he first heard of MARTIN LUTHER KING's death on the news report the night of April 4, 1968, and he and his wife went to Miami, Florida, on April 5, 1968, where they maintained an apartment, Apartment 5, 500 Northeast 83rd Street, Miami, Florida. He said he stayed in Miami, Florida, until coming to Waynesville, North Carolina, to get his tourist court ready for opening on April 10, 1968.

Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.
