JERRY RAY, NORTHBROOK, ILL. FETTERS ANSWERED THE LETTER AND HAS BEEN CORRESPONDING EVER SINCE. DICKINSON DESCRIBED RAY AS BEING A "KOOK" IN THAT THE TENOR OF HIS LETTERS INDICATES HE WANTS TO BE DOMINATED BY FETTERS SHOULD THEY EVER LIVE TOGETHER.

MAJORIE LOUISE FETTERS NEE JONES, AKA MARJORIE CARLUS, MRS. CHARLES CARLUS, MRS. CLYDE FETTERS, INTERVIEWED TODAY INDEPENDENTLY OF DICKINSON. SHE FURNISHED SUBSTANTIALLY THE SAME INFO AND ADMITS BEING FORMER "STRIPPER".

SHE STATED SHE HAS BEEN CONTACTED IN THE PAST RE A WSTA MATTER IN NORFOLK, VA., UNDER THE NAME MARJORIE JONES.

SHE DESCRIBED AS W/F, DOB [REDACTED], AT FAIRMONT, W. VA., FIVE FEET TWO INCHES, HAIR NATURALLY BROWN, BLEACHED BLONDE AND ALSO WORN RED, EYES BLUE, ONE TWENTY LBS.,

SEVERAL FACIAL SCARS, AND SEPERATED BUT NOT DIVORCED FROM CLYDE FETTERS.

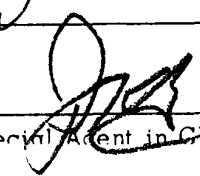
