HYMAN BECKMAN, Owner, H. Beckman Chevron Service Station, 1506 North Normandie Avenue, was interviewed at his place of employment, at which time he furnished the following information:

BECKMAN was shown Chevron service order No. 423676 which was made out in the name of GALT. BECKMAN related he had filled in the service order with the name GALT, no first name given, and had finalized the service order wherein the notation was made "Pd. Cash" and his initials. BECKMAN could not clearly recall the transaction where a Mustang, license 1-38993, no state given, was brought to his service station on February 13, 1968, to have some repair work performed. Mr. BECKMAN related that to the best of his recollection he and AL BALLAN had a brief conversation with the individual who brought this vehicle into the station at approximately 12 noon on February 13, 1968. From looking at the service order, he assumes AL BALLAN had made out the service order containing the work to be performed on the Mustang. Mr. BECKMAN further related the individual bringing the vehicle into the service station had told him that he did not have a telephone number where he was staying as he would only be in Los Angeles for a few days. The individual left the vehicle at the service station, gave the station a time as to when he would like to have the vehicle, and left the area of the station proceeding on foot west on Sunset Boulevard, Los Angeles. The individual returned to the station at approximately 4:30 or 5:00 P.M. in the afternoon. BECKMAN did not observe what direction he came from when returning to the station to pick up the vehicle. Mr. BECKMAN recorded his name at the top of the service order and at the time the bill was paid, made the notation "Pd. Cash" with his initials. BECKMAN does not recall this individual asking for maps at anytime. Only maps carried by BECKMAN are ones of California and Los Angeles which are Standard Oil maps unmarked by BECKMAN to identify his service station.

ALBERT BALLAN, Mechanic, H. Beckman Chevron Service, 1506 North Normandie Avenue, Los Angeles, was interviewed at his place of employment, at which time he furnished the following information:

BALLAN located H. Beckman Chevron Service Station copy of Chevron Service Order No. 423676 which was made out in the name of GALT. The service order indicated that on February 13, 1968, a Mustang with the license 1-38993, no state recorded, speedometer reading 34,185, was brought to the H. Beckman Chevron Service, 1506 North Normandie Avenue, Los Angeles, where two front wheel seals were replaced. The front end was aligned, and the front wheels were repacked. The total charge for the bill was \$12.47 which, according to the service order, was paid in cash.

BALLAN stated he recognized the handwriting on the service order to be that of his own, with the exception of the name "GALT", "Pd. Cash" and the initials of the person receiving the cash from GALT for the work performed. BALLAN stated he did not know which employee had filled out this portion of the service order.

BALLAN stated he could not recall having taken the service order for the above described vehicle, but this could have been done by another employee and he had been advised orally of the work to be performed on the vehicle. He could have, based upon another employee's instructions, then made out a service order. BALLAN related he could not recall the individual bringing the vehicle into the service station for the above repair work, nor could he recall whether the individual stayed at the station while the work was being performed. BALLAN could not recall the time of the day the vehicle was brought into the service station nor could he recall the time it was picked up from the service station.

BALLAN advised the work performed on the Mustang would take an hour to an hour and a half to complete if an individual did nothing else at the service station, such as pumping gas and waiting on customers. BALLAN stated that while performing work on the Mustang he would have had to wait on customers and assist with the other duties of the station. The time it would have taken for the job would have depended upon how busy the station was on February 13, 1968. BALLAN further stated that he was not sure he had performed the work on the Mustang as H. Beckman has another service station located at 8th Street and Western Avenue, Los Angeles, where work is sometimes sent if too large a volume of work is at the Chevron station located at 1506 North Normandie Avenue, Los Angeles.

BALLAN added that had the work been performed at the service station on 8th Street and Western Avenue, Los Angeles, no additional record would be made other than the one at the Chevron service station on Normandie Avenue, Los Angeles.

BALLAN related he did not believe the Mustang had been serviced at the H. Beckman Chevron Service Station anytime prior inasmuch as a record is maintained on the service orders of all regular customers. The service order which he had in his possession did not indicated GALT to be a past customer.

BALLAN voluntarily furnished H. Beckman Service Station's copy of Chevron Service Order No. 423676 to Special Agents of the FBI.

On April 11, 1968, DALE LEROY DYKEMA, 8066 Ring, Long Beach, California, telephone number 596-5212, was interviewed, at which time he furnished the following information:

He has a business address at 3325 Wilshire Boule. vard, Los Angeles, California, telephone number 386-1420. He was the court-appointed Receiver for the apartment building at 1535 North Serrano, Los Angeles, California, during foreclosure proceedings on that property. He stated that his records revealed that he collected the rent on Apartment No. 6 at this address from ERIC GALT for November and December 1967, and, when he attempted to collect the rent on approximately January 18, 1968, he learned that GALT was no longer a tenant. DYKEMA furnished a letter dated December 21, 1967 that he had written to GALT, instructing GALT to send rent payments directly to DYKEMA and to direct any questions or problems to him. GALT returned this letter to DYKEMA. He also furnished a brief letter that he had received from GALT dated January 21, 1968 and postmarked in Los Angeles on January 22, 1968, indicating that GALT had moved.

DYKEMA recalled GALT, stating that he had seen him at his apartment on several occasions when he would collect the rent, and furnished the following physical description:

Mrs. MARGARITA (TRANK) POMERS, 6021 Western Avenue, Buena Park, California (telephone 710-522-7000), was interviewed at her residence on April 12, 1968, at which time she furnished the following information:

She was, together with her husband, TRANK POTERS, the manager of the apartment building at 1535 North Serrano, Los Angeles (Hollywood), California, from July 1967, to December 15, 1967. During the time she managed the apartment building, she and her family resided in apart- and ment 12-A, on the first floor of the building.

She recalled that during a day of bad weather in November 1967, Mr. ERIC CALT came to the building and said that he was seeking an apartment to rent. He said that he had seen a vacancy sign out in front of the building, and was seeking an apartment that he could rent immediately. She said that a bachelor apartment (apartment number 6) on the first floor of the building was available. She showed it to him and he said he would take it.

Mr. GALT explained the he was normally employed as a salesman; and that he had left applications for positions as a salesman with several firms. He asked if it would be permissible for him to use her telephone until he could get one installed. She said that it would. He did not receive any telephone calls over her phone; nor did he ever use it following that first encounter, to the best of her recollection.

Mrs. POURS said that as his apartment only had one chair in it; she made arrangements to get another chair for him. The day she took the extra chair to his room she saw he had a telephone installed in the apartment.

Mrs. POWERS said that Mr. GALT paid her in cash, one hundred dollars basic monthly rent, plus twenty-five dollars fee for cleaning the apartment, plus a two dollar and fifty cent key deposit. Mr. GALT was instructed, by Mrs. POWERS, that he could use the apartment building's utilities for the first three days; but that during that time he should go to the utility companies and make personal arrangements

to have the utilities for his apartment installed in his own name. Some time after the three day grace period had lapsed, Frs. PO TRS learned that Mr. CALT had not gone to the utility commanies and had not made the arrang ments for installation of utilities in his own name. Mrs. POTRS said when she learned this she contacted Mr. DALE DYKEM, the court-appointed receiver managing the financial affairs of the apartment building, and obtained permission for Mr. CALT to continue use of the building's utilities upon payment of an additional ten dollar payment. It was her understanding that Mr. CALT would be expected to make such an additional payment above his basic 100.00 basic rent on a monthly basis.

Mrs. POWERS said she never saw CALT have any visitors, nor did he have anyone living with him in Apartment "6, to the best of her knowledge. She did not know him to have any employment; and he did not mention to her the names of any of the firms he allogedly had placed applications with for jobs. He was a very quiet tenant, and did not mix with the other occupants of the building. She did not recall Hr. GALT ever using the swimming pool at the apartment.

He drove a small white car, make or model not recalled by Mrs. POTERS. He parked it in the basement and usually walked to the nearby shopping areas. Mrs. POTERS said she had the distinct inpression that his car did not have California license tags; as she recalls speing it on several occasions when there was some discussion as to whether it was parked in the mace in the basement garage alloted to apartment number six.

Ins. PCMERS said she recalled putting Mr. GALT's name up on the apartment directory posted near the front entrance to the building. He did not object; but she said it was possible that he never noticed it posted there.

Mrs. POERS said that she had filled out a rent receipt for Mr. GAVE, when she first rented him the room. She said that she and her husband moved from the apartment building on Servano approximately December 15, 1967, and so did not take any more rent partments from Er. CAMP, who was still residing in Apartment 6, then they moved to Buena Park, California.

JENNIE MORGAN, Apartment 6, 1535 Serrano, Los Angeles, California, was interviewed in connection with her knowledge of ERIC GALT. She provided the following information:

She stated she is the wife of GERALD ALTON MORGAN, Warrant Officer, United States Army, presently in Vietnam. She stated she and her four year old son, JERRY, moved into Apartment 6 at this address on February 12, 1968. She stated the apartment was not clean in that various Los Angeles newspapers were lying around on the floor. A telephone was in the apartment but was not in service. No letters or other material were left lying around indicating the identity of the former tenant. Only one letter was received by her at this address which was not addressed to her. This letter, apparently addressed to a former tenant, was returned to the Post Office Department. She stated she did not know if this letter was from out of state nor can she recall to whom it was addressed or the name and address of the sender. She denied knowing ERIC GALT or ever hearing of him. She stated that she and her husband did own a 1955 Pontiac Le Mans, which was recently repossessed by the Security First National Bank. She stated she is employed as an Inhalation Therapist at the Physical Therapy Department of Westside Hospital, 910 Fairfax, Los Angeles, California. She denied being known as GINGER, claiming that only one person has ever called her by this nickname, that was the wife of a serviceman in Germany. She denied knowing anyone by the name of ANITA or SUE.



THOMAS R. DAVISON, Apartment 7, 1535 Serrano Avenue, Los Angeles, was interviewed at his home at which time he furnished the following information:

DAVISON advised he has resided at this address since April 1, 1967. He advised that he was familiar with the name ERIC GALT only from the name having appeared on the mailbox in the apartment house. When asked if he was acquainted with the former tenant who resided in apartment 6. 1535 Serrano Avenue, Los Angeles, during December, 1967, and January, 1968, DAVISON replied that he had only seen this individual who was a white male in the hallway of the apartment house. He never had any conversation with the individual and never saw him under circumstances under which he could make an identification. He stated the only time he saw the individual who resided in apartment 6 was as he passed his door in the hallway. The light bulb in the hallway is continuously burned out and the only light available to see anyone in the hallway is from his room. DAVISON related he did not know if the individual had a vehicle or if he was employed while a tenant in the apartment building. DAVISOR commented the individual, to the best of his knowledge, did not have any girlfriends and never had any noisy parties in his apartment.

DAVISON stated he had ascertained from the landlord that when GALT skipped from the apartment, he had taken a key belonging to the building. The landlord told DAVISON that GALT had returned the key by mail. Shortly after GALT skipped from the apartment house, a male and female who resided on the second floor of the apartment house skipped. DAVISON did not know the names of these individuals.

Miss SYLVIA BLANK, Manager, Gramercy Park Apartments, 1831 Gramercy Place, was contacted at her place of employment during the early morning hours of April 12, 1968, and after being advised of the identity of the contacting agents, she was interviewed regarding her knowledge of ANITA KATZMINKEL and the occupants of Apartment 303.

BLANK stated that she has never heard of ANITA KATZWINKEL and that the occupants of Apartment 303 were a couple by the name of FLIKEID. She then explained that she took over as manager of the Gramercy Park Apartments on April 1, 1968, from the previous manager RUTH SMITH. Apparently SMITH had some sort of difficulty with the apartment owners because she left in a rush and did not tell BLANK anything about the job.

BLANK stated she recalled that on the day she took over as manager of the apartments, April 1, 1968, she had not been in her apartment for more than five minutes when Mr. TOM FLIKEID came in and paid her \$140.00 for the rent of Apartment 303 for the month of April, 1968. At the same time, he told her that he and his wife would be leaving on a three month vacation at the end of April and that he would vacate their apartment at that time.

BLANK stated that for approximately the first week after she took over as manager, she did not stay at the apartments at night because she did not have her drapes up. One day during that week, possibly on the 4th or 5th of April, she arrived at the apartments and found a note from Mr. FLIKEID, along with the key to their apartment. This note advised that they had moved out of their apartment. She did not see them go nor did she know the moving company that had moved their furniture. She thinks they possibly might have had their furniture stored, rather than taking it along with them as they rented an unfurnished apartment and had a lot of furniture.

BLANK stated that there is one person in the apartments who might know what moving company moved the FLIKEIDs. That

SMITH can be contacted through the apartment's owner, Dr. GILL MARTIN, who is a dentist and who resides in Orange County, California, and who has a phone number of 714-541-3386.

BLANK then stated she believed that it was the Friday following April 1, that she found the note from FLIKEID in her mailbox. They also left a lot of food in their refrigerator and a pair of woman's shoes and a torn man's bathrobe. BLANK stated she owed the FLIKEIDs the balance of the \$140.00 rent money Mr. FLIKEID paid on April 1.

BLANK stated she could not furnish any descriptive data regarding the FLIKEIDs as she never saw Mrs. FLIKEID, and only saw Mr. FLIKEID for about five minutes on one occasion. She did advise she thought her first name was SUE.

BLANK then made available the note she had found in her mailbox that was signed Mr. FLIKEID; one Rental Application, dated May 17, 1967 signed THOMAS FLIKEID; and one Standard Rent Agreement dated December 5, 1967, for Apartment 303, signed by Gramercy Park Apartments lessor agent, RUTH SMITH, and by lessee, THOMAS M. FLIKEID. The note was written on a 3 x 5 piece of white note paper and bore the inscription, "Keys from 303 Sorry we could not get to know you better Mr. Flikeid".

After furnishing the above information, BLANK stated that something occurred to her on the night of April 11, 1968, that might have some bearing on the FLIKEIDs. She then stated that at about 9:30 p.m., April 11, 1968, there was a knock on the door to her apartment. She opened the door and there was a white man standing there who she could only describe as being in the late thirties, having dark brown wavy hair, and whose eyes were red-rimmed as if he had been drinking. She could not recall smelling alcohol. This man asked BLANK if she knew what happened to the previous occupant of Apartment 102 who had moved upstairs. BLANK advised that she was afraid of the man and told him she did not know; however, SUE FLIKEID formerly was the occupant of Apartment 102 and later moved to Apartment 303. BLANK stated that after she told the man she did not know, she heard him go to the present occupants of Apartment 102 and

ask them the same question. Shortly, thereafter, she observed this man walking up and down in front of the apartment house. He did this for approximately three or four minutes and then left the area. She did not see this man enter an automobile.

Miss BLANK stated she could not furnish any further information regarding the FLIKEIDs, but stated that if she did recall anything she would immediately contact the Los Angeles FBI Office.

During the early morning hours of April 12, 1968, Miss ANITA LOUISE KATZVINKEL was contacted at her residence of Apartment 9, 1727 North Garfield Place, and after being advised of the identity of the contacting Agents, she was interviewed regarding her background, associates, and knowledge of ERIC STARVO GALT.

KATZWINKEL stated she knew and had associated with a girl by the name of GINGER and another girl by the name of SUE. She identified GINGER as GINGER NANCE and SUE as SUE HARRIS, also known as Sue Flickeid. She denied knowing anyone by the name of ERIC STARVO GALT. When asked to furnish the details surrounding her association with NANCE and HARRIS, she furnished the following information:

NANCE, HARRIS and she grew up together in Dixon, Illinois, and all three attended the same high school and ran around with the same "crowd". While still in high school, HARRIS' parents sent her to Los Angeles, California, to live with her aunt, Mrs. (FNU) GOSS, because her parents felt HARRIS was running with a wild crowd and that she would be better off in California.

During May or June, 1967, KATZWINKEL and NANCE decided to go to California and meet with HARRIS. They left Dixon, Illinois, traveling in a bronze colored 1960 or 1962 Rambler which belonged to CHARLEY DAY, NANCE's ex-husband. This car broke down on Highway 66 just outside Oklahoma City, Oklahoma, so they abandoned the car there. At this point they met two men who gave them a ride to San Diego, California. These men were from San Diego but KATZWINKEL could not furnish any additional information regarding them other than they were white males. From San Diego they obtained a ride to Los Angeles, California, and arrived in Los Angeles the Tuesday before Mother's Day in 1967.

Thereupon they took up residence in the Palms Motel, located somewhere on Sunset Boulevard in Hollywood, California.

KATZWINKEL and NANCE rented a room at the Palms Motel for approximately two weeks and thereafter moved to the Serrano Apartments, located at 1535 Serrano Avenue, Hollywood, where they rented Apartment 6. Both the room at the Palms Motel and the apartment on Serrano Avenue were rented in KATZWINKEL's name. They rented this apartment until about the middle of June 1967; however, KATZWINKEL stated that she spent only about one or two nights at this apartment because in the meantime she had met THOMAS HUNTER. Shortly after meeting HUNTER she moved into his apartment located at her present address of 1727 North Garfield Place. NANCE continued to reside in the Serrano Avenue apartment until the middle of June. Thereafter, she returned to Dixon, Illinois, and KATZWINKEL has not seen her since then.

Regarding NANCE, KATZWINKEL stated that while in Los Angeles she dated a Negro, whose name and further descriptive data was unknown to KATZWINKEL. KATZWINKEL stated that upon returning to Dixon, Illinois, NANCE was arrested by police authorities there on a bad check charge and was supposed to have served six months in prison. NANCE has been married a couple of times and goes by the name of GINGER DAY, GINGER NANCE or GINGER CUNNINGHAM. NANCE was the last name of one of her husbands, KENNETH NANCE. CUNNINGHAM is the name of her father, who was last known by KATZWINKEL to reside in Bellflower, California.

According to KATZWINKEL, when NANCE left the apartment at 1535 Serrano, she left a number of her clothes and personal items in her apartment. She locked the door of the apartment and KATZWINKEL had to ask a friend of hers to help her open the door. Some boy friends of NANCE's in Dixon, Illinois, who might know her whereabouts at the present time are JIM LEIGH (phonetic), CHARLEY GULF, and TOM SHERIDAN.

Regarding SUE HARRIS, also known as Sue Flickeid, KATZWINKEL stated that when she and NANCE arrived in California in May or June, 1967, they found HARRIS living in a common-law relationship with TOM FLICKED at the Palms Motel. When asked whether or not HARRIS was operating as a prostitute, KATZWINKEL stated that she was. KATZWINKEL denied

working as a prostitute but did admit on occasions she would answer HARRIS' phone and set up dates for HARRIS. When asked whether or not TOM FLICKEID was gainfully employed, KATZWINKEL stated that she did not know his employment but that he was not a pimp for HARRIS. When asked if she had ever lived with HARRIS or FLICKEID at their apartment at 1831 North Gramercy Place, KATZWINKEL stated she had not. When advised that the phone number at their apartment was listed in her name, KATZWINKEL stated that SUE HARRIS had obtained her permission to put the phone in her name because HARRIS owed the phone company a large amount of money on a previous phone under her own name. When asked whether GINGER NANCE had acted as a prostitute while in California, KATZWINKEL stated that she had not because "she was too fat and ugly".

When asked if she knew the present whereabouts of SUE HARRIS and TOM FLICKEID, KATZWINKEL stated that they were presently on a three-month vacation touring the Southern states. She advised that just prior to leaving they had purchased a 1967 Ford Thunderbird for this vacation from Cort Fox Ford in Hollywood. When asked if she knew where they obtained the money for this automobile, KATZWINKEL stated she believed HARRIS had paid \$500.00 of her own money as down payment for this car. She stated she last saw HARRIS and FLICKEID on the night of February 14, 1968.

When asked if she knew where HARRIS and FLICKEID were at the present time, KATZWINKEL stated that they wanted to be in Dixon, Illinois, by April 12, 1968, to visit HARRIS' mother there. KATZWINKEL described TOM FLICKEID as a white male American, 6', about 170 pounds, light brown hair, blue eyes, very Norwegian looking, well built, a very neat dresser, left-handed, and somewhat of a braggart. She also stated that he smoked, which she remembered to be Camel cigarettes, and drank Scotch and water.

After furnishing the above information, KATZWINKEL was asked again if she had ever known anyone by the name of ERIC GALT or anyone using the last name of GALT. She stated that she had not. She was asked if she knew anyone who owned

a white Ford Mustang. She stated she did not. She was then asked if she could ever recall having furnished her name and address on Serrano Avenue to anyone. She stated that she could not recall ever having done so. She was then advised that her name and her address of her apartment on Serrano Avenue had been located on the paper found in a white Mustang which had recently been recovered by the FBI in Atlanta, Georgia. She was then asked if she could give any reason or explanation as to why her name and address would have been on the paper located in this automobile. KATZWINKEL stated that she had no idea. When asked what the word "Oklahombe" meant to her, KATZWINKEL stated that she had no idea, other than it sounded like a misspelling of the word Oklahoma.

At this point in the interview the results set forth above were discussed once again with KATZWINKEL, and she was asked whether or not she could furnish any further information regarding any point covered above. She stated that she could not at this time remember or recall any further details surrounding her trip to California and her association with NANCE, HARRIS or TOM FLICKEID, nor the reason her name and address would have been on a piece of paper found in an automobile recovered in Atlanta, Georgia.

After relating the above information, KATZWINKEL made available to the interviewing Agents three colored snapshots. One was a snapshot of herself standing in front of the apartment house located at 1727 North Garfield Place; the second was a snapshot of SUE HARRIS in a bathing suit on a beach, and the third was a picture of TOM FLICKEID seated in a chair facing the camera with SUE HARRIS on his lap.

The following descriptive data was obtained from KATZWINKEL:

During the late afternoon hours of April 13, 1968, KATZWINKEL was contacted at her place of employment and was agreeable to being reinterviewed. She was interviewed in a Federal Bureau of Investigation automobile located in the 5300 block of Santa Monica Boulevard.

During the course of this interview she was asked to reiterate the details of her trip to California and her association with GINGER NANCE and SUE HARRIS. She was asked specifically how she and NANCE had obtained a ride from San Diego to Los Angeles. She stated that when they arrived in San Diego, NANCE telephonically contacted her father, Mr. (FNU) CUNNINGHAM, who picked them up in San Diego and took them to his trailer in Bellflower, California. They spent the first night at his trailer in Bellflower. The next morning he drove them to the Palms Motel on Sunset Boulevard, in Hollywood, California. There they met up with SUE HARRIS who, at that time, had an apartment at the motel with TOM FLICKED. KATZWINKEL and NANCE rented room No. 7 at the Palms Motel and KATZWINKEL rented it in her name and paid for the room.

When asked where she obtained the money for the room, KATZWINKEL stated that while coming to California she called a friend of her brother's by the name of HOWARD CARLSON, and he sent her \$30.00. She called CARLSON from some place in Texas. CARLSON resides in Mendota, Illinois, and he agreed to send her \$30.00 by Western Union telegram. This money was sent to her at the Western Union Office in San Diego, California.

When asked why she chose the Palms Motel, KATZWINKEL stated that she had corresponded with SUE HARRIS prior to leaving Dixon and HARRIS had made reservations for her at the Palms Motel.

KATZWINKEL advised that they had stayed at the Palms Motel for two weeks. When asked how much rent they paid for their room and where they obtained the money for it, KATZWINKEL stated that the room ran them about \$20.00 a week and that she had filled "dates" at the motel on two or three occasions to obtain money.

When asked where she contacted these "dates", KATZWINKEL stated that she worked for SUE HARRIS and that HARRIS had the contacts. She was paid \$10 to \$15.00 per "trick" and this money was paid to KATZWINKEL and not to HARRIS. KATZWINKEL stated that HARRIS was running a call girl service by herself and that HARRIS would send those "dates" to her that she did not have time to fill herself.

During this time TOM FLECEID, who was living with HARRIS, was employed by the Hollywood Carpets as an installer. KATZWINKEL stated she did not fill any "dates" with any persons from FLICKED's place of employment and would recall doing so because she knew the people FLICKED worked with. KATZWINKEL stated HARRIS took her to the Vegas Club located on Hollywood Boulevard and she met some of her contacts there. HARRIS, NANCE and KATZWINKEL went to the Vegas Club regularly, according to KATZWINKEL. When asked if she recalled a Negro guitar player there, KATZWINKEL stated that there was a Negro guitar player at the Vegas Club whose first name was TONY.

KATZWINKEL stated that after staying at the Palms Motel for about two weeks, she and NANCE moved to the Serrano Apartments and rented Apartment 6 in her name. She asked if she ever received any utility bills at the apartment, KATZWINKEL stated that her utilities were included in the rent for the apartment.

When asked whether or not she ever filled a "date" while living in the Serrano Apartments, KATZWINKEL at first stated she did not because although the apartment was rented in her name for about three weeks, she herself lived there one or two nights. After asking her to think over this question for awhile, KATZWINKEL stated that she did fill one "date" at the Serrano Apartments. Her customer was a man whose name she thought to be TOM REGGIE, who ran a laundry located on Sunset Boulevard. This "date" had been given to her by SUE HARRIS and was a regular customer of HARRIS'. REGGIE did laundry for HARRIS and was repaid by her favors rather than with money. KATZWINKEL described REGGIE as a white male, about 35 to 40 years of age, 5'10", about 250 pounds, black curly hair, possibly having a hairline mustache, and driving a white panel truck. KATZWINKEL stated that she met REGGIE at HARRIS' apartment and that he drove her and GINGER to the Serrano Apartments where she turned the "trick". Afterwards REGGIE took both she and NANCE to lunch in his white truck.

KATZWINKEL was then asked if she would be willing to furnish samples of her handwriting and she advised that she would be agreeable to do so. She was then given a white, lined tablet and asked to write various words in sequence on the tablet. These words included her name, ANITA KATZWINKEL, GINGER and DAY; the address 1535 Serrano, Oklahombe, and Apt. 6. After writing these words, she was then shown the colored photograph of a Kleenex box top on which appeared the writing "GINGER DAY & ANITA KATZWINKEL, etc." After looking at this photograph, KATZWINKEL stated that the writing depicted in the photograph appeared to be her writing but she could not recall ever having given her name and address to anyone. She stated that the word "DAY" appearing immediately above and after the word "GINGER" in the photograph was the last name of GINGER DAY, who is identical to GINGER NANCE. She stated she knew nothing whatsoever of the words "Oklahombe" and "Broult" which also appeared in the photograph. When asked whether or not Oklahombe was the name of a Negro guitar player at the Vegas Club, KATZWINKEL stated that she did not think so. When asked whether or not she could give any explanation as to why her name and address were found in an automobile believed to have belonged to ERIC GALT, KATZWINKEL stated that she had no idea whatsoever.

RATZWINKEL was then asked if she normally gave her name and address to her customers. She stated that she did not. She then advised that it was possible that she had given her name and address to a Negro male by the name of TOM WASHINGTON, whom she met at a bowling alley on two occasions. This bowling alley is located on Hollywood Boulevard. Both she and NANCE used to hang out at this bowling alley and this Negro man bowled in a league on either a Tuesday or a Thursday evening. He also drove a white Mustang convertible. KATZWINKEL further described this man as about 30 years of age, light complected, but she did not know where he was employed. She also advised that she never dated this man but did think it possible that she might have given her name and address to him.

KATZWINKEL was then shown an artist's conception of ERIC GALT and photographs of J. VERNON. She stated that she has never seen either of these two individuals. She was then shown the colored photograph of a green colored bedspread and stated that this did not mean anything to her.

When asked if she could furnish any further information regarding the above matter, KATZWINKEL stated that she could not; however, if she did recall anything as a result of these interviews, she would immediately contact the FBI Office.

On April 13, 1968, DAVE HELLER, Owner, Paul Vegas Club, 5510 Hollywood Boulevard, Los Angeles, California, advised that ANTHONY HARRISON and BOB TAYLOR were the only Negro musicians at his club during 1967 and 1968 to date. He advised that he does not know the whereabouts of BOB TAYLOR but he stated that ANTHONY HARRISON is working for the FriarTuck's Inn, Manhattan Beach, California, and he has unlisted phone number RE 4-4216. HELLER advised that the term or word "olkahombe" is unfamiliar to him. HELLER was shown the artist conceptions received from Memphis and Birmingham and HELLER advised that the person depicted in the artist conception received from Birmingham was somewhat familiar. HELLER was shown photographs of JEROME VERNON and he stated that VERNON had been in his club. HELLER advised that the name GALT was unfamiliar to him. HELLER was unable to furnish any information pertaining to ERIC GALT.

Miss SYLVIA BLANK, Manager, Grammercy Park Apartments, 1831 Grammercy Place, was contacted at her place of employment, and after being advised of the identity of the contacting Agent was interviewed regarding the unknown white male who had contacted her at her apartment on the night of April 11, 1968.

She was shown the artist's conception of ERTC GALT, compiled in Memphis, Tennessee, and the artist's conception of GALT, which had been compiled by the Los Angeles FBI Office. She was then asked if either of these two pictures resembled the white male who had contacted her on the night of April 11, 1968. After looking at both of them for a short period of time, BLANK stated that the composite of GALT, prepared in Memphis, appeared to resemble the person, but the person she saw had a full head of hair, but not combed in the style shown in the Memphis picture.

When asked to further describe the man who contacted her, BLANK stated that she did not get a real good look at him, but did notice he had dark, piercing eyes, which were red-rimmed, either from drinking or from lack of sleep. Although the man was clean-shaven, he had a "rumpled appearance", and to the best of BLANK's recollection, was dressed in a white shirt and slacks. He spoke nicely and in a quiet tone. BLANK stated she thought he would have been a very nice looking man if he were cleaned up.

BLANK stated that after she told the man she did not know where the person was he was looking for, the man went to the present occupants of Apartment 102. She knew he asked the occupant at that apartment the same questions that he had asked her as she could hear them talking even though her own door was closed. She stated Apartment 102 is located just down the hall from her own, and the man had inquired after a girl, whose first name began with the letter "S", possibly SUE, who had lived in Apartment 102, but who had moved to one of the upstairs apartments.

the man apparently left the apartment house, as the next time she saw him was when he was walking up and down on the sidewalk out in front of the apartment. He walked up and down for about three or four minutes and then walked across the street to where he had parked his car. BLANK stated that it was very dark that night, but she thinks his car was an older model, make unknown, four door sedan, dark in color, with a bad muffler. She knew the muffler must have been bad, as it made a loud noise when he drove off.

At the time of this contact, BLANK advised that she had found something else that the FLIKEIDs had left behind when they moved. She furnished a paid room receipt from the Miramar Hotel, Post Office Box M, Santa Barbara, California, in the name of T. M. FLIKEID, 1831 North Gramercy, Hollywood, California, a review of which indicates FLIKEID spent January 20, 1968, at this motel.

Later during the day of April 15, 1968, BLANK was recontacted at her place of employment by Special Agents THEODORE M. GARDNER and FREDERICK E. BECKER, and was shown a picture of a person believed to be ERIC SARVO GALT. She was asked if this person resembled the white male who had contacted her on the night of April 11, 1968. She stated that it did not.

EWEN L. STINNETT, Co-Owner, Hollywood Carpet, Inc., 2952 West Pico Boulevard, phone 735-1365, advised that he could not recall having ever employed an individual named ERIC GALT during his two and one half years in business as the Hollywood Carpet, Inc.

STINNETT viewed two composite artist's conception photographs of individuals, and he stated that one of the composite photographs somewhat resembled a former employee names THOMAS FLICKEID.

STINNETT described FLICKEID as follows:

STINNETT said that FLICKEID had worked for him in the Fall of 1967, and up to about November or December 1967. STINNETT advised that FLICKEID worked with a man named DOUGLAS BRZUZIWSKI and both FLICKEID and BRZUZIWSKI now work for the Colorado Carpet Service, Glendale Boulevard, Glendale, California. STINNETT stated that any additional records concerning possible employment of ERIC GALT and the employment of FLICKEID could only be obtained on April 13, 1968. Mr. STINNETT said that he did not recognize the other composite photograph which was exhibited to him. STINNETT said that although one of the composite photographs somewhat resembles FLICKEID, he could not identify FLICKEID from the photographs.
