On 5/24/68, Officer DESANNO, O'Hare Field, Chicago Police Department, telephonically advised that he had received information from Hertz Rent-A-Car, Chicago, that a Miss DUFFY, Hertz Rent-A-Car, Rockford, Illinois airport, rented a Mustang color green, bearing 1968 license HC 8409 and Hertz No. 31060, to an individual identifying himself as MIKE SKOFF, on 5/23/68. SKOFF reportedly stated his plane had been grounded and he needed to report to his place of employment, the Palwaukee Airport, Glenview, employer CHARLES PRIESTER, residence 2748 Covert Road, Glenview.

Inquiry by SA WALKER determined that one MIKE SKAFF is the son of news broadcaster VINCE LLOYD and part owner of the Palwaukee Airport. It was also determined that MIKE SKAFF was employed as claimed.

Inquiry was made into this matter inasmuch as Miss DUFFY advised on 5/24/68 that she received a wanted flyer of JAMES EARL RAY and she was certain that MIKE SKAFF and RAY were one and the same. In view of the above, no further investigation.

On May 9, 1968, TOM NEUCOMB, Manager, Enco Service Station, Torrence and Pulaski, Calumet City, furnished information that ROBERT CAREY on April 29, 1968, driving a 1960 Ford Pickup, past a fraudulent check. He used Enco credit card belonging to ARTHUR G. NIX. The check was drawn on a bank in Huntsville, Texas. He stayed at the Crown Motel, Calumet City. NEUCOMB understood that he had skipped without paying his bill. He advised that in a conversation with the manager of the Crown Motel they agreed that CAREY looked very similar to the subject RAY. CAROL JONES advised that CAREY had Texas license [REDACTED] and reiterated that he appeared very similar to subject RAY.

On May 9, 1968, teletype was sent to Houston and San Antonio and CAREY was subsequently eliminated.

On 5/24/67 MRS R. PULLIA, 5447 W. Chicago Ave. advised that she had been residing at this address for the past 3 years. She stated that there are no residents in this building who have been there longer than she has.

PULLIA stated that the building is presently owned by a MR. GRANDINETTI who took it over from the PILGRIM REALTY COMPANY in December of 1967.

On 5/24/67 MRS E.H. MELONE, saleswoman, PILGRIM REALTY CO., 5637 W. Lake St. advised a search of her records re past tenants at 5447 W. Chicago Ave. failed to reflect anyone by the name of MRS. IRENE COLLINS ever having lived at this address. She added that a check with other members of the firm re COLLINS was negative.

She stated her Company managed this building from July 1, 1963 to October 31, 1967.

It is noted that in interview with MRS. PULLIA, supra, she stated she never knew anyone by the name of IRENE COLLINS ever having lived at the above mentioned address.

The following investigation was conducted by
SA JOHN J. SHERIDAN at Rochelle, Illinois, on 5/6/68:

Chief of Police FRANK DANEKAS and Captain HAROLD GRAY, Rochelle Police Department, were shown the photographs of JAMES EARL RAY and they both stated they know of no one in Rochelle, Illinois, area resembling the subject.

ROBERT DOWD, Station Agent, CB&Q Railroad, Rochelle, Illinois, advised that he was on duty the night of May 3, 1968, and he recalls no one resembling a photograph of the subject traveling on any train going through Rochelle. His records shows that for the night of May 3, 1968, the Burlington Silver Glade left Rochelle at 10:07 p.m. and he sold three tickets on that train. One was an adult fare to Chicago, and he also sold two half fares to Aurora. He stated the half fares would have been to children under 12 years of age. He could not specifically recall to whom he sold the adult ticket to Chicago, but stated that definitely the person did not resemble the photograph of JAMES EARL RAY. He stated that no names are taken when a person purchases a ticket on the train unless they apply for advance reservations beyond Chicago.

Mr. JERRY EWALT, and GEORGE VRANA, Station Agents CB&Q Railroad, Rochelle, Illinois, were shown photographs of JAMES EARL RAY and neither of them could identify the photograph of any individual they ever saw around the railroad station at Rochelle, Illinois.

A recheck was made of the records of the Rochelle Credit Bureau and Mr. J. C. MARSHALL, Owner, advised that he has no records on JAMES EARL RAY under his true name or any known alias nor could he identify the photograph of anyone he had ever seen in the past.

ALLEN advised that he recalled the individual on the train referred to and that it was definitely not JAMES EARL RAY.

After numerous attempts O.A. WESTLUND, Brakeman on the Burlington Silver Glade on 5/3/68 was contacted at his home at 581 South Lincoln St., Aurora, Illinois. WESTLUND stated ALLEN had mentioned the above individual to him but he did not even recall seeing the man. He was unable to identify a photograph of JAMES EARL RAY.

Mrs. PLATT advised that HELFRITCH applied for employment at Condell Hospital on 4/11/68 and was employed 4/15/68 as a kitchen helper. He is presently employed in this capacity and has indicated he plans to terminate his employment in approximately ten (10) days, supposedly to go to school. She advised that he indicated to her that he had been in service (Military), however, this has not been checked, nor has any of his references been checked. She further advised that HELFRITCH indicated to her that he has, in the past, taken correspondence courses and has taken courses in photography. She stated that although he lists his DOB as [REDACTED], it is her opinion that he is considerably older than this. She indicated that she has seen photos of subject ~~XXXXX~~ (RAY) and that HELFRITCH closely resembles the photos, although she could not recall particular points of similarity.

Mrs. PLATT stated that any contact with her should be made at her home and Agents contacting her should telephone her prior to appearing at the home. She explained that her husband ~~is~~ is in service and she is extremely cautious about anyone who comes to her house without prior telephonic contact. She will cooperate in every way possible, but she does not want to be exposed as the source of this information and does not want to be contacted at her employment, because of possible embarrassment.

Review of captioned file revealed that in checking country clubs, a Mr. ERIC HELFRICH, Hickory Knoll Golf Course, Lake Villa, Illinois, was contacted. Mrs. HELFRICH was telephonically contacted above date and upon asking to speak to ERIC HELFRICH, she advised whether the Agent desired to talk to Junior or Senior. She then informed that her son, ERIC, was presently employed at Condell Hospital, Libertyville, Illinois, and that his birthdate is [REDACTED]. The foregoing eliminates HELFRICH as subject.

Re Memo of SA ALTON E. BRAMBLETT dated 5/8/68

On 5/13/68 Jerome Friedman owner of Jerry's Food Market 115 E. 47th Street Chicago, Ill. was contacted regarding his statements that a man who strongly resembles JAMES EARL RAY has been making food purchases in his store.

Friedman stated that the man he suspects has been coming into his store for about a week and that he lives somewhere in the neighborhood. Friedman described him as follows:

Jerry's
Friedman viewed several Photographs of Ray and chose a 1960 photograph, after hair and mustache were shaded in by pencil as that most resembling the man frequenting his store. On subsequent interviews Friedman advised that the suspect was living with a Negro female in a common law relationship but his address was still unknown. An attempt to locate suspect through a neighborhood investigation was negative.

On 5/28/68 Friedman was recontacted and stated that suspect was living at 4705 S. Michigan. Subsequent investigation at that address revealed that a white man was living with a negro female on the third floor and that he fit the general description previously given. This individual was subsequently contacted and although he vaguely resembled the 1960 photograph of Ray with hair and mustache added, it was obvious that he was not Ray. A comparison of fingerprints was also made with negative results.

On 5/20/68, Mrs. THERESA PELLEGRINO, 502 East Memorial, Bensonville, Illinois, advised her mother is NANCY COSENTINO, who resides at 502 East Memorial. It is noted COSENTINO is the sister of DE CORE. PELLEGRINO advised she and her mother have not seen DE CORE since before Christmas, 1967, and have no idea as to where he may be living. She advised she cannot recall DE CORE ever having mentioned the name JAMES EARL RAY. She advised should DE CORE contact them she would have him immediately contact the FBI.

On 3/20/68, Mrs. MARTHA BUTTITTO, 9241 North Maple Court, Morton Grove, Illinois, advised DE CORE is her brother. She stated DE CORE contacts her with regularity, yet she has no idea as to where he may be living. She advised the next time DE CORE contacts her she would immediately have him contact the FBI.

On 5/21/68, Mrs. BUTTITTO telephonically contacted the writer at which time she advised her brother would be at her residence at approximately 5 PM, 5/21/68 and would be available for interview.

On May 28, 1968, female using name FRANCES E. RAY, address 6149 Rugby, Huntington Park, California, telephonically contacted Los Angeles FBI and Quincy, Illinois Police Department concerning the whereabouts of ~~JERRY~~ RAY.

FRANCES E. RAY, who claims is a second cousin to JAMES EARL RAY, interviewed by the Los Angeles Division on May 30, 1968, and stated she is related to JAMES EARL RAY, but disclaimed any knowledge of his whereabouts or activities or that she has ever met him.

FRANCES E. RAY is a self-professed alcoholic and advised that telephonic contact was made with the FBI, Los Angeles and Quincy, Illinois Police Department, because she felt very depressed for the subject RAY.

FRANCES E. RAY advised she is divorced and has resided in Los Angeles since 1933 and is presently receiving public assistance from Los Angeles County.

NORMA JEAN DOUGLAS, 6319 Rugby, Huntington Park, California, daughter of FRANCES E. RAY, was interviewed by the Los Angeles Division on May 30, 1968, and disclaimed any knowledge of RAY's whereabouts or activities and advised FRANCES E. RAY is a chronic alcoholic and prone to make frequent prank telephone calls.

The following lead was set forth in the May 30, 1968, Los Angeles teletype for Springfield Division and is being reset for the Chicago Division:

Springfield (Chicago) through JERRY RAY, ascertain how well known a relative FRANCES E. RAY of Huntington Park, California might be.

On 5/29/68 WINSTON MOORE, Superintendent, Cook County Jail, telephonically contacted SA DONNELLY in regard to a letter which he had received from an inmate on Tier B-3. MOORE advised that the writer of this letter had requested that either SA DONNELLY or SA ROBERT A. KEANE contact him inasmuch as he had info concerning the death of Dr. MARTIN LUTHER KING.

MOORE requested from SA DONNELLY any info he might have concerning the individual who wrote this letter. SA DONNELLY advised MOORE that it was his feeling that the writer of the letter would have been the captioned subject. MOORE advised that he would attempt to determine if PIERSON who is presently incarcerated in the Cook County Jail and is located on Tier B-3 wrote the letter and if so, he would disregard the request of PIERSON, inasmuch as PIERSON is mentally unbalanced.

WILLIAM PIERSON was originally contacted by SAs DONNELLY and KEANE in connection with a TFIS investigation concerning the theft of several cartons of clothing from United-Buckingham's terminal, in McCook, Illinois. At the time PIERSON was contacted he was employed by Burns Detective Agency as a part time security guard. PIERSON denied any knowledge of the theft at the time of the interview but stated that if he received any information concerning this theft he would immediately contact either SA DONNELLY or SA KEANE. (It is noted that PIERSON was furnished with the names of Agents and office telephone number of the interviewing Agents.)

On several occasions WILLIAM PIERSON has contacted either SA DONNELLY or SA KEANE at the Chicago

Office and supplied information concerning possible violations, however, on each occasion the information he furnished was checked out and none of it was ever substantiated.

It is pointed out that on or about 4/25/68 WILLIAM PIERSON was arrested by the Chicago PD for the armed robbery of 2 gas stations in Chicago. At the time of the arrest, PIERSON advised arresting officers that he was a member of the Chicago PD and had some arrest slips to prove it. This story of PIERSON's was checked out by the Chicago PD and it was shown that PIERSON had made four arrests posing as a Chicago police officer, however, the records of the Chicago PD show that PIERSON has never been an officer of the Chicago PD.

It is also to be pointed out that PIERSON has never been an informant of this office and furthermore was only approached to furnish information if he received it concerning the theft at United-Buckingham and nothing else.

On 5/24/68, Mr. VICTOR H. ABSIL was interviewed at
his place of business, the K and A Tool Company, 3161 North
Elston, where he provided the following information:

He was fishing along with JOHN N. POST approximately
two miles off Highland Park in Lake Michigan. While fishing,
he noticed another boat approximately one-half mile away, and
some time between 6:30 PM and 7:00 PM, he again noticed this
boat on fire. They immediately proceeded to this boat and
rescued two men out of Lake Michigan. They then secured
the capsized aluminum boat (row boat type) and towed it to
shore. During their trip to the shore, neither of the rescued
men offered their names or any background information con-
cerning themselves. They were extremely suspicious and were
very interested in whether anyone else had noticed the fire
in their boat. Although one appeared to be in shock, they
refused to go to a hospital nor did they want any assistance
from the Coast Guard or a nearby yacht club. Upon reaching
shore, the individuals left the boat, indicated that they
would send a check to ABSIL to cover his expense, and before
ABSIL could dock his own boat both had left the scene. He
has no idea what type of trailer or car was used to haul
away the aluminum boat.

Mr. ABSIL was displayed photographs of the subject,
and he indicated that the most recent photograph of the subject
appears to have the same type of nose as one of the men who
was rescued from Lake Michigan. He described the two individuals

Mr. ABSIL did not see either stand up so he could not estimate their height. He indicated they were dressed in boots and warm jackets which are common for fishing during this period of the year.

On 5/24/68, Mr. JOHN N. POST was interviewed at his place of employment and provided the following information:

He provided basically the same information as Mr. ABSIL and stated that this was an extremely odd incident inasmuch as they had saved two men's lives and both were not thankful or willing to discuss themselves or this incident. He considered them both extremely evasive and seemed to shy away from any publicity or contact with the U.S. Coast Guard concerning this matter.

He was of the opinion that both possessed southern accents.

Mr. POST was displayed photographs of the subject without making any identification. He indicated that the most recent photograph of the subject with Mr. ABSIL had liked seemed to be a person older than those he assisted.

He advised that he gave his business address to the individuals involved, and they indicated that they would send him a check to cover his expenses.

On 5/28/68, Mr. POST was recontacted and displayed a photograph of JERRY RAY. He indicated that this photograph bore some resemblance to unknown subject number 1; however, he never saw the man's hair line due to the fact that he was wearing a cap.

To date he has not heard from either of the unknown subjects, and should he hear from them, he will immediately contact the Chicago Office of the FBI.

On this date, an anonymous male caller, who claimed to be an escapee from Washington State Prison, Walla Walla, Washington contacted the writer at 12:02 AM. He advised that he is aware that JAMES EARL RAY is under arrest and there has been some publicity about a "fat" man who supposedly met RAY on several occasions. The caller advised that he is the "fat" man referred to in the papers and stated that he is enroute ^{by car} to Washington State to turn himself in to authorities. He advised that he ~~ex~~ escaped in February 1967.

Caller further advised that, following his escape, he went to Dallas, Texas where he met an individual by the name of GENE BASS, owner of a Meat Packing Company in Dallas. Caller claimed that BASS gave him \$1600 to do the job that was done by JAMES EARL RAY, he accepted the money, then contacted RAY on several occasions to give him money which he had obtained from BASS. He delivered money to RAY AT Mobile, Montgomery, Birmingham, Alabama and Windsor, Ontario, Canada.

Caller advised that BASS is not the sole supplier of money for assassination ~~of~~, but there are numerous people involved, primarily at Montgomery, Alabama. He claimed that he can furnish names of individuals involved, but preferred not to give them over the phone. He stated that he feels certain that RAY will talk and he wants to avoid having to run from authorities. He stated that he will be available for interview, upon his return to Washington State. He indicated that he preferred to serve Federal time in prison, was invited to come to the office and stated that he would arrive shortly. He indicated that he was in the Chicago area and since the operator cut in to advise that three minutes were up, he was calling from a pay-phone.

This individual ~~xxxx~~ advised that the \$1600 paid him by BASS was in Postal Money Orders..... he would furnish no further information, but stated he would come to the Chicago Office this date.

" Martin Luther King 2 pass ports arrested in
England planned to fly to Belgium"

There were no other notations on this paper, or any other notations on other scraps of paper relating to captioned matter. SIMS advised the purse belongs to Mrs. RUBY CLONTZ, 5901 Lindsay, Hodgkins. SIMS advised there is a serious question in his mind as to the mental stability of CLONTZ. He stated he has received several complaints from CLONTZ, one of which was a "big cat" trying to break into her house. Upon investigation an alley cat was found to be on the porch. He stated several other types of complaints similar to this have been received. He also stated CLONTZ drinks rather heavily.

Inasmuch as the information on the scrap of paper was public knowledge and CLONTZ appears to be mentally unstable and a drinker, it was not felt she should be interviewed.

BUCKLIN advised that TIBBS resides in the Sunset Trailer Park with an address of 508 5th Street, Northfield, Illinois, however, the trailer park is just located north of Glenview, Illinois, on Waukegan Road. He explained that for the last approximate two years TIBBS had the job of checking the security of the Sportsman Country Club, Northbrook, Illinois, for the patrol service checking the Sportsman Country Club area in a roving patrol approximately three times a night and in this capacity became well-acquainted with JERRY RAY, brother of JAMES EARL RAY, and had coffee with JERRY RAY on a nightly basis during this period at the Sportsman Country Club where JERRY was employed. BUCKLIN stated that TIBBS is an extremely capable guard and a person that can be trusted in every respect.

GLENN TIBBS interviewed on 8/6/68 at the above address, furnished the same information set out above concerning the background of his acquaintanceship with JERRY RAY at the Sportsman Country Club. He stated that after the publicity broke concerning JAMES EARL RAY being suspect in the KING murder, JERRY RAY told him that JAMES EARL RAY was his brother.

He stated that JERRY RAY also flew to Philadelphia, Pennsylvania, on another occasion and before JERRY RAY departed the Sportsman Country Club to fly to Philadelphia, Pennsylvania, he expressed concern about transportation from O'Hare Field to Sportsman Country Club upon his return from Philadelphia; therefore, he (TIBBS) gave him his telephone number telling JERRY RAY that in the event that he could not obtain a ride from O'Hare Field to Sportsman Country Club upon his return from Philadelphia, to phone him and he would drive to O'Hare Field and return him to the Sportsman Country Club. It is noted previously in this investigation RAY visited an acquaintance MAJORIE FEDDEHS at Camden, New Jersey which is across the river from Philadelphia, Pennsylvania.

TIBBS stated that other than the fact that RAY told him that he had a brother JOHN RAY and a sister, name unknown, in St. Louis, Missouri, he spoke little about his relatives or life before he became employed at the Sportsman Country Club, however, JERRY RAY did say that JOHN RAY asked him to go into the tavern business with him in St. Louis, Missouri, and JERRY RAY appeared to be very cross to his brother JOHN RAY.
