ØR. MARTIN LUTHER KING, JR.

Synopsis: To advise all Field Offices on proper handling of information and inquiries received concerning the recent civil suit filed by the family of Dr. Martin Luther King, Jr.

**Details:** On 08/26/1998, after a personal plea by Coretta Scott King, Dr. King's widow, to President Clinton, Attorney General Janet Reno announced the authorization of an inquiry into conspiracy claims regarding the 04/04/1968 assassination of Dr. King, based on the allegations of a retired FBI agent and Lloyd Jowers, who at the time of King's death, owned Jim's Grill, which was co-located in the rooming house from which the shot that killed Dr. King, was fired.

In 1998, the Shelby County Prosecutor's Office conducted a seven-month investigation into the allegations and found no credible evidence to support claims of a conspiracy. In October 1998, as a result of the conspiracy allegations, the King family filed a wrongful death suit against Jowers in Shelby County, Tennessee. Subsequently, on 12/08/1999, a jury found that Jowers and "unknown conspirators" within the government were liable for Dr. King's death, although no branch of the government was specifically held liable in the claim. This inquiry by the Department of Justice is ongoing and continues to receive extensive national media coverage, however, the FBI was recused from participation.

Based on the jury's finding, the Department of Justice (DOJ) requested that the FBI not follow-up on any investigative leads or initiate any new investigations concerning this matter. Instead, any information or inquiries received regarding Dr. King's assassination should be forwarded to DOJ Attorney Barry Kowalski, who is directing the inquiry, with an information copy to FBIHQ, C/CRS, Hate Crimes Unit. 
