This is to record that at 2:00 PM this date, Mrs. LOUISE NOLT, 1211 Girard St., Akron, Ohio, home phone 773-3494, telephonically contacted the Office to advise that while driving North on I-71 near Mansfield, Ohio about 1:45 PM instant date, she observed an old model car, pale blue with rusty top, bearing Ala. License plates 3 -34652, travelling at high rate of speed. She stated this car appeared to have only the driver as a passenger and was likewise travelling North on I-71. Mrs. NOLT further noted she became suspicious of the individual driving this car as he held his hand to his face each time he passed another car.

Mrs. NOLT also advised the above desc. car had a KKK emblem about 2 to 3 ins. high in center of rear window.

Mrs. NOLT stated she was bringing the above info. to the FBI's attention in view of "what happened in Memphis."

It is noted that Mrs. NOLT seemed rational and sincere in furnishing this info. and it is to be further noted that she called from a pay station near I-71 at the Ashland Interchange.

It is suggested that appropriate inquiries be conducted to further identify the driver of above Ala. car. Mrs. NOLT desc. him only as white male, possible 30's, heavy beard and shaggy hair.

Re telephone conversation of SAC CHARLES G. CUSICK, Cleveland, with SAC ROBERT G. JENSEN, Memphis on 4/6/68.

SAC JENSEN advised that the investigation regarding the assassination of DR. MARTIN LUTHER KING at Memphis on 4/4/68 is being handled under the code name of MURKIN.

Mr. JENSEN advised that the subject of this murder has not been identified to date. The rifle used in this killing has been traced to Birmingham, Alabama. He advised that numerous prints of the subject were located on personnel effects abandoned by the subject in the rooming house. Mr. JENSEN also stated that additional artists conceptions are being prepared from other witnesses who observed the unknown subject. The subject is considered to be a good size man and may be about 6'1".

All of the latent fingerprints regarding the unknown subject have been forwarded to the Latent Fingerprint Section, FBI Laboratory.

In the event information is received at the Cleveland Office regarding suspects to this murder where the name of suspect is known, it should be determined if this suspect has a local police record. The identity of the suspect, along with any local police department number should be furnished to the Identification Bureau to have his prints compared with the subjects prints.

In view of the fact the identity of the subject is unknown to the Memphis Office, all leads regarding captioned matter should be thoroughly handled.

The Memphis Office should receive a copy of any communications directed to the Identification Bureau of other Field Offices.

It is to be noted this file pertains only to the assassination and has nothing to do with Racial Disorders.

Mr. SANFORD SOBUL, WJW TV, telephonically advised ~~he~~ received a telephone call from a source who told him that one WALTER ISSELL resembles the artists conception drawing of the assassin of MARTIN LUTHER KING. SOBUL stated his source believes ISSELL was arrested in Cleveland in 1967 on a Neglect Charge and subsequently left town. The source believes that after ISSELL left, a small arsenal was located in his home in Chesterland. Because of this SOBUL believes Secret Service might have checked ISSELL out as they may have considered him a threat to the President.

The writer telephonically contacted the CVPD and determined the following:

WALTER NATHANIEL ISSELL has CVPD # 93528 and FBI # 3975450. He is described as a white male, born [redacted] 5'9", 157, dark chestnut eyes, medium blond hair, 2" scar on left cheek bone. This description was dated in 1958. His last known residence was listed as 36085 Matoma Blvd., Eastlake in 1964. His record consisted mostly of traffic biolations, but he was confined to Mansfield Reformatory in 1958 for Grand Larceny, and he was charged with Resisting Arrest in 1964.

In view of the information furnished by SAC ROBERT JENSEN, Memphis Office indicating the assassin is believed to be over 6' tall, and no mention of a noticeable scar on left cheek bone, it does not appear ISSELL fits the description of the assassin.

SA BURKE telephonically furnished above information to Fingerpring Examiner LOGAN CATTERALL, Identification Division who stated he would have suspect latents compared with those of WALTER NATHANIEL ISSELL. If check negative Cleveland would not receive any reply.

This date at 11:45 PM writer was telephonically contacted by, FTS, Night Supervisor James M. Sturigis, Detroit FBI office and advised the following info.

Sturgis stated the following info was given to him by GEORGE MOORE, FBI Washington and was advised to pass it along to both CV and CI offices.

In view of possible racial disturbances arising from assassination of King all offices should do the following:

Take all necessary precautions regarding personnel proceeding to office tonight, tomorrow and over week-end.

Be sure personnel are most judicious as to when and where to travel depending on local conditions.

Each SAC will have to exercise prudence and issue appropriate instructions under the circumstances.

Each SAC must understand he has the responsibility to have adequate manpower on duty to handle any emergency which might arise during hours ahead.

SAC Cusick and Supervisor were advised of the above.
