At 4:45 P.M. this date, JACK HAMILTON, FR 46009, telephonically advised that a <u>DFWAYNE DALIAS</u> fits the description of that given in the newspaper describing the assassin who killed Dr. KING. HAMILTON advised that Mr. DALIAS has displayed and published anti-Negro literature and vehemently denounces the Black Race. HAMILTON said he believes DALIAS is some kind of nut and this is why he has brought this matter to the attention of the FBI.

HAMILTON stated Mr. DALIAS has an envelope company both here in Dallas, Texas and in Memphis, Tenn. and that Mr. DALLAS is originally from Mississippi. HAMILTON said DALIAS has a brother now in Mississippi who was here in Dallas, Texas until they moved their printing operation to Mississippi.

HAMILTON advised Mr. DALLAS is very outspoken about his beliefs and concentrates his attacks mostly against the Colored Race and Jews. HAMILTON stated Mr. DALLAS has in the past printed a lot of anti Negro literature and has supported the American Nazi Party.





The apostle Paul asked, "Am I therefore become your enemy, because I tell you the truth?" If I become your enemy because I tell you the truth then your enemy I am willing to be.

No matter how resistant or unhelpful you are or shall be to me you are or will become a friend provided you believe in truth.

To compromise with the foolishness infiltering the American way of life today is to provide a ledge whereby anti-God may lodge and root itself, and thus destroy the well-being of a great nation and its people.

We cannot dodge or be passive toward today's issues and do the job required of us as citizens of our Republic - America.

We must take the message across the breadth and depth of our land. Together we win - apart we lose.

COMMUNISM — People say communism will come to America. Communism will not come to America — it is here.

METHODS — Communist methods are marching, revolting, demonstrating, looting, and defiance of law and order in whatever country it occurs.

MOB VIOLENCE - Turn back the pages of time and recall in foreign countries how we read of violence through mobs and the ultimate overthrow of governments. Remember how baffled we were as to why the people failed to rise against it?

In America it is happening through the same pattern and gesture — Yet rank and file Americans refuse to stand against such ruthless-

The question is are we going to be ruled by mob violence, pressure groups, and cheap politics or by the decent, respectable citizenry of the Republic.

INTERNAL COMMUNISM — Finds favor in liberal government through terror, bombings of schools and churches, beatings, lawlessness, and by crying police brutality and discrimination. PURGE — Communists and liberals purge their opposition by calling them extremist, bigot, isolationist, horse and buggy days, insanity inference, brotherhood, and constantly harping that the people demand more services from the government.

UNITY - Take note that the liberal, communist, socialist, and internationalist speak for the same programs whether in Washington or in Moscow. Read your daily newspaper and observe their unity of thought.

LIBERAL - The liberal is a first cousin to the communist.

Communists and liberals theorize that government must become big and the people must be taught to depend upon government.

The liberal policy not only includes aid to communism, but includes construction of industry in communist countries. Under liberal leadership we are doing both.

Liberals say there are two kinds of communism. If so, it shows itself in two forms — Federal Aid and Foreign Ald.

ADMINISTRATION - Co, unism and the present administration in Washington appeals the lust in man. They want people to seek something free with dividual consideration for consequence. Our nation and our national way of life stand in propardy. What does the Administration propose? They propose more of the medicine that has made America sick unto death. All Americans should be as sick of the medicine men.

Too many people in America have forgotten to remember to think thoroughly.

Russia and communism must be dropped from our dole system.

FREE - Notice how everything has become free to the communist, adulteress, lazy, and the masquerader at the expense of the productive worker and tax payer.

TAXATION — We are working hard to make more money to pay more taxes, so our government can sell to and extend credit to Russia, so Russia can enslave more people. Do you think God will hold us guiltless? I do not think God will hold us guiltless. TRADE — Why trade with communist countries? Russia wants trade with us because they manufacture goods using slave labor and can ship goods into the United States to sell at prices much lower than we can manufacture and sell the same goods at our high labor cost.

Look how this gap widens when our labor union chiefs demand more and more for less and less. We lower tariffs, too!

Foreign aid coupled with foreign trade allows for the disappearance of our gold reserves.

VOTING — The voting privilege is not free. Our forefathers paid with their lives, fortunes, and sacrifices for the privilege to vote. Voting requirements that include the poll tax are fair.

Voting is a heritage not to be taken lightly and should be exercised unselfishly with full awareness given to the best interest of our country in preference to personal motives.

DISCRIMINATION — Let one negro cry discrimination and the Army is alerted and sent immediately. The administration is trigger happy against its own people, but scared to death of the enemy. SENSES — There are five senses. We shall consider only two; these are hearing and feeling.

I hear Russia rattle their bombs——I feel the Administration shake. I feel them shake through disarmament negotiations, Cuban inspections, missile removals, hot lines, treaties, and another conference.

NUCLEAR WAR — If nuclear war is going to win future wars, Mr. Administration, explain to me why 200 million foot soldiers will go for Israel in the Battle of Armageddon in the ending war of wars? Answer this question before you tell us we cannot stand against Russia because we might trigger a nuclear war and destroy civilization. Another question please — — to whom do you refer when you speak of peddlers of fear, Mr. Administration?

It is worthy of further note that it is not man who destroys that Army.

DAVID AND GOLIATH - Viewing the American scene today reminds me of the defiance of Goliath during the day of David.

I think that I must feel the pangs of disbelief coupled with disgust that, David felt when Goliath strutted in the Valley of Elah observing the tremble of some of his fellow countrymen.

To me" the picture is absolutely the same except for two things: I am no David and the Russian is no Giant.

The Premier's subjects in Russia would love a piece of his hide and I think we should avail to them that privilege.

DEAD END - The boys dying daily from hot bullets, if they could talk, would tell us of the fallacy of the dead-end policy called cold war.

COLD WAR - We disarm while the enemy arms. We pull troops out while they send troops in. We give; they receive. We train enemy pilots; they shoot ours.

There is no such thing as a cold war. The coldest spot of the cold war is in Washington. It is the Administration that has frozen and these men are very cold.

What has happened to the value of every American life? We should weep and fight rather than fright and compromise.

On the afternoon of 4/8/68, SA WILLIAM H. PATTERSON, U. S. Secret Service, Dallas, Texas, telephonically advised that captioned individual is a Protective Intelligence Case of U. S. Secret Service, and is known to have, in the past, owned a 20 millimeter cannon and a .50 caliber machinegum. He is from Dallas and is currently in Dallas. Approximately two weeks ago this individual was in Cleveland, Ohio, According to a SANFORD SOBUL, of a TV station in Cleveland, Ohio, he has learned from a source of his (SOBUL's) that captioned individual looks like the composite description of the killer of MARTIN LUTHER KING.

Mr. PATTERSON stated there is a complete file with a photograph of this individual available through Secret Service Headquarters in Vashington, D. C. PATTERSON stated he did not have captioned individual's current place of residence and employment in Dallas available but that he had talked with ISSEL on Friday, 4/6/68, at which time ISSEL was cooperative and expressed a desire to be contacted at any time at his residence but did not want to be contacted at work.

SA PATTERSON advised that in the event an Agent of the FBI desired to interview ISSEL to contact him (PATTERSON) who would make the residence address available, as well as accompany the Agent if desired, since he has the confidence of ISSEL.

At 4:40 PM this date I accepted a collect call from CHARLES SHIPWASH, 405 Cloverhouse, Lufkin, Texas, Telephone NU 4-4968. SHIPWASH indicated that approximately 2½ hours ago while at Pete's Liquor (beer joint), 12 miles west of Lufkin, he had a 15 minute conversation with a man known to him only as SANDY. He stated that SANDY indicated that he had made a big mistake and had made a shot. SHIPWASH asked what he was referring to and SANDY indicated he had shot KING. SANDY showed SHIPWASH a 3006 rifle in his car, which was described as a 1957 solid dark blue Chevrolet, two door.

SHIPWASH described SANDY (LNU) as white, male, age 31, 5'8", 160 to 170 lbs., blond, sandy hair, wearing blue and gray plaid jacket, charcoal trousers. SHIPWASH requested that his name be held in confidence and was furnishing this information for the FBI's information. He said the telephone number mentioned above is that of his landlady with whom any messages could be left.

I immediately checked with the operator and determined that SA KILLGORE is presently in the Lufkin PD and a stop was placed for him to immediately call the Dallas Office.

The above information was furnished to SA KILLGORE and he was requested to notify the SAC if there appeared to be some substance to this information; otherwise, a memorandum to the Dallas file concerning his inquiry would be sufficient.

RE: SUSPECT ISAAC WELDON KIRK

COP EARL ANDREWS, Mansfield, Texas, on this date advised that he had been contacted by F. J. TERRELL, Texas Ranger, regarding suspect KIRK. He stated TERRELL advised he had heard rumors that KIRK might have been the murderer of MARTIN LUTHER KING. ANDREWS stated it was his understanding that KIRK was employed by a communications company located in Garland or Richardson, Texas, which builds micro relation towers and that KIRK and his crew were last known to have been located at Madison, Tennessee, and that KIRK and his crewhad been out of contact with the company and apparently missing since 4/3/68. ANDREWS stated that KIRK is the husband of AGNES KIRK, Justice of the Peace at Mansfield. KIRK is in Mansfield only two or three times a year and was last in Mansfield at approximately Christmas time, 1967. advised that KIRK was supposedly in possession of a 1968 Ford XL Fastback, light blue in color, which is titled in both his and his wife's name. ANDREW stated he would obtain the license number of this vehicle and would advise. He stated most of his information regarding this matter had been obtained from E. J. TERRELL.

Texas Ranger E. J. TERRELL, Fort Worth, Texas, advised this date he had heard a rumor several days ago that the people in Mansfield, Texas were of the opinion that suspect KIRK might be responsible for the murder of MARTIN LUTHER KING. He stated he proceeded to Mansfield and there talked to AGNES KIRK, wife of the suspect, O. L. WATSON, Constable; and Chief ANDREWS. He said it was his opinion that KIRK's wife was the one who started the rumor. He said apparently the basic reason for the rumor was that KIRK bears a general resemblance to the artist conception of the killer which has appeared in the newspapers. He advised that KIRK has allegedly been employed for 10 or 12 years as a construction foreman in charge of seven or eight crews

which build micro wave towers and that the employing company is the Rohn Construction Company located in Richardson, Texas.

TERRELL advised that he had checked with the Tarrant County SO and had determined KIRK had three arrests. He stated he was unable to find his notes to provide additional details regarding these arrests. He stated the above was approximately the extent of his investigative results at the present time.

Deputy Sheriff DUANE HITT, Tarrant County SO, Identification Division, Fort Worth, on this date advised records there reflect that ISAAC W. KIRK had been arrested by that office on three occasions as follows:

11/24/53 3/12/59 7/13/61

The charge on each occasion was contempt of court. He stated that the fingerprints taken for the arrest of 3/12/59 had been sent to the FBI and had been returned marked no record. He stated Tarrant County SO No. for KIRK was 19536 and that the DPS No. was 733305. HITT further advised that KIRK's birthdate was recorded as 4/3/25, at Cleburne, Texas, and he was described as follows:
