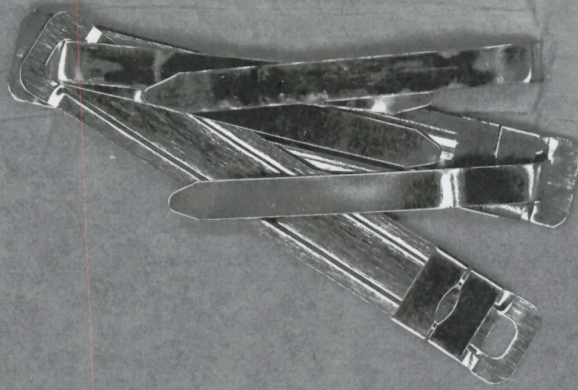

HALTER advised that the gun used in the shooting was purchased at the Wimberly Thomas Hardware, 1809 First Avenue South Birmingham, 3/30/68, (Remington with scope). Name used was HARVEY LOWMEYER (believed fictitious). Approximately two hours before the shooting person believed identical with LOWMEYER purchased binoculars at 162 South Main in Memphis (no name). These binoculars and gun recovered at 422½ South Main, believed to be the place where shots were fired from.

Person making purchases and believed murderer described as: WMA, 26 - 32, 5' 11", 160-175#, medium build, dark hair combed straight back, did not wear hat or glasses, neat appearance, wore dark coat and trousers.

In view of the above and since all investigation negative, it is imperative that we determine if W. DAVIS and B. CHIDLAW remained in Houston upon their arrival this AM. Accordingly, SA SCHOONOVER is running down hostesses and other background on crew members so they can be interviewed about possible descriptions of these two and any other pertinent information.

Miss KRAUSE was contacted 4/5/68, and questioned about passengers W. DAVIS and B. CHIDLAW who came aboard Flight 157 at Memphis. She stated that this flight was late in arriving at Memphis and had gone to Operations to pick up some forms and upon her return she went about her normal business. According to KRAUSE, the names of passengers coming aboard the airplane are not taken and the only thing she looks for is the envelope of the passenger that contains the ticket showing the passengers class of travel. As it was a late hour when this flight left Memphis, the lights inside the cabin were turned down for the convenience of other sleeping passengers and KRAUSE was not able to get a close look at anyone and could not make a definite statement that she could recall the passengers, W. DAVIS and B. CHIDLAW. She is to leave Houston at 10:50 p.m. on Friday 4/5/68, flight 50 for Shreveport and Memphis.

Efforts were made to contact VICKIE McLUCAS at her residence telephone and she would not be in until about 7 p.m. McLUCAS has flight to New York on Delta Airlines night of 4/5/68.
