On 4/15/68, Chief of Police EVANS, Conroe, Texas, telephonically advised that an individual by the name of KEN ANDREWS, Springville, New York, was in his office and had some information that might relate to the King Assassination. Chief EVANS said that he had been talking to ANDREWS and from all appearances he appears to be a responsible individual.

ANDREWS then got on the phone and furnished the following information:

On 4/13/68, ANDREWS was driving by himself from California to Conroe, Texas. On 4/13/68, at approximately 10 AM at Benson, Arizona, ANDREWS picked up a hitchhiker dressed in an Army un form. The hitchhiker claimed his name was DON TANNER, and that his home was in Lakeville, California, and that he was assigned at Fort Polk, Louisiana. The more ANDREWS talked with TANNER, the more suspicious he became of ANDREWS stated that TANNER gave a lot of conflicting statements regarding his past whereabouts and also made some remarks regarding racial matters that were highly suspicious.
