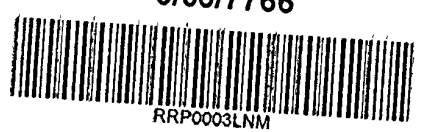

On 4/15/68, Chief of Police EVANS, Conroe, Texas, telephonically advised that an individual by the name of KEN ANDREWS, Springville, New York, was in his office and had some information that might relate to the King Assassination. Chief EVANS said that he had been talking to ANDREWS and from all appearances he appears to be a responsible individual.

ANDREWS then got on the phone and furnished the following information:

On 4/13/68, ANDREWS was driving by himself from California to Conroe, Texas. On 4/13/68, at approximately 10 AM at Benson, Arizona, ANDREWS picked up a hitchhiker dressed in an Army uniform. The hitchhiker claimed his name was DON TANNER, and that his home was in Lakeville, California, and that he was assigned at Fort Polk, Louisiana. The more ANDREWS talked with TANNER, the more suspicious he became of him. ANDREWS stated that TANNER gave a lot of conflicting statements regarding his past whereabouts and also made some remarks regarding racial matters that were highly suspicious.

On 4/14/68, ANDREWS bought a San Antonio newspaper at Fredericksburg, Texas. In this paper, ANDREWS saw the composite drawing of the alleged assassin in the King murder. ANDREWS claims that the above mentioned hitchhiker is a "dead ringer" with the drawing. ANDREWS described the hitchhiker as follows:

TANNER also told ANDREWS that he owned a GTO with tilted seats in it, but when ANDREWS asked TANNER what became of the car, TANNER's answer was evasive.

ANDREWS left TANNER on 4/14/68 at the Trek Motel, Highway 81, Austin, Texas, at about 2 PM. ANDREWS also indicated that TANNER checked into Unit 6 of the above motel inasmuch as ANDREWS helped carry his bags into that unit.

ANDREWS then got on the phone and furnished the following information:

On 4/13/68, ANDREWS was driving by himself from California to Conroe, Texas. On 4/13/68, at approximately 10 AM at Benson, Arizona, ANDREWS picked up a hitchhiker dressed in an Army uniform. The hitchhiker claimed his name was DON TANNER, and that his home was in Lakeville, California, and that he was assigned at Fort Polk, Louisiana. The more ANDREWS talked with TANNER, the more suspicious he became of him. ANDREWS stated that TANNER gave a lot of conflicting statements regarding his past whereabouts and also made some remarks regarding racial matters that were highly suspicious.

On 4/14/68, ANDREWS bought a San Antonio newspaper at Fredericksburg, Texas. In this paper, ANDREWS saw the composite drawing of the alleged assassin in the King murder. ANDREWS claims that the above mentioned hitchhiker is a "dead ringer" with the drawing. ANDREWS described the hitchhiker as follows:

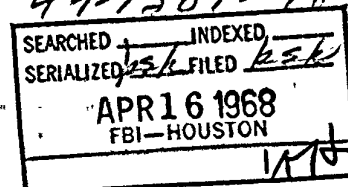
