Mr. WADE recalled the conversation he had with officer FRANK FLETCHER of the Houston PD. Mr. WADE stated that he mentioned to FLETCHER that it was a bad time for CLARK to be moving to Memphis, but Mr. WADE did not mean to infer by that statement that CLARK had anything to do with the Murder of Dr. MARTIN LUTHER KING.

She stated that Mrs. McDONALD works part time at a local bary down the street.

Mrs. BRYAN F. JENKINS was contacted 4/25/68, and states that she works part time as a waitreds and that her husband BRYAN works for the Houston Post Newspaper in Houston and manta that in the past several days he has been off from work due to an operation. She states that at this time her husband drove their 1965 Ford to Maxistanfloreatew days vacation and did not know just what day he would return to Houston.

Recommended no further investigation re this lead.

At about 10:15 p.m., 5/2/68, Mr. CALVIN PLYLER. Rartow, W. Va., telephonically advised SA GEORGE A. PATTERSON that on 4/22/68 two white males in a 1961 or 1962 white Chevrolet Impala bearing Louisiana license, number unknown, purchased gas and tires in the amount of \$42.28 at PLYLER's Gulf Station in Bartow, using Gulf Credit Card # 13 12 88 15 52 in the name of S. G. STEINER, address not recalled in Louisians. One of the men who was wearing cowboy hat and cowboy boots signed the purchase slip with the name, JAMES HAMMONS. He stated he was from Oklahoma and had just arrived in the area to work with a core drilling outfit. PLYLER discovered that HAMMONS left the area immediately after the purchase. and there are no drillers in the area. Also, this credit card had been cancelled about one week prior to 4/22/68.

On 5/2/68, PLYLER read in a newspaper that JAMES EARL RAY had an associate from New Orleans, La., named STRIN and similarities in names, STEIN and STEINER, caused him to conclude that HAMMONS may have been RAY. He could not recall descriptions of the man with HAMMONS, other than he was a white male with a "fat face." PLYLER said he recorded license number of the Chevrolet on the purchase slip, but no longer has record of the number as the slip has been forwarded to Gulf Oil Company Headquarters in Philadelphia, Pa. PLYLER also advised that information that the card had been cancelled came from Gulf headquarters in Houston, Texas.
