GERTRUDE WALLING, 1120 College Street, Quincy. Illinois, advised that she formerly resided at 904 Lind Street, Quincy, Illinois. She advised that when she lived on Lind Street she occasionally rented rooms in her home and sometime around 1956 she rented a room to JOSEPH ELMER AUSTIN. She advised that she remembered AUSTIN'S date of birth to be 1898 inasmuch as her year of birth was the same and that was the only person she had ever lived in a house with who was born the same year as her. She stated that AUSTIN when he came to Quincy, Illinois, came to Quincy through some contact with a Catholic priest in either Quincy or Chicago. She advised that AUSTIN had been in the Illinois State Penitentiary and came to Quincy in an effort to obtain a job and that apparently this unknown Catholic priest had obtained AUSTIN a job in Quincy. However, AUSTIN lived at her home less than one month when he left and she heard shortly thereafter that he had been arrested and was returned to prison. She stated that she could not remember the name of the town in which he was arrested and had not seen AUSTIN since 1956. stated as far as she knew AUSTIN did not have any relatives. or associates in Quincy, Illinois, and that AUSTIN was not related to her. He simply lived in her home for a period of less than one month and that was as a border.

She advised that she did not know JAMES EARL RAY and had never known AUSTIN to speak concerning RAY under RAY'S true name or known aliases.

She stated that she is certain JOSEPH ELMER AUSTIN was not a Quincy resident and that he knew nothing concerning Quincy at the time he moved to Quincy.

Photographs of JAMES EARL RAY were exhibited to GERTRUDE WALLING and she advised that she hadanswer seems this individual before.

On May 10, 1968, ELIZABETH ROTH, Credit Bureau of Quincy, Inc., 528 North Fifth Street, advised that her file contains very little information concerning JOSEPH ELMER AUSTIN other than a newspaper clipping which showed that JOSEPH ELMER AUSTIN, age 59; had been arrested on August 4, 1957, in Robertson County, Tennessee, with JOHN GEWIN SCROGGINS, age 38, and a DORRIS CALVIN MEACHAM of Elkton, Kentucky. The three had been arrested for the alleged kidnapping of a Guthrie, Kentucky, motel clerk and had allegedly taken him across the state line into Robertson County, Tennessee, where they robbed him of \$139.00 and set him free. The trio was stopped for speeding near Ashland City, Tennessee, and the \$139.00 believed stolen from the Guthrie, Kentucky, motel clerk was found scattered along the highway near the scene of arrest.

AUSTIN was then committed to the Central State Hospital in Nashville, Tennessee, after Government attorneys said they believed he might not be mentally capable of advising with council.

The article showed that AUSTIN came to Quincy, Illinois, in April, 1956, and previous to that he had been sent back to prison three times for violation of parole and had spent three months in a tuberculosis sanitarium in Jacksonville, Illinois.

E. HILLIARD ALLEN SANDERS

On 5-1-68, SA's FRANK E. CORN, SR., and ROBERT C. HAINES, interviewed HILLIARD ALLEN SANDERS, at 137 East Acton Street, Wood River, Illinois.

SANDERS stated that he was incarcerated in the Missouri State Penitentiary, Jefferson City, Missouri, on 1-20-52, upon conviction of an armed robbery charge at St. Joseph, Missouri. He said he was released on parole on 9-1-64.

SANDERS advised that he never became acquainted with or had knowledge of JAMES EARL RAY during the time he was incarcerated in the Missouri State Penitentiary. He said that while he was in the penitentiary, he worked at several trades and that the last two jobs he had in the penitentiary had to do with the sewing machine mechanical section and that the last job he had was a halltender from 1963 to 1964.

SANDERS said that upon parole he went to Gadsden, Alabana, where he lived and worked for approximately 18 months; that he then went to Camden, South Carolina, where he was employed by the firm of E. I. DUPONT for 9 months. SANDERS said that he then came to Wood River, Illinois, where he has been working on construction at the Shell Oil Company Plant in Wood River. He said that he arrived in Wood River in 7-67 and has resided in Wood River since that time.

SANDERS concluded by stating that when national publicity was released concerning the identification of JAMES EARL RAY, he viewed photographs appearing on television and in the news media and determined that he had never known RAY while both were at the Missouri State Penitentiary.

F. WILBUR CONNORS

On 4/20/68 WILBUR CONNORS, aka MANNY CONNORS, 825 South Fifth Street, Quincy, Illinois, was interviewed by ASAC DONALD T. SULLIVAN and SA ELYON H. DAVIS and furnished the following information:

On that date was the first he had learned of his wife, KATHERINE DORIS BUSKIRK, had been arrested with WALTER RIFE and JAMES EARL RAY in Hannibal, Missouri, in 1955. He advised that he had never heard his wife mention JAMES EARL RAY and is quite certain that she did not know RAY or have much of any contact with him. He pointed out in 1955 his wife was only seventeen years of age and that she did not have a criminal record and for this reason he did not believe she had been involved with RAY and RIFE in any crime.

WILBUR CONNORS advised that his sister-in-law, LAURA CONNORS, owns the Virginia Hotel, 534 North Second Street, Quincy, Illinois. CONNORS advised that he is in this hotel on almost a daily basis and can state that WALTER RIFE was certainly working each day at the restaurant and the Virginia Hotel from the period 3/27/68 through. 4/4/68.

CONNORS advised that he personally does not know JAMES EARL RAY and does not have any information concerning RAY's activities or whereabouts.

On 4/20/68 LAURA CONNORS, owner, Virginia Hotel, 534 North Second Street, Quincy, Illinois, was interviewed by SA ELYON H. DAVIS and ASAC DONALD T. SULLIVAN and furnished the following information.

Around 2/6/68 she had leased the restaurant in the Virginia Hotel to WALTER TERRY RIFE. She advised since that date the restaurant has been operated by RIFE and that RIFE has been working in the restaurant every day. She advised that RIFE's wife, JAN RIFE, gave birth to a baby in late 2/68 and for this reason WALTER RIFE had worked from approximately 7:00 each morning until 11:00 at night operating the restaurant. She stated that certainly WALTER RIFE was working during the period 3/27/68 until 4/4/68.

She advised that she does not know JAMES EARL RAY, FBI No. 306443A, and after viewing five different photographs of RAY advised that this is not an individual who she has ever known. She stated that MELBA MARIE RYAN does live at the Virginia Hotel and that she had learned on the previous night that MELBA MARIE RYAN was a sister to JAMES EARL RAY. She stated, however, in her conversations with MELBA MARIE RYAN, MELBA MARIE RYAN had denied any knowledge of the whereabouts of RAY and she does not believe that RAY has contacted the sister since his escape from the Missouri State Penitentiary.

On 4/20/68 ARTHUR CONNORS advised that he is the husband of LAURA CONNORS, owner of the Virginia Hotel, 534 North Second Street, Quincy, Illinois. ARTHUR CONNORS advised that he can verify that WALTER RIFE was working at the restaurant in the Virginia Hotel during the period of 3/27/68 through 4/4/68.

ARTHUR CONNORS also viewed photographs of JAMES EARL RAY, FBI #306443A. CONNORS advised that this individual was completely unknown to him and he has never seen him at the Virginia Hotel.

G. KATHERINE DORIS BUSKIRK CONNORS

On 4/20/68 KATHERINE DORIS BUSKIRK, presently married to WILBUR CONNORS and residing 825 South Fifth Street, Quincy, Illinois, was interviewed by ASAC DONALD T. SULLIVAN and SA DAVIS.

She advised that she had never met JAMES EARL RAY, FBI #306443A, until one night during 1955 when WALTER RIFE, an acquaintance of her, approached her in a tavern in Quincy, Illinois, and asked her if she wanted to go with RIFE to Hannibal, Missouri. While in the automobile, she was introduced to JAMES EARL RAY and after arrival in Hannibal, Missouri, WALTER RIFE and JAMES EARL RAY were arrested concerning some postal money orders that had been stolen. She advised that she had never seen RAY before that date and has never seen him since. She stated that she had no information concerning the whereabouts of RAY or any information concerning the background of RAY.

She advised that her husband did not know RAY and had never heard of her being arrested with RAY and RIFE in Hannibal, Missouri.

She advised that she is acquainted with MELBA MARIE RYAN since MELBA MARIE RYAN resides at the Virginia Hotel but that she did not know that this was a sister of JAMES EARL RAY.

She advised that she would furnish any information of value that she might learn to the FBI concerning RAY or the RAY and RYAN family; however, she had none to furnish at the present time.

The following investigation was conducted by SA ELYON H. DAVIS:

On April 24, 1968, ART CONNORS, whose wife LAURA CONNORS, owns the Virginia Hotel in Quincy, Illinois, advised that he had received no information concerning JAMES EARL RAY. He advised that he intends to cooperate in every way with the FBI in this matter and will immediately advise the FBI of anything concerning RAY's whereabouts.

He advised that RAY's sister, MELBA MARIE RYAN, has stated numerous times she has no information as to RAY's whereabouts. He advised that KATHERINE BUSKIRK, now married to CONNORS' brother, WILBUR CONNORS, known as MANNY CONNORS, has told him that she knew nothing concerning RAY other than she was arrested with RAY and WALTER RIFE at Hannibal, Missouri, in 1955. Inasmuch as she was not involved and knew nothing concerning the passing of the stolen money orders, she was released on the same day of the arrest and no charges pressed against her.

CONNORS advised he is certain in his own mind that neither MELBA MARIE RYAN or WALTER TERRY RIFE has any information concerning the whereabouts of RAY.

H. JOSEPH ADAMS

The following investigation was conducted at the Menard Branch, Illinois State Penitentiary, on April 26, 1968:

On April 26, 1968, MAX FRYE, Warden, Menard Branch, Illinois State Penitentiary, advised that one of the inmates by the name of JOSEPH ADAMS, who works in the Office rs Mess at the Penitentiary, indicated to him recently that he was acquainted with JAMES EARL RAY having been with him at the Missouri State Penitentiary in Jefferson City, Missouri.

Warden FRYE stated that he did not question him concerning his contacts or knowledge of RAY but thought it might be of value to interview him.

On April 26, 1968, JOSEPH ADAMS, also known as Shorty, who has Menard #11745 was interviewed at the penitentiary and advised after viewing a photograph of RAY that he was acquainted with RAY when RAY was at the Missuri State Penitentiary.

ADAMS advised that he left the penitentiary for Menard last October, 1967, and that when he got there, RAY was already there.

ADAMS advised that his only knowledge of RAY was that RAY brought food over to the hospital where ADAMS was working and he assumed that RAY apparently worked in the prison kitchen.

ADAMS advised that he never talked directly to RAY at any time nor did he ever observe him with any other inmates. He described RAY as a very quiet individual and this is all the information he had concerning him.

She advised that she was the owner on record, and operated the M & N Tavern, 106 (rear) -5th Street, Peoria, Illinois, during 1958 and 1959. She said she purchased the tavern from MILLIE and MAC BURDIN who now operate the "Galley" a basement night club at the Hotel Jefferson, Proria, Illinois. She said prior to 1958, she had operated bars at the Beer Barrel, 1034 Northeast Adams Street, Peoria, Illinois, and also the Pour House, 800 North Main Street, Peoria, Illinois. She advised she was born in Norfolk, Virginia, and came to Peoria, Illinois, at the age of 16. She advised that she married SAM ALLEN in early 1950 and she and ALLEN had had business interests in the above taverns between 1953 and 1959.

She stated she divorced ALLEN in 1958 and married RAY M. TYLER, a brick layer by trade, in 1960. She advised she is the mother of two children, ages 7 and 8. She stated she has been steadily employed as a waitress at the Piere Narquette Hotel, Peoria, Illinois, for the past six years.

B. INTERVIEWS WITH POSSIBLE INMATES OF JAMES EARL RAY

On 4/28/67, FRED PETRAKIS, 2904 North Avalon Place, Peoria, Illinois, a former inmate at Pontiac Penitentiary, was shown a 1955 photograph of JAMES EARL RAY Without effecting an identification.

PETRAKIS advised that for about one and one-half months in late 1953, he served as a barber at the Pontiac Honor Farm in the penitentiary, however, he does not recall RAY. Prior to this, he cut immates' hair at the main prison and served thirty-three months at Pontiac from 1950 to early 1953 before being paroled. PETRAKIS advised that he took inmate: NCRMAN DEAN's place as a barber and that DEAN may recall RAY.

On 5/1/68, NCRMAN DEAN, barber, 927 Court Street, Pekin, Illinois, a former inmate at Pontiac Penitentiary, was shown a 1955 photograph of JAMES EARL RAY without effecting an identification. DEAN advised that he was discharged from Pontiac during the winter of 1952 and never cut hair on the Honor Farm. He possessed no information regarding RAY and was not aware that RAY was confined at Pontiac during the time of his incarceration.

On 4/29/68, CHARLES E. REED, was interviewed by EA LARRY W. GREEN concerning his knowledge of the present location of JAMES EARL RAY.

It is noted that the referenced teletype contains the address of NEED, as 223 - 6th Street, Madison, Illinois. This address should be corrected to show REED's address as 2023 - 6th Street, Madison, Illinois.

REED stated that he was at the Pontiac State Farm, Pontiac, Illinois, in 1952. He stated that he entered Henard State Penitentiary at Chester, Illinois, in late 1949 and was subsequently transported to Pontiac Prison, Pontiac, Illinois, in late 1950. He stated he remained there on a farm until he was relased August 29, 1952. REED stated at the time he was on the prison farm, there were about 150 persons working there. He stated that his job was to deliver the mail to each dormatory daily and that he was familiar generally with every person located on the farm at that time.

When questioned about the subject, REED stated that he does not recall the name nor does he remember associating with a person named JAMES EARL RAY. He stated that he was familiar with the name since it had been in the news frequently in recent days, but it had never come to his attention until now that RAY may have been at Pontiac State Farm while he was there. He further stated that he does not recall any particular person who may have been friends with the subject. It is noted from the referenced teletype that subject entered the farm at Pontiac August 12, 1952. REED recalls that he was dismissed from Pontiac, August 29, 1952. He stated that he was 19 years old at the time he was on the farm. He further

related that he has not kept in contact with anyone he net while at the farm and knows nothing of the whereabouts of any of the inmates who were incarcerated at the farm while he was there.

REED is described as:

Age Approximately 38 51 6" Height Weight 140 Hair Blonde, crew cut Eyes Blue Complexion Ruddish Limps due to a crippled right leg Marital status Single, lives with his mother at the above noted address Saitation worker Employer riding on sanitation trucks

in the Madison-Granite City. Illinois area

REED has 5 brothers living in the Madison-Granite City area and 1 sister. It is noted from a criminal check at the Madison city PD that CHARLES E. REED has had some credit problems as well as being arrested for speeding and disorderly conduct since his release from Pontiac. (also from Granite City PD records)

The following investigation was conducted by SA ELYON H. DAVIS:

On May 2, 1968, Deputy Sheriff, JOHN BLIVEN, Mc Donough County, Macomb, Illinois, advised that KENNETH D. FOSDYCK no longer resides in Bushnell, Illinois, but resides in Macomb, Illinois. He stated that FOSDYCK has a criminal record and is holder of FBI #442 181 A. He advised that FOSDYCK is presently employed by Burell Florists in Macomb, Illinois, and resides at 321 College Street, Macomb, Illinois. He advised that the record of FOSDYCK shows he was first arrested on October 14, 1948, for tampering with a motor vehicle and has later arrests for robbery, petty larceny, auto larceny, probation violation; however, Deputy BLIVEN advised that the last known arrest for FOSDYCK was on December 3, 1954 when he was returned to the Illinois State Penitentiary at Joliet, Illinois, for parole violation.

He furnished the following physical description of FOSDYCK:

On May 2, 1968, ELMER BURELL, Owner, Burell's Florists, Macomb, Illinois, advised that KENNETH D. FOSDYCK is employed by him and has been for a number of years. He stated that FOSDYCK resides at the Florist at 321 College Street, Macomb, Illinois, and that during the past several years FOSDYCK has been working regularly. He advised that FOSDYCK was working during the period of March 27, 1968, through April 4, 1968.

A number of photographs of JAMES EARL RAY were exhibited to ELMER BURELL. He advised that he has never seen anyone with FOSDYCK remotely resembling RAY. He also advised that he had never heard FOSDYCK mention RAY and felt certain that this individual had not been in Macomb in the recent past.

On May 2, 1968, KENNETH D. FOSDYCK was interviewed at 321 College Street, Macomb, Illinois. A number of photographs of JAMES EARL RAY were exhibited to FOSDYCK. FOSDYCK furnished the following information:

The photographs of JAMES EARL RAY are vaguely familiar to him as someone he has seen in the past.

FOSDYCK advised that he (FOSDYCK) was assigned to the Illinois State Penitentiary Honor Farm at Pontiac, Illinois, from September 15, 1952 until February 5, 1954. He advised that there was not a large number of individuals residing at this Honor Farm and it is quiet possible that he knew JAMES EARL RAY vaguely during this period of time. FOSDYCK advised that he certainly has not seen RAY since-February, 1954, and has had no information concerning RAY's whereabouts.

On 5/7/68 Chief of Police DEAN WATSON, Kewanee, advised that he knew of a DWIGHT ROWE having formerly lived in Kewanee, but advised that he had not seen him in years. He further advised that both of ROWE's parents were deceased, but that he believed ROSE V. JACABSON, 111 Hollis Street, Kewanee, was related in some way to ROWE.

On 5/7/68 Mrs. ROSE V. JACABSON, 111. Hollis, Kewanee, advised that DWIGHT ROWE was her first husband's brother. She further advised that ROWE quite often visits her children, but has not done so since the assassination of MARTIN LUTHER KING. She has never heard him mention JAMES EARL RAY. Mrs. JACABSON advised that ROWE presently resides at 905 Third Street, Green Rock, Illinois.

On 5/7/68 attempts were made to contact ROWE, 905 Third Street, Green Rock, Illinois, but were unsuccessful.

On 5/8/68 DWIGHT PIERSON ROWE, 905 Third Street, Green Rock, Illinois, advised that he had served time at Pontiac, Illinois, but stated he did not remember JAMES EARL RAY. He stated that to the best of his knowledge the first he had ever heard of RAY was when his picture appeared in the newspapers in regard to KING. ROWE advised that he met so many other men while in Pontiac using so many different names that he could have met RAY and not realized it.

VI. PRIOR THREATS AGAINST MARTIN LUTHER KING, JR.

DAVID V. LANSDEN, Attorney, Cairo, Illinois, advised on April 27, 1968, that he has had BENNY K. PINKSTON, FBI #314 7431 as a client on 2 or 3 occasions. LANSDEN. states that PINKSTON is a heartless individual who professes to be a separationist and usually acquires small amounts of money from businessmen in the white community by soliciting donations in \$1 and \$2 amounts to promote his separation of the races program.

LANSDEN stated that PINKSTON usually carries a quantity of JOHN BIRCH literature and distributes same and generally operates in the Sikeston, Missouri, or Forrest City, Arkansas area.

LANSDEN was unable to recall any conversation wherein PINKSTON threatened the life of MARTIN LUTHER KING, JR. nor does he recall PINKSTON ever consulting him as to what might happen if he killed KING.' LANSDEN states to the best of his knowledge, PINKSTON is probably in Forrest City, Arkasas where he has a mother and other relatives. LANSDEN stated to the best of his recollection, he last saw PINKSTON 3 or 4 years ago.

VII. "INTEROFFICE" LOOKALIKES AND POSSIBLE SUSPECTS

A. VINCENT DE PALMA

On April 6, 1968, RONALD LORENZEN, Managing Editor, Times Democrat, Davenport, Iowa, advised he received a telephone call from EDWARD BUMGARDNER of 917 - 6th Avenue, Erie, Illinois on April 5, 1968. BUMGARDNER advised him that the photograph displayed on television of the assassination suspect appears to be that of one VINCENT DE PALMA: BUMGARDNER also advised that he is a former Minuteman and the assassination may have been committed by a member of the Minutemen.

B. CARL RICE

JUDITH LOTT, 1103 West North Crest, Peoria, Illinois, telephonically advised on April 5, 1968, she viewed a composite drawing of suspect in slaying of captioned individual on Channel 25 WEEK television, Peoria, Illinois, which individual resembles CARL RICE, Minneapolis, Minnesota. LOTT was described as:

LOTT continued by saying RICE was previously involved in narcotics and racial matters. He attended Blake School, Minneapolis, resided with father, Doctor CARL RICE, suburb of Edina, Minneapolis, approximately 10 years ago. HARLEN BARRD, WEEK TV, Peoria, Illinois, advised the composite drawing of suspected slayer of captioned individual was shown on television April 5, 1968, which drawing was from UPI Wire Photo Service.

C. WILLIAM RAY KING

On April 7, 1968, Detective Sergeants JOHN COLEMAN and ROY WEST, Rock Island Police Department, advised an anonymous telephone call was received at the Police Department that a white male wearing gold colored clothing was at the Ft. Armstrong Hotel in Rock Island Illinois, either had a gun or guns or made statements that he had killed someone or that he had been in Memphis, Tennessee, when MARTIN LUTHER KING, JR. was killed. The voice was very muffled and the exact comments could not be distinguished.

Both proceeded to the Hotel where they immediately located BILLY RAY KING whom they checked for a gun. In subsequent conversation, they determined that KING came from Louisiana and spoke very bitterly of MARTIN LUTHER KING. He stated he got what he deserved and when asked if he had killed him, this person responded that even if he had he wouldn't tell them. They decided to take him to the Police Department for further investigation.
