MARTIN LUTHER KING....AT COMMUNIST TRAINING SCHOOL



The above picture was made by an employee of the State of Georgia, at the Highlander Folk School in Monteagle, Tennessee during the Labor Day week-end of 1957. The photographer was sent to the Highlander Folk School by the Georgia Commission on Education. The Highlander Folk School was abolished by an act of the Legislature of the State of Tennessee at a later date because it was charged with being a subversive organization.

Those numbered in the picture are:

1. Martin Luther King, Jr., of the Montgomery boycott and the Birmingham riots. Karl Prussion, a counterspy for the FBI for twenty-two years, charges that Martin Luther King belongs to sixty Communist-front organizations — more than any Communist in the United States. He is promoted and encouraged by the Kennedys.
2. Abner W. Berry of the Central Committee of the Communist Party.
3. Aubrey Williams, President of the Southern Conference Education Fund, Inc., The Transmission Belt in the South for the Communist Party.
4. Myles Horton, Director of Highlander Folk School for Communist Training, Monteagle, Tennessee.

These "Four Horsemen" of racial agitation have brought tension, disturbance, strife and violence in their advancement of the Communist doctrine of "racial nationalism."

Rev. King is the hero. I am the one that got hurt - a real American.



SELMA AND VICINITY

Outside Selma, Alabama, but in the same county (Dallas), there is an enormous plantation - the Minter plantation - which stretches for miles and miles along the highway and the county roads. This is one of the plantations which existed back in the days of slavery; it has passed on to succeeding generations of Minters. A large number of Minter tenants are now suffering because Mr. Minter has not liked their participation in the freedom movement.



Mrs. Bertha Lee Perkins, pictured above with her husband and five of her 13 children, participated in the Selma marches at the time of the Pettus Bridge bloodings, and spent time in jail. Her family is one of those whom Mr. Minter will be evicting after the deadline of December 31.



Mrs. Pearl Moorner, second from the right in the back row, has participated in many phases of the struggle. She is a central figure in the Minter plantation group of tenant farmers which has been receiving Operation Freedom aid during the past year. On Mrs. Moorner's right is Arthur Brown who has spent his life on this plantation and who picks cotton by feeling for it, as he lost the sight of one eye years ago, and has nearly lost the sight of the other. Piles of cotton can be seen in front. Mr. Brown and the Moorers are among those who face eviction on December 31.



This is the Moorner family (two children are away at school). Mrs. Moorner is at the left of the truck's tailgate, and her husband, Mr. Will Moorner, is at the right. The sign on the back of their truck says "Vote Independent," a very unpopular sign with the white landowners who not only are seeing Negroes go to the polls and vote but are seeing them campaign for Negroes who are for the first time running for office against the party machines. The three boys in the truck attend the formerly all-white elementary school.



Pictured above are the nine children who are attending the formerly all-white schools in Wilcox County, outside Selma. Sherryl Threadgill (who lives in Camden) is standing second from the right in the back row. She was struck a hard blow on the nose by a white boy at school. Fearing her nose had been broken, her parents took her to Selma for an examination. Fortunately it was not broken. Sherryl returned to Camden undaunted and more determined than before to remain in school. Seated on the car to her left is her father, Rev. Thomas Threadgill. At the extreme left is Albert Gordon, who drives the children to and from school, since busses for white children refuse to pick up Negroes.
