EVERS HAD BEEN SPEAKING AND ON ONE OCCASION GOT INTO AN AUTOMOBILE WITH [REDACTED] AND HAZEL CONFIDENTIALLY ADVISED HIM THAT HE HAD BEEN OFFERED FIFTEEN THOUSAND DOLLARS BY AN UNSPECIFIED PERSON TO KILL EVERS.
