At 5:45 p. m. , Mr. A. C. Hayden, Information Unit, Department of Justice, telephonically advised that at 5:30 p. m. , today, Beatrice Rosenberg, a secretary in the Attorney General's Office, had received a telephone call from an individual who identified himself as Frederick Dunstan. Dunstan had a "Negro" accent and claimed he resided on Route 350, ~~Whitefield~~ North Carolina. Dunstan said he was calling the Attorney General to report ~~at~~ that time a white man was in his house, was drunk, had a gun, and said he killed Martin Luther King. Dunstan claimed he was scared and that was the reason for his call.

A check of the postal guide disclosed no Whitefield, but a Whiteville was found. A check of Bureau files disclosed no information identifiable with Dunstan or Dunston. A search slip on possible variations is being sent by the Service Unit; however, no references appear for the locality of North Carolina. *Yc*

At 6 p. m. , Acting Night Supervisor Thomas H. George, Charlotte, was provided the above information and instructed to expeditiously conduct investigation concerning this matter.
