Legat, Mexico City had been instructed to obtain photographs of McLaren which Memphis and Birmingham will exhibit to witnesses.

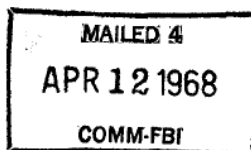
