A REVIEW OF MEMPHIS FILES TO IDENTIFY MEMBERS OF THE KKK AND OTHER HATE GROUPS HAS BEEN INITIATED AND A LIST OF NAMES TOGETHER WITH IDENTIFYING DATA WILL BE FURNISHED TO THE BUREAU IN ORDER THAT THEIR FINGERPRINTS MAY BE COMPARED WITH LATENTS NOW AVAILABLE IN THIS CASE.

MOTELS IN THE AREA ARE BEING CHECKED FOR REGISTRATION CARDS UNDER PERTINENT NAMES. MOTEL PERSONNEL ARE BEING QUESTIONED REGARDING THE LOSS OF A BEDSPREAD SIMILAR TO THE ONE RECOVERED IN THIS CASE, AND EFFORTS ARE BEING MADE TO IDENTIFY THE OWNERS OF MUSTANGS WHO STOPPED IN THESE MOTELS IMMEDIATELY PRECEDING KING'S MURDER. LEADS TO IDENTIFY AND ELIMINATE MUSTANG OWNERS ARE BEING SET OUT.
