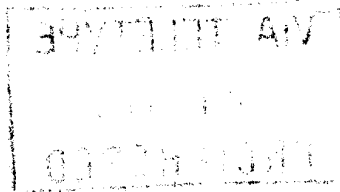

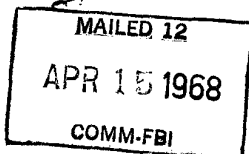
My dear Senator:
