MC AFEE, make a statement to the effect that he had relatives in the South, one of whom fits the artist's sketch of the killer of MARTIN LUTHER KING, JR. as it appeared in the newspapers. PETRONELLA also stated that MC AFEE remarked that this relative might be capable of the act.

After numerous attempts to contact WAYNE C. MC AFEE on 4/12/68, and 4/13/68, it was determined he was on a vacation trip, whereabouts unknown. On 4/16/68, WAYNE C. MC AFEE, 684 Donald Drive, North, Bridgewater, N.J., was interviewed at his residence. MC AFEE stated he has no relative who in the slightest way resembles the unknown assassin of Dr. MARTIN LUTHER KING, JR. He stated that last week he had commented to several other teachers at the Bridgewater East High School where he, MC AFEE, teaches, that he would feel sorry for the family

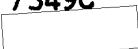
