MRS. RUTH WHICHARD RE-INTERVIEWED INSTANT DATE. SHE ADVISED THAT SHE WAS IN LITTLE ROCK, ARKANSAS ON THREE TWENTYNINE THIRTY SIXTYEIGHT AND HAD NO CONTACT WITH WILLIAM JAY OGLESBY ON THESE DATES AND HAD NO KNOWLEDGE OF HIS WHEREABOUTS ON THESE DATES.

AS TO WHY SHE DID NOT CONTACT THE FBI PRIOR TO INSTANT DATE, SHE EXPLAINED THAT ON THE DAY ~~OF~~ DR. KING WAS KILLED, FOUR FOUR SIXTYEIGHT, SHE WAS AT THE RESIDENCE OF HER SISTER-IN-LAW, MRS. PHYLIS LONG, POWELL AND HOME STREETS, MEMPHIS TENN., TELEPHONE THREE TWO SEVEN DASH ONE EIGHT SIX TWO. ABOUT TWO PM THIS DATE OGLESBY CAME TO MRS. LONG'S RESIDENCE. HE LEFT A FEW MINUTES LATER AND WAS GONE UNTIL ABOUT THREE PM. OGLESBY WAS WITH HER CONSTANTLY UNTIL AT LEAST MIDNIGHT. OGLESBY COULD NOT HAVE KILLED DR. KING.

WHICHARD ADVISED SHE WAS CONCERNED ABOUT OGLESBY BUT DID NOT BECOME ALARMED UNTIL ABOUT SEVEN THIRTY PM THURSDAY FOUR EIGHTEEN SIXTYEIGHT

WHEN OGLESBY CLAIMED TO HAVE SEEN TWO FBI AGENTS THAT HAD KNOCKED ON HIS TRAILER DOOR AFTER WHICH OGLESBY BURNED BEER CANS TO DESTROY FINGERPRINTS ALSO, THE GUNS WERE LAID OUT ON A BED ALONG WITH AMMO. WHICHARD USUALLY SLEPT ON THIS BED WHILE STAYING WITH OGLESBY. SHE WAS TOLD BY OGLESBY NOT TO MOVE THE GUNS AND ADVISED TO USE ANOTHER BED AT THIS TIME SHE NOTICED OGLESBY CARRIED A TWENTYTWO CALIBER REVOLVER IN A FRONT PANTS POCKET WHEN HE LEFT RESIDENCE. SHE BECAME MORE ALARMED AS OGLESBY AT THIS TIME TALKED FREQUENTLY OF FACT THE WHITE MUSTANG WAS^{AS} IN SOUGHT AND "THEY" WERE IN TEXAS AND PEOPLE WOULD BE SURPRISED THAT A WOMAN WAS INVOLVED IN THE MURDER OF KING. ON FRIDAY FOUR NINETEEN SIXTYEIGHT AFTER GETTING AWAY FROM OGLESBY SHE DISCUSSED THE ABOVE FACTS WITH MRS. LONG, HER SISTER-IN-LAW, WHO INSISTED THAT WHICHARD CONTACT THE FBI. SHE WAS AFRAID FOR HER OWN SAFETY TO REPORT FACTS TO FBI AND FELT THAT SHE ^SHOULD RETURN TO LITTLE ROCK. ON SATURDAY ON HER WAY TO LITTLE ROCK SHE DECIDED TO CALL THE FBI IN LITTLE ROCK AND IMMEDIATELY PLACED A CALL ABOUT ELEVEN PM ON ARRIVING AT HER RESIDENCE.

WHICHARD ADVISED THAT SHE HAD NEVER BEEN EMOTIONALLY INVOLVED OR HAD AFFAIR WITH OGLESBY. SHE HAD MET OGLESBY THROUGH HIS SISTER WHEN WHICHARD LIVED IN LITTLE ROCK IN JANUARY NINETEEN SIXTYEIGHT WITH HIS SISTER BONNIE WALKER WHO NOW RESIDES ONE FIVE ONE THREE GREGORY, JACKSONVILLE, ARKANSAS. WHICHARD EXPLAINED THAT SHE HAD MEARLY USED OGLESBY FOR A PLACE TO STAY AND FOR TRANSPORTATION IN MEMPHIS AREA. SHE EXPLAINED THAT SHE FREQUENTLY USED MEN AS SHE WAS NOT EMPLOYED.

WHICHARD ADVISED SHE HAD NO ILL FEELINGS FOR NEGROES AND DID NOT APPRECIATE OGLESBY ATTITUDE TOWARD NEGROES. THROUGH OGLESBY OFTEN MENTIONED GIRLS, SHE FELT THAT HE DOES NOT ASSOCIATE WITH GIRLS OTHER THAN HERSELF.

MEMPHIS AT MEMPHIS, TENN., WILL INTERVIEW MRS. PHYLIS LONG, POWELL AND HOME STREETS, CONCERNING OGLESBY AND CONCERNING CONVERSATION WITH WHICHARD FRIDAY FOUR NINETEEN SIXTYEIGHT.

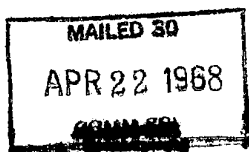

Submitted herewith in separate enclosure is the clothing Dr. KING wore at the time of the shooting. This was removed at St. Joseph Hospital in Memphis and brought to the Memphis PD by Det. E. S. BURLLEY, Memphis PD, and turned over to SAC ROBERT G. JENSEN. Preliminary examination indicates what appears to be bullet entry in collar of shirt and collection of large amounts of blood on clothing. This being submitted to Laboratory as possibility exists it may determine point of entry at which bullet entered KING's body. Laboratory also conduct serology examination and any other examination deemed appropriate by Laboratory.

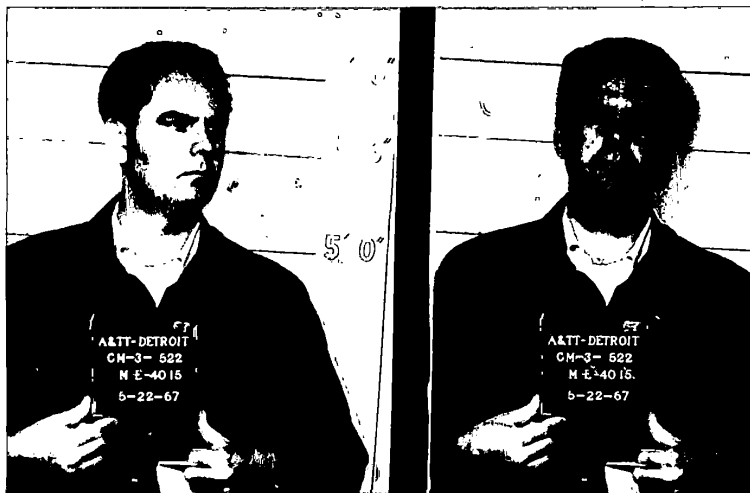

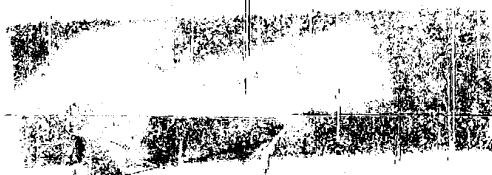

On 4/10/68 PAUL LEONARD, owner of the Sea Ranch Motel on S. Padre Island, Texas, advised that on the past Saturday night he went by the home of BILL HUCKABY, Missouri carpenter doing work for him, re additional work desired. A drinking party was in progress, and he was introduced to persons present including a man who had just driven in from Tennessee. On the latter date he boarded the Greyhound bus at 12:30 PM at Crossville, Tenn., being taken to the bus by SONNIE BROWN LEWIS, JR., Rt. 4, Box 242A, Crossville, Tenn.; and he arrived at Memphis, Tenn., at 9:55 PM where his wife had come, by prearrangement, from Little Rock. 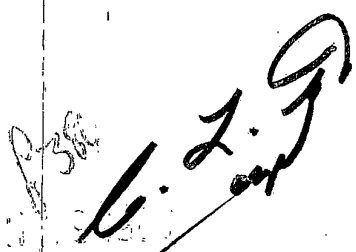
