In connection with the investigation into the murder of Martin Luther King, Jr., 4/4/68, it is noted that a rifle which is believed to be the murder weapon and a small bag containing various personal items have been recovered after apparently being abandoned by the subject.

Attached is a set of colored photographs showing these items.

It is noted that the rifle which is believed to be the murder weapon has been traced to a retail gun dealer in Birmingham, Alabama, who sold the weapon on 3/30/68 to an individual using the name of Harvey Lowmeyer. This individual gave an improper address and it appears most likely that the name he used is fictitious.

In the attached photographs is a picture showing a tee shirt and a pair of shorts that were in a small zipper bag. Both of these items bear laundry marks on red tags which were prepared by a Thermo Seal marking machine. It is noted that the front end of these marking tapes have been cut on the bias and the manufacturer of these machines has advised that this peculiarity indicates the laundry marks were made by one of only five or seven machines that have been manufactured by this company. The records of the manufacturer are being checked on an expedite basis to identify the laundries using these particular machines and they will be immediately contacted as soon as their locations are known.

Also included in the attached photographs is a picture of a blanket or a bedspread which was wrapped around the rifle when it was recovered. This appears to be the type of blanket or bedspread often used by motels and extensive investigation is underway in Tennessee, Alabama, and Mississippi in an effort to identify the source of this item.

The attached photograph showing binoculars, toilet articles and other personal items found in the blue zipper kit shows two cans of Schlitz beer. These beer cans bear Mississippi tax stamps. These beer cans also have certain numbers on one end of the can which may afford a possible means of identifying the distributor through whom the beer was sold. Photographs showing these markings have been sent to the Jackson Division, which is making every effort to trace the cans of beer.

In addition to the specific items detailed above, extensive investigation is underway throughout the field to trace each of the items that was found with the rifle, which is believed to be the murder weapon.

ACTION:

All phases of this investigation are being vigorously pursued on a top priority basis.

At 6:35 pm 4/22/68, John Mapother, Clandestine Service, Central Intelligence Agency (CIA), furnished the following information to Night Supervisor James F. McGuire by telephone: (u)

CIA sources in Panama have reported two American citizens are being detained in Panama City, Panama, at the request of the Costa Rican authorities. Allegedly, they are being detained in connection with the assassination of Martin Luther King. These individuals are identified as Tom Wolman, born [redacted] in New York. Wolman has Passport Number JO85474, issued 1/29/68, and his permanent residence is shown as 30 Larrys Lane, Pleasantville, New York. The other individual is identified as Douglas Harry Hulbard, Passport Number 330926. Hulbard is described as a former soldier who has returned to Panama to be married. CIA did not have any further descriptive data regarding Hulbard. C

These two individuals were traveling in a Chevrolet, License Number 23GH19, Motor Number 13 387 13 113711. The vehicle and license plates could not be further described by CIA. According to CIA, Wolman's passport indicates he had entered and departed El Salvador and Honduras on 4/17/68; Nicaragua on 4/18/68. C

(c) [Mr. Mapother advised he has no indication why the Costa Rican authorities have requested the detention of the above-described individuals.] Further, he does not know of any factual connection of these individuals with the King case. He said CIA sources were trying to develop this matter further. He also advised that CIA would send the FBI a written communication concerning this matter on 4/23/68. (u)

At 9:10 pm 4/22/68, [Norman Poulin, CIA] orally advised that a check had been made with the [Costa Rican authorities and] determined that [Costa Rica has no information regarding the above-mentioned individuals; that Costa Rica did not request Panamanian authorities to hold these individuals, that they have no request from any American authorities to detain them; and that they have
