The following paragraphs summarize information relayed telephonically to the Bureau, and are forwarded to you for confirmation and for your files.

2. On 28 April 1968, our representative in Addis Ababa reported that Doctor Klausy Steer, a West German citizen and Director of the African Scientific Department, E. Merck Aktiengesellschaft, Karmstady, Germany, visited the American Embassy, at the request of the local German Ambassador, and reported that he had seen a man in Lagos, Nigeria GTHLOPIA on 23 April 1968 who strongly resembled newspaper photographs of Eric Stavre Galt, who is currently wanted in connection with the assassination of Dr. Martin Luther King. Dr. Steer said that he saw the Subject at the desk of the Bristol Hotel on the afternoon of 23 April when both were checking out of the hotel. Dr. Steer was accidentally given the hotel accounting receipt for the Subject, on which he noted "Name: Joe Musgaque, Room No: 403, Receipt No: D 52138, Account No: 08325." In a short conversation with Subject, Dr. Steer learned that Subject was employed by the "Wilder Oil Company" and was enroute to Warri, Nigeria on an 18 month contract. Subject told Dr. Steer that he had recently arrived in Lagos from Las Palmas via Accra on Nigerian Airlines.

3. The above information was orelayed to the Bureau upon receipt by our duty officer on 29 April We were advised that the Bureau records did 8 6/ 3286 REC- 6944





ANGELLES - The LOS search for the slaver of Dr. Martin Luther King Jr. is more than a mathum for James Earle Ray, alias Eric Starvo Gult. For the search is that of a troubled nation crying to locate its soul, of a republic in search of its own value system.

Presidential aspirant Hubert Humphrey came class to the truth a few days ago when he said we are not lost, that we are a nation growing up and trying to find better ways. The assassination of Dr. King has intensified the search for better ways and I suspect there will be a good deal of foundation shaking, in high places at that, before the entire matter is put to rest.

I am speaking specifically of the Federal Bureau of Investigation and its director, J. Edgar Hoover.

It is open public knowledge that Hoover deeply aisliked Martin Luther King. He once referred to King as "the most notorious liar in the nation." Now Hoover is called upon to locate King's assassīn.

There are a few black people indeed who believe Hoover will work overtime in this search. The feeling is not without some foundation. Either the Fbf is idept or the those records reveal. bungling of the King case is intentional.

Hing has been dead a month now and the FBI is yet to ask the cooperation of Los Angeles Police Denartment. Yet Ray lived in Los Angeles for several months and it is known that he made at least three trips from Los Angeles to New Orleans and that he carried a Los Angeles man with him on one occasion.

Let me make it plain, very plain: America's blacks never have and do not now trust elther J. Mügur Hoover or the FBI. Those of us who have been assigned to cover civil rights stories in the south know all too well how rauch the FBI can fumble when it does not wish to solve a case.

The suspicion is defended by the fact that the FBI "leaked" a story to newsmen that suggested that a Negro with an chimus toward King was behind the assassination. The story was completely false, but if newsmen had written it, Dr. King would have been smeared even in his grave.

J. Edgar Hoover would do his nation a great service if he were to admit publicly his distilke for Dr. King and then share the hunt for the assassin with a less prejudiced аволсу.

Perhaps the cause of justice would be better served if the investigation was placed under the guidance of a Warren-type commission composed of both blacks and whites.

The murder of Dr. King was an organized and well planned exercise. This was not the deed of "some white nut." Rather there is a sense in which society itself committed the act. And it is certain that powerful men in American society were part of the deed most foul.
