He left Mexico City on Wednesday via Mexicana Airlines at Madrias (PH) in the Yucatan Peninsula and spent one night at the Madrias Hotel. The next day he flew from Madrias to the Island of Iznio (PH) where he stayed for a week in the best hotel on the island. There is no telephone service on this island. When he got ready to leave, the hotel declined to accept his American Express or Diners Club credit cards. He had to go back to Madrias where he wired home for money to pay his expenses back to the states. He took a plane out of Madrias back to New Orleans and then back to Savannah arriving in Savannah either Wednesday or Thursday night, 5/15 or 16/68.

The following description was obtained from observation and interview:

White Race Sex Male 33 Age DOB POB Savannah, Georgia 5' 11" Height 195 - 200 Weight Hair Brown, died blond Thin scar from right temple Scars and marks across top of right eye and nose; his left leg was broken in seven places and the ankle smashed in an automobile accident two years ago making it necessary to use a cane at all times.

ANDERSON said he was talking to a Negro policeman in the store at 800 Pennsylvania Avenue when the news came over the radio that MARTIN LUTHER KING was killed. He said thereafter he went with his father and some other employees to a local restaurant for a steak. He said he also attended a memorial service for Dr. KING the following Sunday in Savannah. He denied having a pistol in his possession at any time.
