In connection with transportation of subject Ray from London to the United States, the question of when the local authorities, namely the Tennessee State authorities, will take custody of subject Ray has been decided today.

SAC Jensen, Memphis, has been in touch with the Sheriff and the Sheriff has indicated that he plans to take subject Ray into custody upon arrival of the plane in the United States at the Memphis Naval Air Station.

This will facilitate the handling of subject Ray insofar as the Bureau is concerned inasmuch as it had been indicated it would be preferable to have the Tennessee authorities assume the responsibility of taking Ray into custody as soon as the plane touches down.

The Sheriff has selected a special group to handle the subject and has made preparations for transportation from the airport to the jail in anticipation of assuming this responsibility.

Assistant Attorney General Vinson will be advised of the decision of the Sheriff to handle subject Ray upon touch down at the Memphis Naval



DID YOU KILL LUTHER KING? NO, I DID NOT

JAMES EARL RAY sat in a witness box surrounded by detectives yesterday and answered just three questions by his counsel, Mr. Roger Frisby about the death of American civil rights leader Dr. Martin Luther King.

"Did you know Dr. Martin Luther King personally?"—"No, sir, I never met him."

"Did you have any kind of grudge against him?"—
"No. sir."

"Did you kill him?"—"I did not kill Dr. Martin Luther King."

*TRAPPED *

Mr. Ray, said at Bow Street, London, to be wanted in America for the murder of Dr., King in Memphis, Tennessee, on April 4, spent less than five minutes in the witness box.

He was facing extradition proceedings brought by the U.S. Government on the murder charge and for his alleged

escape from a prison where he was said to be serving 20 years for armed robbery.

The case was adjourned until Tuesday.

Forty-year-old Mr. Ray was arrested at Heathrow Airport, London, on June 8 in the name of Ramon George Sneyd, and charged with possessing a forged passport and a firearm without a licence.

Detective Chief Superintendent Thomas Butler, head of the Flying Squad, said that when he told Mr. Ray that he believed he was wanted for "serious criminal offences, including murder." in America, Mr. Ray, who had been standing up, suddenly slumped down.

"He put his head in his hands and said, 'Oh, God'," the police chief alleged. "After a moment or so he added, 'I feel so trapped'."

But Mr. Ray denied either saying these things or collapsing.

'CALCULATED'

His counsel, Mr. Frisby, said that the murder—whoever committed it—was political and not extraditable.

Mr. David Calcutt, for the American Government, said

that Dr. King had been the victim of a "calculated, brutal and sinister murder."

He added: "My case is that this tragic death was the work of the single hand of this man."

FBI fingerprint expert George J. Bonebrake told the court he examined fingerprints found on a rifle, telescopic sight and binoculars abandoned after the killing.

He compared them with known fingerprints of James Earl Ray and, he claimed, found "they were one and the same individual."

He had also compared fingerprints taken in England with these, and, he again alleged, found them to be of the same man.

'I'm not the Luther

By ARNOLD LATCHAM

THE man the eyes of the world are on went into the witness box in a heavily guarded London court yesterday . . . and did not give his name.

In a four-minute statement the man protested his innocence of the murder of American Negro leader Dr. Martin Luther King.

But he declined to sign the court record of his words. "How do I sign it?" he asked as he sat composedly in the witness-box, hemmed in by police.

answers to five questions, went into the file unsigned and headed: "The defendant, neither on oath nor affirmation, states as follows."

WHO IS HE?

These moments of drama came at Bow Street, where the man arrested at London Airport in the name of George Sneyd appeared on extradition proceedings.

The U.S. Government seeks to prove he is James Earl Ray, escaped jailbird, wanted for a "calculated, brutal, and senseless" killing at Memphis, Tennessee.

At 3.30, defence barrister Mr. Roger Frisby, who never referred to his client by name but only as "the man the Americans are seeking to extradite," announced: "I'll call my client."

In a high, deep-South accent, the defendant, answering Question

No.1, agreed that he was the man arrested at London Airport on June 8 by Detective-Sergeant Phillip Birch, Scotland Yard Special Branch.

QUESTION 2: Did you know Dr. Martin Luther King personally?—No, sir.

QUESTION 3: Did you ever meet him personally in your life?—No, sir, I haven't.

QUESTION 4: Have you ever had any kind of grudge against him?—No, sir.

QUESTION 5: Did you kill Dr. Martin Luther King?—
No. sir.

Dressed in blue and black check jacket over short-sleeved blue sports shirt, with creased dark trousers, the defendant walked to the witness box with a guard of five detectives

He prepared to affirm. Then as the court clerk prepared to writt deposition documents, the magistrate. Mr. Frank Milton, said: "He is charged as Ramon Sneyd. He can take the oath in any name helikes."

the death of Luther King

THE man accused of murdering Civil Rights leader Dr Martin Luther King yesterday denied the killing.

Ramon George Sneyd was asked at Bow Street: 'Did you kill Dr King?'

Sneyd — said by American police to be escaped convict James Earl Ray—replied: 'No sir.'

He was asked: Did you k n o w Martin Luther King? Had you ever met him? Had you a n y kind of grudge against him?

Each time he replied: 'No.'
When he moved from the dock to the witness-box a circle of heavily built Special Branch detectives, some of them armed, moved with

One stood next to him. Nine others shielded him from everyone except the magistrate and lawyers.

Defending counsel, Mr Roger Frisby, said: 'I would prefer him not to take the oath or affirm at these proceedings.'

Sneyd, wearing a dark blue suit, open-necked blue shirt and horn-rimmed glasses, was asked by Mr Frisby: 'Are you the man arrested at London Airport on June 8?'

Sneyd replied: 'Yes.'

TWO counts

Mr Frisby said that the whole burden of his case was that the killing was political and that Martin Luther King was a political figure.

'If this is so,' he said, 'this is not an extraditable offence under the treaty between us and the United States.'

He said to him: 'As a result of inquiries made since you were detained, we have very good reason to believe that you are not a Canadian citizen, but an American.'

Sneyd was said to have replied: 'Oh well, yes I am.'

The superintendent went on: 'I now believe your name is not Sneyd but James Earl Ray, also known as Eric Starvo Galt and other names, and that you are wanted at present in the United States for serious criminal offences, including murder.'

SNEYD EXTRADITION IS ILLEGAL,

SAYS DEFENCE

POLICE CHALLENGED

By GUY RAIS

MR. ROGER FRISBY, counsel for James Earl RAY, the man wanted by the American Government concerning the murder of Dr. Martin Luther King, argued at Bow Street yesterday that the assassination had political motives, and that Ray could not be extradited to America.

Ray appeared in court as RAMON GEORGE SNEYD, 40, the name under which he was arrested at Heathrow Airport on June 8 by Special Branch officers. The application for his extradition was on two grounds—that he was "a fugitive criminal accused of murder" and "a fugitive convicted

robbery."

Two British charges against Sneyd—of possessing a forged passport, and a firearm and ammunition without a certificate—were adjourned until after the extradition hearing.

Mr. DAVID CALCUTT, for the American Government, outlined events which he said led to the murder of Dr. King in Memphis on April 4, and claimed that the Negro leader's assassination was the work of the "single hand" of Sneyd. STORY WHILE . . YOUR VANCE

"TRAPPED" REMARK Police evidence denied

Det. Chief Supt. THOMAS BUTLER, head of Scotland Yard's Flying Squad, said that when he told Sneyd he believed he was the man wanted for murder in America, Sneyd replied: "Oh, God. I feel so trapped."

But SNEYD said that he did not make the remarks alleged by Supt. Butler, and after a brief adjournment, Mr. FRISBY added: "He wishes to state most emphatically he did not make the observa-

Several detectives stood around the witness box as Sneyd gave evidence for three minutes. At his counsel's request, he did not take the oath.

In a short appearance in the witness box, SNEYD agreed that he had been arrested at Heathrow on June 8.

Questioned by Mr. FRISBY, he said: "I have never met Dr. King. I have never had any kind of grudge against him."

Mr. FRISEY: Did you kill Dr. King? No. Fir.

Just before the adojurnment, Mr. Frisby said the offence specifically mentioned in Article Three of the extradition treaty between Britain and America was one of robbery with violence.

This meant, in his submission, that before the magistrate ordered extradition, he must be satisfied that there was a prima facie case that this man had committed robbery with violence.

Regarding extradition on the murder accusation, Mr. Frisby said: "I am suggesting that this offence was one of a political character, and therefore does not become an extraditable offence."

The case was adjourned until Tuesday, and Sneyd was remanded in custody on all the charges. Mr. Milton said the British charges would be heard in seven,

On April 4 this year Martin Luther King had been the victim of a calculated, brutal and senseless murder, a murder that was bitter with irony. Though he was a leader of men, he never sought any power for himself.

"Though his name was a very password for peace, he met a violent death," Mr. Calcutt said. "This tragic death of Dr. King was the working of the single hand of this man."

On March 29, Sneyd had gone into a shop at Birmingham, Alabama, and bought a rifle, telescopic sights and ammunition from a Mr. Wood. There was a customer in the shop at the time.

The following day Sneyd was not satisfied, and changed the rifle for a Remington 760, which had telescopic sights attached. He also bought ammunition and a box for the gun.

"On April 3, Sneyd booked in at the New Revel Motor Hotel at Memphis," Mr. Calcutt said. "On the following day, he checked out of that hotel and on that day in Memphis he bought a pair of binoculars."

Also on that day, Dr. King was at Memphis, staying at the Lorraine Motel, a pleasant modern

'Booked a room opposite motel'

Mr. Calcutt continued: "From a bathroom window at 4241₂ South Main Street, a person could see into Dr. King's room. At 4 p.m., this defendant went to 4241₂ South Main Street, where accommodation was available, and he booked a room."

As he did this, he was seen by a witness—a Mr. Stevens, who was in an adjoining room. After Sneyd booked in, he used the bathroom and lavatory three times, each for a long while, before 6 p.m.

"At six o'clock, Mr. Stevens says he heard a shot fired from the bathroom. He came out of his room and saw a man leaving below. He says it was the man

near the end of the hallway.

"He was carrying a bundle in his right hand. It was at least three or four feet long and six to eight inches thick, and was wrapped in newspaper. Although I did not get a long look at him, I think it was the same man I saw earlier with Mrs. Brewer."

Mr. CALCUTT added that an autopsy was carried out by Dr. Franchisco, medical examiner of Shelby County. "It revealed that Dr. King died from the gunshot would almost immediately. The bullet severed the spinal column after entering through his right chin and the right of his neck."

Sneyd searched at Heathrow

Det. Sgt. PHILLIP BIRCH, of Scotland Yard's Special Branch, said that he was on passport control on the outward section, Number Two Building, Heathrow Airport, at 11.30 p.m. on June 8.

Sneyd had approached and presented two Canadian passports to the immigration officer. "As a result of what I had previously learned, I asked the defendant to accompany me to the Special Branch office at the airport, so that he might be questioned," Sgt. Birch said.

In the office, he searched Sneyd and found a loaded .38 revolver in one of his trouser pockets. He then detained Sneyd until other police officers arrived.

"CANADIAN CITIZEN" "Oh God" statement

Det. Chief Supt. ARTHUR BUTLER, of Scotland Yard, said that at Heathrow the man said his name was Sneyd and he was a Canadian citizen, born in Toronto.

At Cannon Row Police Station, where Sneyd was taken, he said to him later: "We have good reason to believe that you are not a Canadian citizen, but an American."

Sneyd had replied: "Oh well, yes I am."

Supt. Butler had continued: "I now believe your name is not Sneyd but James Earl Ray, also known as Eric Starvo Galt and other names, and that you are wanted in the United States for serious criminal offences, including murder in which a firearm was used."

He then told the court: "The accused had been standing up, but at this he suddenly slumped down on the seat behind him, put his head in his hands, and said: 'Oh, God'."

After a moment or two he had added: "I feel so trapped." While he was with detective, Sneyd was quiet and made no admissions, Supt. Butler added.

Mr. George J. Bonebrake, of the FBI's Fingerprint Department in Washington, then gave evidence about fingerprints on the rifle and binocular, and was cross-examined by Mr. Frisby about American attitudes towards Dr. King.

At the end of prosecution evidence, Mr. MILTON told Sneyd that he was cautioning him about his rights to produce witnesses to give evidence, and his right to give evidence on his own behalf.







The "calculated, brutal and senseless murder of Negro leader, Dr. Martin Luther King, was outlined at Bow Street today.

Mr. David Calcutt, on behalf of the U.S. Government, alleged that the killer was Raymond George Sneyd, alias James Earl Ray.

He applied for extradition on the grounds that Sneyd was "a fugitive criminal accused of murder and a fugitive criminal convicted of robbery.

He said: "This is a murder which was bitter with irony. Though Martin Luther King was a leader of men he never sought any power for himself.

Bought gun, bullets

"And though his name was a very password for peace, he met a violent death." Robert Kennedy, the assassinated senator, had said of Dr. King: "He gave himself to love."

Mr. Calcutt then told the story of how Sneyd was alleged to have murdered Dr. King.

He said on March 29 this year Sneyd bought a rifle, telescopic sights and ammunition in a shop in Birmingham, Alabama.

He went back to the shop next day and said he was not satisfied. He changed the rifle for a Remington 760 rifle, with telescopic sights attached.

He also bought ammunition, and took away with him a box which was not the right one for that rifle

On April 3. Sneyd checked in to the New Rebel Motor Hotel, Memphis, and signed the register. The following day he bought a pair of binoculars. On that day Dr. King was in

424 South Main Street and was
allocated a room. He was seen
there by another witness, a Mr.

During the afternoon, Mr. Stevens heard Sneyd use the bahroom at the back of the building thre times. On the third time he stayed in the room for a long time.

Mr. Calcutt said Sneyd must have left in a hurry. He left behind some binocular straps. Sneyd dropped his "kit"—rifle, sights and binoculars—in

front of a shop farther along the street and drove off alone. Police later found this equipment Sneyd's fingerprints were on it. Evidence could be called to show there was "a very strong likelihood" that

the bullet that killed Dr. King came from that rifle.

Mr. Calcott said that Sneyd was jailed for 20 years in 1959 for armed robbery. He escaped from the Missouri state prison in April, 1967.

The monopoly situation must rule out an Imps counter bid. Yet Imps originally bought its share stake in Gallaher's to block an American bid-and that was in 1932.

Philip Morris-its most famous cigarette is Marlboro—is the U.S. fourth largest tobacco firm.

Today Gallaher was officially saying nothing about the offer. A spokesman said a statement would be made later today.

The death of Dr. Martin Luther King was "the working of the single hand" of a man who appeared at Bow Street today under the name of Ramon George Sneyd, said Mr. David Calcutt, for the United States Government.

Mr. Calcutt was seeking the extradition to America of Sneyd, whom the U.S. police say is James Earl Ray.

The extradition application was on two grounds—that Sneyd was "a fugitive criminal accused of murder" and "a fugitive criminal convicted of robbery."

The extradition charges accuse him of murdering Martin Luther King junr., in Shelby County, Tennessee, and with having been sentenced for robbery in America in February, 1960.

'Senseless'

Mr. Calcutt went on: "On April 4 this year Martin King was the victim of a calculated brutal and senseless murder.
This is a murder which was bitter with irony. For he was a leader of men. He never sought any power for himself though his name was a passport for peace. He met a violent death.

Perhaps the irony reaches its peak when it is remembered that only a day or so after this man's death it was indeed Senator Robert Kennedy who said of tis man King: 'He was a man who gave himself up to justice and love."

Mr. Calcutt claimed that the case for the American Government was that his tragic death was the work of the 'single hand of this man."

Outlinging the events in America, before Dr. King was murdered, Mr. Calcutt alleged that Ray went into a shop in Birmingham, Alabama, on March 29. There he bought a rifle with telescopic sights and ammunition from a Mr. Wood. Another man was a customer in the shop at the time.

On the following day, he was dissatisfied with the equipment and changed it for a Remington 760 rifle with the number 461476. Attached was a telescopic sight with the mark A17350.

He also bought ammunition and a box which was not the ight box for that particular gun. A few days lated, on April 3, Ray booked in at a motor hotel in Memphis. He signed the register and the card was available for the court to see.

He checked out of the hotel the next day and bought a pair binoculars with the mark DQ408664.

On that day, Dr. Martin Luther King was staying at Memphis at the Lorraine Hotel -a pleasant modern building with a balcony.

From that balcony, Mr. Calcutt said, it was possible to look across to the back of buildings which faced on to South Main Street, Memphis.

More than 30 journalists, including many Americans, and 30 members of the public listened closely to the murder story while it was being revealed for the first time in a court of law.

Mr. Calcutt, referring to the fact that one could look across to South Main Street, said Ray booked in at a rooming house with this view at four o'clock that day.

Booked in

He was seen by the proprietor of the block, Mr. Stephens, and he was allocated a room. Mr. Stephens heard the bathroom and lavatory, which were one room, being used by this man.

He used the room on three occasions and on the third occasion stayed in the room for a long time.

Mr. Stephens was in a room adjacent to the bathroom and he heard a shot being clearly fired from the bathroom. A minute later Mr. Stephens came out of his room and saw a man leaving the block. It was the same man who had booked the room.

He must have left in a hurry because he left binocular straps. And as he came into the street he turned left and dropped his kit, the rifle and binoculars. He then made off alone in a car

which was waiting nearby.

Police came shortly afterwards and took possession of the rifle and binoculars. On them were

found Ray's fingerprints.







HOW RAY SHOT LUTHER KING Bow St. story

'Calculated, senseless, brutal murder'

Evening Standard Reporter

THE FULL STORY of how Martin Luther King was killed was told for the first time today—in Bow Street court.

It happened when James Earl Ray, the man wanted by the American government for the murder of Dr. King, was accused of the "calculated, brutal and senseless" killing of the Negro leader in Tennessee two months

He sat composedly in front of the dock as Mr. David Calcutt, for the U.S. Government, spoke of the epitaph given to Dr. King by Bobby Kennedy shortly before he himself was assassinated: "A man who gave himself up to justice and love."

Extradition sought

The accused faced the court in the name of Raymond George Sneyd, 40, under which he was arrested at Heathrow Airport earlier this month by Special Branch officers.

But extradition proceedings against him in the name of Ray accusing him of killing Dr. King are taking precedence over English charges of possessing a firearm and a forged passport at the airport.

Mr. Calcutt told the court the application for

extradition was made on two separate grounds:

The defendant is a fugitive criminal accused

of murder;
The defendant is a fugitive criminal con-

The extradition charges accuse him of murdering Martin Luther King junr., in Shelby County, Tennessee, and with having been sentenced for robbery in America in February, 1960.

Mr. Calcutt claimed that the death of Dr. King was the work of "the single hand" of Ray.

The allegations

cutt alleged:

RAY BOUGHT a rifle with telescopic sights together
with ammunition at a shop in Birmingham, Alabama.

RAY BOOKED into a rooming house in Mephis three days later, and was given a room which looked directly on to the Lorraine Hotel, where Martin Luther King was staying.

RAY BOUGHT a pair of binoculars in Memphis

on the day Dr. King was shot.

RAY WAS SEEN to run out of the rooming house shortly after shots were fired, and drop the rifle and

RAY'S FINGERPRINTS were found on the rifle and on straps of the binoculars.

Det. Chief Supt. Arthur Butler, head of the Flying Squad, said when he told the defendant he believed he was the wanted man, James Earl Ray, he replied: "Oh, God . . . I feel so trapped."

Ramon George Sneyd went into the witness box at Bow Street Magistrate's Court yesterday and denied that he had killed Dr. Martin Luther King, the civil rights leader.

An application for his extradition to the United States was made at the court and adjourned until next Tuesday. Mr. Sneyd, who was arrested at London airport, was remanded in custody.

He was asked five questions by Mr. Roger Frisby, his British lawyer, after being advised by his counsel not to take the oath or to affirm.

Mr. Frisby asked: "Are you the man who was arrested at London Airport?—Mr. Sneyd replied: "Yes,

Did you know Dr. Martin Luther King?—No. sir.

Had you ever met him personally in your life?—No, sir.

Have you ever had any grudge of any kind against him?—No, sir.

Did you kill Dr. Martin Luther King?—No, sir. Earlier in the hearing, before Mr. Frank Milton, the Chief Metro-Magistrate, Mr. objected from his seat in front of the dock to certain parts of the evidence given by Detective-chief Superintendent Thomas Butler, head of the Scotland Yard Flying Squad.

Two passports

Chief-superintendent Butler said he asked Mr. Sneyd his name because on two Canadian passports he had been carrying his name was given as Sneyd and Sneya. The defendant was alleged to have rephied: "I cannot understand why I am here. My name is Sneyd.

Chief-superintendent Butiler went on: "I said: Both these passports show that you are a Canadian subject born in Toronto on October 8, 1932. Are these details correct?' He replied: 'Yes, of course they are.'"

Later, in a cell at Cannon Row Police Station, Chief-superintendent Butler said he told him: "I now believe that your name is not Sneyd but James Earl Ray, also known as Eric Starvo Galt and by other names, and that you are wanted at present in the United States for serious criminal offences, including murder in which a firearm was used."

No admission

He added: "The accused had been standing up but at this he suddenly slumped down on the seat behind

him and put his head in his hands and said: 'O, God.'

"After a moment or two he added: 'I feel so trapped.' I cautioned him and he replied: 'Well, yes. I cannot say any more now. I can't think right'."

Cross-examined by Mr. Frisby, the detective agreed that at no time had Mr. Sneyd made any admission of

any kind.

Soon after Chief-superintendent Butler had left the witness box Mr. Sneyd stood up and said,: "There has been some testimony which I think has been false. I think he has imagined some things and I very much disagree with him and I would like to give my side of it.

Mr. Frisby immediately inter-jected and asked for a 10-minute adjournment while he took instruc-

tions from his client.

When they returned Mr. Frisby said: "He tells me he disagrees with a large part of the evidence given by Chief-superintendent Butler. In particular, he wishes to state most emphatically that he did not make the observation, "I feel so trapped". Nor did he say: "Oh, God". Nor did he collapse into the seat in the manner in which the Chief-superintendent des-cribed. Indeed, he wishes it to be made known that he made no statement to that or any other police officer and he refused to sign his fingerprint form".

Mr. George Jacob Bonebrake, of the Federal Bureau of Investigation. said he had examined the finger-prints of Mr. Sneyd and Ray and those found on a rifle, telescopic sights and a pair of binoculars found in a street in Memphis soon after Dr. King had been shot. All these, he said, were made by the same person.

Stay in Memphis

The only witness to be called by Mr. Sneyd's lawyers was Mr. Peter Hopkirk, a journalist employed by The Times, who said he appeared in

court on subpaena.

He said that he arrived in Memphis the day after Dr. King had been shot and spent a total of between five or six days there. He said it was no secret that Dr. King was disliked by many white people living in the south.

Asked by Mr. Frisby on what ground, Mr. Hopkirk replied: "1 would say on the grounds of what he stood for. I doubt whether many white people knew him personally so there would be no room for any personal animosity to my know-

ledge.

Our Legal Correspondent writes: The defenece case rests on the argument that the murder of Dr. Martin Luther King is an offence of a political character for which there can be on extradition. The Extradition Act, 1870, makes this provision but gives no guidance on the meaning of

a political character'

In his submissions Mr. Frisby cited judicial authorities to support his contention that murder can be a political offence for the purposes of extradition. He said that a political offence was an act done for a political motive during a period of political unrest Mr. Sneyd's unsworn statement in the witness box demonstrated, he said. that there was no evidence that the crime was committed for any personal motive.

Mr. Frisby quoted from an extradition case in the House of Lords in 1962, where Lord Reid had said that an act to compel a government to change its policy could be political. It was the defence's submission that this was what Dr. King and his

followers were doing.

Williams brought his 57ft. ketch past the finish at 2.32 a.m. today —26 days, 20 hours and 32 minutes after he left Plymouth, according to his unofficial time.

On the charge sheet he was named as Ramon George Sneyd, 35. The Americans say he is James Earl Ray but he himself gave no name when he went into the witness-box.



Sheriff William N. Morris, Shelby County, Tennessee, has surnished the following information regarding his plans to transport James Earl Ray from the Memphis Naval Air Station to the Shelby County Jail and to provide for the security of the prisoner in the jail.

Transportation to the jail will be handled by the Sheriff's Tactical Unit. The prisoner will be transported in an armored car which will be accompanied by approximately five other automobiles. Four of the automobiles will each be manned by five fully armed and uniformed deputies. The other automobile will be occupied by four deputies armed a with automatic weapons.

A special cell block is being prepared on the third floor of the Shelby County Jail. Ray will be housed in this unit which contains five separate cells. No other prisoners will be in this cell block. Steel plate is being installed inside the windows of this cell block and windows If the County Office Building, the only adjacent building, will also be secured. The Sheriff is arranging for public business normally transacted In the County Office Building to be handled at other locations while Ray in jail.

The cell block selected for Ray has two television monitors as well as an audio monitoring system. A group of fourteen specially selected deputies will be exclusively assigned to Ray's custody. Two of these guards will be within the cell block at all the best to keep the prisoner under constant observation and to maintain a written log. Food for Ray will be selected on a random basis from food served other
