Stoner is Vice Chairman of the National States Rights Party, an anti-Semitic and anti-Negro organisation with headquarters based in Savannah, Georgia. Stoner is also one of three attorneys of record for James Earl Ray.

A hearing is set at Memphis, Tennessee, on 5/26/69 and at this time the judge will act on motions filed by atturneys of James Earl Ray requesting a new trial.
