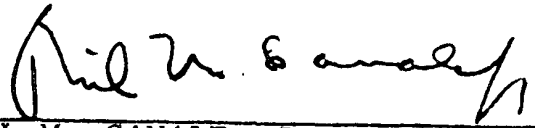

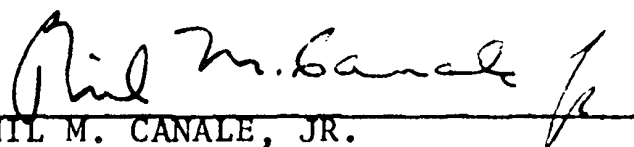

AFFIDAVIT OF DR. J. T. FRANCISCO

Now comes the affiant, after first being duly sworn and says as follows:

That he is Dr. J. T. Francisco and resides and is domiciled at 1196 Yorkshire, Memphis, Shelby County, Tennessee, United States of America; that he is employed by the University of Tennessee as a pathologist and by Shelby County, Tennessee, as Medical Examiner for Shelby County, Tennessee; that he is a duly licensed and practicing physician of the State of Tennessee and holds a Doctor of Medicine Degree from the University of Tennessee and has practiced medicine for thirteen years and has served as medical examiner for Shelby County, Tennessee, for seven years. That as part of his duties as medical examiner, he examines all violent, unusual, or unnatural deaths that occur within the County of Shelby, State of Tennessee, for purposes of discovering the cause of death and recommending autopsies upon such deaths investigated if he deems it necessary. During his seven years as medical examiner, affiant has examined approximately nine thousand bodies and performed approximately three thousand autopsies. Affiant is further certified by the American Board of Pathology in Anatomic, Clinical and Forensic Pathology. That affiant is forensic pathology consultant to the Chief Medical Examiner of the State of Tennessee. That on April 4, 1968, acting pursuant to his duties as medical examiner of Shelby County, Tennessee, and under order from the District Attorney General for the Fifteenth Judicial Circuit consisting of Shelby County, Tennessee, said District Attorney General being Phil M. Canale, Jr., and with the consent of Corretta Scott King, the widow of Dr. Martin Luther King, Jr., affiant performed an autopsy on the body of Dr. Martin Luther King, Jr., starting at approximately 2140 hours at the morgue of the University of Tennessee and John Gaston Hospital, located in the Institute of Pathology at the University of Tennessee, 858 Madison Avenue, Memphis, Shelby County, Tennessee.

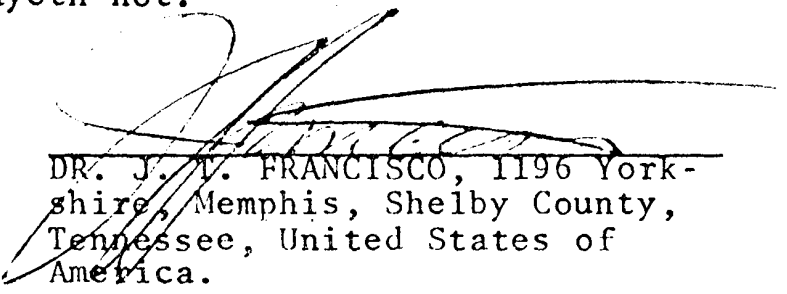

That during the examination and autopsy, affiant removed ^{a bullet} from beneath the skin in the region of the left scapula 56 inches superior to the right heel and 3 inches to the left of the midline of the spine, this being the termination point of a bullet that entered the right chin, passing through the chin and neck. That after removing the bullet, affiant physically marked the bullet by scratching the Autopsy No. 252 on the base thereof, and placed the same in plastic and enclosed the same in a Manila envelope, marking thereon and gave the same into the custody and gathering a written receipt from Lt. J. D. Hamby of the Memphis, Tennessee, Police Department. In accordance with the laws of the State of Tennessee, affiant did reduce the findings from the autopsy he performed upon the body of Dr. Martin Luther King, Jr., to writing in the form of an autopsy report bearing Case No. A68-252, did sign same under date of April 11, 1968, and filed said autopsy report with the Shelby County Medical Examiner, District Attorney General of the Fifteenth Judicial Circuit comprised by Shelby County, Tennessee, and with Chief Medical Examiner for the State of Tennessee. Affiant has examined a copy of the aforesaid autopsy report, which is attached and marked exhibit hereto, a certified and authenticated copy of which appears, is attached and is made by reference a part of the Governor's application for requisition, and certifies that it truly and accurately represents his findings in the autopsy of the body of Dr. Martin Luther King, Jr., and further certifies that it is a true and correct copy of the autopsy report filed with the Office of the Chief Medical Examiner for the State of Tennessee, Cordell Hull Office Building, Division of Post Mortem Examination, Office of Chief Medical Examiner, Nashville, Tennessee. That affiant has examined Certificate of Death, Tennessee Department of Public Health, Division of Vital Statistics, bearing File No. 2066, being a copy of the Certificate of Death on



Dr. Martin Luther King, Jr., same being attached and marked exhibit hereto, a certified and authenticated copy of which appears, is attached and is made by reference a part of the Governor's application for requisition, and does certify that it represents a true and correct copy of the original Certificate of Death on Dr. Martin Luther King, Jr., signed by affiant on April 5, 1968, giving the cause of death as gunshot wound to the thoracic cord. Affiant has examined survey report and plat, identified to affiant as being a drawing of the crime scene, said document bearing the notation in the lower right hand corner, Prepared by Arthur C. Holbrook, Memphis, Tennessee, April 23, 1968, Tenn. Cert. No. 5173, copy of said drawing being attached and made exhibit hereto, a certified and authenticated copy of which appears, is attached and is made by reference a part of the Governor's application for requisition, and affirms that the trajectory of a bullet traveling along the path as indicated in said drawing would be consistent with the entry of the bullet and subsequent course through the body of Dr. Martin Luther King, Jr.

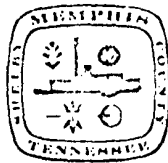

DEAR MR. HOLLOMAN:

PER YOUR REQUEST, DATED APRIL 22, 1968, THROUGH MR. CHARLES B. BLACKBURN, DIRECTOR, DIVISION OF PUBLIC WORKS, I WAS INSTRUCTED TO MAKE CERTAIN ENGINEERING MEASUREMENTS RELATIVE TO THE MURDER OF DR. MARTIN LUTHER KING. THESE MEASUREMENTS WERE TO BE FROM A POINT WHERE THE WEAPON WAS FIRED TO THE AREA WHERE DR. KING WAS STRUCK. THE MEASUREMENTS WERE TO BE TRIANGULATED.

THIS MORNING, APRIL 23, 1968, I AND SEVERAL ENGINEERING EMPLOYEES FROM THIS DEPARTMENT, MET WITH LTS. A. S. ZELINSKI AND J. L. HARRISON, OF THE POLICE DEPARTMENT, AT THE SCENE OF THE MURDER. THE MEASUREMENTS AND CALCULATIONS, HEREINAFTER DESCRIBED, WERE MADE BETWEEN 8:30 A. M. AND 10 A. M., THIS DATE.

I WAS SHOWN, BY LTS. ZELINSKI AND HARRISON, THE SPOT WHERE DR. KING WAS STANDING AND THE WINDOW FROM WHICH THE SHOT WAS FIRED AND THAT THE BULLET ENTERED DR. KING AT A POINT 59 INCHES ABOVE THE BALCONY FLOOR OF THE LORRAINE MOTEL, AND THAT THE GUN WAS RESTING ON A POINT ON A WINDOWSILL OF A BUILDING WHICH FRONTS ON SOUTH MAIN STREET AND ACROSS MULBERRY STREET FROM THE LORRAINE MOTEL.

AN ENGINEER'S TRANSIT WAS PLACED OVER THE SPOT WHERE DR. KING WAS SHOT. THE TELESCOPE BEING 59 INCHES FROM THE BALCONY FLOOR, AND THE INSTRUMENT WAS MADE LEVEL.

FROM THIS POSITION TWO TRIANGLES WERE ESTABLISHED, WITH A BASE LINE COMMON TO THE TWO TRIANGLES, ESTABLISHED AND MEASURED. ANGLES WERE TURNED, CHECKED, TURNED AGAIN, AND CHECKED AGAIN AND EVERY EFFORT WAS MADE TO PROVIDE FOR THE UTMOST ACCURACY OF THE CALCULATIONS.

THE LEVEL DISTANCE FROM THE POINT FROM WHICH THE SHOT WAS FIRED TO THE POINT WHERE DR. KING WAS STANDING IS 206.36 FEET. THE DISTANCE ALONG THE FLIGHT OF THE BULLET FROM THE POINT FROM WHICH IT WAS FIRED TO THE POINT WHERE DR. KING WAS STANDING IS 207.02 FEET.

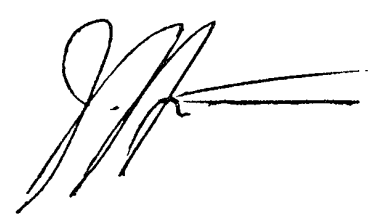

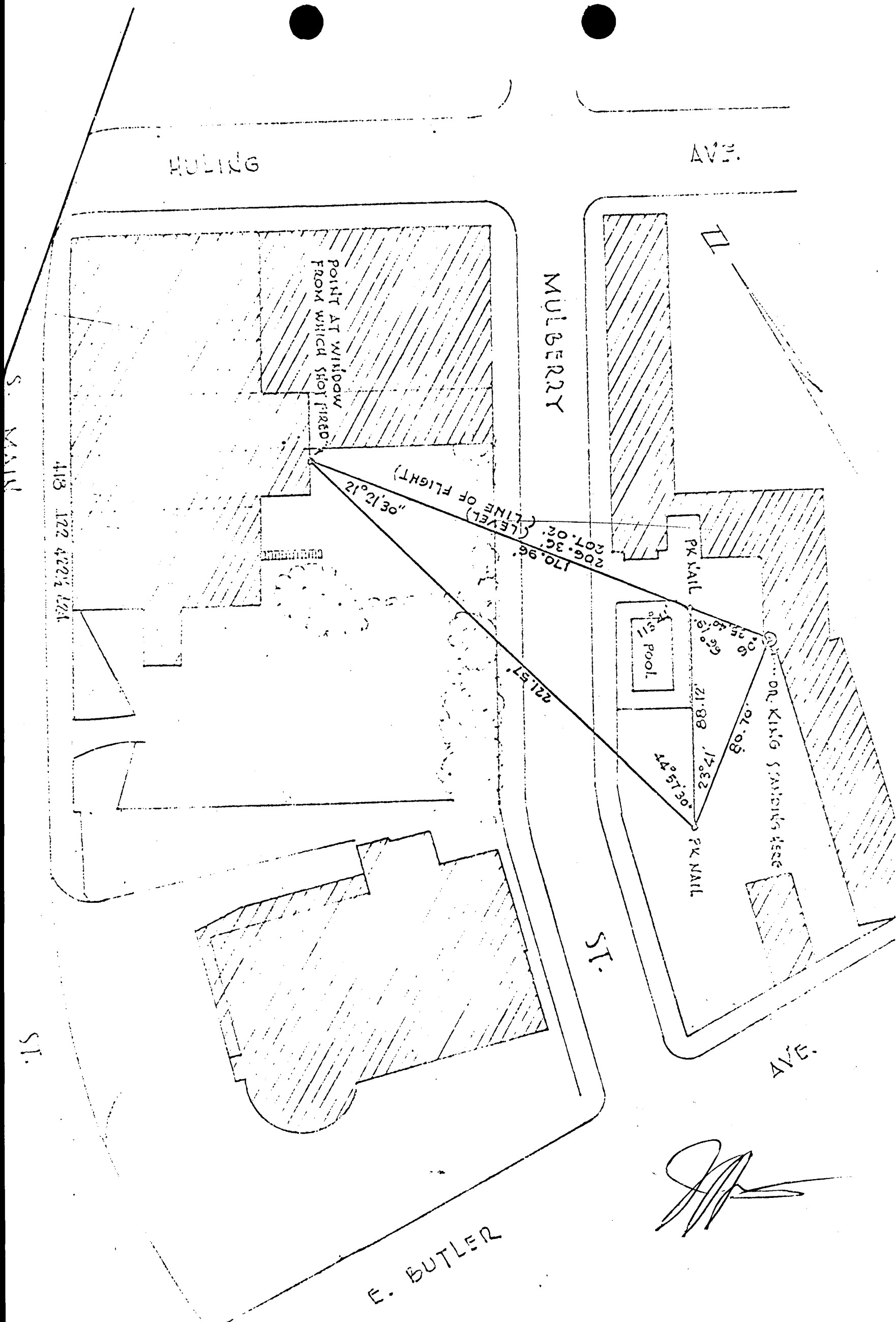

NARRATIVE OF FINDINGS Death was the result of a gunshot wound to the
chin and neck with a total transection of the lower cervical and
upper thoracic spinal cord and other structures in the neck. The
direction of the wounding was from front to back, above downward and
from right to left. The severing of the spinal cord at this level
and to this extent was a wound that was fatal very shortly after its
occurrence.

The purpose of this report is to provide a certified opinion to the County Medical Examiner and the District Attorney General. The facts and findings to support these conclusions are filed with the office of the State Medical Examiner.

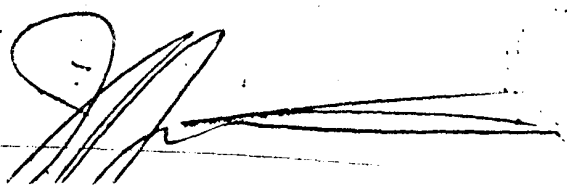

EXTERNAL EXAMINATION OF THE BODY

This is a well developed, well nourished Negro male measuring 69 1/2 inches in length and weighing approximately 140 pounds. The hair is black, the eyes are brown. There is a line mustache present.

EXTERNAL MARKS AND SCARS

There is a remote midline scar present in the center of the chest and a remote scar present extending to the right axilla measuring 8 inches in length. There is a sutured vertical surgical incision present at the base of the neck. A sutured incision is present in the right chest at the anterior axillary line. Three needle punctures are present in the precordium, having no hemorrhage present surrounding the area. There are blood splatters present on the palm and dorsum of the right hand. A remote scar is present in the right lateral chest. Sutured incisions are present in the left ante cubital fossa, one that is obliquely directed measuring 2 inches in length, one that is horizontally directed measuring 1 inch in length. There are two sutured incisions present on the medial aspect of the left ankle. The superior incision measuring 2 inches in length, the inferior incision measuring 1/4 inch in length. There is an extensive excavating lesion affecting the right side of the face beginning at a point 1 inch lateral to the right corner of the mouth and 1/2 inch inferior to the right corner of the mouth that measures approximately 3 inches in length. At the superior aspect of this gaping wound there is an abrasion collar that measures 1/3 of an inch in maximum thickness, having brownish discoloration present at the superior margin. Adjacent to this area there is extensive laceration of the soft tissues of the face with a fracturing of the right side of the mandible. A re-approximation of the tissues reveals the laceration to extend to the base of the neck and into the base of the neck with intervening skin unaffected in this area. The second penetrating wound at the base of the neck in the superior aspect of the chest measures 3 inches in length. The missile path is through the external jugular vein and vertebral artery. There is a penetration into the lateral aspect of the base of the neck into the upper thoracic and lower cervical cord totally severing the lower cervical and upper thoracic cord passing through the spinal column at the level of C7 and T1 into the posterior aspect of the back. The bullet is removed from the posterior aspect of the back, 56 inches superior to the right heel and 55 1/2 inches superior to the left heel, 3 inches to the left of the midline of the spine in the medial aspect of the left scapula. The entrance wound is 61 1/2 inches superior to the right heel and 59 inches superior to the right heel with the head turned and positioned so that the wound in the face corresponds with the path of the missile into the neck and spine. The total thickness from the entrance wound to the posterior aspect of the back is 8 1/2 inches in thickness. The angle of the penetrating wound is approximately 45° from a sagittal plane at an angle from right to left inferiorly and anterior to posteriorly at about a 30° angle with a coronal plane.

SECTION

The abdominal panniculus measures an inch in maximum thickness. The skeletal muscles are red and fibillary. There is scarring present over the right anterior-superior chest with pleural adhesions present in this area.

BODY CAVITIES

There is approximately 25cc. of blood present within the right thoracic cavity and some subpleural hemorrhage that is present affecting the right and the left in the posterior apex. The missile did not enter the right pleural cavity.

GROSS DESCRIPTION OF THE ORGANS

HEART: The heart weighs 450 grams. The myocardium is pale brown. The valvular surfaces reveal no significant changes. There is focal yellowing of the subendocardial areas affecting the left aspect of the interventricular septum. The right ventricle measures 5mm. in maximum thickness. The left ventricle measures 20mm. in maximum thickness. The coronary ostia originate in normal position and have a normal distribution over the epicardial surface. There is minimal intimal proliferation present. Focal yellow plaqueing is present in the ascending aspect of the aortic arch but ulceration is not present. There is no significant dilatation affecting the chambers of the heart.

AORTA: Focal yellow plaques are present throughout the aorta but ulceration and calcification is not present. The great vessels originate normally. There is perivascular hemorrhage affecting the right carotid artery but no penetration of the wall. The right subclavian artery is lacerated.

ESOPHAGUS: Partially digested food fragments are present throughout the esophagus.

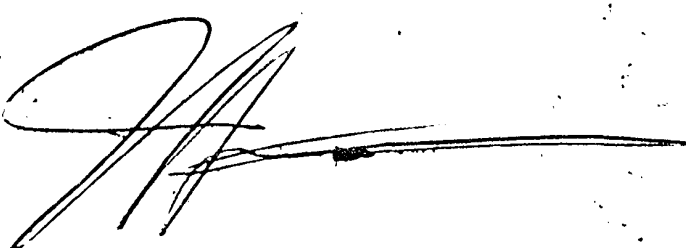
TRACHEA: Hemorrhagic mucoid material is present throughout the upper trachea.

LUNGS: The right lung weighs 300 grams. The left lung weighs 325 grams. There is diffuse congestion, consolidation and hemorrhage affecting the right upper lobe of the lung. Frothy fluid is expressable from the sectioned surface. There is minimal wrinkling of the pleura diffusely throughout the pulmonary parenchyma.

BRAIN: The brain weighs 1400 grams. There is some flattening of the gyri and narrowing of the sulci. The cerebral vessels are symmetrical. There is no subdural, epidural, or extradural hemorrhage present. There is no significant flattening throughout the cerebral vessels.

KIDNEYS: The kidneys weigh 175 grams on the left and 150 grams on the right. The capsular surface is smooth. The parenchyma is of normal coloration. The cortical-medullary junction is prominent.

PANCREAS: The pancreatic parenchyma is well preserved. The lobular pattern is preserved. There is no fatty infiltration present. The parenchyma is yellowish-grey.

LARYNX: There is diffuse hemorrhage present throughout the superior larynx along with submucosal hemorrhage that is present within the intra-laryngeal areas. There is a tracheostomy perforation that is superior to the thyroid penetrating to the right of the pyramidal lobe.

THYROID: No significant changes.

SPLEEN: The spleen weighs 80 grams. The capsule is wrinkled. There is no capsular thickening present. The follicles are not prominent.

STOMACH: The stomach contains approximately 10cc. of partially digested food fragments. There is no ulceration present.

DUODENUM: No significant changes.

GALLBLADDER: The gallbladder contains approximately 5cc. of light green bile. No stones are present.

LIVER: The liver weighs 1600 grams. The parenchyma is pale yellowish-brown. The lobular pattern is accentuated. The parenchyma is quite soft.

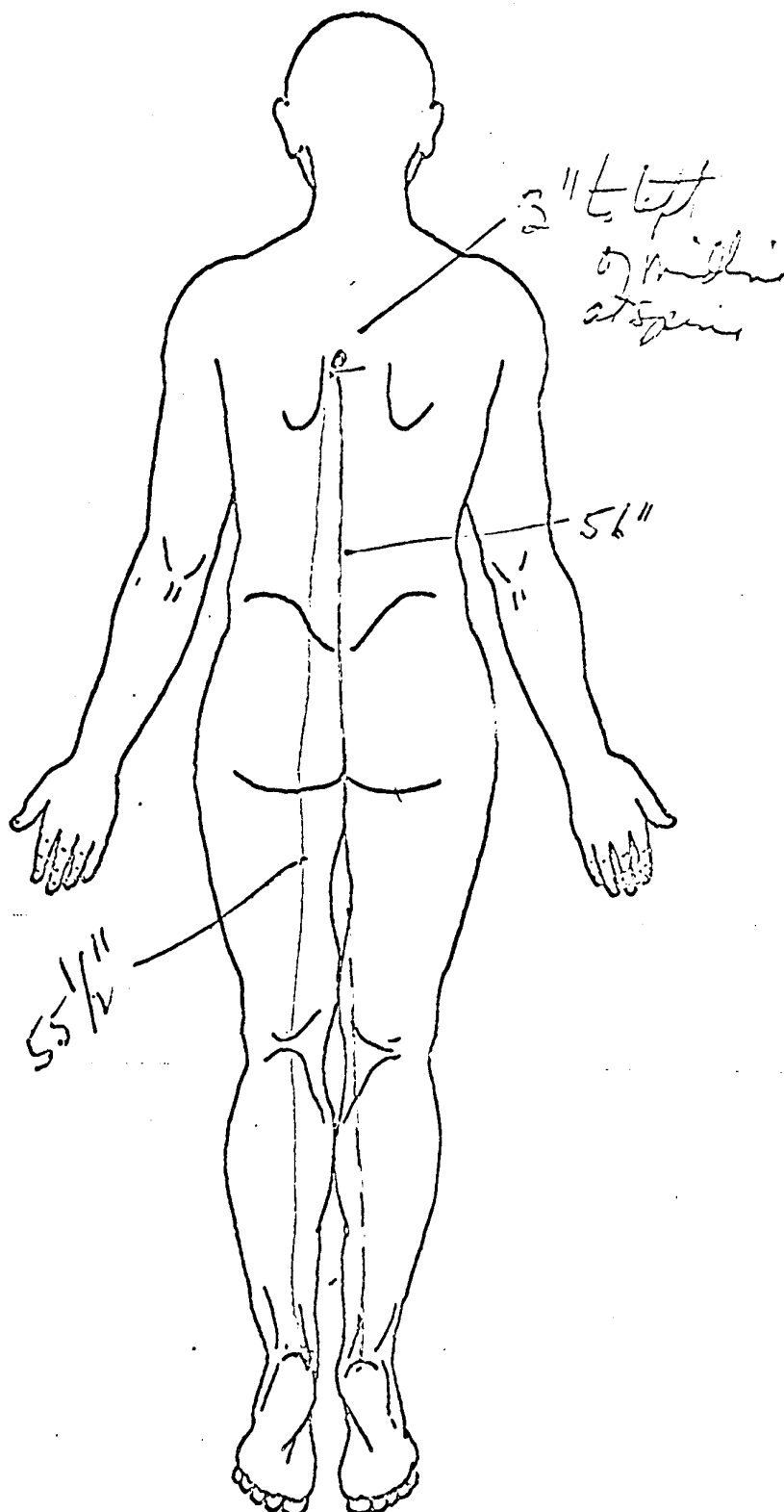
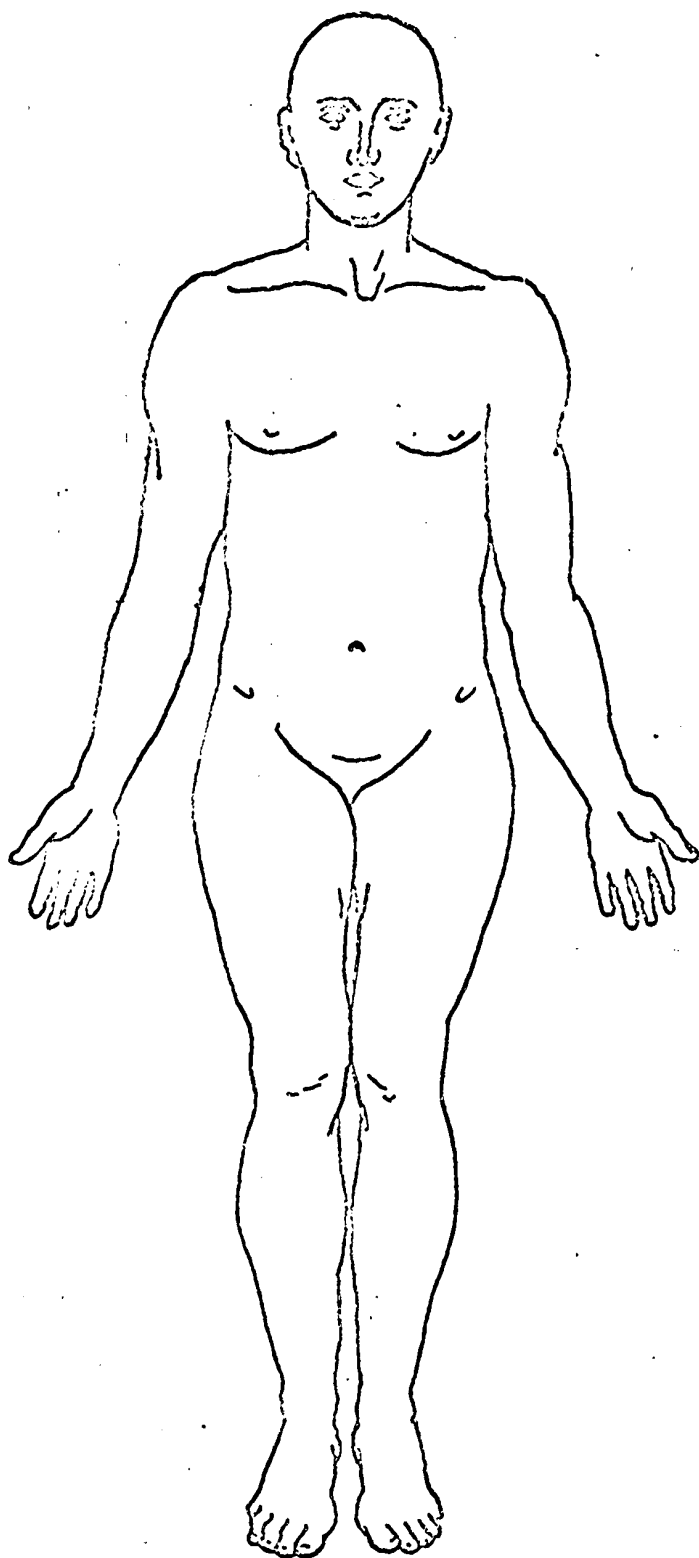
BLADDER: There is approximately 25cc. of cloudy yellow urine present.

ADRENALS: The adrenals are in normal position and weigh 8 grams together. The cortex is bright yellow. The medulla is grey.

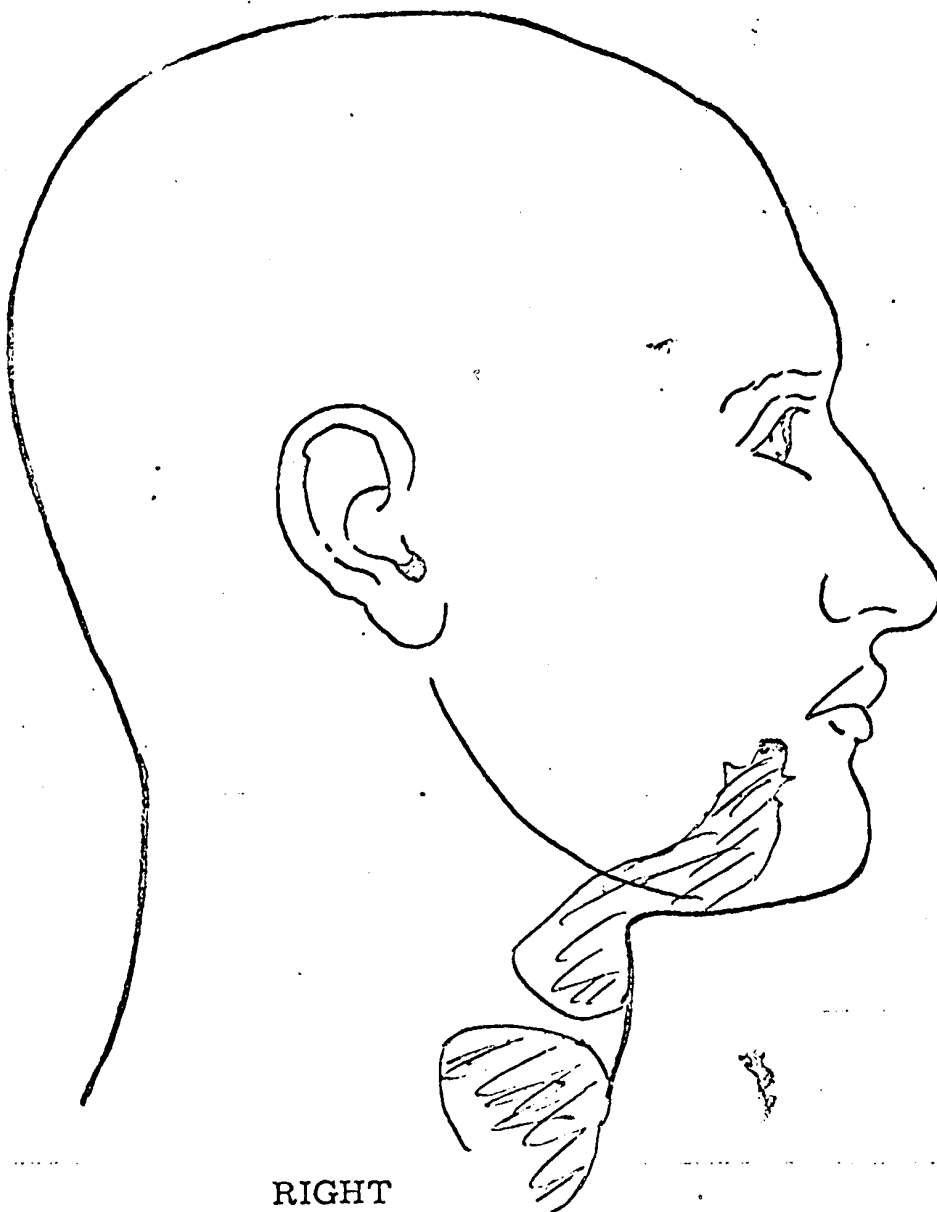

MICROSCOPIC SUMMARY

6: Focal areas of intra-alveolar hemorrhage are present throughout. Otherwise the alveoli are well preserved without hyperdistention or collapse. There is a loss of bronchial epithelium free within the lumens of the bronchioles. The pulmonary vessels reveal no significant changes.

PANCREAS: The pancreatic parenchyma is well preserved. The islets and acini are well preserved. There is minimal congestion present but no fibrosis or hemorrhage.

KIDNEY: The glomeruli and tubules are well preserved. There is no parenchymal fibrosis evident or vascular proliferation present. The tubules are filled with eosinophilic material. There is no collapse of the tubular lumen.

THYROID: The follicles are uniform and regular. There is a small quantity of extravasation of mature erythrocytes into peri-follicular locations. Cellular inflammatory reaction is not present. There is no margination of polymorphonuclear leucocytes within the areas of hemorrhage.

LIVER: There is diffuse cytoplasmic vacuolation throughout the hepatic cytoplasm being distributed throughout the lobules and in both pericentral and periportal locations. A small number of mononuclear cells are present in portal areas. There is some variation in size, shape of the hepatic nuclei. The vacuoles that are present are irregular in size, being numerous in some cells and being single large vacuoles in others with a disruption of cytoplasmic borders in some.

ADRENAL: There is congestion of the inner cortical zones of the adrenal. The cytoplasm is otherwise well maintained. The cortico-medullary ratio is maintained.

SPLEEN: The follicles are present but without secondary reactive centers. There is some congestion of the pulp but focal hemorrhage is not present.

HEART: The myocardial fibers are well preserved. The nuclei are regular. Fibrosis is not present throughout the myocardium and cellular inflammatory reaction is not present. The atrium reveals no significant changes.

SKIN: There is dermal hemorrhage present but no accumulation of polymorphonuclear leucocytes. Blackened debris is present throughout the hemorrhagic area of the dermis having no identifiable form. There is pronounced eosinophilia of the collagen bundles. There is hemorrhage into the dermal layers with an alteration in the tinctorial properties of the epithelium with focal fragmentation of the epithelium adjacent to the area of dermal hemorrhage.

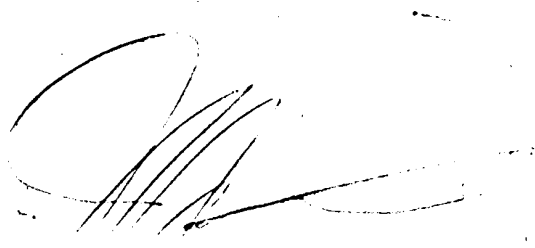

CORONARY:

There is moderate intimal proliferation along with an extra cellular deposition of lipid within the sub-intimal areas along with lipid filled macrophages present in this location. Small foci of perivascular mononuclear cells are present in the regions of most pronounced intimal proliferation.

PROSTATE:

The glandular elements are well preserved without any significant increase in collagenous connective tissue. Inflammatory reaction is not present.

All measurements and angles were reduced to writing by affiant and Arthur C. Holbrook, Engineer of Surveys, Plans, and Designs, Tennessee License #5173, and the same is a true and correct copy of the survey conducted by affiant, pursuant to his duties on April 23, 1968.

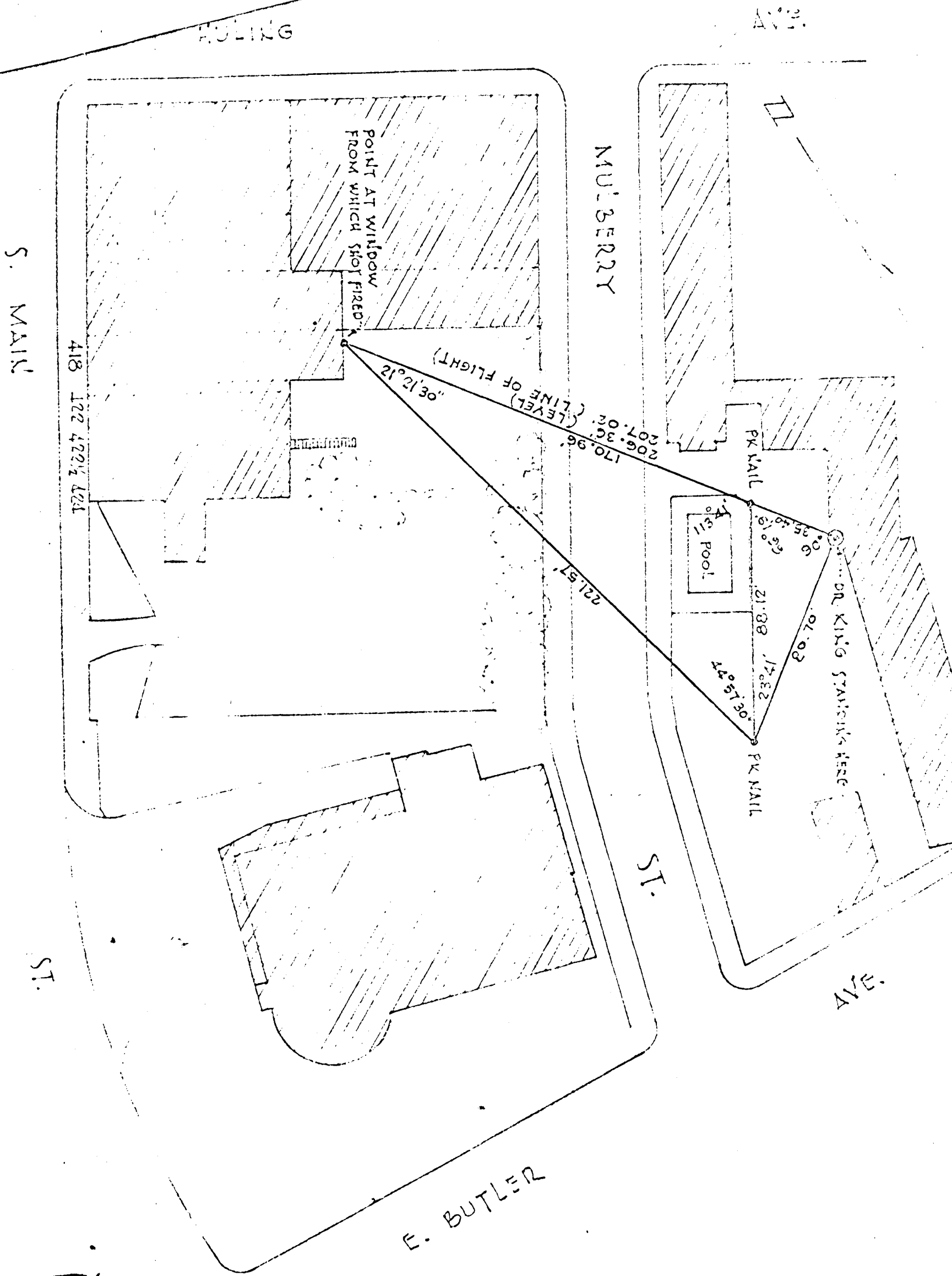

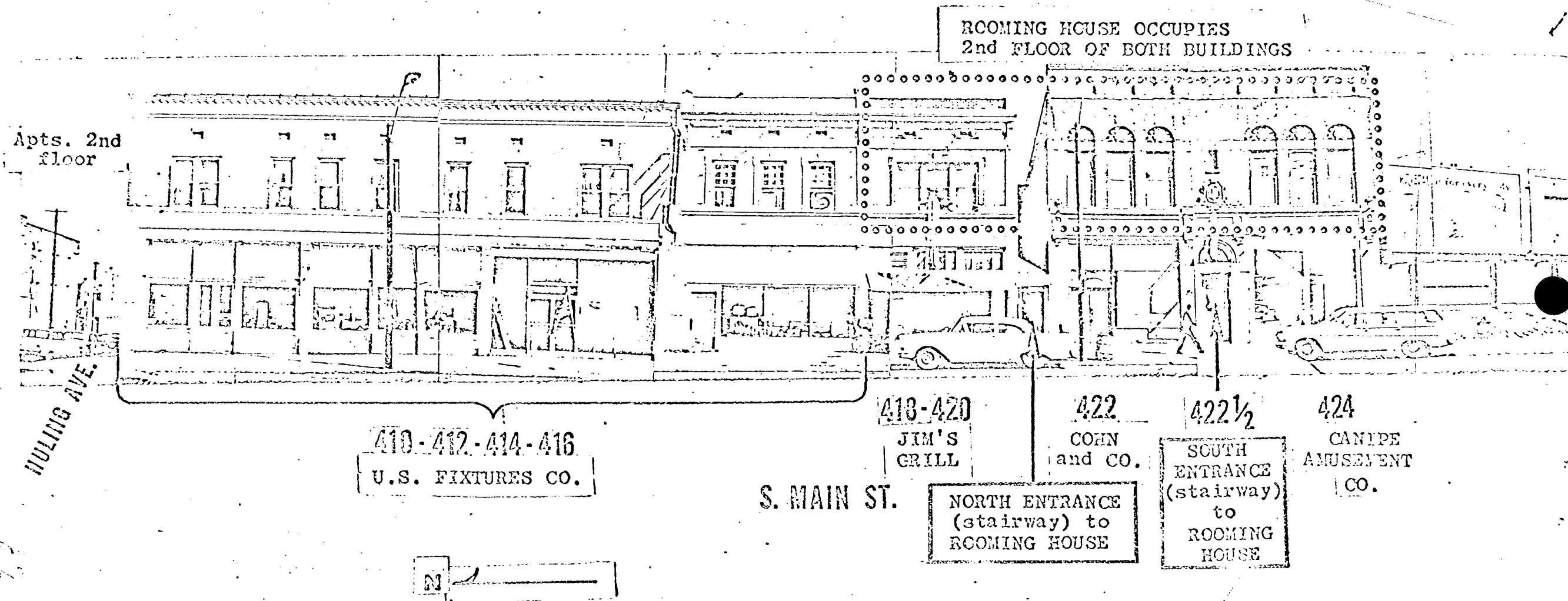

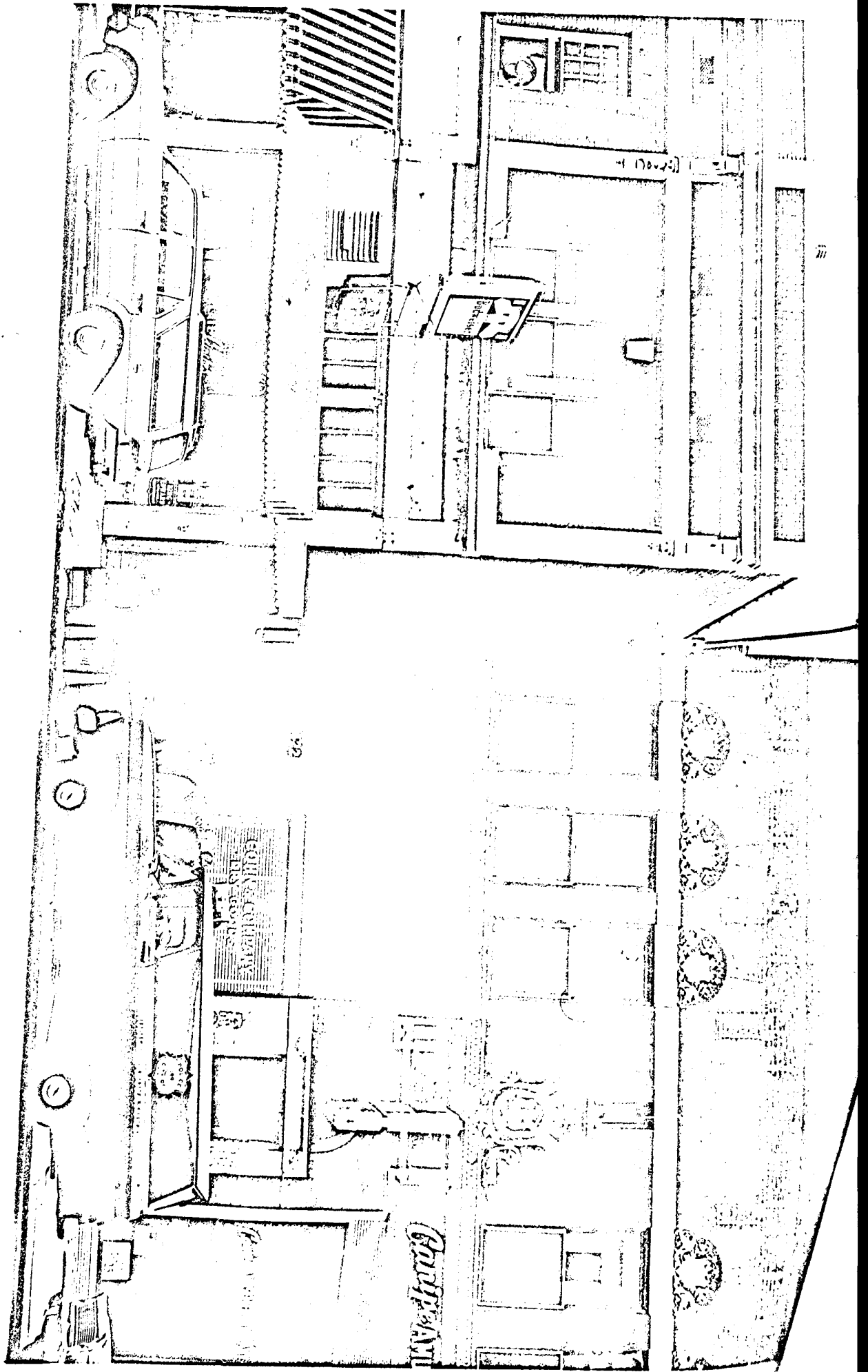

AFFIDAVIT OF INSPECTOR N. E. ZACHARY

Now comes the affiant, N. E. ZACHARY, after being duly sworn, and states as follows:

That his name is N. E. Zachary, and that he resides at 1507 Old Hickory, Memphis, Shelby County, Tennessee, United States of America, and that he is employed by the Memphis Police Department, holding the rank of Inspector of the Memphis, Tennessee, Police Department; and that on April 4, 1968, he was an inspector of detectives of the Memphis, Tennessee, Police Department, in charge of the Homicide Division; that on the date of April 4, 1968, he was so acting and on duty and was assigned to and did conduct and supervise the investigation of the killing of Dr. Martin Luther King, Jr., that as part of the investigation, the affiant personally searched the scene of the killing, and as a result of the search of the scene, ^{at about 6:15 p.m.} he personally recovered a certain bundle and articles approximately a block west of the actual spot where Dr. King was slain, specifically being in the doorway of 424 South Main Street, Memphis, Tennessee, this being one door south of the doorway leading from 422½ South Main Street. That the said bundle and article consisted of a green and brown bed spread measuring 106½ inches by 85½ inches and was of a herringbone design; a zipper type bag, which measured 15 inches x 20 inches x 5 1/4 inches Tel-Star model Japanese make, which contained a pair of "Banner" binoculars Bushnell make 7 x 35, Serial Number DQ 408664; a Georgia-Alabama Standard Oil map; copy of the Memphis Commercial Appeal newspaper, first section only, issue of April 4, 1968; a Standard Oil map of the United States; a binocular case with instruction booklet, lens cloth and guarantee card; a yellow cardboard binocular box with black writing;

a leather strap-type carrying case; a "Gillette" travel kit, with store label Oliver Rexall Store, Whitehaven, Shelby County, Tennessee, price \$1.89, which contained a razor, lotion shaving cream, deodorant, hair cream and razor blade dispenser; grey-blue paper sack bearing "York Arms Company" name with receipt dated 4/4/68 in the amount of \$41.55; nine .30-06 Springfield caliber cartridges (five Remington-Peters and 4R-A-55) in Peters cartridge box, Index Number 3033; and two cans of "Schlitz" beer, pull tab type can, along with the plastic six pack carrying device which was in a brown paper sack; along with numerous other miscellaneous toilet articles, underclothing and socks.

Also in this bundle there was a Browning rifle box for a .243 Winchester caliber rifle, Serial Number 474425, which contained a .30-06 Springfield caliber Remington "Game-master" slide-action rifle, Model 760, bearing Serial Number 461476, attached to the rifle was a Redfield telescopic sight, which bore Serial Number A17350, and the rifle chamber was seen by me to contain a .30-06 Springfield caliber Remington-Peters empty cartridge case, when examined in my presence by agents of the Federal Bureau of Investigation.

All of the above enumerated articles were confiscated by the affiant in his duties as Inspector of the Memphis, Tennessee, Police Department in the investigation of the slaying of Dr. Martin Luther King, Jr. The said articles from the time of confiscation were in my physical possession and control until on the same date all of the said enumerated articles were given into custody of the Federal Bureau of Investigation of the United States of America, specifically to Robert G. Jensen,

Special Agent in charge of the Memphis office of the Federal Bureau of Investigation, and Robert Fitzpatrick, Special Agent of the Memphis office of the Federal Bureau of Investigation, to be personally conveyed by Special Agent Robert Fitzpatrick to the Federal Bureau of Investigation laboratory in Washington, D. C. for criminal analysis.

That on the said date of April 4, 1968, affiant, as part of the investigation, received from one of his officers participating in the investigation, namely, Lieutenant J. D. Hamby, of the Homicide Division of the Memphis Police Department, one battered lead slug, that had been removed from the body of Dr. Martin Luther King, Jr., by the medical examiner, Dr. J. T. Francisco, in Lt. Hamby's presence. This slug particularly marked by Dr. Francisco and enclosed in a small envelope, was given by the affiant, on the same date, into the custody of Cy Bush of the Memphis office of the Federal Bureau of Investigation.

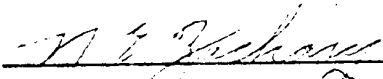
Also found in room 5B that had been rented in the name of John Willard, there were two straps found by Capt. R. L. Williams one of which was black leather, which is 5/8ths of an inch in width and which matched the strap on the binocular case found in the evidence in front of 425 South Main Street, Memphis, Tennessee; also a black leather strap 11/32nds of an inch in width, which attaches to the binoculars for carrying purposes, these straps being confiscated from the room by Capt. R. L. Williams of the Memphis, Tennessee,

Police Department and Lieutenant Glen King of the Memphis, Tennessee, Police Department.

On May 3, 1968, the aforementioned evidence was returned to the Memphis office of the Federal Bureau of Investigation and Mr. Robert G. Jensen, Special Agent in charge of the Memphis office of the Federal Bureau of Investigation, turned this evidence back into the custody of the affiant, who, in turn, placed same in the custody of the Criminal Court Clerk of Shelby County, Tennessee, at Memphis.

The attached photograph marked Exhibit I accurately portrays the doorway to 424 South Main Street, Memphis, Tennessee, as it was on April 4, 1968, and accurately portrays the location where the bundle was found and confiscated by me, said bundle showing in the photograph being the bundle previously referred to by me in this affidavit, and containing the articles as previously described in this affidavit.

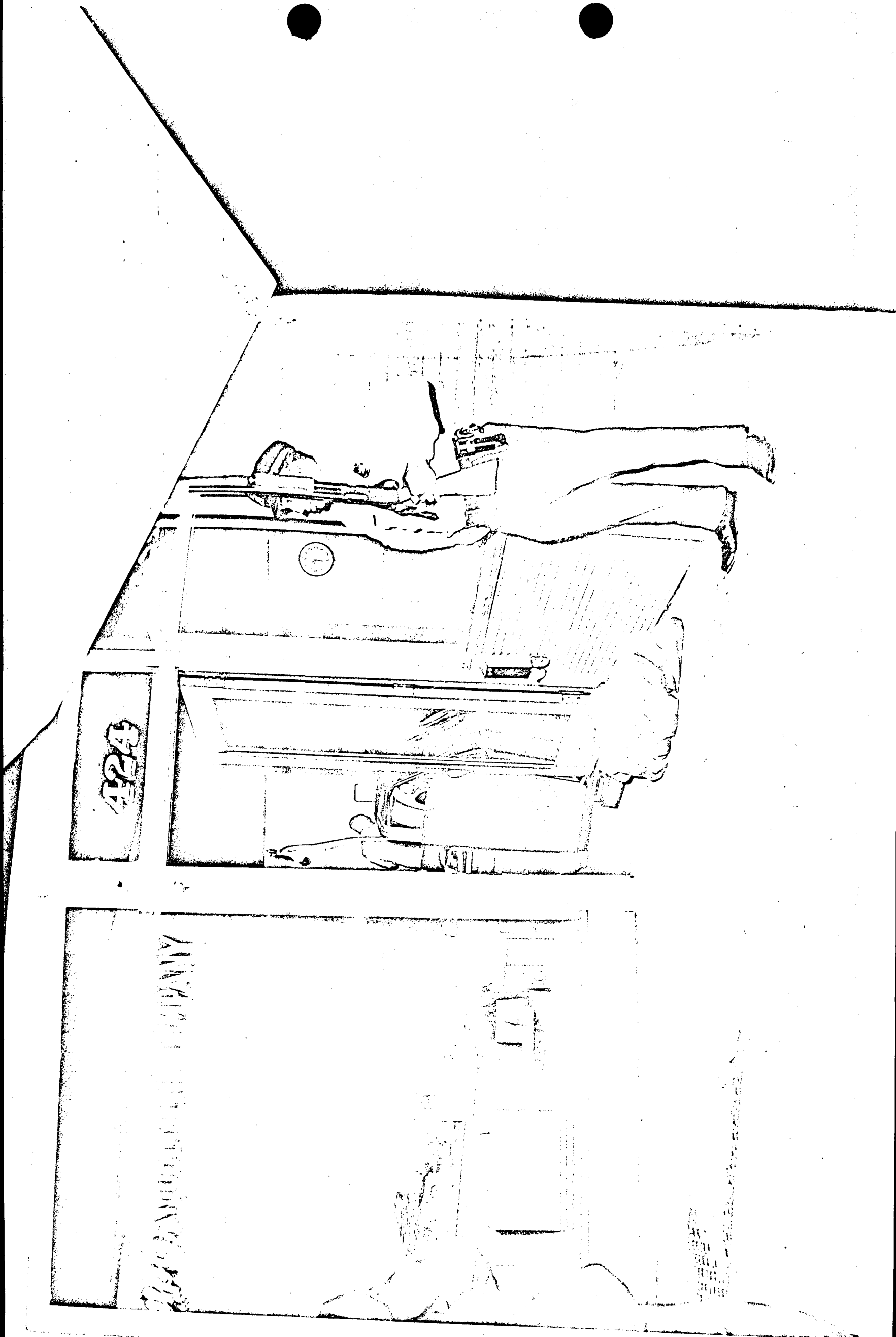
