

JAMES EARL RAY

HALL stated that he was later confined at Central Prison, Raleigh, North Carolina, awaiting trial at Wilmington, North Carolina. He stated that while at Central Prison, he was interviewed on several occasions by North Carolina Central Prison Superintendent of Transportation, STEPHEN ALBERT BERRY, and HALL alleged that BERRY apparently found out about the sketch which had been given to him by Special Agent BILL WALDEN of the Bureau of Alcohol, Tobacco and Firearms Division, and that BERRY came to his cell at Central Prison and requested that HALL give him the sketch. HALL stated he told BERRY he did not have the sketch and then BERRY searched his cell and found it. According to HALL, BERRY then stated that JAMES EARL RAY had been gotten out of the country, and the same method could be used to get him (HALL) out of the country. From this statement, HALL alleged that he assumed BERRY had some knowledge of the KING murder, and believed that BERRY might be somehow involved in the murder.

HALL further stated that, during an interview on February 9, 1977, that North Carolina Central Prison Superintendent of Transportation, STEPHEN ALBERT BERRY, told him that he, BERRY, was a member of the Ku Klux Klan and they, BERRY and other prison officials, would help him the same way "they" helped JAMES EARL RAY when he killed MARTIN LUTHER KING.

STEPHEN ALBERT BERRY on interview on February 8, 1977, stated his job at Central Prison is to review all grievances filed by the inmates at Central Prison. BERRY stated that HALL's most recent incarceration at Central Prison was on December 7, 1976. BERRY stated that he estimates HALL has filed between ten and fifteen grievances since the above date which referred to alleged threats or mistreatment against him, and these grievances have been investigated and have failed to substantiate that HALL was ever threatened or mistreated. BERRY stated HALL has accused him of being a member of the Ku Klux Klan and also alleged that BERRY said that when Dr. KING was killed, they did not get the right man and that it would be the same way with him; they would have him killed and put the blame on a white inmate at Central Prison.

HALL's most recent allegation at North Central Prison is that attempts are being made on his life by putting razor blades in his prison food.

The subject heard about Ray was he was an escaped convict who had been on a strange year long odyssey landing up in Memphis. What we heard from Ray was that his travels had been directed and financed by an underworld character he knew only as Raoul. It seemed a simple case when James Earl Ray pleaded guilty but just three days later he recanted claiming that he had been railroaded into the plea by his own attorney Percy Forman. For eight years courts have refused to grant him a new trial. For eight years the questions about a possible conspiracy have persisted and all this time Ray has declined to tell his side of the story on television until I went to interview Ray last week at Brushy Mountain Penitentiary in Tennessee where he is serving a 99-year sentence as the assassin of Martin Luther King, Jr.

Did you fire the shot that killed Dr. Martin Luther King?

Ray - No and I think now, sir. Based on investigations of those who have represented me if we could prove it through some type, judicial proceedings.

6:01 p.m. immediately after Dr. King was shot people with him pointed toward a rooming house across the street. Ray had rented a room there that day. The state claims he fired the fatal shot from there. Ray says he has an alibi. Now this of course is critical.

Ray - Yes

As your recollection as to where you were between let us say 5:50 p.m. and just after 6:00 April 4, 1968, you remember going to the service station; Ray - yes, having the tire fixed; Ray - I didn't have it fixed they said they suddenly was busy, the business didn't have time for it, and I never did get the tire fixed.

My point is that you were not in the rooming house or were you between let's say after 5:30 p.m.?

Ray - No I'm positive I wasn't in there after 5:30.

Let me take you back to that day in the court room when you had your day in court. Short day it was. Did the judge ask you whether you were doing it voluntarily, the guilty plea, and you said yes sir. I can't understand if you knew that you didn't pull the trigger on the gun that killed Dr. King, why you would go that far and say those things?

Ray - Well this was all decided on March the 9th the day before the plea was entered. At that time I had determined it was no way I could force Percy Forman to going to trial with any prospects of success. I assumed if I did enter a plea of guilty and I could have had an investigation after the plea, with newly discovered evidence, it's a possibility the case could have been reversed and won the trial.

That same day when you entered your guilty plea there was a whole series of questions involving the voluntary nature of your plea, that you knew what you were doing, that you weren't being forced, that you knew you were giving up your right to appeal, all of those things were layed out to you. You answered to all of those yes you knew what you were doing.

Ray - If I had all to do over again I really don't see how I could have done anything different.

If somebody else did it, why sit here silent, why not tell everything you know and do everything you can to find the other people?

Ray - Well I don't I think a lot of people have a sort of a pollyanna view of the legal system, all you got to do is go to the prosecutor and say oh here's where it is, turn me loose, that's it. That's not the way it is. If you testify with the prosecutor he'll just use what you tell him to weave in his story. It doesn't necessarily mean he's going to turn you out or anything like that.

The Attorney General, if I read his language correctly, and perhaps I don't, at least in a between the lines fashion has held out the following prospect: That if you would reveal to him information that you've never revealed before, help solve the "conspiracy aspects" case, that perhaps some arrangement could be worked out for reduction of your sentence. Now what do you think about that?

Ray - Well I don't think much of anything about that. This thing of being state witness, even being perceived to be a state witness is a, there's a lot of pitfalls there, I mean you can look these people like Valachi and then winds up dying in solitary confinement. If I testified for anyone, it would be for myself. I'm not concerned with the States case, that's their problem. But I don't want to get involved in any type of situation whereby I would have to rely on the Justice Department because they have a, I think they have sort of an inherent hostility being aware of my background anyway so I'm going to keep them at arms length.

Would you be willing to talk here at present with the Attorney General?

Ray - No I can't see an advantage of having ex-parte meeting with the Attorney General. I have no objection if he wants to question me under oath on a witness stand.

Let me stop for a moment and ask you, are you willing to testify before a House Committee set up to look into the death of Dr. King as well as the John Kennedy assassination?

Ray - I think it would all depend. I think if they go on the premise that I'm guilty the only things they are interested in are finding out maybe who else is involved. I don't see much point in me testifying then. If I do testify I don't want to, I wouldn't want to testify in any type of Executive Session and the various members, leak various, not the members of Congress but members of staff leak information out like they did the Church Committee where they say that Ray said this and Ray said that. I'll be willing to testify in public, not necessarily on T.V. or anything, but have a public record where it would be available to anyone who is interested in it.

According to Ray he was in Memphis on the day of the assassination under instructions from a man he says he knows only as Raoul. A man whose instructions he claims he had been following for a year. He says he thought Raoul brought him to Memphis to take part in a gunrunning scheme. Could you describe Raoul for me?

Ray - Well I couldn't describe him except to say he appeared to be a Latin, average height 5'8" or 9", 150 pounds, and hair was only thing that stand out. Most of the Latin's have dark hair and he had kind of an auburn look, dark auburn. That's the only thing that really distinguished him from anyone else. Course I suppose you could dye your hair or something if you wanted to.

Did he at anytime give you any indication of his being in contact with or belonging to any group?

Ray - No, my impression was more or less a some type of thing for monetary gain with no mention of politics or anything like that.

Did he ever mention to you the possibility of assassination or hit man operation?

Ray - No I don't, that would have been, that would have been kind of out of my league, I don't really think I have the constitution for all that type of stuff. I don't say that as a virtue. Actually it might be a handicap in this type of society.

And in the bothersome question where the money came from.

Ray - Oh ya, I think it was the \$9,500 and \$10,000.

This is from the time you escaped from the Missouri Prison in April of 1967 from the time of your arrest in London after the King killing in 1968.

Ray - Yes

You estimate you spent between \$9,500 and \$10,000.

Ray - It would have to be somewhere in between there, yes.

Where did you get the money?

Ray - Well I suppose I got it, a certain amount, I never got a large sum of money at one time, think \$2000 is the most I ever came across at one time. And I got this off the individual I mentioned, this Raoul, alias, or whatever you want to call him.

You have to know, how many people who hear you tell the story will say to themselves that is a cock-in-bull story if ever I heard one.

Ray - Yes

That James Earl Ray has gotten himself in a world of trouble. He's trying to concoct some story that will help him out it, and this Raoul never existed and that thing is fantasy from beginning to end.

Ray - I think so, I think I have based on my background the, you know in jails and out, I think people would be skeptical of anything I testified to, to the media.

Let me see if I understand you here. You're saying, alright you understand that people are skeptical, perhaps even cynical about your story of Raoul and all this.

Ray - Yes

But that you are convinced that you could put yourself under oath and put other people under oath with wide ranging subpoena powers that it would be proven that Raoul did exist.

Ray - I don't know, this certain individual, I think it would be proven that someone did exist whether it is that particular name or not. I think I could have my previous testimony corroborated.

What about the charge that you're a racist, always have been?

Ray - If I went before a jury and tried to pretend like that I spent a life time as a humanitarian administering the poor or less they'd know I was either crazy or lying so there's a lot of self-segregation in the United States. I think a good example is probably in Federal prisons.

No, but there is something deeper than that. That you hated black people, always hated black people.

Ray - I usually get someone, yes, on the individual person, but I think there is an instinctive tendency to associate with people that you have something in common with and your background and things like that. I don't think that's a, means you plot to kill the other person or anything like that but just an inconsequential thing that I can see.

Want to run past you various theories that have been put to me as a reporter working on this assassination case over a good many years. And get your reaction to them as theories. First, unnamed money interests were somehow responsible for Dr. King's death. They wanted to prevent Dr. King from leading his peoples march on Washington for one thing.

Ray - Well that's the theory I've heard most the one the attorneys have discussed most. They say he was up beyond the integration state and interested in economics.

Well another of the theories is that white racists were responsible. Their motive for wanting to get rid of Dr. King is obvious.



Ray - No I think that would be totally false. I think it's their theory that Dr. King's activities was actually helping them, politically.

Three, the theory involving black militants being responsible, that Dr. King had become too non-violent for their plans and they wanted to take away leadership for their black movement.

Ray - No, that's one of the two theories that I think the attorneys that represented me wanted to put forward, but I just, I can't subscribe to that type of theory.

How about the communists who, so the theory goes, wanted to stir up black hatred and foment rebellion. Fidel Castro for example it is claimed had a special interest in this.

Ray - No I doubt it very much.

Have you ever thought about a possible connection between the Dr. King death, your situation and the assassination of President Kennedy?

Ray - My lawyers have discussed it with me, I don't think that's valid theory at all because

You don't

Ray - I don't think you could string a bunch of homicides together because there's different motives and different interests.

When I asked one of your former attorneys what your basic story was, this is what they said to me. "James Earl Ray would like to have the credit for killing Dr. Martin Luther King but does not want to have to pay the price.

Ray - That type of conversation there is, that is more suited for something, entertaining talk shows or something like that. There's no, someone would have to be insane to get involved wanting publicity in killing someone for publicity because, to me it is I can't perceive anyone, there is people like that but I can't perceive anyone wanting that type of publicity.

And you didn't do it?

Ray - No, I didn't do it.

James Earl Ray's story comes down to this, that he didn't do it and the State certainly has never proved it in court. To someone familiar with the case Ray's story seems to show, that for the time being at least, Ray is unwilling or perhaps unable to shed any really new light on the King assassination.

# King Panel Might Call Miami Man

## House Panel Contacts Ex-Police Lieutenant

A former Miami police lieutenant said Sunday that he may be called to testify before a congressional committee about receiving a pre-assassination tip in 1968 that Martin Luther King might be killed. Charles Sapp, the former police man, said the information came in April 1968 from a Miami Police Department paid informant, Willie Somerset, who five years earlier had claimed advance notice of President John Kennedy's assassination.

"We have been contacted by a spokesman for the House Assassinations Committee," Sapp said Sunday, "and I've told them I'd be happy to testify as to what I know."

SAPP SAID he can't recall the exact time element, but it was shortly before King was killed. King was killed on April 4, 1968.

Other sources told The Herald that the telephoned tip was received by the lieutenant April 3, Sapp, who retired in 1971, headed the department's intelligence-gathering unit.

Somerset, an admitted racketeer who then was trying to organize his own National Foundation for Labor, claimed to have overheard the death threat at a union affair in Washington, according to Sapp.

He said he overheard two men discussing King for meddling in union affairs. If you remember, King was helping the Memphis sanitation workers who were out on strike," Sapp said.

"Somerset told me the man said they were going to take care of King, and I told him to take care of King, and I told him to take care of King."

Somerset was once a member of the National States Rights Party and claimed to have heard, during a conversation 11 days before the Kennedy killing, of plans to shoot...  
Sapp said Sunday, "I can't remember the exact day he called me, but I'm certain the FBI got an immediate report on the tip, because the agents were in our office every day, and they got the same information I went on to the chief."  
Sapp's distant connection with the King case came to light last September as part of a Miami magazine article dealing with the assassinations of King and Kennedy...  
Two weeks ago, Sapp said, he was contacted by an investigator for the House committee...  
"WE TALKED for a while, but I said they'd be in touch with me, but I haven't heard anything from them yet," Sapp said.

Dear Bill:

As you recall, during a recent telephone conversation, you were advised that Ben D. Gibbens, Investigator, Criminal Division, Louisiana Department of Justice, informed the United States Attorney that a previously reliable informant of his claims to have been present during a meeting at which several men discussed the murder of Martin Luther King. The informant advised Gibbens that he can identify two of the men who were present at the meeting and that one of those "put up a considerable amount of money" to have King murdered. The informants said he saw the money change hands. He can identify the man who gave the money but not the man to whom the money was given. The meeting in question, according to the informant, occurred in Memphis, Tennessee, prior to King's death. The informant was himself in jail in Memphis, Tennessee, when King was murdered.

The informant also advised Gibbens that while in Chicago he worked for a "gangster" who offered him money to kill a Chicago man named "Giacanno". That individual was in fact later killed by persons unknown to the informant. The informant surmised that the "gangster" hired others to complete the assassination plot when the informant refused.

The informant also advised Gibbens that he knows who was responsible for the death of a man named "Murphy" whose body was found in the trunk of an automobile on Cicero Avenue in the Chicago area. The informant told Gibbens that Murphy's head looked like it had been mashed in a vise.

The informant also claims to have knowledge of those responsible for the theft of varying amounts of plutonium and mercury in the Oklahoma area.

Following the United States Attorney's telephone conversation with you, Gibbens met with the informant who advised that he would not be interviewed locally but would only discuss these matters with Justice Department investigators from Washington. Gibbens did not seek to obtain more detailed information from the informant, but advises that the informant asserts that he can supply more detailed information to Justice Department investigators.

The informant is an inmate in a Louisiana jail who is presently facing a sentence of life imprisonment. He claims to have been convicted at a trial where perjury was suborned by state law enforcement officials. Gibbens advises that the informant, in exchange for his cooperation, only requests that the matter be looked into by Justice officials. The informant specifically requests that two witnesses, whose testimony he claims was perjured, be interviewed.

Whether this information is valuable or accurate is something that neither Gibbens nor the United States Attorney can assess. Gibbens does not feel that he is in a position to evaluate the accuracy or reliability of the information. He simply requests that the United States Attorney relate these sketchy details to you in the event that someone in the Justice Department might be interested in interviewing his informant. Gibbens would be willing to be present during an interview between Justice investigators and his informant. The informant has indicated that he will discuss the matter with Justice investigators only in Gibbens' presence.

Should anyone decide to pursue this matter further, they can contact Gibbens or the United States Attorney. As indicated on the telephone, the United States Attorney has no idea who the informant is or where he is presently located. The United States Attorney's and Mr. Gibbens' interest in this matter is in seeing that this report is conveyed to the U. S. Department of Justice.

This refers to the assassination of Martin Luther King in Memphis in April, 1968.

Attached Louisville teletype indicates that Congressman M. G. Snyder, Kentucky, revealed on a recently taped TV news conference that he had received letter from an unnamed, retired police officer who alleged that he, former police officer, had been approached by three FBI Officers and three or four prominent citizens with a \$500,000 offer to kill Martin Luther King on two occasions. Unnamed police officer made tapes of these two meetings, one of which was stolen, the other, unnamed officer turned over to the House Select Committee on Assassinations (HSCA).

Congressman Snyder said he has heard the tape recording but could not attest to its authenticity but indicated that Congressman Samuel L. Devine, Ohio, had checked background of former police officer and found him to be "solid citizen."

Snyder stated that the HSCA has this matter currently under investigation.

A review of FBIHQ files pertaining to the assassination of Martin Luther King has failed to reveal any prior allegations of an alleged conspiracy involving FBI personnel in a plot to kill Martin Luther King.

SNYDER INDICATED THAT HE HAD RECEIVED LETTER A FEW WEEKS AGO FROM "CITIZEN" WHO IS RETIRED AFTER MANY YEARS, FROM RESPONSIBLE POLICE DEPARTMENT AND THAT THIS "CITIZEN", NOT FURTHER DESCRIBED, HAD BEEN APPROACHED BY THREE (3) "FBI OFFICERS" AND THREE (3) OR FOUR (4) "PROMINENT PEOPLE AT THAT TIME IN THAT POLICE DEPARTMENT". SNYDER NOTED THAT THIS UNNAMED "CITIZEN" RECEIVED THIS "OFFER" ON TWO (2) SEPARATE OCCASIONS IN HIS AUTOMOBILE WHERE HE HAD TAPE RECORDER SECRETED. TAPES WERE MADE OF THE "OFFER" ON BOTH OCCASIONS, HOWEVER, ONE TAPE WAS SUBSEQUENTLY STOLEN. OTHER TAPE "CITIZEN" RETAINED AND FURNISHED SAME TO HSCA AFTER REPORTEDLY TRAVELING TO WASHINGTON, D.C., AT HIS OWN EXPENSE.

SNYDER HAS SPOKEN WITH "CITIZEN" PERSONALLY AND IN SNYDER'S OPINION, "CITIZEN" APPEARS TO BE RESPONSIBLE. SNYDER BELIEVES INSTANT "LEAD" AND OTHER LEADS SHOULD BE "CHECKED OUT". BECAUSE OF INSTANT "LEAD", UNITED STATES REPRESENTATIVE SAMUEL L. DEVINE (OHIO), RANKING MINORITY MEMBER OF HSCA, NOW INTENDS TO VOTE FOR CONTINUATION OF HSCA FUNDING.



SNYDER REVEALS THAT LETTER WAS RECEIVED IN "REGULAR UNITED STATES MAIL" AND THAT BASIC ALLEGATION IS THAT UNNAMED "CITIZEN", WHO IS RETIRED POLICEMAN, WAS APPROACHED BY "MEMBERS OF FBI AND UNNAMED POLICE DEPARTMENT" AND ENCOURAGED TO ASSASSINATE MARTIN LUTHER KING, JR. WHEN ASKED WHY SNYDER RECEIVED LETTER, SNYDER REPLIED "TIME WILL HAVE TO TELL" AND THAT HE "DIDN'T WANT TO GO INTO THAT".

SNYDER FURTHER REVEALED THAT UNNAMED "CITIZEN" HAS BEEN TO WASHINGTON AND THAT HSCA NOW HAS POSSESSION OF TAPE RECORDING WHICH IS BEING "WASHED DOWN" TO ELIMINATE BACKGROUND NOISES SUCH AS RUNNING AUTOMOBILE ENGINE. SNYDER HAS HEARD TAPE HIMSELF AND DESCRIBED SAME AS HAVING "SOME PRETTY INAUDIBLE SECTIONS" WHICH ARE BEING WORKED ON AT PRESENT. SNYDER NOTED THAT TAPE PURPORTS TO DEAL WITH INSTANT SUBJECT MATTER. SNYDER INDICATED THAT HE COULD NOT ATTEST TO AUTHENTICITY OF TAPE RECORDING SINCE HE WAS NOT ELECTRONICS EXPERT, BUT NOTED SAME MUST BE DETERMINED.

SNYDER DECLINED TO ANSWER INTERROGATORIES AS TO WHETHER LETTER CAME FROM HIS CONGRESSIONAL DISTRICT OR LOUISVILLE,

KENTUCKY, NOTING HE DID NOT THINK HE OUGHT TO PLACE UNNAMED  
"CITIZEN" IN JEOPARDY IF ALLEGATION IS TRUE, OR PEOPLE  
MENTIONED THEREIN IN JEOPARDY IF ALLEGATION FALSE. SNYDER  
BELIEVES HSCA WILL HAVE TO DECIDE WHEN NAMES OF INDIVIDUALS  
ALLEGEDLY INVOLVED ARE TO BE RELEASED AND MADE PUBLIC.

SNYDER DECLINED ANY FURTHER COMMENT ON MATTER, NOTING

ARTICLE CAPTIONED "SNYDER GIVES PANEL ALLEGATION OF PLOT TO  
ASSASSINATE KING", WHEREIN SNYDER IS REPORTED TO HAVE  
REVEALED, DURING TAPING OF ABOVE TELEVISION NEWS CONFERENCE,  
THAT HE HAD TURNED OVER TO HSCA AN ALLEGATION THAT FBI  
AGENTS AND POLICE PLOTTED TO KILL MARTIN LUTHER KING, JR.

SNYDER IS REPORTED TO HAVE RECEIVED THE ABOVE-MENTIONED LETTER IN "LATE FEBRUARY" FROM FORMER POLICEMAN WHO CLAIMS HE WAS TWICE OFFERED \$500,000 TO KILL KING. SNYDER REPORTEDLY WOULD NOT REVEAL NAME OF FORMER POLICEMAN OR NAMES OF THREE (3) FBI AGENTND POLICEMEN ALLEGEDLY INVOLVED IN PLOT.

SNYDER MADE NO CONNECTION BETWEEN ALLEGED OFFER MADE TO UNNAMED RETIRED POLICEMAN WITH MORE THAN TWENTY (20) YEARS SERVICE, AND ACTUAL KILLING OF KING.

RICHARD A. SPRAGUE, CHIEF COUNSEL FOR HSCA, IS QUOTED AS HAVING SAID MARCH 18, 1977, THAT SNYDER HAD TURNED OVER MATERIAL CONTAINING THE ALLEGATION TO HSCA AND THAT MATTER IS CURRENTLY "UNDER INVESTIGATION".

SNYDER REPORTEDLY INDICATED THAT FORMER POLICEMAN HAD ATTEMPTED TO TURN TAPE REVEALING \$500,000 OFFER, OVER TO ATTORNEYS FOR JAMES EARL RAY, CONVICTED KILLER OF MARTIN LUTHER KING, JR., BUT WAS FINALLY ASKED BY INVESTIGATOR FOR ATTORNEYS, "WHERE HE PLANNED TO HIDE IF HE TRIED TO DO ANYTHING WITH TAPE".

DETAILS: This is the case concerning the assassination of Martin Luther King, Jr., in Memphis, Tennessee, on 4/4/68. James Earl Ray pled guilty to this murder in State Court in Tennessee and presently is serving a 99-year sentence. *JA*

On the night of 3/15/77, a videotaped interview of James Earl Ray appeared on national television on Columbia Broadcasting System's (CBS) "Who's Who." The original interview of Ray by CBS correspondent Dan Rather had taken place a week earlier at the Bushy Mountain Prison in Tennessee where Ray is presently incarcerated.

Ray has never consented to an interview by the FBI and recently declined to be interviewed by the Office of Professional Responsibility (OPR), USDJ, which conducted an inquiry into the FBI's investigation of King.

In this interview with Dan Rather, Ray stated he had not fired the shot which killed King and stated he was not in the rooming house (from where the fatal shot was fired) at the time of the shooting. Ray stated he was in Memphis, however, had gone to a service station to attempt to get a tire fixed at the time of the shooting. Ray also stated he was in Memphis at the instructions of "Raoul" who he stated was a gunrunner. Ray stated he utilized between \$9,500 and \$10,000 between the time he escaped from a penitentiary in Missouri in April of 1967 until his apprehension in London in June of 1968. He advised the largest sum of money he received at one time was \$2000 which he received from "Raoul." It is noted that previous investigation by the FBI never identified "Raoul," and the recent report by OPR of the King investigation stated, in part, in reference to Ray's claim about getting air in a tire, and the existence of "Raoul," that it ". . . views the exculpatory content of these varying and patently self-serving tales to be unbelievable." The OPR report also stated "we concluded Ray was lying about the existence of a 'Raoul.'"

During this interview with Dan Rather, Ray also stated he pled guilty since he felt there was no way he could force his attorney to go to trial. Ray felt that after his guilty plea, investigation could be conducted to obtain new evidence to reverse the guilty plea. Dan Rather pointed out to Ray that by so pleading he gave up his right to appeal. It is noted the recent OPR report examined Ray's guilty plea and stated "Thus, Ray has judicially confessed that he intended to and did kill Dr. King."

In response to a question by Dan Rather as to whether he would cooperate with the U. S. Justice Department in return for a possible reduction in sentence, Ray stated he did not rely on the Justice Department. He also stated he would not talk to the Attorney General at prison, however, would have no objection to talking under oath on a witness stand.

In response to a question by Dan Rather regarding whether he would testify before the House Select Committee on Assassinations, Ray stated that if he did testify he would not testify in Executive Session but rather in public. ✓

In conclusion Dan Rather stated that James Earl Ray's story comes down to this: That he did not do it and the state has never proved it in court. Dan Rather concluded by saying of Ray's interview, ". . . for the time being at least Ray is unwilling or perhaps unable to shed any really new light on the King assassination."
