EVER BEING INSTITUTIONALIZED FOR MENTAL PROBLEMS, ALTHOUGH HE WAS SUPPOSEDLY JAILED AT NEW BROWNSVILLE, TEXAS IN 1975 AFTER THEIR DIVORCE.

SINCE DIVORCE, WILSON CALLS HER FREQUENTLY AND ON THIS PAST THURSDAY, 8-17-78, HE PHONED AT ABOUT 10 TO 10:30 P.M. CENTRAL DAYLIGHT TIME. HER SON, [REDACTED] AGE 14, ANSWERED THE PHONE BUT SHE LISTENED ON THE EXTENSION. WILSON WAS VERY DRUNK AND TOLD [REDACTED] HE WOULD BE ON TV SOON AS HE HAD KILLED MARTIN LUTHER KING. WILSON SAID THE FBI WOULD ARREST HIM SOON THEN HUNG UP.

THIS WAS THE FIRST TIME WILSON EVER MENTIONED KING AS THE TOPIC OF KING'S ASSASSINATION NEVER CAME UP DURING THEIR MARRIAGE. WILSON HAS NEVER MENTIONED JAMES EARL RAY TO HER. SHE KNOWS NONE OF WILSON'S ASSOCIATES AND DOES NOT KNOW WHERE HE WAS IN APRIL, 1968. MRS. HUNTER ADVISED WILSON'S STORY ABOUT KILLING KING WAS ATTEMPT ON HIS PART TO GAIN ATTENTION.

Reference Jackson teletype to the Bureau this date, captioned "Select Committee on Assassinations, U. S. House of Representatives," Bureau file 62-117290, concerning information received regarding Wilson.

PURPOSE: To set forth information received and subsequent action taken concerning a Burgess Audie Wilson. (903)

SYNOPSIS: Information has been received from our Jackson and Memphis Offices which indicates that a Burgess Audie Wilson claims to have assassinated Dr. Martin Luther King, Jr. Discussions have been had with Deputy Assistant Attorney General (DAAG) Robert L. Keuch, Criminal Division, U. S. Department of Justice (DOJ), who has advised that efforts should be undertaken by the FBI, with or without the cooperation of the Sheriff of Shelby County, Tennessee, in order to locate and interview Wilson to obtain whatever information he has to offer on the assassination of Dr. King. The House Select Committee on Assassinations (HSCA) has been advised of information received to date. Results of Bureau file searches are set forth.

DETAILS: At approximately 9:45 a.m. this date, ASAC Murray, Jackson Division, telephonically advised that at approximately 1:15 a.m. this date a William Gladden had telephonically contacted the Jackson Office and advised that an acquaintance, Bill Wilson, claimed to have killed Dr. King and was now willing to surrender to the Sheriff of Shelby County, Tennessee, at the Holiday Inn in Biloxi, Mississippi, on this date. Jackson was requested to sutel information received, followed by an LHM.

At approximately 10 a.m., SAC, Memphis Division, telephonically advised that he had received a telephone call from Sheriff Barksdale, Shelby County, Tennessee, who advised that a Burgess Audie Wilson had telephoned him twice and advised that he (Wilson) had been the "trigger man" in the assassination of Dr. King, that his daughter had driven the white Mustang, and that he would surrender only to Sheriff Barksdale at the Holiday Inn, Biloxi, Mississippi, at 9:30 a.m. on 8/20/78.

Subsequent to the receipt of this information, DAAG Robert L. Keuch, DOJ, was informed of the above, at which time he requested that immediate oral dissemination of the information be made to the HSCA. Accordingly, the information was transmitted to Committee representative Gerald Hamilton. Mr. Keuch also instructed that any media inquiries received by the FBI were to be referred to the DOJ. This information was transmitted to Memphis, Jackson, and Public Affairs Office, FBI Headquarters.

Since it was anticipated that Sheriff Barksdale would inquire as to the desires of the FBI and DOJ in this matter, Mr. Keuch advised that he would confer with the Civil Rights Division of the Department.

Subsequently, at 11:35 a.m., Memphis Division advised that the meeting between Barksdale and Wilson had changed to the Holiday Inn at Gulfport, Mississippi, on 8/18/78.

At approximately noon this date, contact was had with Mr. Keuch to inform him of the change in the meeting time and place, at which time Mr. Keuch advised that his office had received a call for him from Sheriff Barksdale. Mr. Keuch further advised that as a result of discussions with Deputy Attorney General Turner, Civil Rights Division, DOJ, it had been agreed that Sheriff Barksdale would be requested to meet with Wilson in order to ask Wilson to provide a statement to the FBI or, in the event that Wilson refused this request, that Sheriff Barksdale himself obtain the statement from Wilson. In addition, Mr. Keuch advised that since Sheriff Barksdale had attempted to contact him personally, he would prefer to pass these requests to SAC Trimbach in Memphis himself and also to ask the Memphis Office to attempt to identify the daughter of Wilson and Wilson's father-in-law who was reportedly residing in Memphis, Tennessee.

At approximately 12:20 p.m., SAC Trimbach called to confirm the requests received from Mr. Keuch and advised that his office would contact Sheriff Barksdale accordingly. Also at this time, SAC, Memphis, advised that information received from Sheriff Barksdale indicated that Wilson is known by FBI number 879 421 E, having last been arrested 3/1/76 on a theft charge. SAC Trimbach was advised that FBI Headquarters was in continual contact with DAAG Keuch and that Memphis Division should comply with the requests of DOJ.

At 2:40 p.m., ASAC Richard Blay, Memphis Division, advised that contact with Sheriff Barksdale disclosed that Sheriff Barksdale was unable to travel to Gulfport, Mississippi,

and meet with Wilson at this time since the potential for civil disorder and resultant demands on law enforcement in Memphis, Tennessee, were enormous. Sheriff Barksdale further advised that he has received numerous threats against his life in the recent past and he could not be certain that this was not an effort to place his life in jeopardy. ASAC Blay further advised that Sheriff Barksdale was amenable to any cooperative effort that might facilitate the FBI's location and interview of Wilson.

At 2:45 p.m., contact was had with Mr. Keuch and he concurred in an FBI effort to locate and interview Burgess A. Wilson in order to ascertain the facts of this matter.

At 2:50 p.m., ASAC Blay was advised to proceed with a course of action that would result in the location and interview of Burgess Wilson and further to coordinate all efforts with the Jackson Division.

INFORMATION IN BUREAU FILES

Based on information initially furnished, Burgess A. Wilson was not immediately identifiable in Bureau files. However, upon receipt of FBI Identification report, FBI number 879 421 E (copy attached), which showed that Burgess Audie Wilson had been arrested in San Antonio, Texas, and New Braunfels, Texas, it was then determined that he appears identical to Bureau document 89-2207-1 wherein, on 7/12/72, Burgess A. Wilson, New Braunfels, Texas, furnished information concerning an alleged threat made against Congressman Henry B. Gonzalez. Bureau document 65-65718-4 sets forth information received from the San Francisco Office in 1959 relating to a Staff Sergeant Burgess A. Wilson, Jr., who had furnished information concerning a possible espionage case. This information may or may not be identical to Burgess Audie Wilson.

CONSCIOUS OF EACH OTHER'S ACTIVITIES. HE IS POSITIVE HIS FATHER OBTAINED THE JAPANESE RIFLE FROM AN UNKNOWN SOURCE AFTER HE WAS IN THE MILITARY SERVICE, WHICH WOULD HAVE BEEN AFTER 1970. RECALLED HIS DAD SHOWING IT TO HIM WHEN HE CAME HOME ON MILITARY LEAVE. STEVEN NEVER FIRED THE WEAPON BECAUSE HE WAS AFRAID THAT IT WOULD NOT FUNCTION PROPERLY, AND SECONDLY, BECAUSE THEY NEVER HAD ANY AMMUNITION FOR THE RIFLE. HE PERSONALLY NEVER KNEW OF HIS DAD USING THE WEAPON. HIS DAD HAD THE STOCK OF THE WEAPON WORKED ON BY A FRIEND WHO WAS A FURNITURE REFINISHER IN CANYON LAKE, TEXAS, BUT THAT WAS THE ONLY WORK EVER DONE ON THE RIFLE. THE GUN WAS OF JAPANESE MANUFACTURER, AS IT HAD JAPANESE PRINTING ON ITS VARIOUS PARTS.

WILSON'S DAD GAVE THE GUN TO HIM WHILE HE WAS IN THE SERVICE, AND HE HOOKED THE RIFLE AT A PAWN SHOP IN SAN ANTONIO SOMETIME IN THE EARLY 1970'S, DATE UNRECALLED. HE HAS NO RECEIPT OR BILL OF LADING FOR THE RIFLE.

MARK WILSON, 514 SOUTHEAST GARDENS, BURLESON, TEXAS, CONTACTED AUGUST 21, 1978, AND ADVISED THE FOLLOWING:

HE PERSONALLY HAS NO KNOWLEDGE OF HIS FATHER'S WEAPONS, AS HE HAS NO INTEREST IN THEM. HIS DAD WAS DEFINITELY AT HOME IN GRANDVIEW, TEXAS, TAKING CARE OF HIMSELF AND HIS BROTHER AT THE TIME DR. KING WAS KILLED IN MEMPHIS. HIS DAD FLEW HIS PLANE, A BONANZA BEECH-CRAFT, USUALLY ON WEEKENDS, FROM A SMALL AIRFIELD NEAR TOWN. HE BELIEVED HIS DAD OWNED THE PLANE, HOWEVER, HE IS NOT POSITIVE. WILSON STATED HIS DAD WAS NOT AWAY FROM THE HOUSE ON THE DAY DR. KING WAS KILLED, AS HE WAS TAKING CARE OF HIS BROTHER AND HIMSELF AT THE TIME, WHILE HIS MOTHER AND SISTER FLEW TO MEMPHIS TO SEE THEIR GRANDPARENTS.

MRS. BETTY LOU WADE, 233 SMITH ROAD, BURLESON, TEXAS, RECONTACTED ON AUGUST 21, 1978, AND ADVISED THAT SHE HAD NO RECOLLECTION OF HER FORMER HUSBAND HAVING A JAPANESE RIFLE. SHE STATED SHE SEPARATED FROM BURGESS WILSON IN 1974, WHICH WOULD MEAN HE MOST PROBABLY OBTAINED THE RIFLE AFTER THAT PERIOD. SHE IS SURE SHE WOULD HAVE BEEN AWARE OF THE GUN, IF HE HAD BOUGHT IT

WILSON TOLD FORTNA THAT HE DROVE TO THE STATE LINE AIRPORT IN KANSAS CITY,

CRUZ CAME TO THE AIRPORT AND PICKED UP WILSON'S THUNDERBIRD AND TOOK IT FROM THE AIRPORT SO IT WOULD NOT BE NOTICED. WHEN WILSON ARRIVED IN MEMPHIS, HE BORROWED A WHITE FORD MUSTANG THAT HE HAD PURCHASED FOR HIS DAUGHTER, DEBORAH. DEBORAH HAD DRIVEN FROM KANSAS CITY TO MEMPHIS IN THE MUSTANG. WILSON TOLD FORTNA THAT HE WENT TO THE MOTEL WHERE MARTIN LUTHER KING WAS STAYING AND THAT HE USED A JAPANESE SNIPER RIFLE AND SHOT KING HOLDING THE RIFLE ON HIS HIP. HE STATED THAT THIS RIFLE IS NOW IN THE POSSESSION OF WILSON'S SON, STEVE. WILSON TOLD FORTNA THAT HE WAS DRIVING AWAY FROM THE SCENE IN THE MUSTANG, AND HE WAS STOPPED BY THE MEMPHIS POLICE, BUT HE TALKED HIMSELF OUT OF A TICKET, AND THE CAR WAS NOT SEARCHED. CUNNINGHAM stated the nature of this inquiry concerned whether or not motels were required to maintain records of registrations by name for a certain number of years in order to substantiate tax status. He stated this inquiry also was made to the National Hotel and Motel Association.

CUNNINGHAM pointed out that this inquiry would have to be replied to in the negative as he knows of no records a motel has to maintain for tax purposes in respect to individual registrations.

SUBJECT: MURKIN

PURPOSE: To advise of an allegation made by Burgess Audie Wilson, Jr., that he murdered Martin Luther King, Jr.

SYNOPSIS: This investigation concerning the Wilson allegation was conducted pursuant to the instructions of Deputy Assistant Attorney General Robert Keuch, Criminal Division. Wilson, white male, age 46, has made allegation that a "Mitch" Last Name Unknown (LNU), brought up the idea of killing King for \$50,000 contract. "Mitch" instructed Wilson to meet two white males at a Memphis bar. Wilson advised he flew to Memphis and daughter Deborah (also Debra) picked him up in her Mustang. Wilson advised the two white males furnished him with FBI credentials, and showed him where King was to hold the rally. They told him to be in the crowd at the rally and a decoy shot was to be fired and he was then to shoot. They said King had a habit of raising his arms over his head when he was making a speech and the second time he did so, the shots were to be fired. Wilson advised on day of murder, he was in crowd standing near a wood fence approximately 60 feet from where King was standing and that when King raised his arms the second time, he shot him. (It is noted King was shot as he exited his motel room and stood on a balcony, not while he was attending a rally giving a speech). Wilson advised he had the rifle strapped to his belt under a suit coat and attached to belt on a swivel. The barrel protruded from below coat, but no one questioned him about it. He stated after the shooting, he was stopped by the police, but he showed them the credentials and they let him go. He then walked down the street to where he left the Mustang parked. Debra Ann Jones, daughter, stated she definitely did not travel to Memphis in Mustang, and Wilson remained in Kansas City at time of King murder. She advised Wilson is intoxicated most of time and feels he definitely has mental problems. Other relatives also described his drinking problem.

DETAILS: This investigation concerning the allegation of Burgess Audie Wilson, Jr., was conducted pursuant to the instructions of Deputy Assistant Attorney General Robert Keuch, Criminal Division, on 8/18/78, and the House Select Committee on Assassinations (HSCA) was also advised of the initial developments of this allegation on 8/18/78 per the request of Mr. Keuch. Mr. Keuch also conferred with the Civil Rights Division.

On 8/18/78, Mr. William Don Gladden, owner of a gift shop, Ocean Springs, Mississippi, advised that Bill Wilson (Burgess Audie Wilson, Jr., white male, age 46), has been operating a watch repair business out of a room in Gladden's gift shop since July, 1978. Wilson told Gladden he had a drinking problem and was trying to establish himself and work hard in the watch repair business in hopes of getting over this problem.

Gladden advised that at 11:45 p.m., 8/17/78, Wilson telephonically contacted him at his residence saying he had to talk to Gladden and his wife about something that could not wait until the morning. Gladden met with Wilson at Gladden's gift shop at 12:15 a.m., 8/18/78.

Gladden advised Wilson apparently had been drinking inasmuch as his eyes were very red and he smelled of alcohol. Gladden advised he did not talk like an intoxicated person and in his opinion seemed to be very depressed. Wilson told Gladden that he was the man who murdered Martin Luther King. Wilson stated that he had once purchased a white Mustang for his daughter and his daughter had travelled in the white Mustang to Memphis at the time of the King killing. Wilson advised that he was in Memphis at that time but had documented himself to be in Kansas City as an alibi. Wilson stated he had talked with the sheriff at Memphis, Tennessee, and was to meet with this sheriff at the Gulfport, Mississippi, Holiday Inn during the morning of 8/18/78.

On 8/18/78, Wilson telephonically contacted the Memphis sheriff and stated he would appear at the Holiday Inn in Gulfport at about 6:30 p.m., on 8/18/78. The sheriff could not leave Memphis to meet with Wilson at the Holiday Inn.

Special Agents of the FBI contacted Wilson at the Holiday Inn on 8/18/78; however, he declined to discuss information regarding the assassination of Martin Luther King. The FBI subsequently received information from NCIC that Wilson was wanted by the New Braunfels, Texas, Police Department, for a probation violation on a warrant issued 4/18/78. This information was furnished to the Ocean Springs PD and Wilson was arrested by the Ocean Springs PD and incarcerated in the Ocean Springs Jail.

On 8/19/78, Wilson was interviewed by FBI Agents at the Ocean Springs Jail. He advised in the course of his jewelry business he met a white male Italian who introduced him to another white male Italian by the name of Mitch (LNU) and Mitch's brother. Mitch brought up the idea of killing King and said there was a \$50,000 contract on him. He never said who put out the contract but said he could get the money for Wilson if he killed King. Wilson advised that approximately 5 or 6 months before King's murder, he started gathering information on the movements and whereabouts of King and used to fly his own airplanes to different places where King was supposed to be. Mitch

furnished him with a Japanese sniper rifle and he had the rifle until just before Christmas of 1975 when he had it reworked at a gun shop. His son reportedly thereafter sold the rifle. Mitch called Wilson at his store in Grandview, Missouri, and told him King was going to Memphis. Wilson advised he flew to Memphis and was picked up at the airport by his daughter Deborah in her 1965 white Mustang. Deborah and her mother Betty Lou Wilson were staying at the residence of Wilson's father-in-law Vernon Hooton in Memphis. Mitch had instructed Wilson to meet two men at the Wonder Bar in Memphis and he met 2 males who furnished him with FBI credentials, which Wilson stated had a black and white photograph of Wilson on the credentials. These 2 men then took him and showed him where King was to hold the rally. They told him he was to be in the crowd at the rally and that a decoy shot was to be fired and that he was then to shoot King. They said King had a habit of raising his arms over his head when he was making a speech and the second time he did so the shots were to be fired. Wilson stated on the day of the murder he was in the crowd standing near a wood fence approximately 60 feet from where King was standing and when King raised his arms the second time, he shot him. (It is noted King was shot as he exited his motel room and stood on a balcony, not while he was attending a rally giving a speech.)

He advised he had the rifle which he used strapped to his belt under a suit coat and attached to his belt on a swivel. The barrel protruded from below his coat but no one questioned him concerning it. He said that he had practiced a great deal swivelling the rifle and firing it. He advised after the shooting, he was stopped by the Memphis Police but he showed them the credentials and they let him go. He walked on down the street to where he had left the Mustang parked. Wilson advised that approximately 1 week before the murder, Mitch gave him \$25,000 in \$20 bills and following the murder, Mitch gave him another \$25,000 at which time he gave the credentials back to Mitch.

Betty Lou Wade, ex-wife, stated she was married to Wilson on 4/4/68, and can positively state Wilson was at Grandview, Missouri, on 4/4/68, and could not have been in Memphis, Tennessee. She advised Wilson has experienced

mental problems for years and described him as a "liar and con artist who can't differentiate between truth and fantasy" and she said he definitely needs medical help. During recontact on 8/20/78, Wade advised the visit to Memphis by herself and daughter was several weeks after the King murder. She also advised Wilson had bought his daughter a cream colored Mustang but said he never drove on any trips to her knowledge.

On 8/18/78, Vernon and Opal Hooten, the former father-in-law and mother-in-law of Wilson, advised they are of the opinion the Mustang was never transported from Missouri to Memphis. On the night of 8/17/78, Wilson called Vernon Hooten and also his son James Hooten. While Wilson was talking with either James Hooten or his wife, he remarked he had killed King in 1968. James Hooten and his wife are of the opinion that Wilson was exaggerating and do not believe him regarding the King assassination. The Hootens described Wilson as a very heavy drinker; however, they pointed out that when drinking, he talked coherently and his movements do not give evidence he is intoxicated. Vernon Hooten believes Wilson would falsely confess to a crime in order to have a place to sleep and eat if he was in need of food and shelter. Opal Hooten was unable to provide specific dates when Betty Lou Wade and Debra Jones visited, but recalls they visited on occasions when both she and Mr. Wooten were ill.

On 8/18/78, James Hooten advised Wilson is an extremely heavy drinker and is of the opinion that Wilson had nothing to do with the assassination of King but due to the mental deterioration of his mind, may believe he did.

On 8/19/78, Allison T. Wilson, brother of Wilson, advised Wilson has been an alcoholic and is a confirmed liar. He stated his brother has often confessed to various crimes in order to be locked up so he will be able to get sober.

On 8/19/78, Mrs. Avis Hunter, ex-wife, advised she married Wilson in December of 1974 after going with him for only 5 weeks. She divorced Wilson in June, 1975. During the marriage Wilson drank frequently and would become crazy, rambling and silly, although never violent. He would frequently tell her "wild" untrue stories including that he was in the mafia. On 8/17/78, Wilson telephoned her residence and told her 14-year-old son that he, Wilson, would be on TV soon as he had killed King. Wilson, who was very drunk, said the FBI would arrest him soon. This was the first time Wilson ever mentioned the King murder to her.

On 8/20/78, Jo Ann Childress, ex-wife, advised she met Wilson in September of 1977; they were married in November of 1977; they separated in February of 1978; and the divorce was finalized in April of 1978. She advised Wilson is a "very convincing liar and con man."

On 8/19/78, Deborah (also Debra) Ann Jones, daughter, advised her father bought her a 1965 Mustang in 1968. She was in Memphis, Tennessee, with her mother visiting a grandfather at the time of King's murder. She and her mother flew from Kansas City to Memphis. Her father Wilson remained in Kansas City with her 2 brothers, Stephen and Mark Wilson, ages 14 and 10. She definitely did not travel to Memphis in the Mustang and the car was in very poor condition and could not make it to Memphis. While in Memphis, her mother called Kansas City at least 2 times and talked to her father. Wilson calls her frequently and on the night of 8/17/78, Wilson called her, was obviously intoxicated and told her the FBI was going to put him in jail for the murder of King. She advised her father definitely has mental problems.

On 8/20/78, Stephen Wayne Wilson advised he was 15 on 4/4/68, and recalled seeing King's death on TV at home in Grandview and his father Wilson was also with him at that time. He states there was no way his father could have killed King. He described his father as an alcoholic with serious mental problems and never heard his father make a statement he killed King.

Mark Anthony Wilson advised his father Wilson is a very sick man and possibly insane; feels his father could not have killed King since to the best of his recollection, Wilson was in Grandview on that date; describes father as habitual liar and alcoholic.

On 8/22/78, Mr. Keuch was advised of the information in this memorandum, and he requested that the HSCA also be advised, which was done on 8/22/78. Mr. Keuch was also advised that two copies of the reports from our field offices (one for his consideration for referral to the HSCA) would promptly be furnished to him which he stated was sufficient.

On 8/22/78, William L. Gardner, Chief, Criminal Section, Civil Rights Division, was also advised of the information in this memorandum and that copies of our field office reports would follow which he stated was sufficient.

Investigation is continuing to further resolve this allegation.

WILSON STATED THAT HE GREW UP IN GRENADA, MS., WHERE HIS FATHER WAS A BAPTIST MINISTER. GLADDEN RECALLED THAT HE (GLADDEN) HAD ONCE PURCHASED A USED MUSTANG FOR HIS DAUGHTER. ON SEEING THE VEHICLE WILSON REMARKED HE HAD ONCE PURCHASED A WHITE MUSTANG FOR HIS DAUGHTER.

DURING THE CONVERSATION ON THE EARLY MORNING OF 8/18/78, WILSON STATED THAT HIS DAUGHTER HAD DRIVEN THE WHITE MUSTANG TO MEMPHIS AT THE TIME OF THE KING KILLING. WILSON COMMENTED THAT HE WAS IN MEMPHIS AT THAT TIME, BUT HAD DOCUMENTED HIMSELF TO BE IN KANSAS CITY AS AN ALIBI. WILSON STATED THAT JAMES EARL RAY WAS THE "FALL GUY." "RAY ONLY SAW ME TWICE, BUT I KNEW HIM. RAY WAS SUPPOSED TO HAVE GOTTEN AWAY CLEAN. I'M SURPRISED RAY HAS BROUGHT IT ALL BACK UP AGAIN BECAUSE HE WOULD HAVE HIS PAROLE IN TWO YEARS."

WILSON TOLD THE GLADDENS THAT HE WOULD NOT SEE THEM ANYMORE AFTER TONIGHT AND HE WANTED THEM TO HAVE ALL HIS EXPENSIVE WATCH REPAIR EQUIPMENT.

WILSON, AGAIN REFERRING TO THE KING ASSASSINATION, STATED, "IT WAS PART OF A GROUP CONSPIRACY." HE PROVIDED NO FURTHER DETAILS STATING HE WOULD ONLY DEAL WITH THE
