ZAMMAR REFUSED TO GIVE THE YEARS THAT HIS BROTHERS DIED INDICATING THAT THE INFORMATION IS IRRELEVANT. ZAMMAR SAID THAT HE REFUSES TO ANSWER ANY MORE QUESTIONS REGARDING THIS MATTER.

IT WAS STATED IN A PREVIOUS TELETYPE THAT ZAMMAR HAD A TOTAL OF FOUR BROTHERS IN THAT MITCH WAS THE FIFTH BROTHER. WHEN MITCH SAID PREVIOUSLY THAT THERE WAS A TOTAL OF FIVE BROTHERS IT WAS UNDERSTOOD THAT HE WAS INCLUDED IN THE FIVE BECAUSE HE ONLY NAMED FOUR BROTHERS.

REVIEW OF THE FAA RECORDS ON SEPTEMBER 1, 1978, BY THE OKLAHOMA CITY OFFICE IT IS NOTED THAT FISCHER'S SALES AND SERVICE, INC., PURCHASED A PLANE FROM A CONNIE C. MILLER OF 9618 SAGAMORE, KANSAS CITY, MISSOURI, ON MAY 27, 1968. FISCHER'S SALES AND SERVICE THEN SOLD THE AIRCRAFT TO WILSON AND LOU CREWS, 553 NORTH SCOTT, BELTON, MISSOURI, ON JUNE 6, 1968.

DON FISCHER, FISCHER'S SALES AND SERVICE, INC., BOX 6516, LEAWOOD, KANSAS, WAS REINTERVIEWED ON AUGUST 31, 1978. FISCHER INDICATED THAT WILSON WOULD HAVE HAD ACCESS TO THE PLANE PRIOR

TO WILSON'S PURCHASE ON JUNE 6, 1968, BECAUSE FISCHER RENTED THE PLANE TO WILSON ON NUMEROUS OCCASIONS. FISCHER ALSO SAID THAT WILSON WOULD NOT HAVE HAD ACCESS TO THE PLANE WHEN C. C. MILLER WAS THE OWNER BECAUSE MILLER NEVER RENTED THE PLANE TO ANYONE.

FISCHER SAID THAT WILSON PAID FOR THE RENTAL OF THE PLANE THROUGH THE GI PROGRAM. FISCHER SAID THE VETERANS ADMINISTRATION PAID 90 PERCENT OF THE RENTAL. FISCHER SAID THAT IN ORDER TO GET PAID HE WOULD HAVE TO SEND THE FLIGHT TIMES FOR A PARTICULAR MONTH TO THE VETERANS ADMINISTRATION IN WICHITA AND THEY IN TURN WOULD SEND A CHECK BACK DIRECTLY TO FISCHER. FISCHER SAID THEN HE HAD WILSON SIGN THE CHECK OVER TO HIM.

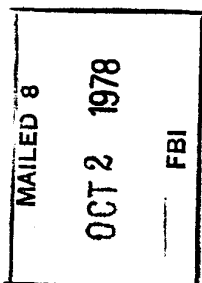

BY A LONG-TIME ACQUAINTANCE OF HIS WHO ATTENDED CHURCH WHICH WAS PASTORED BY WILSON'S FATHER IN THE PAST. WILSON WAS PICKED UP AT THE AIRPORT BY HIS DAUGHTER, DEBRA, IN HER 1965 WHITE MUSTANG, WHICH WILSON HAD PREVIOUSLY BOUGHT FOR HER. AFTER WILSON ALLEGEDLY SHOT DR. KING, HE WAS RETURNED TO THE AIRPORT BY DEBRA, AGE APPROXIMATELY 18, AND HE FLEW THE BONANZA BACK TO KANSAS CITY, LAND ING AT AN AIRPORT LOCATED IN KANSAS ON THE HIGHWAY TO OLATHE, KANSAS. THIS AIRPORT WAS OPERATED BY (FNU) FISHER FROM WHOM WILSON HAD PURCHASED THE BONANZA AIRCRAFT.

ON AUG. 21, 1978, NINA SORRELL, WHO IS EMPLOYED AT THE BAPTIST HOSPITAL, MEMPHIS, ADVISED HER FORMER HUSBAND WAS FORMERLY ASSISTANT MANAGER OF THE CHARLES BAKER AIRPORT, MEMPHIS, AND ATTENDED CHURCH IN MEMPHIS PASTORED BY BURGESS WILSON, SR., AND IS ACQUAINTED WITH BURGESS AUDIE WILSON, JR. BOB SORRELL IS CURRENTLY EMPLOYED BY SWISS CHEMICALS, P. O. BOX 2175, BEAUMONT, TEXAS. HE RESIDES AT KUNTZE, TEXAS, IN A TRAILER PARK. HIS CURRENT RESIDENCE ADDRESS IS NOT IMMEDIATELY AVAILABLE.

INTERVIEWING AGENTS THAT HE HAD SHOT AND KILLED MARTIN LUTHER KING IN MEMPHIS, TENNESSEE. AMONG OTHER INFORMATION WHICH WILSON FURNISHED TO THE INTERVIEWING AGENTS, WILSON ADVISED THAT DURING THE PERIOD IN WHICH HE SHOT AND KILLED KING HE RESIDED AT 13125 HERRICK AVENUE, GRANDVIEW, MISSOURI, AND THAT HE WAS AT THAT TIME IN THE AIR FORCE RESERVES, RICHARDS GEBEUR AFB, EMPLOYED AS A CIVIL SERVICE EMPLOYEE.

WILSON ALSO STATED THAT AT THE TIME OF KING'S DEATH, HE HAD OWNED A RED AND WHITE BONANZA AIRPLANE, REGISTRY NUMBER 34L, AND A CESSNA 310 TWIN-ENGINE BLUE AND WHITE AIRCRAFT. WILSON PROVIDED THE IDENTITY OF THE INDIVIDUAL FROM WHOM HE HAD PURCHASED ONE OF THESE PLANES, THE BONANZA, AS BEING (FNU) FISHER.

INVESTIGATION AT KANSAS CITY DIVISION REGARDING THESE PERTINENT BITS OF INFORMATION FURNISHED BY WILSON HAS YIELDED THE FOLLOWING INFORMATION:

IN REVIEW OF THE 1969 COLE'S DIRECTORY, KANSAS CITY, DISCLOSED THAT WILSON WAS SUBSCRIBER TO PHONE NUMBER SO 1-6526 AT 13125 HERRICK AVENUE, GRANDVIEW, MISSOURI.

INDICES, COMPUTER CRIMINAL HISTORY, AND THE LOCAL CRIMINAL HISTORY WERE CHECKED WITH NEGATIVE RESULTS. FURTHER INVESTIGATION WITH THE GRANDVIEW POLICE DEPARTMENT INDICATED THAT THE ONLY RECORD, CRIMINAL, TRAFFIC, OR MISCELLANEOUS, THAT WILSON HAD WAS A VIOLATION ON 8/9/69 FOR NOT DISPLAYING A CITY STICKER. WILSON PAID THE FINE ON 8/26/69.

DON FISHER, FISHER SALES AND SERVICES, LEAWOOD, KANSAS, WAS CONTACTED AND INDICATED HE BOUGHT THE STATE LINE AIRPORT, LEAWOOD, KANSAS, IN 1964. FISHER REMEMBERS THE SALE OF A MODEL G, NUMBER 56 BONANZA TO WILSON. HE SAID HE DOES NOT REMEMBER THE PARTICULAR DATE. HE SAID HE REMEMBERS THE SALE BECAUSE HE PURCHASED THE PLANE FROM A C.C. MILLER, A RETIRED EXECUTIVE WITH WESTERN AUTO PARTS. HE SAID MILLER BASED THE PLANE AT STATE LINE AIRPORT UNTIL HE BOUGHT THE PLANE FROM MILLER. HE SAID HE THEN SOLD THE PLANE TO WILSON. FISHER SAID ALL THE RECORDS PERTAINING TO THIS PURCHASE WERE DESTROYED IN A FIRE LAST YEAR. FISHER THINKS THAT WILSON

PURPOSE: To advise of status of investigation pertaining to allegation made by Burgess Audie Wilson, Jr., in August, 1978, that he murdered Martin Luther King, Jr.

SYNOPSIS: Wilson said he shot King in a crowd at a rally when King raised arms during a speech. (It is noted King was shot as he exited his motel room and stood on a balcony, not while attending a rally giving a speech.) Relatives stated Wilson in Grandview, Missouri, at time of King assassination. Relatives also state Wilson had drinking and mental problems. Subsequent investigation revealed Wilson did not have access to the aircraft he claimed to have used at time of King assassination. He also claimed he drove a new Thunderbird to the airport, but records reveal he purchased 1968 Thunderbird in October, 1968. (King assassinated 4/4/68.) On 9/18/78, Deputy Assistant Attorney General Robert L. Keuch advised no further investigation re Wilson allegation is necessary; and pursuant to his authority, copies of our investigative reports are being made available for access to the House Select Committee on Assassinations.

DETAILS: By J. S. Peelman to Mr. Moore memorandum, dated 8/22/78, you were advised of an investigation conducted pursuant to the instructions of Deputy Assistant Attorney General Robert L. Keuch, Criminal Division, re allegation made in August, 1978, by Burgess Audie Wilson, Jr., that he had assassinated Martin Luther King, Jr., in Memphis, Tennessee, on 4/4/68. Wilson told Bureau Agents he shot King using a rifle on a swivel while in a crowd at a rally when King raised his arms during a speech. (It is noted King was shot as he exited his motel room and stood on a balcony, not while attending a rally giving a speech.) Wilson's ex-wife, daughter, two sons and a brother stated Wilson was in Grandview, Missouri, at time of King assassination. Relatives also stated Wilson has drinking and mental problems.

Subsequent extensive investigation has been conducted to further resolve this allegation. Wilson claimed he flew from Grandview to Memphis in a Bonanza Aircraft. Ownership of this Bonanza Aircraft was traced which revealed Wilson did own this aircraft in 1968, but did not have access to this aircraft until after 5/27/68. (King assassinated 4/4/68.) Federal Aviation Administration records revealed C. C. Miller owned the aircraft from 4/18/60 - 5/27/68. Miller was interviewed and advised he never rented or leased the plane to anyone to fly the plane while he owned it. Miller also said that he was sure nobody flew the plane without his knowledge because of a recording tachometer off of which he logged his flight hours. He said that if somebody had flown the plane, he would have known about it because the distance from Kansas City (Grandview area) to Memphis and back is far enough that he would have noticed a discrepancy in his log book when he recorded the flight hours off the tachometer.

Wilson also claimed to an associate that he drove to the airport in Missouri, prior to his flight to Memphis, in a new Ford Thunderbird. Loan records,

Johnson County Bank, Kansas, revealed Wilson purchased a 1968 Ford Thunderbird on 10/9/68. (King was assassinated on 4/4/68.)

On 9/18/78, Mr. Keuch advised that no further investigation re this Wilson allegation is necessary. Mr. Keuch has been furnished copies of our investigative reports re this Wilson allegation, and pursuant to his authority, copies of these reports are being made available for access to the House Select Committee on Assassinations.

Original interview of ELAINE DUNKELBERGER was based upon the request of Officer GARY GOAD, Flint Police Department, Flint, Michigan, a personal acquaintance of DUNKELBERGER. Officer GOAD advised that DUNKELBERGER had been reluctant to contact the FBI because she was fearful her information would be considered a hoax.

ELAINE DUNKELBERGER is a white female, age 50's, husband HAROLD F. DUNKELBERGER, G-9103 Fenton Road, Grand Blanc Township, Michigan. DUNKELBERGER advised that she obtained a B.A. Degree in English from West Liberty State College, West Virginia, in 1944, and a M.A. Degree in Library Science from the University of Michigan in 1961.

DUNKELBERGER displayed a strong anti-communist attitude during the interview, but showed a sincere disposition in explaining her thoughts regarding ANDREW R. L. MC NAUGHTON as possibly identifiable with RAJOL. DUNKELBERGER also suggested

On September 14, 1978, Elaine Dunkelberger, Grand Blanc Township, Michigan, was interviewed by a Special Agent of the Federal Bureau of Investigation (FBI) concerning possible information with regard to the identity of an individual named Rauol, referred to by James Earl Ray in Ray's testimony before the U.S. Congressional Assassination Committee. Dunkelberger is employed as a librarian in the Flushing School System, Flushing, Michigan, and has a Masters Degree in Library Science.

Dunkelberger stated that she began a study for the cure of cancer around 1960 that led her to considerable research concerning the drug laetrile. Dunkelberger advised that prior to the recent hearings with regard to the assassinations of Dr. Martin Luther King, Jr. and President John F. Kennedy, that she had never associated these assassinations with her study of laetrile. Dunkelberger stated that when James Earl Ray made referrals to Rauol in his testimony and began to set forth the background of Rauol, that this background closely paralleled that of an Andrew R.L. McNaughton, a well known advocate of the drug laetrile. Dunkelberger advised that in Ray's testimony, he described Rauol as being a gun runner and engaged in drug operations across the Mexican border. Dunkelberger further advised that Ray claimed that he met Rauol originally in Canada and later in California in 1968 before the assassination of Dr. King. Dunkelberger stated that the background of McNaughton closely fits that of Rauol and in her opinion makes him a person possibly identifiable with Rauol, and possesses the potential to organize and carry out an assassination.

1. An article which appeared in a magazine entitled, "Laetrile" published by DMR Publications, Milwaukee, Wisconsin, in 1977, provided a profile of Andrew R.L. McNaughton. (Photograph of McNaughton and excerpts from the article are attached.)

The article described McNaughton as a 60 year old Canadian and a well known advocate of laetrile that created the non-profit McNaughton Foundation that specializes in independent research and is particularly interested in scientists who are unable to get backing from orthodox research organizations. The article stated that McNaughton was also known for his unusual background and frequent run-ins with the law.

McNaughton was described as acting as a gun runner to guerrilla forces in Israel, Cuba and other Latin American countries and had been linked to a member of the Mafia. The article also cited a 1972 conviction for McNaughton for conspiracy to manipulate Pan American mining stocks and advised that the U.S. Government had been seeking to bar McNaughton from the United States as an undesirable alien. The article concluded stating that McNaughton had been living in Tijuana for the last six years promoting a chain of American laetrile clinics and manufacturing plants.

2. In a book entitled, "The Amazing Story of Laetrile" by Michael L. Culbert, 1976, Chapter 12, "Andrew McNaughton: Pioneer of the Human Spirit", sets forth further information regarding McNaughton. The chapter makes referrals to McNaughton as a double agent and arms supplier for the Batista Government, while diverting the same to Castro as an undercover member of the July 16 Movement. The chapter also stated that McNaughton was born in England and was the son of General A.G.L. McNaughton, a former commander of the Canadian Armed Forces and past president of the United Nations Security Council. A quote of McNaughton also appears in the chapter in reference to his memoirs of a double agent and supporter of Castro and is as follows:

"I believe it is the duty of us all to stand up to dictatorship. It is our duty, but it is not an opportunity that is given to every man. When it is given, as it was to me, what ought a man to do? Mind his business (or) do what he can so that one segment of humanity can taste freedom? I chose the latter course and this would always be my choice."

3. In a book entitled, "In His Image - The Cloning of Man", a book by David M. Rorvik, 1978, an acknowledgment was made to McNaughton in the introduction of the book. The book pertains to an elderly, wealthy individual named "Max", who desired to clone one of his cells into a young female to produce an offspring. Dunkelberger advised that she believed that "Max" in this book is in actuality a reference to McNaughton.

Another section of the book also makes reference to the proposed cloning of the dead. Dunkelberger stated that the lack of accountability concerning the brain of President Kennedy since his assassination, as brought forth in recent news accounts, leads her to believe that McNaughton and his associates would have possibly been involved in the assassination of President Kennedy.

4. Dunkelberger advised that based on her studies that she considered McNaughton to be of very high intelligence and possibly suffering from megalomania.

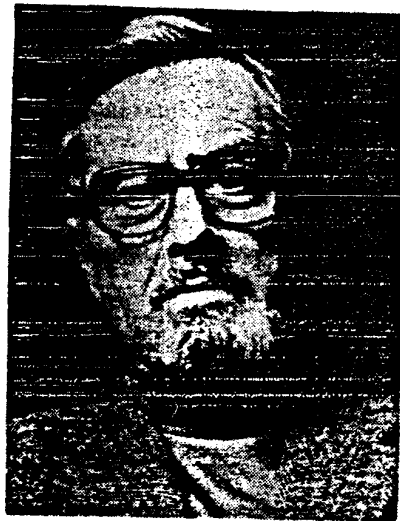
Dunkelberger stated that McNaughton could have disliked Dr. King for his stance on passive resistance in dealing with the problems of the black people. Dunkelberger further advised that a possible motive of McNaughton's in the Kennedy assassination would have been the Bay of Pigs incident.

Dunkelberger also cited testimony of Ray as meeting Rauol originally in Canada and again in California during 1968 and of Ray being arrested in London. Dunkelberger stated that McNaughton was born in England, had lived and was educated in Canada and had the McNaughton Foundation centered in California. Dunkelberger felt the testimony of Ray and the correlation regarding the background of McNaughton to be significant in showing a possible connection between Rauol and McNaughton.

Dunkelberger advised that she realized her thoughts with regard to McNaughton seemed to be far fetched and complex, but felt it was her duty to make her thoughts known.

Dunkelberger during the interview set forth her thoughts in much greater detail and dealt in more complex terminology. Dunkelberger stated that she would be willing to more fully elaborate on her thoughts if requested to do so in the future.

The following are excerpts taken from an article which appeared in a magazine entitled, "Laetrile" published by DMR Publications, Milwaukee, Wisconsin, in 1977, providing a profile of Andrew R.L. McNaughton:

"Sixty year old Canadian Andrew McNaughton is one of the most well known and publicized advocates of Laetrile. He is known for his somewhat unusual background and frequent run-ins with the law. In the past, McNaughton has undertaken Jesuit classical studies, engineering and geology, served as chief test pilot for the Royal Canadian Air Force, been a stockbroker and has acted as a gunrunner to guerilla forces in Israel, Cuba and other Latin American countries. McNaughton has also been in the news for his alleged link to a member of the Mafia, who donated \$130,000 to the McNaughton Foundation after Laetrile purportedly saved the life of his sister. McNaughton was convicted in 1972 for conspiracy to manipulate Pan American mining stocks. After his appeal, the sentence was reduced to one day in jail and a \$10,000 fine. Since that time, the U.S. Government has been seeking an order barring McNaughton from the U.S. as an undesirable alien.

"McNaughton has been responsible for producing much of the contraband Laetrile being "smuggled" across the border, in Cyto-Pharma, a Laetrile manufacturing plant. The plant's operation began in 1971 and has a monthly capacity of 3,000 pounds of amygdalin.

"Andrew McNaughton created the non-profit McNaughton Foundation which specializes in independent research. They are particularly interested in scientists who are unable to get backing from orthodox research organizations. Laetrile first came to the attention of the Foundation after McNaughton met with Ernst Krebs, Jr. late in 1958. McNaughton circulated Krebs's theory among scientists, who agreed that it was worth further study. McNaughton obtained permission for a Canadian investigation of Laetrile under the McNaughton Foundation's sponsorship. Since that time McNaughton has been among the most active proponents of the use of Laetrile and is convinced of its efficacy:

"The evidence accumulated by our medical advisors convinces us that if Laetrile is used in early cancers there need not be terminal cases. And when proper diagnosis is available to identify cancer in its pre-tumor, pre-clinical stages, we can confidently expect that Laetrile will remove even the dread of early cancers from our lives."

"The Foundation first operated in Montreal, then moved to Sausalito until 1971 when California authorities started prosecuting clandestine laboratories. The Foundation moved to Tijuana, Mexico, where it is now located.

"As evidenced by McNaughton's background, it is apparent that the unorthodox and the unconventional are his guiding lights. Once the subject of Laetrile was introduced, it is consistent that McNaughton should ally himself against the FDA and other government agencies which epitomize orthodoxy and conventionalism, particularly after his attempts to follow the conventional route of an FDA new drug researching, (IND), was frustrated. McNaughton says:

"The real quacks are those who pretend to knowledge they don't have about Laetrile, and condemn it without knowledge. We have many patients who say Laetrile has cured their cancer. We don't agree - we never say it cures. At best, we say it will eliminate a tumor."

"McNaughton has been living in Tijuana for the last six years. He is currently promoting a chain of American Laetrile clinics and manufacturing plants. And he hopes to train doctors and chemists to operate the proposed U.S. plants and clinics.

ON SEPTEMBER 14, 1978, ELAINE DUNKELBERGER, G 9103 FENTON ROAD, GRAND BLANC TOWNSHIP, MICHIGAN, WAS CONTACTED BY AN AGENT OF THE FBI AND ADVISED THAT THROUGH HER RESEARCH WITH REGARDS TO A CURE FOR CANCER, SHE MAY HAVE DISCOVERED THE IDENTITY OF RAOUL, REVEALED BY JAMES EARL RAY. DUNKELBERGER STATED THAT SHE WAS EMPLOYED AS A LIBRARIAN FOR THE FLUSHING SCHOOL SYSTEM, FLUSHING, MICHIGAN, AND HAS RECEIVED AN UNDERGRADUATE DEGREE IN ENGLISH AND A MASTER'S DEGREE IN LIBRARY SCIENCE.

DUNKELBERGER STATED THAT SHE BEGAN A STUDY OF CANCER ABOUT 1960 AND HAS DONE CONSIDERABLE RESEARCH CONCERNING LAETRILE.

DUNKELBERGER ADVISED THAT SHE HAD PREVIOUSLY NEVER ASSOCIATED THE ASSASSINATION OF MARTIN LUTHER KING TO HER STUDY OF CANCER UNTIL JAMES EARL RAY TESTIFIED BEFORE THE CONGRESSIONAL ASSASSINATION COMMITTEE AND REFERRED TO A MAN NAMED RAOUL. DUNKELBERGER STATED THAT RAY'S STATEMENTS WITH REGARD TO HAVING MET RAOUL IN CANADA AND OF HIS GUNRUNNING AND DRUG OPERATIONS ACROSS THE MEXICAN BORDER CLOSELY FIT THE BACKGROUND OF A ANDREW R. L. MC NAUGHTON, A WELL KNOWN AND PUBLISHING ADVOCATE OF LAETRILE.

DUNKELBERGER PRODUCED AN ARTICLE FROM A MAGAZINE ENTITLED LAETRILE - SPECIAL REPORT, 1977, THAT SET FORTH A BRIEF BACKGROUND OF MC NAUGHTON. THE ARTICLE DESCRIBED MC NAUGHTON AS A 60 YEAR OLD CANADIAN, BORN IN ENGLAND, THAT HAD FOUNDED THE MC NAUGHTON FOUNDATION, WHICH SPECIALIZED IN INDEPENDENT RESEARCH PARTICULARLY FOR SCIENTISTS UNABLE TO GAIN FINANCIAL SUPPORT FROM ORTHODOX RESEARCH ASSOCIATIONS. THE ARTICLE DEPICTED MC NAUGHTON AS A WEALTHY, WELL EDUCATED CANADIAN THAT HAS ACTED AS A GUNRUNNER FOR GORILLA FORCES IN ISREAL, CUBA AND OTHER LATIN AMERICAN COUNTRIES AND HAS ENGAGED IN THE SMUGGLING OF LAETRILE FROM MEXICO INTO THE UNITED STATES. THE ARTICLE ALSO STATED THAT MC NAUGHTON HAD HAD VARIOUS ENCOUNTERS REGARDING

CRIMINAL ACTIVITIES AND AS A RESULT OF A 1972 CONVICTION FOR THE MANIPULATION OF PAN AMERICAN MINING STOCKS, THE UNITED STATES GOVERNMENT HAD BEEN SEEKING AN ORDER BARRING FROM THE UNITED STATES AS AN UNDESIRABLE ALIEN. THE ARTICLE FURTHER STATED THAT MC NAUGHTON HAD BEEN LIVING IN TIJUANA FOR THE LAST SIX YEARS PROMOTING A CHAIN OF AMERICAN LAETRILE CLINICS AND MANUFACTURING PLANTS.

DUNKELBERGER ADVISED THAT MC NAUGHTON WAS ORIGINALLY BORN IN LONDON WHERE JAMES EARL RAY WAS FINALLY ARRESTED AND HAS TRAVELED EXTENSIVELY THROUGHOUT THE WORLD. DUNKELBERGER STATED THAT RAY'S ACCOUNT OF MEETING RAOUL IN MONTREAL AND HIS STATEMENTS REGARDING THE ACTIVITY OF RAOUL CLOSELY PARALLEL THAT OF MC NAUGHTON. DUNKELBERGER FURTHER ADVISED THAT SHE FELT MC NAUGHTON POSSESSED A VERY HIGH DEGREE OF INTELLIGENCE AND WITH HIS WEALTH WOULD RENDER HIM CAPABLE OF ORGANIZING AND CARRYING OUT AN ASSASSINATION.

DUNKELBERGER STATED THAT HER STUDIES REVEALED MC NAUGHTON WAS A DOUBLE AGENT AND SUPPORTER OF CASTRO IN CUBA AND FOR THAT REASON, HE MAY HAVE HAD A DISLIKE FOR KING BECAUSE OF HIS STANCE ON PASSIVE RESISTANCE IN DEALING WITH THE PROBLEMS OF

DUNKELBERGER ALSO MADE REFERENCE TO A BOOK ENTITLED IN HIS IMAGE - THE CLONING OF MAN, BY DAVID M. RORVIK, AND STATED THAT SHE BELIEVED THAT "MAX", A WEALTHY MAN REFERRED TO IN THE BOOK, WAS A PORTRATE OF MC NAUGHTON. DUNKELBERGER WAS ACKNOWLEDGED BY RORVIK IN THE INTRODUCTION OF THE BOOK AND BOTH WERE CLOSE ASSOCIATES. DUNKELBERGER CITED A PASSAGE IN THE BOOK THAT MADE REFERENCE TO THE CLONING OF THE DEAD AND RELATED THIS PASSAGE TO RECENT ARTICLES REPORTING THE LACK OF ACCOUNTABILITY FOR THE BRAIN OF PRESIDENT KENNEDY AFTER HIS ASSASSINATION.

DUNKELBERGER ADVISED THAT SHE WAS ORIGINALLY VERY RELUCTANT TO MAKE KNOWN HER THOUGHTS REGARDING MC NAUGHTON TO THE FBI, BUT FELT THAT IT WAS HER DUTY TO MAKE KNOWN HER FINDINGS. DUNKELBERGER FURTHER STATED THAT SHE REALIZED HER THEORY WITH REGARDS TO MC NAUGHTON'S POSSIBLE INVOLVEMENT IN THE ASSASSINATION OF KING AND PRESIDENT KENNEDY WAS FAR-FETCHED AND VERY COMPLEXED, BUT ADVISED THAT SHE WOULD BE WILLING TO SET FORTH AND DISCUSS HER ENTIRE FINDINGS IF REQUESTED TO DO SO.

ELAINE DUNKELBERGER, WHITE FEMALE, AGE 50'S, ORIGINALLY CONTACTED AN OFFICER OF THE FLINT POLICE DEPARTMENT, FLINT, MICHIGAN, REGARDING HER FINDINGS. THIS OFFICER THEN REQUESTED THAT A FBI AGENT CONTACT DUNKELBERGER REGARDING HER FINDINGS. DUNKELBERGER DISPLAYED A STRONG ANTI-COMMUNIST ATTITUDE DURING THE INTERVIEW, BUT DISPLAYED A SINCERE DISPOSITION IN EXPLAINING HER PREMISE THAT MC NAUGHTON WAS POSSIBLY IDENTIFIABLE WITH RAOUL. DUNKELBERGER ALSO SUGGESTED THAT A PHOTO SPREAD CONTAINING A PHOTO OF MC NAUGHTON BE DISPLAYED TO JAMES EARL RAY.

All describe BURGESS AUDIE WILSON as a liar and conman who has serious mental problems. None have ever heard him make allegation that he killed MARTIN LUTHER KING, JR. STEPHEN WILSON confirms his father gave him a Japanese rifle which he pawned in San Antonio.

BETTY LOU WADE, 233 Smith Street, Burleson, Texas, telephone number 817/295-2200, furnished the following information:

She is the ex-wife of BURGESS AUDIE WILSON. She has been divorced from WILSON for approximately five years. She was married to WILSON on April 4, 1968. At that time, they were residing at an unrecalled address on Herrick Street in Grandview, Missouri, and WILSON had a jewelry business at the Katz Drugstore in Grandview, Missouri. She said the business, known as Wilbur's Jewelers, was subsequently moved to Belton, Missouri, where it was located in a small shopping center.

WADE said she could positively state that WILSON was in Grandview, Missouri at the time Dr. MARTIN LUTHER KING, JR. was shot.

WADE advised that WILSON has had serious mental problems for years, but he declines to seek treatment. She said WILSON has made threatening and harassing telephone calls to her on numerous occasions over the past five years, and her son, MARK WILSON, had his father arrested at Cleburne, Texas, two years ago as a result of one of these calls and due to non-child support. WADE described her ex-husband as a liar and con-artist with serious mental problems. She said he cannot differentiate between the truth and fantasy, and that he lives in a dream world most of the time. She felt he needs medical attention.

WADE said the following relatives of WILSON could substantiate her evaluation:
